PROFESSIONAL LICENSURE.

DIGGORY GEORGE BAILEY INTRODUCED

The SPEAKER. To the left of the Speaker, we have a special guest, Mr. Diggory George Bailey. He is an attorney who drafts legislation for the United Kingdom Parliamentary Counsel Office.

Mr. Bailey was called to the bar of England and Wales in 2000. After qualifying, he spent a year working as a research assistant to the Law Commission of England and Wales. The commission is a statutory body whose function is to keep the law under review and recommend reform where it is needed.

In 2002 he joined the Parliamentary Counsel Office. That office is comprised of about 60 attorneys who are responsible for drafting primary legislation on behalf of the United Kingdom government and also advises government on procedural matters relating to the passage of bills through Parliament.

Currently Mr. Bailey is in Washington, DC, as part of a 6-month fellowship with the Legislative Counsel of the United States House of Representatives. He is visiting Pennsylvania this week to gain firsthand knowledge of how laws are made in Pennsylvania, and I hope all of you will join me in giving Mr. Bailey a warm House welcome and also making yourselves available to answer any questions he may have.

LEHIGHTON HIGH SCHOOL FIELD HOCKEY TEAM PRESENTED

I have 25 outstanding student athletes here from the heart of Carbon County. They are joined by coaches and administrators who also should be commended for their dedication to helping student athletes excel not just on the playing field but for the rest of their lives.

They are also joined by their proud parents who are in the back of the hall with their other teammates, and those parents have also sacrificed and helped to mold these student athletes for the success that they have experienced on the field and off the field.

These 25 young women have reached the absolute pinnacle of Pennsylvania scholastic sport, and it was not easy. In 2006, 2007, and 2008 they worked hard and practiced just as diligently, but they watched another team take home the State title. The fact of the matter is, they did not quit. They just worked harder and became a closer-knit team, and this year has made all the difference.

This year this team had no defeats. The team charged to a perfect 26-and-0 record and was named "The Best Field Hockey Team in America" – let me repeat that – was named "The Best Field Hockey Team in America." They ended their season with six straight shutout wins and defeated Selinsgrove 1 to nothing to bring the State championship home to Lehighton, Pennsylvania.

For the seniors here, this is the end of their school careers that began back in their junior high days, but what careers. Over the last 4 years the team has earned three Mountain Valley Conference titles, three District 11 titles, and posted an unbelievable record of 88 wins, with only 8 losses and 1 tie.

The seniors, joining head coach Shawn Hindy who is here to my left, are National All-American Corrine McConville, Abby Frey, Vanessa Rimbey, Sarah Snyder, Katrina Reppert – Katrina was in an accident on the way down here, but she looks pretty good for all the wear – Tiffany Harleman, and Kelcie Smith. They are leaving behind teammates, seated at the rear of the House, who are ready to build on the legacy, I know. They always do Carbon County proud.

Please join me in celebrating the 2009 State champions, PIAA Field Hockey State Champion Lehighton Lady Indians. Congratulations, ladies.

RESOLUTIONS PURSUANT TO RULE 35

Mr. KRIEGER called up HR 546, PN 2942, entitled:

A Resolution honoring the Lost Boys of Sudan for their tireless courage and pioneering efforts in raising awareness and working toward ending 21st century slavery in their homeland of Sudan and around the world.

On the question, Will the House adopt the resolution?

The SPEAKER. On that question, the Chair recognizes the gentleman from Westmoreland County, Representative Krieger. Mr. KRIEGER. Thank you, Mr. Speaker.

Today I have the privilege, along with Representative Youngblood, to sponsor a resolution recognizing the extraordinary group of individuals collectively known as the Lost Boys of Sudan, who can truly attest that freedom is never free. Each of these courageous men risked their lives time and time again to earn their freedom.

Named by international aid workers after the fictional characters in "Peter Pan," the Lost Boys of Sudan were forced to flee their homes as children after witnessing the murder of their parents, the destruction of their villages, and the capture and sale of their family members into slavery by their government and other Islamic forces during the second Sudanese civil war between 1983 and 2005.

Orphaned with no support, many as young as 5 years old, the Lost Boys of Sudan walked thousands of miles in large groups for approximately 3 months before finally reaching the safety of a refugee camp in Ethiopia. Many of them died along the way due to starvation, disease, and wild animal attacks. Four years later the Lost Boys were uprooted once again due to civil war in Ethiopia and had no choice but to flee back to the war-torn country of Sudan. Many died on that journey as well when they crossed the deadly Gilo River. Those unable to swim were swept away in turbulent currents. Still others were eaten by crocodiles, attacked by hippos, or fell prey to enemy gunfire. The survivors remained in the bush of Sudan, hiding for another year and a half before making their way to another refugee camp in Kenya. All totaled, only 10,000 of the estimated original 30,000 Lost Boys survived this death-defying pilgrimage to freedom.

In 2001 the United States government awarded refugee status to approximately 3,800 of the Lost Boys. Despite knowing little English, having never flown on an airplane, or having even flipped on a light switch, the Lost Boys of Sudan are now thriving in their new nation.

Featured on "60 Minutes" about 10 years ago, "Good Morning America," and in several award-winning books and films, the individuals joining us on the House floor today continue their tireless and pioneering efforts to raise awareness and to end all 21st-century slavery by establishing a nonprofit organization known as the Lost Boys Rebuilding Southern Sudan, and later on today we will put some information in your mailboxes to tell you some more about that organization.

GUESTS INTRODUCED

Mr. KRIEGER. But now that I have told you their story, I would like to take this opportunity to recognize each of the Lost Boys joining us on the House floor today. They are standing at the back of the House. They are Samuel Anei, William Mou, James Ajuong, and Abraham Nhial, and I would ask you to join me for applause for these Lost Boys.

As you can tell, they have an incredible story to tell. And to honor the Lost Boys of Sudan, to remember the many who died along the way, and to add our voices to their call to end human slavery in Sudan and around the world, I would respectfully request unanimous support for HR 546. Thank you all and thank you, Mr. Speaker.

Mr. M. O'BRIEN. Thank you, Mr. Speaker.

I rise today to offer HR 591. Perhaps one of the greatest questions asked by mankind is, why do bad things happen to good people? And perhaps an even greater question is, when that bad thing happens, what do you do with it?

On July 19, 1998, Dwayne Adams was a victim of a drive-by shooting, a senseless crime which left him near blind, and he took that adversity in his life and turned it towards rowing. But that was not good enough to him even though he distinguished himself as a champion. He turned to the youth of inner-city Philadelphia to bring a sport to them that is very seldomly offered – rowing, perhaps one of the most challenging sports both physically and mentally that there is. It has been said that rowing in a 1500-meter competitive race expends the same energy as playing two full-court basketball games back to back without stopping.

While serving in the Senate of Pennsylvania, he served as the Minority Chair of the Senate Public Health and Welfare Committee and was Chairman of a taskforce on violence as a public health concern. Mr. Williams founded and became Executive Director of Black Family Services in 1994, founded the Organized Anti-Crime Community Network and worked with Blacks Networking for Progress and the Delaware Valley Ecumenical Council. The Hardy Williams Award for Excellence was established in his honor by the Black Law School Association of the University of Pennsylvania, and he was its first recipient. He retired from the State Senate in 1998; and

I rise today in support of HR 599, which seeks to recognize February 3, 2010, as "National Girls and Women in Sports Day."

This important national recognition day has been celebrated every year since 1987 on the first Wednesday in February. The goal is to honor the achievements and encourage participation of girls and women in sports. The theme for this year's recognition event is "Stay Strong, Play On," and I think that is most fitting.

Mr. HANNA. Thank you, Mr. Speaker.

I just want to thank the members for the unanimous vote and submit these remarks for the record.

The SPEAKER. The Chair thanks the gentleman.

Mr. HANNA submitted the following remarks for the Legislative Journal:

Thank you, Mr. Speaker.

HR 600 designates February 1, 2010, as "Peripartum Cardiomyopathy Awareness Day" in Pennsylvania. Peripartum cardiomyopathy is a form of heart failure during pregnancy or postpregnancy.

I introduced this resolution on behalf of Heather Moore, a constituent who developed the disease when she became pregnant with her son at the age of 29.

By the time doctors realized what was happening, her son, named "Ty Steven," did not survive because of the late diagnosis. She suffered multiorgan failure and a stroke and spent 3 months in the hospital on a heart pump. She was even the first name on the area's heart transplant list for weeks.

Luckily, Heather has recovered, but she can never get her son back. Heather's doctors told her she cannot have more children, even though she is otherwise healthy, because the risk of peripartum cardiomyopathy grows with each pregnancy.

The exact cause of this disease is unknown. Diagnosis is not always made right away, as some conditions associated with pregnancy – like fatigue, swelling of the ankles, and shortness of breath – are also symptoms of peripartum cardiomyopathy and can mask its presence.

In the United States, peripartum cardiomyopathy complicates one in every 1,300 to 4,000 deliveries and has a fatality rate of 18 to 56 percent.

I wanted to sponsor this resolution because it is important that the public, health-care professionals, and patients learn more about the disease so that we can protect mothers and their babies.

I urge my colleagues to support this resolution. Thank you.

 - (1) An individual who has been convicted of an offense under section 3802 and does not have a prior offense as defined in section 3806(a).
 - (2) An individual whose operating privilege has been suspended under section 1532(c) for a conviction of an offense involving the possession, sale, delivery, offering for sale, holding for sale or giving away of any controlled substance under the laws of the United States, this Commonwealth or any other state and does not have a prior offense. For purposes of this paragraph, any conviction under any Federal or state law relating to any controlled substance or other drug shall constitute a prior offense if it related to the type of conduct against which a subsequent offense is directed.

to automobile usage, cannot apply for an occupational limited license. I want to say as we talk about job creation and making sure people have the ability to go to work, not having the ability to have a license to allow you to get to and from work is very devastating to many.

And so I would hope that we would have an opportunity to really seriously consider taking this issue on and passing it and having parity in our law. So thank you, Mr. Speaker.

I respectfully withdraw my amendment.

BILLS ON THIRD CONSIDERATION

The House proceeded to third consideration of **HB 1616**, **PN 2014**, entitled:

An Act amending the act of February 14, 1990 (P.L.62, No.11), known as the Noncontrolled Substances Reporting and Registration Act, further providing for chemicals subject to registration.

On the question,

Will the House agree to the bill on third consideration? Bill was agreed to.

(Bill analysis was read.)

The SPEAKER. The question is, shall the bill pass finally?

Mr. HOUGHTON. Thank you, Mr. Speaker.

HB 1616 simply adds one substance to the existing noncontrolled substance list, becoming No. 35 on that list. The substance is dextromethorphan, otherwise known as DXM. DXM is a cough suppressant common in Robitussin and other medicines. In its pure form, DXM is a white powder which is sold primarily via the Internet. DXM has euphoric, psychedelic, and dissociative properties when administered in doses well above those which are considered therapeutic medically for cough suppression. Kids call it Robo tripping.

There was a little bit of confusion in the Health and Human Services Committee, and hopefully, I can answer some of those questions right here. The intent here is to simply stop the purchase of DXM in its raw, bulk powder form over the Internet to kids and other abusers.

Doctors, pharmacies, and veterinarians are exempt from having to report and register here under this act.

Also, there is a catchall provision. Any over-the-counter medications are also exempt. This legislation specifically deals with DXM in its raw powder form, and pharmacies can choose to lock it up, but they do not have to. It is totally voluntary.

I ask for an affirmative vote. Thank you, Mr. Speaker. The SPEAKER. The Chair thanks the gentleman.

Bill as amended was agreed to.

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

(Bill analysis was read.)

The SPEAKER. The question is, shall the bill pass finally?

On that question, the Chair recognizes the gentleman from Allegheny County, Representative Markosek.

Mr. MARKOSEK. Thank you, Mr. Speaker.

We are all one text from eternity, but perhaps through the wisdom of the House of Representatives we can forestall that and be a lot more safe and have a lot of our constituents be a lot more safe while they are driving their vehicles.

HB 2070, as we know, will ban texting while operating a motor vehicle, and according to the amendment that we passed yesterday, it will also ban handheld cell phone use while operating a motor vehicle.

This is a big step for us here. As you recall, about 10 months ago we had a similar issue before us, and it actually failed to be passed. But yet as we move forward, in the last year we have seen a dramatic change, a dramatic change in public opinion relative to operating vehicles and being distracted through the use of interactive electronic devices.

I certainly appreciate the members in their support of HB 2070. We cannot and should not allow folks to be distracted, and at some point, at some point, for those who think that this does not go far enough or for those who think perhaps it goes too far, we need to also encourage people to the fact that they have responsibility while operating a 4,000-pound battering ram. When you are behind the wheel, you have a great responsibility. And we can only legislate up to a certain point. At some point, the public has to accept responsibility and use common sense when operating motor vehicles in the fashion that they do.

We have all had anecdotal input from our constituents. I cannot go anywhere in my district without somebody asking me or telling me about a story that they have recently had of

almost being run off the road or in fact being run off the road, or somebody ahead of them at a traffic light and the light changes and the car ahead of them does not move because the person ahead of them is on the phone.

We have a situation today where folks want to answer that phone, and for whatever reason, we are all in the habit, when the phone rings, we answer it, regardless of anything else that we are doing, which is wrong.

None of this legislation will work without really a threepronged attack. If we are going to change the behavior of drivers in Pennsylvania, three things have to happen. We have to have legislation, but we also have to have education and technology. Those are the three things that have to go into changing the behavior of Pennsylvania drivers to get them to be responsible.

A lot of people have said, why are you doing this? Should not folks be responsible on their own? And yes, they should, but we all know that does not always happen. So this is a great, great effort as we move forward here to get folks to be responsible while they are driving, and I certainly ask you, my colleagues, for an affirmative vote on HB 2070.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

On the question, the Chair recognizes the gentleman from York County, Representative DePasquale.

Mr. DePASQUALE. Thank you, Mr. Speaker.

I want to start off by thanking Chairman Markosek for his leadership in getting this legislation through the Transportation Committee, and with Chairman Geist and their bipartisan cooperation in getting this bill to where it is today.

As most of you know, 3 years ago I introduced the original banning-texting-while-driving legislation, and this legislation is a significant improvement from that original drafting.

And we often do not do this enough, but I specifically want to thank the staff of Transportation today, Stacie Ritter in particular, who had the idea of using money from the fine to go specifically for education of our youth as they are learning how to drive and the dangers of texting while driving.

I am sure there is a big relief today from Laura Kuller, who works with Majority Leader Eachus, that she will stop getting the e-mails from me on all the tragedies that are happening, not just in Pennsylvania but nationally on this issue, as I continue to try to ensure that we would come to this day.

But I also want to remind everyone that we are not done, if this vote goes as I believe it will go, and that is, we need to fight to make sure that this bill comes back from the Senate as strong as possible, that we keep it not only as just a texting ban but a handheld cell phone ban, and that we fight for it to be a primary offense as well, because that will make sure that it is the best public safety bill that you could have in Pennsylvania, and it will make Pennsylvania a leader.

And I will only close with this, that this is probably the one issue that President Obama and former Governor Sarah Palin agree on. This is an issue that Republicans and Democrats agree on, liberals, moderates, conservatives. This is something that over 90 percent of the people of this State want, and I am proud of this House that we are doing the people's work and doing exactly what they want, and that is fighting for safer public roads in Pennsylvania.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman and recognizes the gentleman from Monroe County, Representative Siptroth.

Mr. SIPTROTH. Thank you very much, Mr. Speaker.

Mr. Speaker, I rise in support of HB 2070.

Certainly, as the chairman alluded to, a 4,000-pound ram is nothing that you would like to see coming towards your vehicle or a vehicle of a loved one or relative. But think for a moment of a 26,000-pound-plus vehicle, of which there are many operating on our roads every day.

And I would like to remind the members that through regulation, the Federal government has just imposed restrictions on commercial driver's license individuals that are driving commercial vehicles from texting, and I think it is extremely important that we support that piece of legislation by passing HB 2070 here in the House today so that each and every one of our friends, relatives, loved ones, can be protected from the distracted-driving portion of texting and cell phone use.

Again, I ask you for your support of HB 2070. Thank you, Mr. Speaker.

The SPEAKER. On the question, the Chair recognizes the gentleman from Montgomery County, Representative Shapiro.

Mr. SHAPIRO. Thank you, Mr. Speaker.

Mr. Speaker, I rise today in support of HB 2070. It has been a long time in coming, Mr. Speaker, to reach this day where the House could be on the verge of putting up what I hope will be broad bipartisan numbers to save lives on the roadways in Pennsylvania.

Mr. Speaker, back when you were a chairman of the Transportation Committee, I first introduced legislation to ban the handheld cell phones and texting while driving, and we had about a dozen cosponsors and got a little bit of attention, but the bill went nowhere.

A couple of years ago when we reintroduced the bill, between 30 and 40 percent of this chamber, Democrats and Republicans, came together to cosponsor this measure, but still the bill went nowhere. Today we stand on the precipice of broad bipartisan support for a bill that will no doubt save lives for the people of Pennsylvania.

Mr. Speaker, I will simply say to Oprah Winfrey, who dedicated a show about this just last week: Oprah, we hear you. Pennsylvania is about to become a no-phone zone on our roadways, the result of which will save lives.

Now, we know, Mr. Speaker, that this is the first but an important step on the road to getting this bill passed. It still needs to go over and pass in the Senate, and I am hopeful that it will. But there are four key components in this legislation that I believe should be included in any final bill.

Number one – and this House has done it in the underlying bill – is, we need to have a strict ban for teenage drivers. We know that we need to make our teens safer and our roads safer, and we need that language to stay put. We know that we need a tough law on texting, and the Representative from York spoke ably for many years in trying to bring this about.

We know – and we saw this yesterday with the broad bipartisan support we had – that we need to have a ban on the handheld cell phones. The science shows it and the studies show it, that the combination of those handhelds and the texting together will save lives on Pennsylvania roadways.

And we know, Mr. Speaker, that this needs to be a primary offense – a primary offense. We know that if it is a primary offense, we will save lives on our roadways. It is not about just simply adding fines to motorists; it is about stopping accidents from occurring in the first place. That is what this legislation does.

Mr. Speaker, on a personal note, throughout this process, throughout this roughly 5-year process, I have received more than a thousand e-mails, phone calls, letters, from people all across Pennsylvania supporting our efforts to get this done.

And, Mr. Speaker, I cannot help but think today, on the eve of this vote, of the horror stories that have been shared by so many Pennsylvanians who have been the victims of accidents or who have seen a loved one get hurt or who have barely missed an accident themselves.

I think about Jacy Good, who came and sat in the Speaker's chairs, who had graduated from Lancaster, who had graduated from Muhlenberg, and was driving home the day after graduation, driving home the day after graduation with her family in her car, when they were struck by a motorist who swerved as a result of one of those drivers being on one of those cell phones. Jacy's family in that car died that day, and Jacy was left in a coma.

Today we hopefully will pass this legislation for the Jacy Goods and the so many Pennsylvanians who have been unfortunate victims of people talking on their handheld cell phones and texting while driving. This is a major progressive step forward. This will save lives on our roadways.

And, Mr. Speaker, I thank you, I thank the leader, I thank the chairman of the Transportation Committee, and members on both sides of the aisle for staying committed to this issue, for driving it through, and for ensuring its passage and ensuring safety on Pennsylvania's roadways going forward.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

Does the gentleman from Somerset, Representative Metzgar, wish to be recognized? The gentleman from Somerset County, Representative Metzgar, is recognized on the question.

Mr. METZGAR. Would the maker of the bill please stand for brief interrogation?

The SPEAKER. Will the gentleman, Representative Markosek, stand for interrogation? The gentleman indicates he will stand for interrogation. The gentleman from Somerset, Representative Metzgar, is in order and may proceed.

Mr. METZGAR. Mr. Speaker, I note that the bill as proposed amends section 3752 to state that a report shall be filed by the law enforcement officer that includes "...whether the driver of the vehicle was using an interactive wireless communication device when the accident occurred, and such other information as the department may require...."

I notice the bill does not say precisely how that is supposed to occur, but could you tell me, is the officer supposed to look at the cell phone, or how is that supposed to occur?

Mr. MARKOSEK. Mr. Speaker, the police officer would observe fact-finding rules, the same rules that he would observe in any other accident.

If there was a serious enough accident where they thought they needed to get the records, they could do that. If that were not warranted or not necessary, they would not have to do that, necessarily. Mr. METZGAR. Would they use the phone itself, the actual device?

Mr. MARKOSEK. It would require a warrant to get the records, if they needed to get the records of the cell phone.

Mr. METZGAR. Okay. So there could be a seizure of the phone.

Mr. MARKOSEK. The bill does not permit the seizure.

Mr. METZGAR. But would not this section permit the seizure?

Mr. MARKOSEK. No. The section is merely a reporting requirement that they would fill out at the scene of the accident.

Mr. METZGAR. But the information derived from that would be?

Mr. MARKOSEK. The information derived by that would be whether or not there was a phone present during the accident.

Mr. METZGAR. So if there is a phone present, they would have presumed to be texting or calling or—

Mr. MARKOSEK. It would be recorded that there was a phone at the scene.

Mr. METZGAR. Okay.

Mr. MARKOSEK. If they got a warrant, they could check the records.

Mr. METZGAR. But it says "...including whether the driver of the vehicle was using an interactive wireless communication device."

Mr. MARKOSEK. Would you repeat the question, please?

Mr. METZGAR. It says, on page 11, lines 26 through 29, it says, and specifically line 27, it says "...was using an interactive...." So what you said before would not be quite right?

Mr. MARKOSEK. Any constitutional protections against search and seizure would still remain.

Mr. METZGAR. Okay. Very good.

On the bill, Mr. Speaker?

The SPEAKER. The gentleman is in order and may proceed.

Mr. METZGAR. Mr. Speaker, while this bill is a well-intentioned bill, intentions do not get us very far here in the Capitol, and as we all well know, results are the only thing that matter.

And this bill has some internal inconsistencies. It probably has some seizure problems; it has some proof problems. But I find that we might be in a State, if we pass this bill, where any officer on one of our fine roadways could conceivably say, "License, registration, and cell phone, please."

Thank you very much, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

Does anyone else seek recognition? The Chair recognizes the gentleman from Delaware County, Representative Micozzie.

Mr. MICOZZIE. Thank you, Mr. Speaker.

First, I want to publicly thank Representative Markosek for meeting with the families of a tragedy that happened in Delaware County. There was a young lady who was using an electronic device, crossed over the highway, and two young ladies were walking on a sidewalk where this car came from the other side of the highway, killing instantly a 19-year-old and sending another to the hospital with all kinds of injuries. And the families, one of the girls was my neighbor, Christine Bochanski. And I want to thank the Representative for taking the time out of his busy schedule to meet with them and to kind of comfort them in their tragedy.

I support this bill. I think it is needed. Anyone living in Delaware County knows about the amount of traffic we have in the county, and no matter where you go, there is someone on a cell phone in high-traffic areas.

So I support this piece of legislation and, again, thank Representative Markosek. You know, they get your name and my name mixed up. Thank you.

PARLIAMENTARY INQUIRY

The SPEAKER. On the question, the Chair recognizes the gentleman from Northumberland County, Representative Belfanti.

Mr. BELFANTI. Thank you, Mr. Speaker.

A point of parliamentary inquiry.

The SPEAKER. The gentleman will state his point of parliamentary inquiry.

Mr. BELFANTI. Thank you, Mr. Speaker.

Mr. Speaker, as a result of the rule on 24 hours between second and third consideration, I believe that unless we suspend the rules, we would have to wait until 4 o'clock or thereabouts to vote this. Is that correct?

The SPEAKER. Technically, we do not have to suspend the rules. We could offer a motion to proceed. But without that motion to proceed, the vote cannot occur until 4:47 this evening.

MOTION TO PROCEED TO CONSIDERATION UNDER RULE 24

Mr. BELFANTI. Well, okay. I am not sure I understand the answer, but may I make the motion to proceed?

The SPEAKER. The gentleman would be in order.

He would have to invoke rule 24 indicating that the members have had sufficient time to understand and review the legislation. Is the gentleman so moving?

Mr. BELFANTI. Yes, Mr. Speaker. I believe the members have had enough time not only to read, but through extensive debate, understand the parameters of the bill, and I would like to make a motion that we vote the legislation.

The SPEAKER. The gentleman from Northumberland County, Representative Belfanti, moves, pursuant to rule 24, that members have had sufficient time to review the language and that the House proceed with consideration of HB 2070, PN 3134.

On the motion to proceed, those voting in favor of the motion to proceed will vote "aye"; those opposed, "nay."
