FATHER JUDGE HIGH SCHOOL SOCCER TEAM PRESENTED

The SPEAKER. The Chair recognizes the gentleman from Philadelphia County, Representative John Sabatina, for the purpose of making a presentation.

Mr. SABATINA. Good morning, ladies and gentlemen.

It gives me great pleasure to honor my alma mater and Representative McGeehan's alma mater, Father Judge High School, and specifically, their soccer team. Father Judge Soccer Team became the first team in the city of Philadelphia to win a State title in soccer. Judge entered the State playoffs as the District 12 champion and became the first boys soccer team from the city to win a State playoff game. They earned the right to play in the State soccer final by winning the Catholic League title; the city championship by defeating George Washington High School and wins over Central Bucks East, Downingtown West, and a thrilling 2-to-1 double-overtime victory against Unionville in the State semifinals.

It has been a year of accomplishments for the coach, John Dunlop, and in addition to guiding Judge to a final record of 22-2-2, Coach Dunlop became the alltime leader in victories as coach of Father Judge soccer. He notched his 100th career win and was inducted into the Southeastern Pennsylvania Soccer Hall of Fame.

The team received crucial goals throughout the playoffs from a host of different players, including Nick Morris, who scored the game-winning goal in the city title game and a pair of goals to clinch the Catholic League title. It was Judge's second Catholic League title in 3 years. Judge has received numerous postseason awards for the triumphant season. The team was ranked 12th nationally in a poll conducted by ESPN and 14th in the nation by Adidas soccer coaches poll.

RESOLUTIONS PURSUANT TO RULE 35

Ms. McILVAINE SMITH called up **HR 619, PN 3181,** entitled:

A Resolution honoring the League of Women Voters of Pennsylvania on the occasion of the 90th anniversary of its founding.

On the question, Will the House adopt the resolution?

The SPEAKER. On that question, the Chair recognizes the gentlelady from Chester County, Representative McIlvaine Smith.

Ms. McILVAINE SMITH. Thank you, Mr. Speaker.

I would welcome all members of the League of Women Voters in the House to come and join me here at the podium. I know there are several of you, so if you will please make your way to the podium, I would appreciate it.

"Ninety years ago, Carrie Chapman Catt first proposed a League of Women Voters to 'finish the fight' and work to end all discrimination against women. And so the League of Women Voters was founded on Valentine's Day in 1920, six months before the ratification of the 19th Amendment giving women the right to vote.

"Today..." the League "...remains a grassroots organization with more than 150,000 members and supporters and 850 Leagues throughout all 50 states – thirty-five of those Leagues in Pennsylvania alone. Though the League is known widely for our voter education efforts, we've also brought our expertise to critical issues such as health care reform, global climate change and many others."

And if I could have your attention, please. Let us show a little respect for this group of women – and men. Thank you.

"As we enter into a new year, we know that the League will continue to do what it has been trusted to do for more than 90 years...."

The SPEAKER. The House will come to order.

Ms. McILVAINE SMITH. "...Every one of the critical 2010 initiatives will give citizens a greater voice – in the upcoming census, the 2010 elections, the next round of redistricting..." and the Marcellus Shale issue.

" 'The women who started the movement to give women the right to vote really didn't know where it would end, how it would end, or when it would end,' said League of Women Voters president, Mary G. Wilson. 'And yet they persevered. They persevered in a time when it wasn't fashionable for women to speak out on any issue – let alone try to get some rights for themselves. They worked against all odds – and succeeded.'

"In 1920, after a 72 year struggle, passage of the 19th Amendment appeared to be imminent, and members of the National American Woman Suffrage Association met to form the League of Women Voters, the organization to educate the newly franchised women to effectively use the vote."

These words were written by the executive director of the League of Women Voters, Bonita Hoke, but I need to add a personal note. My cousin, Martha Gibbons Thomas, who was a suffragette, one of the founders of the Chester County League of Women Voters, was the first woman to be elected from Chester County after women gained the right to vote. In 1923 she was sworn in into this House along with seven other members – the first eight women ever to be seated in the Pennsylvania General Assembly – and I am proud to sit right in front of where she sat, and I am proud to carry on the tradition of being a League of Women Voters member of Chester County.

Mr. Speaker, gambling addiction is an impulse control disorder. The compulsive gambler cannot control the impulse to gamble even when he or she is aware of the harm that it is causing to themselves and those around them. The compulsive gambler will continue to gamble whether they are happy or depressed, whether they are winning or losing, whether they have the money to cover their bets or not. Even when the compulsive gambler knows the odds are against them and they cannot afford to lose, they simply cannot stop.

Mr. Speaker, overcoming a gambling addiction is not easy, but recovery is possible if the compulsive gambler is willing to admit he or she has a problem and seek help to fix it. Treatments like cognitive behavioral therapy and support groups like Gamblers Anonymous provide useful tools that the gambler needs to fight the urge and to rebuild his or her life.

Mr. Speaker, as Pennsylvania casinos begin to add table games, we will absolutely see more cases of gambling addiction. Mr. Speaker, it is important that we raise awareness of the problem and the treatments available to those who need them.

Therefore, Mr. Speaker, I urge my colleagues to support this resolution declaring March 2010 as "Gambling Addiction Awareness Month" in Pennsylvania.

I rise in support of HB 1251. As our large baby-boomer population continues to age, the Commonwealth will face ever-greater fiscal challenges in how we pay for long-term-care services. This demographic tsunami will be deeply felt all across State government. While long-term-care insurance has the potential to alleviate some of this burden, it is still a relatively new product and one that is complicated for consumers to both navigate and understand.

As chairman of the House Aging and Older Adult Services Committee, I held a public hearing last year to examine this long-term-care payment option. One of the great concerns that came up was the lack of an appropriate grievance process for those appealing a decision by their insurer. The current process, which is internally based, seems geared toward making people jump through hoops in the hope that they will become frustrated and give up on their appeal.

I am pleased that HB 1251 seeks to address this and other issues by creating greater uniformity in the handling of long-term-care insurance complaints. This is a pro-consumer bill.

Those who purchase long-term-care insurance should be commended for taking the initiative to plan ahead for their long-term-care needs; however, they deserve the peace of mind of knowing that appropriate safeguards are in place to protect them from being sold a bill of goods. While I believe additional regulation of a long-term-care insurance market is still needed, especially with regards to exorbitant rate increases, I will be introducing my own personal bill in the near future, but for now HB 1251 is a very much-needed step in the right direction, and I commend Representative Costa for its introduction and passage.

I urge my colleagues to vote in the affirmative. Thank you, Mr. Speaker.
