#### REMARKS BY SPEAKER

The SPEAKER. We have some special guests in the House today who are here to share their heritage as well as their love of family, the community, and the country.

I ask that we take a moment to recognize a special group of Pennsylvanians and share in their celebration of Greek Independence Day. It was 189 years ago on March 25 that a bishop stood up in a monastery in the mountains, raised the Greek flag, declared independence, and began the arduous task of restoring democracy to its birthplace.

It was the ancient Greeks who developed democracy, in which the power to govern was vested in the people. The Founding Fathers of the United States of America drew upon experience and philosophy of ancient Greece in forming our representative democracy. The SPEAKER. On the resolution, the Chair recognizes the gentleman from Northumberland County, Representative Phillips.

Mr. PHILLIPS. Thank you, Mr. Speaker.

Today I rise to offer HR 671 and ask my colleagues for unanimous support. This resolution seeks to make Pennsylvania families healthier by strongly supporting routine influenza vaccinations for health-care workers who have direct patient contact.

As we all know, when a family member contracts the flu virus, other family members are at risk. When someone within the workplace gets sick, the illness can often be transmitted to other coworkers. This is especially true within health-care facilities. Whether we are referring to a hospital, doctor's office, community clinic, assisted living facility, or nursing home, I believe there is an inherent responsibility to ensure that health-care workers are protected as best as possible from contracting illnesses like the flu.

Mr. Speaker, a study conducted by the University of Virginia Health System showed that when health-care workers' vaccination rates increased from 4 percent in 1987 through 1988 to 67 percent in 1999 through 2000, the proportion of hospital-acquired influenza cases declined significantly among both employees and patients. Unfortunately, flu vaccination coverage among health-care workers remains low despite the documented benefits of health-care workers' vaccination on

patient outcomes, reducing influenza infection among staff and reducing health-care worker absenteeism.

If we can protect these workers, it also helps protect patients and, thereby, helps prevent the spread of illness. Not only will that translate into healthier workers and workplaces but reduced health-care costs. Those are the things that I think we can all support.

Thank you, Mr. Speaker, for the opportunity to say a few words, and I ask members for unanimous support of this resolution.
