PRAYER

Grant that we, who in the history of our country and Commonwealth came from many nations with many different languages and many States, grant that we may become a united people. Support us in defending our liberties, and give to those to whom we have entrusted the authority of government the spirit of wisdom, that there may be justice and peace in our country and Commonwealth. When times are prosperous, may our hearts be thankful, and in troubled times, may we also be thankful and not let our trust in You fail. GUESTS INTRODUCED

The SPEAKER. On that question, the Chair recognizes the gentleman from Luzerne County, Representative Yudichak.

Mr. YUDICHAK. Thank you, Mr. Speaker.

I would like to introduce some very special guests to the House floor. They are here today to help us honor Nanticoke native and a friend of mine, United States Navy Reserve PO2 Brian Patton, who lost his life while serving his country in Kuwait.

Joining us today, his wife of 9 years, Amy Patton; his son, Nicholas Patton; his stepson, Tyler Kozlofski; fellow soldier, chief warrant officer, and brother, Robert Patton; fellow soldier and fellow prison guard at SCI (State correctional institution) Dallas in Luzerne County, PO2 Vincent McClosky; and his extended family, Karen Amesbury, John and Janine Floryshak, Marie Cotter, Brent Makarczyk, and Mary Gillette.

If you will indulge me, I would like to tell you a little bit about Brian Patton. After his wife and children, Brian had three passions: the Chicago Cubs, Notre Dame football, and the University of North Carolina Tar Heels. If we think about what these teams stand for, we see what Brian Patton was made of: loyalty, compassion, commitment. No one could be more loyal than a Cubs fan. Loyalty is a true test of character, a test Brian Patton passed with flying colors as a loving husband, devoted father, and a good friend.

The Fighting Irish, as we all know, just do not play football on Saturdays. Notre Dame's mission as a university is to inspire students to improve the world around them. Brian may not have attended Notre Dame, but he carried with him the Notre Dame spirit. Brian enlisted in the Navy Reserves in 1993 to fight oppression half a world away in the first gulf war conflict. He gave his all to improve the world around him and beyond.

The term "Tar Heels" is synonymous with dedication. The root of the nickname dates back to the Civil War when North Carolina troops were fighting in a battle in Virginia. A supporting column of Virginians retreated. After the battle, the victorious North Carolinians told the Virginians, next time put some tar on your heels so you can stick in the fight. Brian Patton knew about such commitment.

After serving in the first gulf war, Brian worked as a correctional guard in Dallas, continuing to protect and serve this Commonwealth. He could have stayed a civilian; his service of duty he could have ended, but like a good ol' Tar Heel, who does not give up until the battle is won, he volunteered for service in Kuwait as a military police officer. He was deployed again in March 2009, assigned to Operation Iraqi Freedom and Operation Enduring Freedom, a deployment from which he would not return.

Brian died just after midnight on November 19, 2009, when the vehicle he was riding in was hit head-on by a civilian contractor trying to pass a military convoy. Just an hour before that horrible accident, just an hour, Brian called his wife, Amy. It was their ninth wedding anniversary, and he wanted to tell her that he missed her, and they talked about taking a trip to Hawaii when he was done with his latest tour of duty.

Amy, I am sure you will always cherish that last phone call with Brian and the many years of marriage you shared together.

Nicholas and Tyler, every child looks upon his father as a hero. Please know that your dad was indeed a real American hero. You have every right to be proud of your father's service, and always remember just how proud he was to be your dad.

P02 Brian Patton gave all he had in this life for God, family, and country. God bless Brian Patton and the Patton family, and God bless all the brave men and women who have taken up arms to defend this great nation.

Let me add one more thought, Mr. Speaker, before I ask my colleagues to support me in the passage of this resolution, HR 578, honoring Brian Patton. Six years ago this House passed the Sergeant Baker bill that provides educational opportunities at our State colleges for families of soldiers killed in the line of duty. At that time on this floor and at this podium, I prayed that the law would seldom, if ever, be used.
