BILLS ON SECOND CONSIDERATION

The House proceeded to second consideration of **HB 1942**, **PN 3558**, entitled:

An Act amending the act of April 26, 1935 (P.L.90, No.39), entitled "An act to promote uniformity in the assessment and taxation of properties and persons within the territorial limits of cities of the second class A, by providing that city and school taxes within such territorial limits shall be assessed, levied, and collected upon the basis of the assessments for taxation for county purposes; and requiring the furnishing of tax duplicates by the county taxing authorities to such cities and to school districts coterminous therewith; abolishing the department of assessors in cities of the second class A; consolidating tax statements covering city, school, county, and poor taxes therein,

and making uniform the time for levy and collection of said taxes respectively, and regulating the discounts therefrom and penalties thereon," further providing for levy and collection of taxes by cities of the second class A.

The House proceeded to second consideration of **HB 60**, **PN 3554**, entitled:

An Act amending the act of December 3, 1959 (P.L.1688, No.621), known as the Housing Finance Agency Law, providing for the Pennsylvania Housing Affordability and Rehabilitation Enhancement Program; and establishing the Housing Affordability and Rehabilitation Enhancement Fund.

On the question,

Will the House agree to the bill on second consideration?

The SPEAKER. On that question, the Chair recognizes the gentleman from Washington County, Representative Daley.

Mr. DALEY. Thank you, Mr. Speaker.

America is noted as being the land of opportunity, and that is rightfully so, but Pennsylvania is lacking in one area of opportunity, and that is affordable housing, and we need to fix this, not next week, not next month, not next year, but now, and we have been working collectively on this issue.

Chairman Hess and I both believe, as well as the members of our committee, we recognize the need for affordable housing in Pennsylvania, and Pennsylvania needs help and deserves to have safe, decent, and affordable homes. HB 60 will do just that by creating an affordable housing trust fund. HB 60 will keep people in their homes. HB 60 will give everyone a fair chance to achieve the American dream of home ownership.

HB 60 will enable PHFA (Pennsylvania Housing Finance Agency) to build, rehabilitate, and preserve housing for low- to moderate-income people, the elderly, and our disabled community. HB 60 will develop and rehabilitate distressed neighborhoods.

Statistics show that 15,000 Pennsylvanians are homeless and more than 90,000 families statewide are on various housing authorities' waiting lists. These numbers are unacceptable.

This bill does not appropriate funds in any way whatsoever. Instead, we are relying on the housing trust fund, which is supposed to distribute \$1 billion to the States of which Pennsylvania will receive nearly \$35 million. The implementation of this program is contingent upon Federal funding – no State funding, Federal funding.

New language was added in committee to this bill on Monday by Representative Hess that prohibits the funding from being used to implement the program, State funding. And in years where there are insufficient Federal funds, the program will not run; it will cease. PHFA will not have to continue spending money to administer the program, which is unfunded.

Under the provisions of this bill, the Federal stimulus money cannot be used for existing affordable housing programs administered by PHFA, and 30 percent of the funds appropriated to this program must be used to benefit households with incomes less than 50 percent of the area's median income.

The support has been overwhelming. HB 60 has 82 cosponsors, and the legislation has been endorsed by over 300 organizations throughout the Commonwealth – the Pennsylvania Builders, the Realtors, the Housing Alliance of Pennsylvania, the Pennsylvania Banking Department, the Pennsylvania Coalition to End Homelessness, and by you, my colleagues, but more importantly, by our constituents.

In light of the current climate in the housing and financial markets and rising unemployment, we must act quickly and not continue to be behind the mark. A vote for HB 60 is a vote for jobs, a vote that will help stimulate our economy. According to a report of the Housing Alliance, every dollar invested in the program generates about \$1.62 to \$2.28 by stimulating construction and home repairs.

Econsult Corporation reports that each \$10 million invested in the housing trust fund will generate up to \$23 million of economic impact, up to 200 jobs, and \$1.16 million in State tax revenues. We will recognize the benefits of the program rather quickly because hammer-ready construction and rehabilitation projects are direct investments.

Thirty-eight other States have already passed this, Mr. Speaker.

Thank you, Mr. Speaker.

Mr. SEIP. Thank you, Mr. Speaker.

Mr. Speaker, today in the hall of the House I have two constituents here with me from Berks County – Emilie Heath, and her son, Taylor Heath. If you could please stand and be recognized.

Thank you for that nice welcome for my constituents. Emilie is the president of the international Pediatric Stroke Network, and Taylor is struggling with an illness as a result of a terrible stroke when he was born. He is 11 years old right now, and he has had a situation that has really affected the use of his entire right side of his body due to that stroke that he had at birth. He also suffers from a seizure disorder, which has impacted his cognitions, and he is also struggling with many other health concerns.

Mr. Speaker, it is a terrible thing when an adult suffers a stroke, but it is even more difficult and more tragic when a child has this incredibly damaging health event to contend with so early in life. There are many children like Taylor. Nationwide, strokes occurring on or even before birth happen to 1 in 4,000 children every year. Twelve percent of those infants die because of a stroke. Currently there is very little known about the cause or what course of treatment to pursue or prevention of these childhood strokes. Medical research is desperately needed. What we do know already is that early diagnosis and early treatment are critical.

Most people, certainly, would seek out medical attention for an elderly relative who either stopped speaking or had slurred speech or weakness in one side of the body. So it is important to raise awareness that children, too, may suffer strokes. I urge my colleagues to extend an affirmative vote on HR 683, which would designate May 1, 2010, as "Childhood Stroke Awareness Day" in Pennsylvania.

I would also like to recognize, in the gallery, a number of individuals that were at the Education hearing today testifying on behalf and in support of HB 1803, which would provide AEDs (automated external defibrillator) in each occupied building in the school.

Mr. Speaker, Greg Moyer died too soon. He was just 15 when he played his first varsity basketball game in December of 2000. Greg played 10 minutes, went to the locker room at halftime, and died from an unexpected heart condition. The site of the game was 20 miles from the nearest hospital.

Adolph

About 40 minutes elapsed before emergency responders equipped with an automated external defibrillator, or AED, were able to reach Greg. By then it was too late, and Greg was gone.

Greg's parents, Rachel and John, are in fact amazing people. They have made it their mission to see that there is an AED, which could have saved Greg's life, in every public place. They have established a foundation in their son's name to raise money to make AEDs more available. Their work helped result in a State law introduced by former Representative Kelly Lewis that established a program to obtain AEDs for schools. This law also provides for training in the use of AEDs as well as CPR (cardiopulmonary resuscitation).

Mr. Speaker, time passes quickly. Greg's 25th birthday would have been April 25, this Sunday. In honor of his memory and to show support for the work of Rachel and John Moyer, I ask for support of my resolution, HR 707, designating April 25 as "Gregory W. Moyer" Day in Pennsylvania.

Pennsylvania has seen too many of these fatalities; in 2008 alone there were 240 work-related deaths that severely impacted their families, friends, and associates with immeasurable results. My resolution would also honor the Greater Wilkes-Barre Labor Council for continuing to conduct their annual Workers Memorial Day program and candlelight vigil. Over 40 individual unions and their members pay tribute for their fellow workers that suffered death or injury.

The Wilkes-Barre Labor Council continues to endorse procedures that prevent workplace tragedies and improve the health and safety of every worker. This day we remember all the victims of workplace injuries and seek stronger safety and health protections, better work standards, and support more aggressive enforcement of those standards.

I ask all of the members of this House to pay tribute to these workers and support HR 735. Thank you, Mr. Speaker.
