Mr. CREIGHTON. Thank you, Mr. Speaker.

I want to thank the Lancaster delegation. We just had a very exciting venue in the rotunda, and I would like to thank Katie True, Bryan Cutler, Gordon Denlinger, Scott Boyd, Dave Hickernell, John Bear, and Mike Sturla. They are all behind it. It is a Lancaster County initiative, and we want to keep it Lancaster County, but we want to extend it to the State of Pennsylvania.

It is about a word called aevidum. It is a new word that DeWeese does not know, and what it means is— How it all began was this English teacher in one of my districts gave an essay assignment for the students to write about an emotional event in their lives, and the one student, Maggie, wrote a very moving essay about her brother, who had committed suicide.

Now, suicide is one of those sort of bad words we do not like to talk about. We put it in the back of our mind. We really do not think about it too much, but the reality and the hard facts are that the third largest killer of teenagers is suicide. Just today in the Lancaster paper they had the good news and the bad news about health care in Lancaster. Suicide was one of the bad issues. It is growing in Lancaster.

You know, as we go through life, we will all be touched with this issue, whether it is someone from the family, someone from one of our friends. I had two experiences. When I was 5 years old my uncle committed suicide. I do not remember the trauma of that, but I do remember the confusion of that, trying to understand what it meant. Also, I was a teacher in an eighth grade science class, and one of my students committed suicide. As a teacher, you feel an obligation to try to identify with your students, and that was really an issue that touched my heart.

You know, as we go through life, we have mountaintops and we have valleys, and we celebrate the mountaintops, but we do not want to stay in those valleys too long.

So this English class was so moved by Maggie's story that they became determined to do something, and they did. They formed a club. The club was aligned with SADD, Students Against Destructive Decisions, and they came up with a mission statement. Let me read: "To raise awareness of the warning signs of depression and suicide among students. And to save lives." As a result, they have reached thousands of students. The e-mails are coming in continuously; kids seeking help. They have the right chemistry. They have a pledge: I will cover your back. They have a T-shirt. They have a word that DeWeese does not know. They have a counseling network within the school systems. And they also have a soft rock song.

In Bradford County this month, we will have a special recognition of D-day in cooperation with a veterans picnic that we have every year in Bradford County. The focus will be on the heroic efforts that were involved with the D-day invasion.

I would just like to read a little bit of the history there to remind us all of what happened on June 6 in 1944. The American, British, Canadian, and French Allied Forces of World War II set sail from England across the turbulent, frigid waters of the English Channel to launch an invasion of continental Europe. Three years of strategic planning produced the D-day assault on the beaches of Normandy, France, to liberate France and overthrow Nazi Germany. On the night of June 5, 1944, more than 900 planes and 100 gliders of the United States 9th Air Force ascended from British fields carrying parachute jumpers from the 82d and 101st Divisions.

In the early hours of June 6, 1944, the huge armada of 1,796 vessels, including 931 American ships, moved across the English Channel. Approximately 150,000 soldiers, including 57,300 American men, landed at Normandy and 15,000 American paratroopers dropped during D-day. Approximately 6,000 Americans were killed or wounded, many being met with deadly machine-gun fire as they came ashore.

Their faith and courage enabled these brave men to complete their assault, which was the beginning of the end for Hitler and the Third Reich.

I believe it very fitting to remember the sacrifice of these men on this historic occasion of June 6, and therefore I would ask you all to join me in approving this resolution.

Mr. KORTZ. Thank you, Mr. Speaker.

Mr. Speaker, it is with great humility today that we honor the life and times of a former member, Representative Richard Olasz, 38th District, Allegheny County.

GUESTS INTRODUCED

Mr. KORTZ. Joining us today is his loving family. Please rise when I call your names and colleagues please hold your applause until all are introduced. To the left of the Speaker and in the back of the House, son and district justice, the Honorable Richard "Dan" Olasz, Jr., and his wife, Diana; daughter Mary Ann Babjak and her husband, Ron, and their children, Kristen and Michael; daughter Helen Sobocinski and her children, Tom and Steven; daughter Elizabeth "Betsy" Gardner and her husband, Lance, and their children, Sean, Andrew, and Maggie; and Dan's children, Ricky, Amy, and A.J. We welcome all of you to the Pennsylvania House of Representatives today to honor your father and your grandfather. Welcome, everyone.

At this time, Mr. Speaker, I would like to introduce Representative Marc Gergely.

The SPEAKER. The Chair recognizes the gentleman from Allegheny County, Representative Gergely.

Mr. GERGELY. Thank you, Mr. Speaker.

As we are here to memorialize a great man and a person I call a friend, I think we are really here to celebrate his life.

And I want to take a few moments of this chamber's time to kind of reflect on the person he was and the way he influenced my life, and I think it is appropriate to have this for the House Journal for history's sake.

It is an honor to be here. It is an honor to speak on behalf of the Allegheny County delegation – Chairman Frankel, Majority Whip Dermody, and all the rest of the members that had served with Representative Olasz – and I am sure serving with him was a great joy for everybody. He was always a character in the crowd.

In 1996 I was 25 years old. I was newly elected to the McKeesport Area School District. I became the president. It is a big school; AAAA; a lot of money. Rich Olasz was up for reelection. I did not know Rich, and Mayor Lou Washowich called me to his house and said, we need to help Representative

Olasz in his reelection. And the opportunity to meet the Representative happened there, but what was really unique was what he said about Rich Olasz. What he did as chairman of Transportation for McKeesport, what he has done for the Mon Valley – his dedication, his commitment, his caring for people – it reflects what we are in those areas and like many other areas of the State, like Schuylkill County, the northeast, and the Mon Valley, and the Aliquippa Valley, the Beaver County area. Rich represented all of that, and I guess in a way it reflected what I would like to be someday myself. He was a mentor to me. If you are dedicated, if you are caring, you are a person that is inspiring to many folks, and Rich did that. He did get a lot done in the Mon Valley, and we thank him for that. I think the family knows that

Irony is a great teacher, and in 2002 when I did run for this seat, Rich Olasz did not support me, but respectfully he called me. He explained to me why. He supported a close family member, Terrick; the Terrick family. He served with him as a district justice and he was supportive, but the moment I won, he was one of the first phone calls I received, and from there we grew an incredible relationship that really helped a lot of the areas that we served together, because at that point in time he was on West Mifflin Council. We built parks together. We helped the fire departments in Homeville do a lot of great things. And what was unique was – and many of the members can reflect on this - we fought Kennywood. If you remember the amusement tax issues that we dealt with pretty much through, like, '04 to '07, Rich Olasz was the public face of that locally; I was the State face of that here in the legislature. And we, at the end of the day, won that issue on behalf of our residents, on behalf of that entity, and we did the right thing.

So Rich was always, to me, inspiring. We always had our meetings at Bob Evans once a month. He always had his coffee. We would always bring a few friends. What we always did was laugh. He always told me the old stories of the old guys in the House, and you can never really understand that unless you had that opportunity with Representative Olasz.

So in closing, I want to pay homage to him. This is a file folder, but if you are from the Mon Valley, this is called a Hunky briefcase. So in honor of Representative Olasz, I brought mine today down to the floor because he was famous for his great sayings. I know they will say the one that he was always famous for, and Harry Readshaw just told me a couple minutes ago there was always another great one that he said, "If there's a will, there's always a relative."

So in honor of my Hungarian brother – he was very proud that we were both Hungarian. We both served the Mon Valley. There were a lot of similarities to us. It is a great honor to memorialize him today. Thank you.

And it is my honor that I get to introduce Representative Dave Levdansky, who also would like to say a few words.

The SPEAKER. The Chair recognizes the gentleman from Allegheny County, Representative Levdansky.

Mr. LEVDANSKY. Thank you, Marc.

I represent the 39th District, which is just next door and just south of the 38th District, the district that Dick Olasz represented from 1980 to 1998. I got elected in 1984. So I served with him for 14 years, frankly in an atmosphere and a generation of politicians that was quite different from today.

Dick was born in a house that was half in Munhall and the other half was in Homestead. "Spike" Olasz, as he was affectionately known in his younger days, always considered himself a Homestead guy, though. His dad and uncles worked at the Homestead Works of U.S. Steel and so did Dick as he worked his way through college.

Dick Olasz loved the Mon Valley and fought tooth and nail to make it a better place to live, work, and raise your kids every day. When the Homestead Works was shut down in the early 1980s and the machinery was scrapped and sold to India and China, Dick worked to revive that 400-acre site. He was able to get a \$1.5 million State grant to rebuild the flyover ramp that provided the first direct access off of Route 837 into that brownfield site. Dick negotiated with Allegheny County to get the ramp built off the Homestead high-level bridge into the site and worked with Park Corporation, who bought the site from U.S. Steel, and Kennywood to gain access for a nice water park today called Sandcastle. I only mention that because a flyover ramp, if you have never been there, it is actually a bridge, but because you could not get economic development funding for a bridge, there was a new term coined called a flyover ramp. Dick figured out a way. He needed to get access to that site, and he figured out a way to call it a flyover ramp, because it came off a bridge and went over some railroad tracks, and he was able to secure funding. So he figured out a way to make that happen.

He worked tirelessly to support the Carnegie Library of Homestead, which is actually in Munhall, and that silver-tongued Hungarian talked local businesses into doing work at the library for no charge.

Dick Olasz was a man of his word who had a large heart of gold. He was the kind of man and the kind of politician whose handshake was his bond, and you never go back on your word. He was not one to beat around the bush. You always knew where you stood with Dick. If he did not like you, you knew it. If he did like you, you knew that too. Fortunately, I ended up on the like side most of the time.

Dick fought for, as he called, the little guy. That was his perspective here. He saw himself as a blue-collar, working man's kind of politician and State Representative.

Dick liked to play the horses and do a little gambling as well while he smoked those cigars. Years ago when the House would be in session until late in the night, I vividly recall sitting in the Allegheny County delegation, and Dick would join with Steve Seventy, Freddy Trello, Tommy Petrone, and some other members, and they would take a drive down to Atlantic City and try their luck at the casinos. Boy, they would not mind being here today because they would not have to travel out of State to do that.

But Dick Olasz's greatest gift, in my judgment, was his love for people. He never stopped helping people who needed him. He knew his roots, he knew his community, and he was deeply in touch with it.

Dick loved his wife, Marie, with all his heart and was really sort of lost the last 4 years since she passed away. His children, Danny and his three daughters, and grandchildren were his pride and joy, but the loss of Marie left a hole in his heart. I know that they are once again walking hand in hand; that is, once he cleared his paperwork off her dining room table that served as his home office.

Dick Olasz grew up politically at the school of hard knocks. He got started in politics when he fought to keep the Homestead Hospital from closing. He fought so hard in fact that he lost his job over it and was blackballed for a time. Those were rough days for the Olasz family, but Dick prevailed and ran for public office where he successfully served his constituents here in the House from 1980 to 1998.

Now, we all have our favorite stories and memories of Dick Olasz, but there is one quote that if you served with him, you will never forget. He would wind up every speech in the House, whether he was passionately involved in extending insurance coverage for some procedure that the insurance did not cover or whether it was working to raise the minimum wage for working-class people or whatever it was, he always wound up his floor speeches in that strong, strong, booming baritone voice, always saying at the end, "Think about it," "Think about it."

Well, think about the working men and women who struggle day to day to make ends meet and to raise their kids and who love God, family, and their community. Dick, I will always think about it and think about you, and I will always remember you for your strength, your passion, and the love for your family and all whose lives you touched.

Godspeed, good friend, Dick Olasz.

The SPEAKER. On the resolution, the Chair recognizes the gentleman from Allegheny County, Representative Markosek.

Mr. MARKOSEK. Thank you, Mr. Speaker.

Mr. Speaker, in listening to the tributes of our former friend and colleague, Representative Dick Olasz, I was just thinking I would be remiss, particularly as we welcome his family here amongst us today, when I think back about Dick, there were two things that he loved the most in life: One, of course, was his family, as has already been mentioned here, but the other was the University of Notre Dame. Dick was the greatest so-called subway alumni, and I would put the Speaker and Representative Knowles and a few others in that category as well, but Dick was the greatest subway alumni I think that the University of Notre Dame ever, ever had.

And for those of you who are not familiar with the term "subway alumni," it got started back in I think about the 1940s when Notre Dame used to have a very, very tough rivalry with Army, with the military academy at Army. And you would have great Notre Dame-Army football matches in Yankee Stadium, and all of the folks that lived in New York City, particularly the Irish - many of them never ever went to school - they were Notre Dame fans, and they would get on the subway to go to Yankee Stadium to see Notre Dame play Army, and the name kind of stuck. They were called subway alumni, and it pertains to all those people who hold Notre Dame in great esteem and are great fans of the Notre Dame football program and other sports. We call them now subway alumni, and they are often way more enthusiastic than those of us - people like myself, Representative Turzai, Representative Brendan Boyle – who are actual alumni of Notre Dame.

So with the family here, I thought it was only proper that I mention perhaps the greatest subway alumni legislator that this building has ever seen, Representative Dick Olasz.

Mr. MAHER. Thank you, Mr. Speaker.

I have just a couple of quick interrogatories, if the gentleman would respond.

The SPEAKER. Directed to whom?

Mr. MAHER. The majority leader, I suppose.

The SPEAKER. The majority leader indicates he will stand for interrogation.

Mr. MAHER. Thank you, and this is truly informational.

The system as it currently presents this bill indicates that it had been referred to the Rules Committee and does not report further action. I am sure a number of us have heard reports of what had happened to this bill to amend it in the Rules Committee, but just for the sake of clarity, is it correct that the Rules Committee acted to revert SB 441 to the printer's number that was applicable when the bill was delivered from the House to the Senate?

Mr. EACHUS. Yes, Mr. Speaker. It was a unanimous vote to revert to the prior printer's number.

Mr. MAHER. Thank you. I just wanted to clarify what we are considering. Thank you.

The SPEAKER. The Chair thanks the gentleman.

On the question, the Chair recognizes the gentleman from Bucks County, Representative Clymer.

Mr. CLYMER. Thank you, Mr. Speaker.

Mr. Speaker, maybe I can help clarify this.

I support this legislation as it is. For those who voted for SB 441 yesterday, it is the same language you are voting again this afternoon. It provides for "a one-time issuance of a residency certificate for service in a specific shortage area of instruction..." and there are requirements in order to get that certificate.

So you are voting the language exactly as you voted yesterday, and I would ask support for the legislation. Thank you.

The SPEAKER. The Chair thanks the gentleman and recognizes the gentleman from Northampton County, Representative Grucela.

Mr. GRUCELA. Thank you, Mr. Speaker.

Mr. Speaker, I believe this bill, and I understand some of the need for it, but my concern is, your certification requirements, I believe if you read this bill, out-of-State candidates, even if they will have experience, 3 years I believe it is, can come in and be a candidate for a teaching position in Pennsylvania and get a certificate in Pennsylvania at a requirement less than we are giving our students in Pennsylvania. Specifically, I refer to the GPA (grade point average) or the grade average.

It is my understanding, of course several years ago the Governor unilaterally put the 3.0 average in the colleges, the teacher certification. Now, if I read this correctly, an out-of-State candidate who may have completed his degree in West Virginia, Ohio, Mississippi, wherever, may not have that requirement or may have a lower requirement—

Thank you, Mr. Speaker. I think the Governor cut me off. But someone from another State could possibly have a lower GPA. It does not mean they are not a great teacher. My concern is, is the playing field level? Do we have a level playing field for the candidates that want to be teachers in Pennsylvania to those candidates from outside of Pennsylvania who want to come into the State and teach? They may all be great teachers no matter where they are from. I am just concerned that we are being fair to our students, future teachers, in the State of Pennsylvania.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

On the question, the Chair recognizes the gentleman from Bucks County, Representative Petri.

Mr. PETRI. Mr. Speaker, I could not agree more with the comments of the previous speaker, and his experience as a teacher and other members of the General Assembly who have been teachers understand this issue very well. It is just completely unfair to allow people who are out of State to have benefits and rights to go back into the classroom when some of our retired teachers cannot do so and want to do so.

I would urge the members to vote "no."

The SPEAKER. On the question, the Chair recognizes the gentleman from Armstrong County, Representative Pyle.

Mr. PYLE. Thank you, Mr. Speaker.

Mr. Speaker, I would like to concur with the gentleman from Northampton. Although SB 441 intends to fill vital portions of our educational curriculum that we are currently having trouble finding certified teachers – bringing in people with practical life experience to fill those specialized roles has always been a goal – but, Mr. Speaker, what I would offer for the membership here is many school districts already do it through an emergency certification process. That is not why I rise, Mr. Speaker.

In reading this bill, it became apparent that teachers from out of State are in fact treated as a higher class than currently certified Pennsylvania teachers. I would ask one question before voting on this bill. Pennsylvania teachers are required by Act 48 to complete 180 hours of continuing education credits every 5 years by an approved-of provider okayed by the Secretary of Education. Ironically, Mr. Speaker, the Commonwealth of Pennsylvania itself is not a qualified provider. I would ask, if we are going to open up our teaching ranks to people from out of State, who as the gentleman from Northampton has very

capably identified may have less graduation requirements than we require of our teachers, will those out-of-State teachers be subject to Act 48, the same as our in-State teachers?

Let us put Pennsylvanians first, Mr. Speaker. I would say vote against this bill, SB 441. Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman and recognizes the gentlelady from Chester County, Representative McIlvaine Smith.

Ms. McILVAINE SMITH. Thank you, Mr. Speaker.

I wanted to make a comment. Although I understand the arguments, when I went back to college in 1990 to become an elementary school teacher – after I graduated in '95, because it took me 5 years because I was working, et cetera – we were told at West Chester University that we would not be able to find jobs in Pennsylvania. There were no jobs really open and to be had, that most of us should look outside of this State.

I was lucky enough to get a job in my home district and in the school where I went, through the school district in which I graduated. But I also wanted to point out that when my daughter went to Swarthmore College, they had a t-shirt that said, "A 'C' at Swarthmore is an 'A' at Harvard," that grading a lot of times can be subjective and the standards can be different. So even if you are saying that a 2.0 from, say, North Carolina, when they come here to take a job, maybe what we think of our 3.0 if we had graduated from North Carolina, it would have been a 2.0 instead of a 3.0. So you can see it from both sides.

The reason I am supporting this legislation is because I believe that we need to allow certain areas of our State that are having trouble finding accredited teachers to come in and teach. And one of the areas, I know, is Philadelphia – and I know there are other areas around this State, but I am most familiar with Philadelphia – that it is difficult to attract teachers to come and teach there.

There are standards that are written into this legislation that will make sure that these people have got to have, these candidates have got to complete certain requirements to be allowed to stay and teach. So it is not as if we are just allowing them into the schools and that is it. They have 3 years to make sure that they come up with a certificate 1.

So I urge my colleagues to reconsider and to think about it and vote for SB 441. Thank you.

The SPEAKER. The Chair thanks the gentlelady and recognizes the gentlelady from Lancaster County, Representative True.

Mrs. TRUE. Thank you, Mr. Speaker.

The previous speaker was very eloquent in her comments, and I just rise to concur in support of SB 441. One thing I can assure everybody is this issue is thoroughly vetted. It is an important bill, and I would urge the members to support it. Thank you.

The SPEAKER. The Chair thanks the lady.

On the question, will the House concur in Senate amendments to House amendments as amended? Those voting to concur will vote "aye"; those voting to nonconcur will vote "nay."

A Resolution expressing condolences upon the death of Lawrence J. McDonald, Captain of the Fire Department of the City of Philadelphia, and extending gratitude for his many years of service to the people of the City and County of Philadelphia.

On the question,

Will the House adopt the resolution?

The SPEAKER. On the resolution, the Chair recognizes the gentleman from Philadelphia County, Representative Dennis O'Brien.

Will the House come to order.

Mr. D. O'BRIEN. Thank you, Mr. Speaker.

I rise today to honor the life of a friend and a constituent of both Representative Boyle and myself. He is a retired fire captain and a good friend, Larry J. McDonald.

Larry was a fixture in my legislative district, most notably his service at the Liberty Bell Youth Organization where his children played sports growing up. More notoriously, Larry was the father of slain highway police officer Sgt. Patrick McDonald, who was another constituent, a fellow graduate of Archbishop Ryan High School, a member of our community.

And this story, Mr. Speaker, is truly overwhelming. Several weeks ago Captain McDonald collapsed as he was riding his bicycle while training for a triathlon in Atlantic City. I would like to recognize Representative Stern for his dedication to the annual memorial service for the memory of law enforcement officers killed in the line of duty. It was not that long ago that we recognized and honored the life of Patrick McDonald.

During Larry's 31 years in the Philadelphia Fire Department, Captain McDonald was assigned to many of the busiest firehouses, and he was also the recipient of many citations for heroism and going above and beyond the call of duty. He is credited with savings the lives of children, dozens of children and adults. He became a lieutenant in 1982 and was promoted to captain in 1987. According to the Philadelphia Inquirer, "Capt. McDonald was part of a team that rescued 30 people from a 'terrible high-rise fire' at the Drake Tower at 15th Spruce Streets in 1987 and helped to save a nurse and an unconscious patient stranded on a fifth floor ledge..." at "...Episcopal Hospital in 1979."

On September 23, 2008, Captain McDonald was called to Temple University's emergency room. His son, Philadelphia highway patrol officer Patrick McDonald, posthumously elevated to the rank of sergeant, had been shot in the line of duty. Convicted felon Daniel Giddings jumped from his car and ran, subsequent to being stopped by McDonald. When Pat caught up to him, Giddings pulled out a handgun from under his clothes and fired a shot directly into McDonald's heart. Giddings then proceeded to fire 10 more rounds into the 30-year-old McDonald. Officer Richard Bowes, who was shot in the leg, returned fire, killing Giddings. At this point, Larry became a rock for his family and a spokesman for the families of fallen police officers.

Larry was known as an avid fisherman, but most importantly, he enjoyed his family and friends, and we enjoyed him very much as well. I would like you to join me in keeping Larry's wife, Patricia, and daughter, Megan, in our prayers, and I would appreciate your affirmative vote in honoring the life of Cpt. Lawrence J. McDonald.

Mr. BOYLE. I just want to briefly echo the comments, the eloquent comments, of Representative O'Brien. I worked very closely with Larry over the last few years, and his son and I, approximately the same age, had a number of mutual friends.

Larry was a rock in our community, the community that Denny and I share, and what was so impressive about Larry McDonald was that he turned his personal tragedy into a cause, and that was changing the laws by which we live to make them safer for all of our communities and especially police officers.

I was privileged to chair a hearing on the issue of parole reform about a year and a half ago, shortly after taking office, and I invited Larry to testify in front of the committee. He did an excellent job. He was knowledgeable about the issue and brought a passion unlike any other. So it was a tremendous shock when we suddenly lost Larry McDonald a few weeks ago. He was a good friend and a great Pennsylvanian, and we should all do what we can to keep him and his family in our memories and honor his memory. Thank you.
