(a) Findings.—John E. Fitzgerald was a civil engineer who worked on the construction of the designated bridge and later became the first superintendent of the Northeast Extension of the Pennsylvania Turnpike. He served in that capacity for 13 years before retiring.

(b) Designation.—The bridge on the Northeast Extension located in Clarks Summit, which crosses over Routes 6 and 11 in Lackawanna County, is hereby designated and shall be known as the John E. Fitzgerald Memorial Bridge.

(c) Signs.—The Pennsylvania Turnpike Commission shall erect and maintain appropriate signs displaying the name of the bridge to traffic in both directions on the bridge.

Currently PENNVEST may direct funds only to counties with storm water management plans, but that unintentionally leaves many counties and many projects that are much deserving out of those projects, and so this bill addresses the nonpoint source pollution in a lot of counties.

This bill fixes the problem, has the support of the administration and the Senate, and I know you will join with me so we can do the best we can to help out those areas that need this type of project in their areas. Thank you very much.

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

(Bill analysis was read.)

The SPEAKER. The question is, shall the bill pass finally?

On that question, the Chair recognizes the gentleman from Monroe County, Representative Siptroth.

Will the gentleman yield.

The House will come to order. The House will come to order. The House will come to order. The House will come to order. Who wants to be home for the Fourth of July? The House will come to order. We are just trying to get the House one more decibel lower. We will get through this calendar, we will go to our respective caucus rooms, but the gentlemen that want to debate these bills have a right to be heard.

The Chair recognizes the gentleman from Monroe County, Representative Siptroth.

Mr. SIPTROTH. Thank you, Mr. Speaker.

HB 2601 is a simple yet groundbreaking piece of legislation that is aimed at saving the Commonwealth a significant amount of money and at the same time we can increase energy efficiency and conservation by setting standards and leading by example, not only for our residents of Pennsylvania but for other States as well.

This legislation creates the channel for which companies with new environmentally beneficial and cost-reductive technology can test a new product at one of our State agencies for a period of 30 to 60 days. The Department of General Services is authorized to oversee the program and set the standards for compliance.

After the trial period has ended, if the technology has proven it will reduce the cost or increase energy efficiency, the Secretary of DGS, along with the Governor and the administrative head of the testing agency, may recommend statewide implementation of that technology.

The important benefit of this is that the trial of new technologies will have no cost to the Commonwealth. The business must pay for all associated costs with the testing of the new product. Further, the business accepts all liability. Only if the technology is proven to be cost-reductive will the Commonwealth have the opportunity to purchase the technology at the State agencies.

I would like to thank the Secretary and the staff of DGS, Chairman George and his staff, Chairman Hutchinson and his staff for moving this important piece of legislation along.

This legislation is modeled after section 63 of the Connecticut Public Act 09-7, an act concerning test bed technologies. This is a bill that passed unanimously through the Connecticut Energy and Technology Committee and both the State Senate and House of Representatives. It is my hope that this bill will receive the same bipartisan support.

Thank you, Mr. Speaker.

The SPEAKER. The question is, shall the bill pass finally? On that question, the Chair recognizes the gentleman from Lancaster County, Representative Boyd.

Mr. BOYD. Thank you, Mr. Speaker.

I was wondering if the maker of the bill would stand for interrogation, please?

The SPEAKER. The gentleman from Monroe County, Representative Siptroth, indicates he will stand for interrogation. The gentleman, Mr. Boyd, is in order and may proceed.

Mr. BOYD. Thank you, Mr. Speaker.

Mr. Speaker, I looked at my screen and I did not know if there is a fiscal note for this piece of legislation. In your testimony earlier, you suggested that there would be substantial savings for the Commonwealth. Has that been documented with a fiscal note?

Mr. SIPTROTH. The fiscal note reflects a zero impact to the Commonwealth that was presented in the Appropriations Committee.

Mr. BOYD. Thank you, Mr. Speaker.

Another question, if I may. When I read the bill, the technologies that you referred to have to be also tested by a third-party entity. Is that correct? Like a private entity?

Mr. SIPTROTH. That is correct. The bill calls for this technology to be somewhat proven before it gets here, and there are a number of certainly excellent universities that have the abilities to test these technologies, and that information would be provided to the Secretary, as provided for in the bill.

Mr. BOYD. Thank you.

Do you anticipate that these technologies would be patented technologies?

Mr. SIPTROTH. I would expect that they would be patented technologies. After all, these are businesses that are coming forward, Mr. Speaker, and therefore, they want to recover some of their investment as well as save us dollars.

Mr. BOYD. Thank you.

I guess what I am trying to understand is, if the bill actually requires that there is a private testing procedure that goes on,

what advantages are to the State to actually have them duplicate that private-sector service? I am trying to understand what the benefit is there.

Mr. SIPTROTH. Okay. To this point, let me give you a little history, if you do not mind, Mr. Speaker, just for a few moments. A company that was located in my district and has now broadened their entrepreneurial obligations was down here 3 years ago and met with the Department of Environmental Protection, and 3 years later they are just now getting through the COSTARS program. The Commonwealth could have saved significant dollars had the Commonwealth opted, had the Commonwealth opted to purchase this particular product.

What this does is it certainly enhances and reduces the timeframe so that DGS would move a little bit more quickly in evaluating these particular energy technologies, and if they feel that they are acceptable, implementing them in the Commonwealth and through a number of Commonwealth programs.

Mr. BOYD. Thank you.

That concludes my interrogation. If I may speak on the bill?

The SPEAKER. The gentleman is in order and may proceed.

While I commend the maker of the bill for the thought process, when I reviewed the bill, the way I read it is that it is at the sole discretion of the Governor, who has to approve, and then also the department who would end up going into this test or this testing procedure. So it is at their discretion and they pick a technology that they are going to test. The chances are the technology is patented and then chances are if the Commonwealth is going to purchase that technology, they only have the single source to go through. So it seems to me that we are presenting another opportunity for the administration, regardless of who is in charge of the administration, to pick winners and losers again. It is another way of going around the procurement process. And I have a problem with that, particularly when the private sector already accomplishes this process by having independent testing agencies – whether they are through the university or through underwriters, laboratories, or whatever – to test these products and document statistically that there is cost savings. And at that point, if a vendor wants to present themselves to the Commonwealth to sell something, they can do that, and the Commonwealth can choose whether or not they want to go out and get bids on it.

It just seems to me – and it is interesting that the gentleman referred to something that stemmed from his specific legislative district – it just seems to me that this is another opportunity for the administration to pick winners and losers and to handpick specific technologies that they want to promote. I am not saying that that is the gentleman's intent, I just think that that is an unintended consequence of this bill, that if you know someone in the administration and you can get somewhere to get them to test your product that you have an advantage into getting that into Commonwealth buildings. I am not so sure in this era of reform and this era of transparency that that is a wise way to do business.

I like the idea of trying to get the green technologies and get them into our Commonwealth agencies and saving money; I do not like allowing the administration to handpick winners and losers. For that reason, Mr. Speaker, I am going to have to oppose this piece of legislation. Thank you.

The SPEAKER. The Chair thanks the gentleman and recognizes the gentleman from Cumberland County, Representative Grell.

Mr. GRELL. Thank you, Mr. Speaker.

Would the sponsor of the legislation stand for brief interrogation?

The SPEAKER. The gentleman, Mr. Siptroth, indicates he will stand for interrogation. The gentleman, Mr. Grell, is in order and may proceed.

Mr. GRELL. Thank you, Mr. Speaker.

I share the concern of the gentleman from Lancaster County. And my question is, if a technology is proven, according to the process set forth in this legislation, would this legislation allow the Department of General Services to specify that particular technology in a procurement?

Mr. SIPTROTH. It is the intent of this piece of legislation not to do that. They would still go through the RFP (request for proposal) process. Right now DGS can do exactly what you are mentioning. However, this bill does not fast-track that process. This fast-tracks the testing process from between 30 and 60 days.

The Secretary of DGS, if you look at the language in the bill, indicates may, may, may, and that was specifically written in there so that we would not have, necessarily, a review and a purchase. This bill is designed simply to provide a more expedited form of testing.

Mr. GRELL. But, Mr. Speaker – if I may continue?

The SPEAKER. The gentleman is in order.

Mr. GRELL. At the end of that testing process, whether it is expedited or not, is it or is it not within the ability of the Department of General Services to specify that this technology and this technology only is what the department or any agency is requiring in an RFP?

Mr. SIPTROTH. Mr. Speaker, the bill is designed, if you look on page 3, that in fact the Secretary will have the particular product tested, not necessarily purchase. There is nothing in here that says that the process is going to be purchased. It says, the "...process and to undertake such a test program."

Mr. GRELL. Well, then my question would be, does the Secretary of the Department of General Services have the discretion to determine which products will be tested and which products will not be tested? That would open the same concern.

Mr. SIPTROTH. It also says, on page 3 of that bill, line 26, that "The secretary may not direct a State agency to test a technology, product or process unless the business entity or entities benefiting from the field testing pay all of the associated costs." So in reality, yes; I guess the Secretary does have some latitude as to what particular technologies get tested but certainly not required to purchase that technology. They may make a recommendation to a department to put the product out for bid through the normal RFP process.

Mr. GRELL. My final question is this: Is there anything in this legislation that would require the department to allow equivalent technologies to be bid on any procurement using this new technology?

Mr. SIPTROTH. Would you repeat the question, sir? I am having a little trouble hearing you.

Mr. GRELL. I understand. Mr. Speaker, is there anything in the legislation that would require the department to include terminology that equivalent technologies would also be

considered so that they would not have a proprietary patented specification that would exclude all other bidders and lead to more sole source contracts?

Mr. SIPTROTH. Mr. Speaker, there is nothing in the bill that requires the testing or the purchase of a particular product. If there is like technology, there is nothing in this bill that precludes that particular business firm from, certainly, bidding on the process and also entering into a test agreement with the department.

Mr. GRELL. Okay. That concludes my interrogation.

Briefly on the bill?

The SPEAKER. The gentleman, Mr. Grell, is in order and may proceed.

Mr. GRELL. Thank you, Mr. Speaker.

While like my colleague from Lancaster County I support the concept and what is trying to be achieved, I do not think the legislation as it is currently written contains sufficient safeguards to prevent the department and the Commonwealth from selecting certain companies that will go through this process expeditiously and therefore have a leg up, and possibly an exclusive leg up, to receive contracts in the future.

I am going to vote against the legislation. I would hope that if the legislation does pass that the sponsor might be receptive, when the bill goes to the other chamber, to working on some language to clarify that potential, because I do not think that is the gentleman's intention. But as the bill is written, I think it is fatally flawed, and I will not be able to support it today. Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman and recognizes the gentleman from Union County, Representative Fairchild.

Mr. FAIRCHILD. Thank you, Mr. Speaker.

I rise to support HB 2601.

I commend the sponsor for thinking outside the box. I think we need more of that in government. What this bill does is puts the onus on the private entity. There is no cost to the taxpayer. It is a test. There is a trial period. It cannot be less than 30 days nor more than 60 days.

And again, the risk is on the businesses that are promoting the product or process. Too many times government ends up buying a pig in a poke – an untested, unproven product that may fit a particular purpose and may not. This legislation allows that square peg to fit in the square hole, and I commend the sponsor and I will be voting positive.

Thank you, Mr. Speaker.

HB 2405 is the renewable energy bill that much time and effort has been put into by many members of this chamber, staff, members of the administration, and so forth.

What this bill would do is basically three things: It would raise the alternative energy portfolio standard to 15 percent by 2024, it would increase the share of renewable energy to 3 percent by 2024, and it would establish a framework for a carbon capture and sequestration system. The reasons for this – and I personally believe that this is the most important environmental piece of legislation this chamber has faced – the reasons for this are jobs, energy independence, and protecting the environment.

Mr. Speaker, according to a recent Black & Veatch study, this would result in over 125,000 additional job hours. It would also remove up to 16 million tons of carbon dioxide from our atmosphere each year and give us more independence from energy sources overseas.

Mr. Speaker, this is a vitally important bill that this chamber consider. Great effort has been made to try to force this to a vote. There has been a lot of political resistance, resistance from special interest groups, the utilities, the coal producers, the chamber, and so forth. It is important that we do not succumb to those special interests. But, Mr. Speaker, having been here 18 years, I understand that if this motion were to come to a vote today, because of the budget upon us and because of the desire for many members to get to their districts, I fear it would not pass.
