We want to welcome the Blue Star Mothers of America as well with respect for their sacrifices. They are here as guests of Representative Tom Killion. Welcome to the hall of the House, ladies.

## STATEMENT BY MR. KILLION

The SPEAKER. Does the gentleman, Mr. Killion, seek unanimous consent? The gentleman is in order under unanimous consent. The gentleman, Mr. Killion, from Delaware County.

Mr. KILLION. Thank you, Mr. Speaker, and I would like to thank my colleagues for the affirmative vote on HR 189.

The Blue Star Mothers of America was founded as a patriotic service organization in 1942 to unite the mothers who had sons or daughters in the United States Armed Forces. The nonpartisan, nonprofit organization was chartered by the Congress of the United States in 1960.

Mr. Speaker, could I have some order?

The SPEAKER. Members will please take their seats; clear the aisles. The Speaker would ask the members to please clear the aisles and take their seats. The Speaker thanks the members.

The gentleman may proceed.

Mr. KILLION. Thank you, Mr. Speaker.

Eligible members of the Blue Star Mothers include mothers and stepmothers who have sons or daughters who are currently serving in the U.S. military or who are honorably discharged veterans. The work of the Blue Star Mothers of America includes providing support for active-duty service personnel and their families, promoting patriotism, and assisting various veterans organizations.

The work of the Blue Star Mothers of America is increasingly important to the more than 450,000 members of the United States Army Reserve components having been called to active service around the world since 2001, including more than 20,000 Pennsylvania soldiers and airmen, consisting of more than 4,000 soldiers of the 56th Stryker Brigade and more than 1,000 soldiers from the 28th Combat Aviation Brigade who were deployed to Iraq. The dedication, sacrifice, and hard work of the devoted members of the Blue Star Mothers of America merits our recognition.

The Blue Star Service Flag is the official banner authorized by the Department of Defense and for display by families who have members serving in the United States Armed Forces during a period of war or armed conflict the nation may be engaged in for the duration of such activities.

The Blue Star Flag is currently hanging in the East Wing rotunda to recognize May 2011 as Blue Star Mothers of America Month in Pennsylvania. You have joined me in honoring this great organization by your vote in favor of HR 189, and please, once again join me in recognizing the members of the Blue Star Mothers who are in the rear of the House

Thank you, Mr. Speaker, and I have to mention two things. One, we do have a dad with us. We want to honor him as well. Also, if the moms that have sons or daughters currently deployed, if you could stand up so we can give you a special round of applause as well. Thank you.

# **GUESTS INTRODUCED**

The SPEAKER. We have a few other guests with us.

And in the well of the House, as guest pages – they are guests of Representative Lawrence – we have Melanie Delduco, Allison Malone, Anna Malone, and Martin Reynoso. Our young guests, welcome to the hall of the House.

## ITALIAN DELEGATION PRESENTED

The SPEAKER. The Speaker would like to ask the members to please take their seats and give their attention. We have a few other special guests that we are welcoming to the hall of the House today, and we would like to invite them, one of them, at least, we are going to invite to the reader's dais to make some comments.

Located to the left of the Speaker, we have Luigi Scotto, the Consul General of Italy in Philadelphia; Joe Auteri, the president of the Italy-America Chamber of Commerce of Greater Philadelphia; Marco Albonico, as well as Marco Circelli and Peter Alois. They are guests of Representative Vitali and Representative Scavello, and at this time, gentlemen, please rise to be welcomed.

And I invite the Consul General to the reader's podium to address the House. If the members would please give our guests attention and the courtesy, please. Conversation will please cease. The members will please take their seats. The Speaker thanks the members.

You may proceed.

CONSUL GENERAL SCOTTO. Thank you, Mr. Speaker, Sam Smith.

Honorable members of the House of Representatives of Pennsylvania, it is a great honor for me to be here before you to celebrate the 150th anniversary of the Unification of Italy in the State with the richest history in the United States of America.

Mr. Speaker and members of the House of Representatives, on behalf of the Republic of Italy, I would like to thank Representative Greg Vitali for proposing this resolution recognizing the 150th anniversary of the Unification of Italy. As I like to say on this occasion, Italy is a culture of superpower, and I would like to draw your attention to the vital contribution that culture itself can give to the celebration.

I refer to "historical culture," whose heritage of studies on the Risorgimento and the unification process deserves to be recalled in this occasion and offered here for its dissemination and not in simplistic terms. To be speaking of our history here is also a way to spread it among the many American friends of our country to whom we are tied by very firm bonds.

To this end, I would like to recall the words of a great U.S. President, John Fitzgerald Kennedy, who on March 16, 1961, at the 100th anniversary of the Unification of Italy, said, "The [renaissance] which gave birth to modern Italy – like the revolution which forged a United American Republic out of thirteen English colonies – was a 'reawakening' of most deeply held ideals of our civilization – the desire for human freedom, for protection of man's dignity...."

If we are to meet this new challenge facing our civilization, we – Italy and America – must demonstrate to our own people and to the world that free men, acting in the tradition of Mazzini and Garibaldi and Cavour, Lincoln, Washington, Franklin, and Jefferson, can best bring man a richer and fuller life. This is the task of the new Risorgimento – a new reawakening of man's ancient aspiration for freedom and progress.

Today, 50 years after, these words still sound current. From these words, 50 years later, I seem to perceive an ideal continuity with those recently pronounced by President Obama, and I quote: "At a time when the United States was fighting for the preservation of our own Union, Giuseppe Garibaldi's campaign for the unification of Italy inspired many around the

world in their own struggles, including the 39th New York Infantry, also known as 'The Garibaldi Guard.' Today, the legacy of Garibaldi and all those who unified Italy lives on in the millions of American women and men of Italian descent who strengthen and enrich our Nation.

"Italy and the United States are bound by friendship and common dedication to civil liberties, democratic principles, and the universal human rights our countries both respect and uphold."

Today, I think it is essential here to remind everyone and ourselves what we have accumulated in the past, what we have behind us in terms of capabilities and wealth of knowledge in the field of scientific research and production, and to do our best to protect such heritage from being sterilized in any way and grow it even further.

As President Napolitano said, the Italian identity exists, it is strong, and its determining factors, which we never fail to celebrate here in America and particularly in my jurisdiction with the many friends of our country, are the language, the Catholic religion, the culture, and the artistic and historical heritage.

And I would like to conclude this brief address with a few more words from my President, President Napolitano: "I hope we will spare ourselves the trifling misunderstanding of always seeing a lurking intent of an impossible clasp, of the cessation of conflict, physiological to any democracy, between divergent political and social demands. It is time we free ourselves from such petty spectra and bias, to look at the wider horizon of the future of the Italian Nation, to elevate policy-making and institutional operations to the level of fundamental values and common interests."

Thank you very much.

The SPEAKER. The Speaker recognizes the gentleman from Delaware County, Mr. Vitali.

Mr. VITALI. (Speaking in Italian.)

Thank you. What I said was— I really cannot speak Italian, because I did not have enough time to prepare my speech, but I wanted to thank—

The SPEAKER. The gentleman will suspend.

The Speaker was worried what he might be saying about the Speaker in Italian, and he would not understand either.

Mr. VITALI. Well, you are going to need a translator to find that out.

The SPEAKER. Yeah; I know.

Mr. VITALI. But I do want to thank the Consulate for coming today to commemorate the 150th anniversary of the Unification of Italy. We are all proud of our ethnicity, and I know many of my Italian colleagues are joined by others of other ethnicity to sort of celebrate the Unification of Italy as a country, which actually, interestingly, happened at the same time the United States was keeping itself unified during the U.S. Civil War. I thank you for that.

I do want the House to know that this is not simply a commemorative visit. We have a business component of this. The Consulate, along with Joe Auteri, a friend and colleague who is the president of the Italy-America Chamber, who is vitally interested in promoting Pennsylvania business from Italian companies, we are rolling up our sleeves and working today. Joe has already brought Italian companies to this country. We have met with Secretary Krancer this morning for further discussions. We are meeting with the Governor's action team

and the Department of Community and Economic Development at 1 o'clock today to further these Italian-American business interests.

I also want to recognize another friend and former diplomat, Peter Alois, who is here today, along with Marco and Marco, the respective staffs.

I do want to invite the chamber – listen up; this involves food – I do want to invite the chamber for a luncheon. I know that Tony DeLuca was kind enough, president of our Italian-American Caucus, was kind enough to host a luncheon today at 12 o'clock in his office, which is room 115 Irvis, and I cannot guarantee you many things, but I can guarantee you the food will be good Italian food.

And the final point: My Italian friend, Representative Scavello, I want to thank him for not only his Italian lessons but also for helping me cohost this resolution and coordinating this event. So thank you.

Thank you, Mr. Speaker.

The SPEAKER. The Speaker thanks the gentleman.

For what purpose does the gentleman, Mr. Thomas, rise?

Mr. THOMAS. Thank you, Mr. Speaker. On unanimous consent.

The SPEAKER. The gentleman may proceed under unanimous consent.

Mr. THOMAS. On behalf of Representative Donatucci and a couple of my other friends, I would just like to say bene grazie to the gentlemen.

The SPEAKER. The Speaker thanks the gentleman.

For what purpose does the lady, Ms. Donatucci, rise?

Ms. DONATUCCI. Mr. Speaker, under general consent. Thank you.

The SPEAKER. The lady is in order under unanimous consent and may proceed.

Mr. MURT. I do seek recognition, Mr. Speaker, relative to HR 262. Is this the appropriate time to speak on that, Mr. Speaker?

Mr. MURT. Mr. Speaker, I cannot think of a better moment to acknowledge the sacrifice made by the men and women of our military than during the week we witnessed their

proficiency, their professionalism, and their determination in taking out the evil behind the 9/11 attacks.

Mr. Speaker, Americans across our country rightfully praised our military for the decade-long mission in the deserts of Afghanistan, Iraq, and Pakistan. But this week's success makes it too easy to overlook the scars of war that will linger long after our warriors come home. It was not until the Civil War that the medical community first acknowledged the mental wounds suffered by those who were placed in harm's way in defense of our nation. They first called it shell shock, then later on battle fatigue. After the Vietnam war, we called it post-traumatic stress disorder.

Mr. Speaker, regardless of the vernacular, the pain remained the same for our brave veterans – difficulty in adapting to civilian life, alienation of close family and friends, insomnia, hypersensitivity, nightmares, angry outbursts, and even thoughts of suicide by brave men and women who have served in combat.

Mr. Speaker, the veterans of our current conflicts are no different. The medical community estimates that as many as one-third of the veterans from the current conflicts are suffering undeniable signs of post-traumatic stress disorder and other mental illnesses. This is why I believe that during the week that our brave warriors have brought justice to the mastermind behind 9/11 and during the month we formerly commemorate those lost in war, we must acknowledge the medical challenges faced by our soldiers, sailors, airmen, coastguardsmen, and marines. This is why I urge my colleagues, Mr. Speaker, to join me in my call to designate May as "Military Service-Related Post-Traumatic Stress Disorder Awareness Month" in the Commonwealth of Pennsylvania.

An Act designating the bridge that carries Pennsylvania Turnpike Route 43 over the Monongahela River between Denbo in the Borough of Centerville, County of Washington, and Alicia in the Township of Luzerne, County of Fayette, as the PFC Ronald C. "Smokey" Bakewell Memorial Bridge.

On the question,

Will the House agree to the bill on third consideration? Bill was agreed to.

(Bill analysis was read.)

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

Could we have the members' attention. If we could break up the conferences in the aisles and please have the members take their seats.

This bill has to do with a memorial bridge, and we would appreciate the members' attention. The members will please take their seats, clear the aisles.

The question is, shall the bill pass finally?

On that question, the Speaker recognizes the gentleman from Greene County, Mr. DeWeese.

Mr. DeWEESE. Thank you, Mr. Speaker.

The year was 1967. It was Christmastime. A guy from Brownsville, PA, got a draft notice, Ron Bakewell. By early in January, he was at Fort Gordon, then at Fort Polk, and the Tet Offensive was raging in Vietnam. Four hundred kids a week were dying. Twenty-six thousand died in 1968, 26,000 youngsters in our Armed Forces. This young boy from Brownsville entered the summer of 1968 in the northern provinces of Vietnam.

To wear the Combat Infantryman's Badge, as our colleague, young Miccarelli, wears, one has to be in a combat setting under fire for 30 days. Ron Bakewell served only 42 days in Vietnam and had the Combat Infantryman's Badge. He was under fire virtually every day. On a steamy, dusk evening in August 1968, an NVA (North Vietnamese Army) sniper's bullet found him and he was lethally wounded as he was setting up a perimeter defense. One more casualty in that challenging setting in faraway southeast Asia in 1968.

Now, many years later, Mr. Speaker, and thank you for the floor and thank you for the attention of my colleagues, Ron Bakewell, I hope, can be honored by this massive steel and

concrete structure that will span the broad-bosomed Monongahela River and the Pennsylvania Turnpike as it moves north toward our brothers and sisters in Allegheny County. This bridge will be overshadowing where Ronny Bakewell played sandlot ball and tackle football. They did not play touch football in Brownsville, PA. But the Bakewell family did not come to me and ask me to do this; his friends did, the boys he played ball with, the kids he grew up with in the 1960s and when he was even younger during the age of Eisenhower in the 1950s.

Ron Bakewell is every man. We name bridges after admirals and generals, Presidents. We name bridges after Medal of Honor winners and those are as they should be, but every once in a while, a Pfc. (private, first class). Forty-four years since he laid down his life in the jungles of Vietnam, we have the chance to honor him, and I am very, very keen in my respect and gratitude to the members of this chamber for their attention and for their vote in the affirmative so that Ron Bakewell's name shall endure as the bridge that spans the river bears his name. Thank you.

The SPEAKER. The Speaker thanks the gentleman.

On the question recurring,

Shall the bill pass finally?

#### INTERROGATION

The SPEAKER. For what purpose does the gentleman, Mr. Markosek, rise?

Mr. MARKOSEK. Thank you, Mr. Speaker.

Mr. Speaker, I rise under unanimous consent with the intention of interrogating the gentleman from Delaware, the chairman of the House Appropriations Committee.

The SPEAKER. The gentleman is in order under unanimous consent.

Will the gentleman from Delaware County, Mr. Adolph, stand for interrogation? He indicates he will. You may proceed.

Mr. MARKOSEK. Thank you, Mr. Speaker.

Mr. Speaker, we are now into the first week of May, and I know the deadline for passage of the budget is June 30 and things are starting to bunch up on our calendars and we have some time off in the next couple of weeks as well. I know that from the rules of the House that a budget bill would have to be posted by 4:30 p.m. next Wednesday if in fact we would be able to do anything with it the week after we return from the primary break. So my question to you, sir, is, what are the plans of the majority in scheduling and posting the budget?

Mr. ADOLPH. Thank you. Thank you, Mr. Speaker.

Thank you for giving me those deadlines, and we will certainly make those deadlines. We have been working very diligently over the last couple of months trying to put together a budget that fits the needs of many Pennsylvanians, and we should be working on some budget issues next week.

Mr. MARKOSEK. Can you give us an exact time that you intend to post the budget, please?

Mr. ADOLPH. As the chairman does know, we have a meeting set up together tonight, and I was going to politely and courteously tell you all about it over a hamburger, but—

Mr. MARKOSEK. I can hardly wait.

Mr. ADOLPH. Since you want to— Yeah, we are going to be introducing a bill hopefully by Monday. It is still a work in progress. It will be given its due notice, and hopefully the Appropriations Committee will see it some time on Wednesday.

Mr. MARKOSEK. Will the budget take into consideration the latest news that we have relative to the revenues that have come into the State? As we know, we are way above any estimate. Apparently, the stimulus has worked better than anybody thought.

The SPEAKER. The Speaker would remind the gentleman he is under unanimous consent.

Mr. MARKOSEK. May I ask if the budget will consider any of those new revenues being included in the budget spend number?

Mr. ADOLPH. It is amazing how the economy has responded to Governor Corbett's new administration. Unemployment has dropped close to two points in the last several months, and tax revenue has never been greater. So things are definitely looking up. I do not have to tell the gentleman regarding some reserves that we would like to set up to make sure that some of the liabilities that were left to this General Assembly by the last administration in case some of those court rulings come out, that we will prepare to pay our debt to society.

Mr. MARKOSEK. Thank you.

The revenue numbers have come in, and I think you and I both know will be well over half a billion dollars for this fiscal year, which sets a new base, so therefore, over the remainder of this fiscal year and next fiscal year, it will be roughly, minimum, a billion extra dollars. Now, you mentioned some reserve funds. I know in the past that we have had so-called rainy day funds and we certainly have a lot on the books, but for a lot of people out there it is raining right now. Will your budget consider the fact that the Governor's budget has very draconian cuts to education and many other items? Will your budget be using much of this excess funding to restore some of those draconian cuts?

Mr. ADOLPH. Thank you, Mr. Speaker.

I would just like to remind everyone that the year is not over. This is revenue based upon April 30. I am optimistic, as the previous speaker is, regarding the economy. I think there are industries that are developing in the State that have brought in some extra corporate net income tax. It was the corporate net income tax last month that actually was \$200 million over the budgeted amount. I would just like to remind the gentleman that there are extra depreciation rules and so forth that we have to be careful of. The safe harbor estimated taxes that have been paid need to be looked at and make sure that the tax reserve refund section is prepared for that, starting probably sometime in October of 2011.

So we are taking into consideration the reserves. I am telling you I am very, very happy with those reserves. It is certainly much better, I think, moving some of the money to this year's budget by both the Rendell administration as well as the Corbett administration, were wise decisions by both. I am sure we are going to have a very healthy debate and go over where we stand once the budget is introduced. It is hard to talk about all the details when the budget has not been introduced, the bill yet.

Mr. MARKOSEK. Mr. Speaker, I think you recall that the Governor, when he produced his budget proposal on March 8, indicated that their estimate for the surplus, not surplus, but the revenues over what is expected was about \$78 million. We are now up to, as the end of April, \$505 million. So I think it is pretty obvious, while granted there are 2 more months left to the fiscal year, that we will be well over any estimates that we potentially could have even dreamed of not that long ago. My question is, will your budget restore some of the cuts that the Governor had mentioned on March 8, restoring, for example, kindergarten through college, the funding for those line items that have been seriously, seriously cut, over \$1 billion in basic education, \$500 million in higher education, or are we just going to sit on this massive, massive surplus while we have so many Pennsylvanians that are experiencing so many problems because of the horrendous budget cuts?

Mr. ADOLPH. Thank you, Mr. Speaker.

I would just like to remind the speaker that on July 1, we will be without \$3 billion worth of Federal stimulus money. Obviously, any budget that is introduced must take into consideration a loss of about 10 percent of our total revenue. I do believe all the members in this House will, overall, see an improvement on the education appropriation. I am looking forward to working with the gentleman in establishing the best budget possible with the loss of \$3.1 billion in Federal stimulus money.

Mr. MARKOSEK. Mr. Speaker, thank you.

You have been very gracious. I really just have one final question. Will your budget remain at the \$27 billion, \$27.3 billion spend number that has been offered by the Governor? Will it go above that? Will your restoration of cuts that you mentioned be with some of this new money that is available out there as opposed to just shifting budget line items around?

Mr. ADOLPH. I believe that our caucus has remained disciplined and we are not going to overspend what we do not have. We are going to try to stay in the parameters that have been laid out by the Governor. You have to take a look at the projected revenues for next year, at the tax revenues. There are not an awful lot of one-time gimmicks left in order to balance the budget. So we have to really be diligent in taking a look at the actual tax revenues that are coming in next year. I know the gentleman has filed his Pennsylvania income tax on time, and I do appreciate that. We will be working together in order to balance this budget within the tax revenues anticipated.

Mr. MARKOSEK. Well, the anticipated revenues are \$1 billion more than the \$27.3. So can we assume then that, yes, you will spend more than the \$27.3, which we all know we have more than that available?

Mr. ADOLPH. I really do not agree with the billion dollars. You can only spend a \$500 million cash surplus once. You cannot assume that you are going to have the same surplus again next year, and I think that is the trouble that the prior gentleman's caucus had in spending our State government money previously. You cannot spend money before you get it and it seems like you have already doubled it.

Mr. MARKOSEK. So am I to understand then, or so all of us here in the room understand, that you are sticking to the \$27.3 number?

Mr. ADOLPH. We are doing our best to stay and not spend any more than the tax revenues will bring in.

Mr. MARKOSEK. Well, is that a no then? You are going to go over the \$27.3? Because there is going to be more than that, I think we all know. It may not be a billion, but it will be something.

Mr. ADOLPH. It will definitely not be a billion. You can only spend \$500 million once. You do not know what next month is going to be. I think the Governor did a very good job in using a projected increase in revenue of 4 percent. Because of the additional depreciation that our corporations and individual small businesses will be able to use in this fiscal year, we have to be very diligent in making sure that we have reserves for any refunds there, but I do believe by staying disciplined and staying controlled, we will be able to get Pennsylvanians back to work and State government spending under control.

Mr. MARKOSEK. Thank you, Mr. Speaker.

That ends my interrogation. Mr. Speaker, I want to thank the gentleman for his graciousness and all of the members for the additional time here. This is an important time. We have not really gotten into publicly talking about the particulars of the budget until today. So I assume this will be kind of the opening salvo, if you will, but we have a lot of work to do. Our members in the Democratic Caucus are here to work. We will be here right up through July 31, when we finally get the budget done. We are prepared to do that and to provide a budget that helps Pennsylvania, based on the funds that we actually do have.

Thank you, Mr. Speaker.

The SPEAKER. The Speaker thanks the gentleman.

We all assume that he meant June 30. You misspoke and said July 31. We do not plan to be here July 31, just for the record.

Is there any other business before the House?

Does the gentleman, Mr. Thomas, seek recognition under unanimous consent?

The Speaker thanks the gentleman.

We are going to work across the aisles to make sure that we best serve the citizens of Pennsylvania, but we have an obligation to govern and we will meet that duty unlike the past 8 years. Thank you.
