The amount of selflessness they displayed was a great thing to see. # MOMENT OF SILENCE FOR PENN STATE HEAD FOOTBALL COACH JOE PATERNO

#### STATEMENT BY SPEAKER

The SPEAKER. As a Pennsylvanian and also an alumnus of Penn State University, I think I understand what Joe Paterno did. He helped instill character and integrity into everything that was Penn State. The fact is, Joe Paterno made a difference, and that is something that I think we all strive to do, but he accomplished that many times over. Yeah, he made a difference in college football, but more importantly, he made a difference in the lives of thousands of students, athletes, adults, and parents.

Thanks to Coach Paterno, Penn State, this Commonwealth's land-grant institution, did not just have a great football team but had great athletes who got a great education and then earned their diplomas, and that is not something that happened at every major university in this country. Thanks to Coach Paterno, people learned personal ethics and commitment, and those things still matter today.

Coach Paterno was committed to Penn State and the students. He had several lucrative offers to go to the NFL (National Football League) but chose to stay in Happy Valley, and you do not see that kind of commitment much anymore.

And so with the news of Coach Joe Paterno's passing this weekend, I celebrate Paterno's life, his life at Penn State, and I celebrate it with Penn State pride. His class and dignity, reflected by his players and, in a way, through the plain blue and white uniforms that Penn State was known for, those were the kinds of things that I remember about Joe Paterno. He led with pride, yet remained humble. As others grabbed for ever more, he shared his wealth. At the end of each day, he went home to his family. Those are the attributes, those are the things that I admire, and those are examples that we should aspire to follow.

I believe in the end, the legacy of the coach will survive the public rush to judgment he was exposed to by some in the media who chose to react without getting his side of the story. So today I do not mourn Coach Paterno's death per se; I cheer the way he lived, and I give thanks for all that he gave us.

I would ask the members and guests to please stand in a moment of silence in respect for a great Pennsylvanian and in prayer for his family. (Whereupon, the members of the House and all visitors stood in a moment of silence in solemn respect to the memory of Penn State Head Football Coach Joe Paterno.)

Mr. B. BOYLE. Thank you, Mr. Speaker.

Mr. Speaker, United States Naval SEAL (Sea, Air, and Land) Michael Strange was born on the 6th of June 1986 in Philadelphia, Pennsylvania. He graduated from North Catholic High School where he excelled in academics and played varsity rugby.

Following his graduation in June 2004, Petty Officer Strange enlisted in the Navy and reported to RTC (Recruit Training Command) Great Lakes in Illinois. After graduating basic training, he reported to the Naval Technical Training Center, Corry Station, Pensacola, Florida, where he attended cryptologic technician school and graduated second in his class.

His first assignment was Naval Information Operations Command in Hawaii from May 2005 to May 2009. There Petty Officer Strange worked in several high-profile signals intelligence gathering and became a first-line supervisor in charge of multiple analysts. Petty Officer Strange also completed a 9-month deployment to Iraq with an East Coast SEAL team. During this deployment, Petty Officer Strange earned the EXW (Enlisted Expeditionary Warfare Specialist) qualification.

Mr. Speaker, Petty Officer Strange went on to join and was selected for the elite Naval Special Warfare Development Group, often referred to by the name of its predecessor unit, "SEAL Team Six." It was SEAL Team Six, of course, that captured and killed Osama bin Laden.

Petty Officer Strange was a decorated hero and combat veteran with numerous awards, including the Purple Heart, Defense Meritorious Service Medal, Joint Service Commendation Medal with valor and oak leaf cluster, Joint Service Achievement Medal, Combat Action Ribbon, and various other campaign and unit decorations.

Mr. Speaker, sadly, this American hero, this proud native of Philadelphia and northeast Philadelphia, lost his life caused by a rocket-propelled grenade while serving his country in Afghanistan. At the time of his death, he was serving his third tour of duty in Afghanistan.

#### FAMILY INTRODUCED

# STATEMENT BY MR. STEVENSON

The SPEAKER. The Speaker recognizes the gentleman from Mercer County, Mr. Stevenson, under unanimous consent relative to the legislation which has just passed.

Mr. STEVENSON. Thank you, Mr. Speaker.

I would like to take a moment to thank the majority leader's office for their help with this bill, as well as the Professional Licensure Committee as this moved through the House over the last two sessions.

I would also like to take this opportunity to thank the Appraisal Institute and all the real estate appraisal groups throughout the State who have helped in formulating this legislation, as well as the Pennsylvania Association of Realtors and the Pennsylvania Bankers Association, as well as various appraisal management companies who have assisted in the drafting of this legislation.

# **REMARKS SUBMITTED FOR THE RECORD**

Mr. STEVENSON. I also would like to thank my colleagues for their support and would like to submit the balance of my remarks for the record.

The SPEAKER. The Speaker thanks the gentleman.

Mr. STEVENSON submitted the following remarks for the Legislative Journal:

Mr. Speaker, HB 398, which is coming back to the House on concurrence today, seeks to protect consumers, especially those who are in the market to buy or sell a home, by requiring registration of appraisal management companies in Pennsylvania.

We must ensure that we have the most appropriate laws in place to protect consumers, including oversight of appraisal management companies, especially now as housing markets are beginning to recover. Right now these third parties are not regulated, nor are they registered in Pennsylvania. This legislation seeks to correct that oversight.

Specifically, Mr. Speaker, HB 398 would require appraisal management companies (AMCs) to register with the Pennsylvania Department of State and its Board of Certified Real Estate Appraisers. Currently individual certified real estate appraisers are licensed by the Commonwealth, but third-party management companies are not.

Many times appraisal management companies are hired by banks to hire a certified real estate appraiser to facilitate the process. Both banks and appraisers are regulated but not the intermediary AMCs. To ensure the highest integrity in the process, we believe these intermediaries must be registered.

In addition to registration, HB 398 requires appraisal management companies be subjected to the board's regulation and oversight. AMCs that are owned by federally regulated financial institutions are exempt from State registration.

This means that all AMCs must have a system in place to ensure that all appraisals on property located in the Commonwealth are performed by certified appraisers in good standing with the board and that the appraisal reviews are conducted by a certified or licensed appraiser.

Although situations with less than forthright appraisal management companies may be infrequent, State law must not allow these companies to fall through the cracks or go unnoticed. To ensure the integrity of the appraisal process, we must have the tools in place to require accountability and to appropriately respond to unlawful activity. The Senate has amended HB 398 on technical grounds and some restructuring, but the overall intent of the bill remains the same as when we passed this legislation on May 2 last year.

Mr. Speaker, as this legislation now heads to the Governor's desk to be signed into law, I would like to take this opportunity to thank the Appraisal Institute and other appraisal organizations, as well as the REALTORS, Pennsylvania Bankers Association, and various appraisal management companies for their efforts and assistance in developing this legislation.

# BILL ON SECOND CONSIDERATION

The House proceeded to second consideration of **SB 923**, **PN 960**, entitled:

An Act amending the act of May 28, 1937 (P.L.955, No.265), known as the Housing Authorities Law, further providing for powers of an authority.

On the question,

Will the House agree to the bill on second consideration?

Mr. McGEEHAN offered the following amendment No. A07985:

Amend Bill, page 1, line 23, by inserting after "authority" ; and providing for Public Advocate

Amend Bill, page 2, by inserting between lines 28 and 29 Section 2. The act is amended by adding a section to read:

Section 13.1. Public Advocate.–The Governor shall appoint a Public Advocate, to be confirmed by a majority vote of the Senate, to represent the housing interests of nonhousing Authority tenants located in a first class city.

Amend Bill, page 2, line 29, by striking out "2" and inserting 3

On the question,

Will the House agree to the amendment?

The SPEAKER. On that question, the Speaker recognizes the gentleman from Philadelphia County, Mr. McGeehan.

Mr. McGEEHAN. Thank you very much, Mr. Speaker.

Mr. Speaker, this is a bill that deals with housing authorities and reform of housing authorities, and I can tell you, Mr. Speaker, in two decades in this House I have listened to arguments from my colleagues from both sides of the aisle about waste, fraud, and abuse in Philadelphia. I can tell you they are absolutely correct when it comes to the housing authority in Philadelphia. It is rife, rife with waste, fraud, and abuse. Pick up the papers any single day and you will see example after example. Just today's Philadelphia Inquirer spotlights what the Inquirer is reporting as illegal hiring of lobbyists to the tune of \$700,000, besides the fact of their outside counsel that costs taxpayers \$38 million.

Mr. Speaker, I am asking, I have a set of amendments, including amendment A07985, that requires the Governor to appoint a public advocate, to be confirmed by a majority vote of the Senate, to represent the housing interests of nonhousing authority tenants located in the city of Philadelphia; essentially, Mr. Speaker, a public advocate for the people who are paying the taxes in Philadelphia, who are paying for the housing needs of the poor in Philadelphia.

Someone has to speak up for the residents, the homeowners, the taxpayers of Philadelphia. They have been too long ignored and overlooked, and this amendment will ensure that an advocate will be sitting on the board making sure the ultimate decisions are made with the best interests of the taxpayers and homeowners in Philadelphia, and I ask for an affirmative vote.

The SPEAKER. The question is, will the House agree to the amendment?

On that question, the Speaker recognizes the gentleman from Chester County, Mr. Ross.

Mr. ROSS. Thank you, Mr. Speaker.

As you are aware, the underlying bill has to do with Allegheny County and issues that have been well discussed in committee by the House in the past. The issue of the governance of the Philadelphia Housing Authority is a legitimate and serious concern. It is important to note that the mayor, city council, and the Federal Department of Housing and Urban Development have been in the process of reviewing, considering what needs to be done. We have legislation before us in the Urban Affairs Committee to address the subject of governance of the housing authority in Philadelphia, and we are going to, during this upcoming spring, consider that, along with suggestions such as those that are embodied in this amendment here.

The language in this amendment – and to save time I will say the language in the succeeding amendments that are proposed to be offered today – has not been discussed, has not been considered in committee, and it would be wrong for us this afternoon, without that full consideration, to pass them. More importantly, we have been informed by the mayor's office, by the office of the members of city council, and also by the Federal Housing and Urban Development department that they wish us not to pass these at this time.

So therefore, I urge the members to keep the underlying legislation, which has to do with Allegheny County, clean, and I urge a "no" vote on this amendment at this time.

Thank you, Mr. Speaker.

The SPEAKER. The question is, will the House agree to the amendment?

On that question, the Speaker recognizes the gentleman from Philadelphia County, Mr. Thomas.

Mr. THOMAS. Thank you, Mr. Speaker.

Mr. Speaker, I rise to support the majority leader. I think it is important to address this issue on behalf of Allegheny County. And we need to address it without these collateral issues, and this would be tantamount to a collateral issue, and then later on we can talk about whether or not the appointment of a public advocate can root out fraud and abuse. But on this issue, let us keep this bill clean, support Allegheny County, and support the majority chairman.

Thank you, Mr. Speaker.

The SPEAKER. The question is, will the House agree to the amendment?

On that question, the Speaker recognizes the gentleman from Philadelphia County, Mr. McGeehan, for the second time.

Mr. McGEEHAN. Thank you very much, Mr. Speaker.

Mr. Speaker, I heard the comments of the two chairmen, and while I have tremendous respect for both chairmen, I have to take issue with the fact that this issue has not been vetted. As a Representative in a district of Philadelphia for more than 20 years, I can tell you, I heard this issue time and time and time again from my constituents who say, "Rescue us from the fraud, waste, and abuse of the Philadelphia Housing Authority."

I also heard comments that, well, the mayor, the city council, and HUD (Department of Housing and Urban Development) do not want us to go into this right now. Well, those three entities are the very people who got us in trouble. They are the three entities who are responsible for the fraud, waste, and abuse that

is going on every day in Philadelphia and that my constituents, my homeowners, are the victims. So do not come up here and tell me the opinion of the mayor and the city council and HUD should trump the opinions of the members of this House. They are the people who have gotten us in trouble.

Support the taxpayers of Philadelphia. Stand up for when someone wants to do right by the taxpayers and the homeowners in Philadelphia. You have the chance now, not in the spring, not next year. I put up with the fraud, waste, and abuse for 20 years, and I am up to here with it and so are my constituents.

I urge an affirmative vote for the decent, law-abiding, sane taxpayers in Philadelphia.

On the question, Will the House agree to the amendment?

The SPEAKER. On that question, the Speaker recognizes the gentleman from Philadelphia, Mr. McGeehan.

Mr. McGEEHAN. Thank you very much, Mr. Speaker.

Mr. Speaker, what this amendment would do is provide a mandatory audit of the housing authority in Philadelphia every 3 years, and they would be subject to an audit by the Auditor General.

Again, Mr. Speaker, I have heard the arguments in 20 years about fiscal responsibility from entities and arms of the government in Philadelphia. Here is your opportunity. You have a Philadelphia Representative standing up and asking colleagues on both sides of the aisle to stand up and provide some fiscal oversight, and there is no person better to do that than the Auditor General, removed from the governance and any taint within the city of Philadelphia.

This is a fiscally prudent and wise amendment, and I would ask for an affirmative vote.

The SPEAKER. The question is, will the House agree to the amendment?

On that question, the Speaker recognizes the gentleman from Chester County, Mr. Ross.

Mr. ROSS. Thank you, Mr. Speaker.

Once again, this is an example of why it would be better to consider these in committee rather than on the floor. Currently the Federal Housing and Urban Development department does an extensive audit of a great deal of the Philadelphia Housing Authority, and we want to make sure that since a complete audit that was duplicative by the Auditor General does not waste taxpayers' money by reauditing the same books that have already been previously audited by the Federal agency. So this is a good example of why we should not do these kinds of amendments on the floor, why they should be considered as part of the overall review that we are going to be doing this spring of governance and operation of the Philadelphia Housing Authority.

Once again, this is a bill that has to do with housing police in Allegheny County. It is inappropriate and wrong for us to be trying to put this together on the floor on an ad hoc basis, and I urge a "no" vote.

# THE SPEAKER PRO TEMPORE (DARYL D. METCALFE) PRESIDING

The SPEAKER pro tempore. The Chair recognizes the lady from Philadelphia.

Miss PARKER. Thank you, Mr. Speaker.

Mr. Speaker, I rise to ask my colleagues to vote "no" on the passage of amendment 7986.

I want to state for the record, first, that I appreciate my colleague, the gentleman from Philadelphia, for having such a strong concern about issues associated with waste, fraud, and abuse, along with transparency and auditing associated with our Philadelphia Housing Authority. But, Mr. Speaker, I want us to note for the record that in our House Committee on Urban Affairs, we are presently working with the administration in the city of Philadelphia, along with members of the committee, the committee chairman, along with members of our delegation, Mr. Speaker, to develop a concise, Mr. Speaker, bill and language that will address the very issues that the gentleman from Philadelphia is trying to get amended into SB 923.

I want to once again, Mr. Speaker, just for the record, note that I commend the gentleman for noting that we need to attack issues associated with waste, fraud, and abuse not only in our housing authority but in any branch of government, but we should do so, Mr. Speaker, in an extremely concise manner. I think I have a great deal of respect for our committee process. We are working in the Committee on Urban Affairs to do that. And while I commend the gentleman for tackling, attempting to tackle those issues, I will ask my colleagues to vote "no" so that we can work together, we can go through the committee process in Urban Affairs and address the very issues that are contained in this amendment, and I do know that the gentleman has offered several. But I would ask my colleagues to vote "no."

Thank you, Mr. Speaker.

The SPEAKER pro tempore. The Chair thanks the lady.

The Chair recognizes the gentleman from Philadelphia, Mr. Thomas.

Mr. THOMAS. Good afternoon, Speaker Metcalfe.

The SPEAKER pro tempore. Mr. Thomas, Speaker pro tem, but thank you, Mr. Thomas.

Mr. THOMAS. Thank you.

Mr. Speaker, I rise to join the majority leader and our esteemed chairlady of the Philadelphia delegation who has been working with the city, city council, the Philadelphia Housing Authority, and a number of other people, and we are trying to – not trying, we will – address many of the concerns that have been raised by our colleague from Philadelphia County.

And I respect his passion and his commitment to see something happen right away. I share that concern, but now is not the time. Now, the only time before us is to stand with Allegheny County and deal with a very important question that has been raised by Allegheny County in SB 923, and we want it to be clean so that Allegheny County can benefit from the prescription in this bill.

So, Mr. Speaker, I rise again to urge my colleagues on both sides, both sides, to reject this amendment and let us get on to the main question before us. Thank you.

The SPEAKER pro tempore. On that question, the Chair recognizes the gentleman from Philadelphia, Mr. McGeehan.

Mr. McGEEHAN. Thank you very much, Mr. Speaker.

Mr. Speaker, what this amendment will do will be to establish a whistleblower hotline. You know, Mr. Speaker, many times people are intimidated about reporting waste, fraud, and abuse, and what this amendment will do is establish within the Philadelphia Housing Authority a whistleblower hotline, paid for by the authority and monitored by the Office of Inspector General, for reports of wrongdoing and waste.

I know, Mr. Speaker, for those that care about eliminating fraud, abuse, and waste, and those who just give lip service to it, I think it is pretty logical that you need someplace to report that, someone that is going to listen, someone that is going to respond. The mechanism is not in place today, Mr. Speaker, for those individuals who care, like we do, about eliminating fraud, waste, and abuse, to correct that. What this amendment will do is establish a hotline, man the hotline, paid for by the authority, to see that those who care about this issue can report it and that those reports will be taken seriously, and I ask for an affirmative vote.

The SPEAKER pro tempore. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Chester, Mr. Ross.

Mr. ROSS. Thank you, Mr. Speaker.

Once again, this is an example of why we need to review these amendments in committee. I am advised that PHA (Philadelphia Housing Authority) already has a hotline that they encourage the public to use, either a hotline or e-mail for such reports. The phone number is 215-684-8300. And so therefore, if we need to adjust that, we ought to have some conversations about that. That would be appropriately done as part of the review when we consider the bill to regulate the governance of the Philadelphia Housing Authority later this spring.

Because of the confusion associated with this and the fact that it is not appropriate to this underlying legislation, I once again urge the members to vote "no."

Amend Bill, page 1, lines 26 through 28, by striking out all of said lines and inserting

Section 1. The act of May 28, 1937 (P.L.955, No.265), known as the Housing Authorities Law, is amended by adding a section to read:

Section 4.3. Civil Service Merit System.–(a) An Authority located in any city of the first class shall, within twelve months of the effective date of this section, enter into a contract with the State Civil Service Commission for the purpose of establishing a complete civil service merit system protecting the nonmanagement employes of the Authority who are not subject to a collective bargaining agreement under the act of July 23, 1970 (P.L.563, No.195), known as the "Public Employe Relations Act." The contract shall be executed in accordance with the provisions of the act of August 5, 1941 (P.L.752, No.286), known as the "Civil Service Act." The Authority is authorized to make the payments required by the "Civil Service Act."

(b) The contract under subsection (a) shall provide:

(1) For a civil service merit system for all employes under this section. The State Civil Service Commission shall only use the provisions of the "Civil Service Act" in setting standards and principles for employment with the Authority. The State Civil Service Commission shall include in the system the same duties and obligations, rights, prerogatives and appeals provided for employes by the "Civil Service Act."

(2) That employes under this section employed on the effective date of this section shall continue in their present positions, without taking an examination, and may be removed only in accordance with section 807 of the "Civil Service Act."

(3) That the compensation of employes under this section shall be determined by the Authority in accordance with uniform schedules adopted by the Authority using the classifications established by the State Civil Service Commission as a basis for the determination. The compensation of any employe of an Authority under this section on the effective date of this section may not be reduced through an action of the State Civil Service Commission or the Authority during the period the person holds the same position the person held on that day.

(c) Following the effective date of this section until the execution of the contract under subsection (a), employes under this section shall enjoy civil service protection and may be removed only in accordance with the "Civil Service Act." An Authority created in a city of the first class on or after the effective date of this section shall be subject to this section and shall enter into the required contract within twelve months of the date of organization.

(d) Any employe of a housing authority under this section who, on the effective date of this section, has been in provisional status for the immediately preceding two years shall assume the status of a probationary employe for six months. After successful completion of the probationary period, the employe shall be granted regular status.

Section 2. Section 10(ee) of the act, added October 4, 1978 (P.L.1008, No.215), is amended to read:

On the question,

Will the House agree to the amendment?

The SPEAKER pro tempore. On that question, the Chair recognizes the gentleman from Philadelphia, Mr. McGeehan.

Mr. McGEEHAN. Thank you very much, Mr. Speaker.

Mr. Speaker, what this amendment will do is establish a civil service merit system within the Philadelphia Housing Authority. Anyone who paid cursory attention to some of the most egregious examples under the former executive director will know that employees there were subject to what I would term "extortion" to pay for lobbying efforts, to pay for extravagant parties, to pay for the expenses of many of the ancillary, and frankly, questionable if not illegal activities of the former executive director and the entire administration.

Mr. Speaker, those persons had very little recourse and remedy when they were subjected to such abuse. It is systematic of an agency run amok. It is systematic of a system with no checks. It is systematic of an agency where employees were routinely abused. By establishing a civil service merit system within the Philadelphia Housing Authority, we are assuring that those abuses will never happen again, and if they do, there is recourse under the law, and I would ask for an affirmative vote. The SPEAKER pro tempore. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Chester County, Mr. Ross.

Mr. ROSS. Thank you, Mr. Speaker.

Once again, this actually has some very interesting and potentially positive ideas embodied in this amendment, but there are questions about how the transition would take place. There are questions of which members would qualify as management, which would be nonmanagement, and this would cover. It is a complicated question and one that deserves more thorough discussion than the brief conversation we are having here on the floor.

Once again, it is the wrong bill and the wrong time to do this. We will take up the discussion of management of the Philadelphia Housing Authority, discussing this as well as other issues that are important. Please vote "no" now so that we do not preclude that debate.

The SPEAKER pro tempore. The Chair thanks the gentleman.

Mr. McGEEHAN. Thank you, Mr. Speaker.

Mr. Speaker, it is evident that the will of the body is not in favor of these amendments. And I know that, again, the body has as much regard and respect for both chairmen as I do. And seeing that this bill and many of these instances will be covered, I wondered if the majority chairman of the Urban Affairs Committee would stand just for brief interrogation.

The SPEAKER pro tempore. Although there is no question before the House currently, the Chair will give you some leeway. If the majority chairman of the Urban Affairs Committee would entertain— It looks like there is no one available for your interrogation and no question before the House currently, Mr. McGeehan.

Mr. McGEEHAN. I will call up the next amendment then, Mr. Speaker.

The SPEAKER pro tempore. Will the gentleman repeat his remarks. We could not hear you in the microphone.

Mr. McGEEHAN. Mr. Speaker, I will call up the next amendment.

The SPEAKER pro tempore. You are going to pull your amendments? Are you pulling all of your amendments?

Mr. McGEEHAN. Thank you, Mr. Speaker, and thank you for your patience. I want to call up amendment A08166.

The SPEAKER pro tempore. Mr. McGeehan, are you pulling amendments 8164 and 8165 then?

Mr. McGEEHAN. Yes, Mr. Speaker.

The SPEAKER pro tempore. Both of those amendments are pulled. The Chair thanks the gentleman.

Mr. McGEEHAN offered the following amendment No. A08166:

On the question, Will the House agree to the amendment?

The SPEAKER pro tempore. On that question, the Chair recognizes Mr. McGeehan.

Mr. McGEEHAN. Thank you very much, Mr. Speaker.

Mr. Speaker, there is a program that has been in existence for decades that allows private individuals to rent their homes or apartments or whatever to needy individuals and paid for by the taxpayers of Philadelphia and paid through HUD and through your local housing agencies. Many of the landlords in these properties do not just own 1 or 2 or 10 or 100 or 200 units, and many times, Mr. Speaker, these same landlords have a number of violations on their multiple properties and unpaid taxes on a number of their properties.

Mr. Speaker, what this amendment will do is, within the city of Philadelphia, if a landlord participates in the housing voucher program and is indebted to the city for delinquent taxes, they would be ineligible to participate in the housing voucher program, thereby bringing them into compliance with the rest of the owner-occupied residences in the city of Philadelphia. Too many times, Mr. Speaker, we have landlords that do not operate in the best interests of our neighbors, that do not operate in the best interests of our neighborhoods, and who think they can thumb their noses at the localities and the citizens who do the right thing, who pay their taxes, who do comply with the zoning laws in the city; in this case, in the city of Philadelphia.

Mr. Speaker, this has been a tremendous, tremendous, onerous burden on our neighborhoods, and the taxpayers of Philadelphia are asking this body to free them from the shackles of irresponsible landlords, and I would urge an affirmative vote.

The SPEAKER pro tempore. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Chester County, Mr. Ross.

Mr. ROSS. Thank you, Mr. Speaker.

Once again, this is an example of why this bill should go to committee or these ideas should be considered in committee. I am informed by the Philadelphia Housing Authority that they have this as current policy right now, that they are in fact rendering landlords or making landlords ineligible of the housing voucher program if they are delinquent.

So the policy, the idea, may already be in place, but again, I would like to discuss this further in committee and see whether this is really needed rather than just passing it here on the floor today.

Thank you. I urge a "no" vote.

The SPEAKER pro tempore. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Philadelphia, Mr. Thomas.

Mr. THOMAS. Thank you, Mr. Speaker.

Mr. Speaker, I stand in support of the majority leader, but more importantly, Mr. Speaker, it is important that we share this information. Number one, PHA does have a list. PHA is currently dealing with landlords who do not comply with local, State, and Federal requirements. The United States Department of Housing and Urban Development maintains such a list and can take affirmative steps to deal with this particular issue.

And last but not least, Mr. Speaker, our own Pennsylvania Department of Community and Economic Development has oversight of PHA, not only the one in Philadelphia County but all 19 in the Commonwealth of Pennsylvania. I have not seen any complaints filed with DCED (Department of Community and Economic Development). I have not even seen a request sent into DCED regarding this issue. It is a good issue and it is an issue that the committee is going to take up to try and strengthen what is currently in law.

But I would ask my colleague to make a request to the local agency and/or the Pennsylvania Department of Community and Economic Development. When we did away with the Department of Community Affairs, we did not destroy the State's oversight of these 19 public housing authorities in Pennsylvania. So I would ask my colleague and all my members that if this issue is a concern, at least talk to those agencies before we look at a legislative prescription.

But for today Allegheny County is on the table. We need to deal with Allegheny's concern in this bill without all of this other stuff, because I am sure that Allegheny County might not want to deal with all of this stuff. And to my colleague, we will take up your issues as we move forward, so I strongly urge my colleagues on both sides to vote "no" on amendment 8166. Thank you.

The SPEAKER pro tempore. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Philadelphia, Mr. McGeehan, for the second time.

Mr. McGEEHAN. Thank you very much, Mr. Speaker.

Again, I listened to the comments, and while this may be a current policy of the Philadelphia Housing Authority, it does not bear the weight of law. The abuses heaped upon the citizens of Philadelphia for decades have eroded any trust that the citizens of Philadelphia have that this agency will act responsibly and in the best interests of the homeowners and taxpayers of Philadelphia. You have an opportunity today, once again, to do what is right – to do what is right for the homeowners, the taxpayers of Philadelphia; to say, do not trust, verify. That is a famous line. Well, that is the difference between policy and law. This will make it part of Pennsylvania statute that they must comply and not leave it to the capriciousness of the current executive director.

I would ask for an affirmative vote.

The SPEAKER pro tempore. The Chair thanks the gentleman.

On the question, Will the House agree to the amendment?

The SPEAKER pro tempore. On the question, the Chair recognizes the gentleman from Philadelphia, Mr. McGeehan. Mr. McGEEHAN. Thank you very much, Mr. Speaker.

Mr. Speaker, going back again to irresponsible landlords who own properties in residential neighborhoods, who do not live there, and frankly, do not care what happens in their particular units. I have experienced it living in the city of Philadelphia for 20 years and how hard it is to find out who these landlords are, where they are, how we get in contact with them to address the problems in the communities. What this amendment will do is make publicly available the names and addresses of landlords, many of them slumlords in the city of Philadelphia, who do not do right by their communities, who sit by and collect the money and thumb their noses at homeowners and taxpayers.

The city of Philadelphia has seen an exodus of decent, law-abiding, tax-paying citizens out of the city, and one of the primary movers is the decline of the quality of life in our neighborhoods. And a big part of that is landlords who are not responsible, who do not do the right thing, and when you try to contact them, you cannot find out who they are. They hide behind corporations and dummy firms. This would ensure that their names and addresses are publicly available so you and me and my neighbors can call them at 4 o'clock in the morning when the drug trade is going on next door to you, when the music is banging at 4 o'clock in the morning, when cars are coming at all hours of the day and night. You can inconvenience them like they inconvenience you.

Stand up for the decent, law-abiding taxpayers in Philadelphia, and I would urge an affirmative vote.

The SPEAKER pro tempore. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Chester County, Mr. Ross.

Mr. ROSS. Thank you, Mr. Speaker.

I am sympathetic with the idea of having a means of finding out who is actually being cited for violations, but again, we have not thought this through very well at this point. We are putting all the landlords, not just the ones that are behaving badly, into some kind of a database. We do not know how much that is going to cost. We do not know exactly what is involved.

Again, it is a good example of why we need to discuss this in detail in committee and why this is not the appropriate place to try and institute policy on the fly. I urge a "no" vote.

The SPEAKER pro tempore. The Chair thanks the gentleman.

The Chair recognizes, for the second time, the gentleman from Philadelphia, Mr. McGeehan.

Mr. McGEEHAN. Mr. Speaker, I do not know what is going on in Chester County. I do know what is going on in Philadelphia. As a lifelong resident of the city of Philadelphia and as a Representative for 21 years, this is not policy being made on the fly. This is two decades of frustration and an intractable, many times corrupt and wasteful agency.

I am the victim, my neighbors are the victims, my neighborhoods are the victims, and the city of Philadelphia as a whole is the victim. This is 20 years of frustration that is pouring out on this House floor. I am cautioned to be patient, and somehow this is portrayed as something that is not well thought out; it is, Mr. Speaker. It is from listening to thousands and thousands of complaints in more than two decades in public office about the very issues that these amendments attempt to address.

Mr. Speaker, if the landlords are receiving public funds, why should we not know who they are and where they live? If they own a house next to me, why should I not know who they are and how to get in touch with them? If they are benefiting from the public largesse, why should we not know who they are and how to get in touch with them?

These are not done on the fly. I am not running by the seat of my pants. This is hardscrabble life as it exists in Philadelphia, and these amendments are an attempt to empower the citizens of Philadelphia, not to circumvent the committee. I want to work with the chairman, but this is two decades of frustration pouring out on the House floor.

Mr. Speaker, like the other amendments, if you care about doing right by the citizens of Philadelphia, and you really believe – it is not just rhetoric – you really believe about doing away with waste, fraud, and abuse, I urge an affirmative vote.
