Prior to winning the State homecoming queen title, Maeghan was selected by her peers to be named the 2010-2011 Neshannock High School Homecoming Queen in October of 2010. STATEMENT BY MRS. SWANGER

The SPEAKER. Is the lady from Lebanon County, Mrs. Swanger, seeking recognition under unanimous consent relative to HR 680, which was just adopted?

Mrs. SWANGER. Thank you, Mr. Speaker.

I want to thank all my colleagues for voting favorably on this resolution.

I have had some personal experience with melanoma in that my sister-in-law was diagnosed with stage 4 metastatic melanoma about 4 years ago. She was given 6 to 9 months to live. Fortunately, she was among the less than 10 percent who have successfully reacted to treatment and today she is cancer-free.

But melanoma is increasing by leaps and bounds, especially among our young women. In the last few years, it increased by about eightfold and experts attribute a lot of this increase to the use of tanning beds, especially by teenagers.

I will be, hopefully, offering some legislation or an amendment to legislation to ban the use of tanning beds by anyone under 18, and I hope that when that is introduced and considered on the floor, that you will support my efforts.

The SPEAKER. On that question, the Speaker recognizes the gentleman, Mr. Neuman.

Mr. NEUMAN. Thank you, Mr. Speaker, and thank you, Mr. Speaker, for holding this so that the family could be here and witness the passage of this resolution.

On December 19, 2011, we were actually here, and I got up and I spoke briefly about what was happening in my district, and it was December 18 that the shooting occurred. December 19 is the day that we lost a hero in Washington County, and it is very much noticed on our streets already, because John David Dryer was not just a police officer. He was a veterinarian, he was a volunteer fireman, he was a father, he was a son, he was a friend to many, and he will never be forgotten.

And for those of you who do not know John David Dryer, we called him David. And I did not know David as well as I would like to have, but he grew up on a farm in Avella. He developed a passion for animals and he went to a veterinarian school at Ohio State University, and after that he also became a police officer and graduated from the police academy at California University of Pennsylvania. He was a volunteer fireman; he opened up his own veterinarian clinic, and he was a true, true public servant.

With his passion for animals, he was very well trained as a K-9 officer, and truly his specialty was guiding the bloodhounds to find what they needed to find. And on the night of December 18, what we would assume is a routine traffic stop – but as we know, nothing is routine for police officers – David pulled a gentleman over and it turned catastrophic after that, and the main concern of David, as we are told, was the protection of his partner. His partner was shot and wounded as well.

GUESTS INTRODUCED

Mr. NEUMAN. So today here with us – we had the memorial service today for the F.O.P. (Fraternal Order of Police) – and today with us is David's family; his friends; the mayor of East Washington; the chief of East Washington Police; some of his colleagues from the department; most notably his parents, John and JoAnn; and his son and his best friend, Benjamin. If they would all please rise to be recognized before this House.

There are absolutely no words to make sense of this awful tragedy, but I would like to show my support and our support and appreciation by passing this resolution. I ask that we stand, we pause for a moment, reflect the life of David Dryer, and know that we already miss David in our community, but he will never be forgotten for the sacrifices he made for our area and the way that he protected the lives of others, and we will continue to reflect on David's life and let him live on. So please rise, and I ask for unanimous support of HR 578.

The House proceeded to concurrence in Senate amendments to HB 1702, PN 3331, entitled:

An Act reenacting and amending the act of February 1, 1966 (1965 P.L.1656, No.581), known as The Borough Code.

On the question, Will the House concur in Senate amendments?

The SPEAKER. Moved by the lady, Mrs. Gingrich, that the House concur in the amendments inserted by the Senate.

The Speaker recognizes the lady, Mrs. Gingrich, for a brief description of the Senate amendments.

Mrs. GINGRICH. Thank you, Mr. Speaker.

With regard to the changes made in the Senate, there were several more clarifying issues that I would like to share with my colleagues. The first preserves the retirement benefits of former borough employees who have been transferred to a municipal authority under the order of the PUC, the Public Utility Commission, and those former employees will retain their pension rights and the borough will continue to receive the general municipal pension system State aid for those employees. No new employees will be added. That was one thing.

A second thing - actually, two of them incorporate House bills. One House bill pending, HB 18, that deals with the purchasing of used equipment from another governmental unit without advertising and bidding was put into the bill. And secondly, one of the House bills that actually became Act 104, which deals with incompatible offices and civil service background checks was put into the bill.

And finally, the Civil Service Commission. In this case now, the Civil Service Commission may conduct deliberations in an executive session on evidentiary or procedural issues regarding police or firefighter applicants who were denied placement on the certified eligibility list or refused examination. However, the disposition of the matter will constitute official action and must occur in a public meeting.

So those things were incorporated in the Senate and acceptable, and then there are a few editorial revisions, and that would bring the bill to what we see here today for concurrence. Thank you, Mr. Speaker.

BILLS ON SECOND CONSIDERATION

The House proceeded to second consideration of HB 1289, PN 3429, entitled:

An Act amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, providing for sentencing enhancement for trafficking drugs in the presence of a minor.

On the question, Will the House agree to the bill on second consideration?

The SPEAKER. On that question, the Speaker recognizes the gentleman from Armstrong County, Mr. Pyle.

Mr. PYLE. Thank you, Mr. Speaker.

Mr. Speaker, I offer HB 1289, and I would like to be short about this. Here is the central premise. Under Pennsylvania law, people convicted of trafficking drugs in the presence of a minor face no enhanced penalty for their actions.

Mr. Speaker, recently in the 60th District we have had some of those heartbreakers that have prompted this bill. In Kittanning it was a lady, early twenties, selling heroin and cocaine off a coffee table with her kids sitting on the couch. In Ford City it was the same thing about a block and a half from the school. In Apollo a gentleman who had done 10 years of Federal time for cooking crystal meth got out and decided to reestablish business again.

Now, Mr. Speaker, I have a very good friend on the drug task force, and I went to talk to him, and I asked him, "Frankie, what was it like?" Frankie told me when he went in the door, his skin was burning, the kids were crying that their eyes were burning and they could not see, and the really, really hard part about this, Mr. Speaker, is the kids were 4 and 6.

Now, Mr. Speaker, there is a very well-known principle of education called imprinting, and what this principle says is basically everything you are ever going to learn in your life, two-thirds of it you have done by the age of 7. Think about that - how to walk, how to talk, how to taste, how to go to church, how to behave in school. When you take that principle of imprinting and you put a 5-year-old or a 7-year-old on the end

of a couch of a parent who is peddling illegal contraband, schedule II and schedule III narcotics, that kid is going to see that action and they are going to think it is socially acceptable.

Mr. Speaker, the ironic part about HB 1289 is it is not a new law. This is a new law that exists on our books already. What this does is it gives the judges an enhanced sentencing grid that allows them, according to their judgment and their option, to add up to 1 year's jail time for every child that was present during the drug raid.

Mr. Speaker, in a nutshell that is HB 1289. Thank you, Mr. Speaker.

The SPEAKER. On that question, the Speaker recognizes the gentleman from Luzerne County, Mr. Carroll.

Mr. CARROLL. Thank you, Mr. Speaker.

Mr. Speaker, this amendment modifies the penalty in this bill. The current penalty would result in a driver's license suspension of 90 days. It seems to me that in the confusion that exists around these situations, it is a harsh penalty and that a point penalty would be far more appropriate.

In addition, the offender would be responsible for whatever costs are incurred by the emergency responders. So with the result of the paid costs and the two points, I think that is an appropriate penalty for a violation of this section of Title 75.

The SPEAKER. The question is, will the House agree to the amendment?

On that question, the Speaker recognizes the gentleman from Montgomery County, Mr. Stephens.

Mr. STEPHENS. Thank you, Mr. Speaker.

Mr. Speaker, I rise in opposition to this amendment.

This is a serious initiative. It is a national initiative because of the dangers inherent with floodwaters. As a matter of fact, in the flooding that occurred here in this Commonwealth just last year, four people died as a result of entering those floodwaters. This is a serious concern. I think it warrants more than simply the point assignment that the gentleman proposes that would in essence be the equivalent of going 6 miles an hour over the speed limit.

This type of conduct endangers our first responders and it forces them to go into harm's way unnecessarily. The confusion that the gentleman refers to is a nonissue, because the statute requires that you knowingly go past a sign that directs you that the road is closed as a result of the hazard.

So I think this is a serious matter. It places our first responders in harm's way, which is one of the reasons the first responder community supports the bill, and I would urge the members to vote "no" on the amendment and ultimately "yes" on the bill.

The SPEAKER. The question is, will the House agree to the amendment?

On that question, the Speaker recognizes the gentleman, Mr. Carroll, for the second time.

Mr. CARROLL. Thank you, Mr. Speaker.

And I recognize what the sponsor of the bill is trying to do, but my experience tells me that what will happen is that there will be people who will be caught up in this penalty who will come to all of us to seek the relief that some of us may think should be granted as a result of what could be an honest, innocent mistake. And it just seems to me that to impose a 90-day driver's license suspension for an offense like this is too extreme, too excessive, and far exceeds what we should apply in a case of an honest mistake.

So for that reason, Mr. Speaker, I ask for an affirmative vote.

For what purpose does the gentleman, Mr. Vitali, from Delaware County rise?

Mr. VITALI. A brief interrogation.

The SPEAKER. The question is, shall the bill pass finally?

On that question, the Speaker recognizes the gentleman from Delaware County, Mr. Vitali, who seeks interrogation of the prime sponsor, Mr. Stevenson. The gentleman may proceed.

Mr. VITALI. I am sorry; I just wanted a brief explanation of the bill, if I could get it.

Mr. STEVENSON. Thank you, Mr. Speaker.

This is a bill which provides for notice to property rights owners or mineral rights owners when a municipality is considering some type of a land use change. This would provide for notice to the owner of those rights.

Mr. VITALI. Did I hear the term "mineral rights" in there? I am just wondering if this relates to Marcellus drilling at all and notice to landowners. Is that related to this issue at all?

The SPEAKER. Does the gentleman, Mr. Vitali, have a further question?

Mr. VITALI. I am sorry; I did not hear that answer. My question was, would this relate to landowners with regard to Marcellus drilling?

Mr. STEVENSON. Well, that is not the intent of the bill, but I assume it could apply to that. This is a piece of legislation that I have been working on for several terms, primarily with the Coal Association, where an owner of mineral rights may live in a jurisdiction which is somewhat removed from where the actual rights are, and this would provide for the owner to be given notice should the municipality where the rights are would give the owner the ability to hear if they are going to have a zoning meeting or any type of a land-use meeting so that he or she could show up there and present testimony.

Mr. VITALI. So does this increase the amount of notice that a landowner has to receive or decrease it or change its form?

Mr. STEVENSON. This puts the burden on the owner of the rights or the landowner. The burden is on that person to let the municipality know that they would like to be informed if some change is possible.

Mr. VITALI. So right now the notice that is required is what? Right now-

STEVENSON. Normal notice is Mr. newspaper advertisement, something like that, if the municipality is going to hold a meeting where land use is being discussed.

Mr. VITALI. And this would change it from newspaper advertisement to-

Mr. STEVENSON. The owner of those rights would be required to provide to the municipality a self-addressed, stamped envelope with the request that should a meeting of that type be held, they would like to have notice sent to them in that stamped, self-addressed envelope, or if they provide e-mail notice, an address for e-mail notice, the municipality would then send that notice electronically.

Mr. VITALI. And if a landowner had no clue that a meeting was contemplated, how would he - why would he give that self-addressed, stamped envelope?

Mr. STEVENSON. That is exactly the point of the legislation. Oftentimes a municipality may hold a meeting where they plan to discuss land use and the owner may live at the other side of the State and may not read in the local newspaper about that meeting. This provides a way for that owner to receive notice of the meeting.

Mr. VITALI. Have any groups weighed in in opposition to this? Are there any groups – have any groups weighed out in opposition to this, any landowners groups or citizens groups or—

Mr. STEVENSON. No. There has been no opposition. The only suggestion we received this time around, this term, was from the Bar Association, and they suggested that we expand the notice to include electronic notice, which we have done. We appreciate their help in putting this bill together. It has been supported by the Township Supervisors Association and the Coal Association, both of whom have assisted in the drafting of this legislation.

Mr. VITALI. Has the Bar Association given its support to this?

Mr. STEVENSON. Yes. As a matter of fact, I think all members received such notice today by e-mail.

Mr. VITALI. So they are officially in support of this bill? Mr. STEVENSON. Yes.

Mr. VITALI. Okay. Thank you.

On the question recurring,
