#### STATEMENT BY MR. STERN

The SPEAKER. Is the gentleman from Blair County, Mr. Stern, seeking recognition under unanimous consent relative to the resolution just adopted?

The gentleman, Mr. Stern, is in order.

Mr. STERN. Thank you, Mr. Speaker.

In Pennsylvania, a system of free public education is mandated under our Pennsylvania Constitution. To carry out this mandate, the General Assembly created school districts and school boards in 1834.

The SPEAKER. Will the gentleman suspend a minute?

If I could have the members' attention. I would appreciate your attention. If we could hold the conversations down. If necessary, please take them to the rear of the House. I appreciate the members' attention.

Thank you very much. The gentleman, Mr. Stern, may proceed.

Mr. STERN. The General Assembly conferred broad legal powers to local school boards, making them autonomous in many of their operations. Therefore, the school board is a political subdivision of the State for the purpose of convenient administration of the schools in Pennsylvania.

Serving as a school director is one of the most important responsibilities that a citizen can undertake, and across the Commonwealth there are 4,500 individuals – 9 school directors for each one of the 500 school districts – who have taken on this challenging task. I am sure each and every one of you knows the school directors back in your district. We have to remember that the school director's average length of service is only about 6.4 years, with nearly 46 percent of them serving 4 years or less. School directors are charged by law with providing quality education for the youth of Pennsylvania. They must work for the best interests of all students and all citizens. It is a task that

requires constant effort and a strong commitment to serving other people.

In Pennsylvania there are 930,000 students enrolled in pre-K through sixth grade, and in public secondary schools enrollment is 835,000 students. Total students enrolled in public schools in the Commonwealth number 1.7 million students, and by the end of 2016-17 that number is projected to increase to 1.8 million students.

Being a school director is a complex and a varied job. In a broad sense, the general functions of a school board are to plan for the district, set the policy, and evaluate the results, much as we do here as members in the General Assembly. Specifically, the job description includes everything from wrangling budgets and hiring employees to levying taxes and establishing the educational goals that will shape the future of our communities.

While the job requires long hours, provides no compensation, and can sometimes be frustrating, the reward of working with the community and watching students achieve and also succeed in their lives is always worth the effort.

As you know, a school director's responsibility is a tremendous service to our local communities, our students, our parents, and also the local taxpayers. Today we honor each and every one of them and thank them for their devotion and selfless service and sacrifice of their time. I would like to thank the members of the House for voting for January as being "School Director Recognition Month."

The SPEAKER. On that question, the Speaker recognizes the lady from Philadelphia, Ms. Brown.

Ms. V. BROWN. Thank you, Mr. Speaker.

Yesterday we celebrated the life of Dr. King all across the county and the country, and many of us spent time reflecting on the impact of his legacy that he has had in reshaping the American experience. The work of Dr. King and thousands of civil and human rights activists who labored and struggled through some of the most tumultuous decades in our nation's history will never be forgotten. The true measure of legacy is in its ability to affect generation after generation, and Dr. King's influence, with or without a day of remembrance, will continue to be celebrated for years.

Dr. King was a man of many dreams, although for many of us, it was his dream to see a world where men are not "...judged by the color of their skin but by the content of their character" that resonates the most. I want to share my experiences of yesterday of celebrating Dr. King with you.

Yesterday I was so blessed to go to an event that Representative Louise Williams Bishop held which was a gospel celebration of the life of Dr. King, and there were at least

a thousand people there. And as I looked out in the audience, I just thought about the dream of Dr. King of everyone coming together to remember what it was like in the days when he stood and he did his speeches; it was not like what we have today. Because he stood for so many of us, we have so many freedoms that I think many of us take for granted. And yesterday was a day of remembrance for us to stand firmly planted to remember all that our ancestors have overcome so that we could have the right to vote, we could have the right to education, and the right to better jobs. It is important that we remember Dr. King, because he dreamed of a world where peaceful, nonviolent demonstrations could shake the core of a nation and bring about fundamental changes to deep-rooted issues.

There was another celebration that took place yesterday, as hundreds of thousands of people – and yesterday we heard on the news millions of people – crowded our nation's capital to celebrate the inauguration of President Barrack Obama, the 44th President of the United States of America. The occasion was memorable not only for its grandeur, but also for the fact that on this day, set aside to celebrate the legacy of a dreamer, Dr. King, a person of color was sworn in to our highest government office, and this was King's biggest dream. What a fitting tribute to Dr. King. I sat and I watched it with my 99-year-old aunt, who just watched with so much pride, and she looked over at me and she said, "I never thought a Black could be a President." What a way to honor Dr. King.

Today I wish to honor Dr. King again by introducing HR 24 of this year, 2013, and recognizing him as a man of many accomplishments and as an American hero. Could you please just today remember Dr. King, and we have a very special presentation that our Speaker will address very shortly.

**MARTIN LUTHER KING, JR., TRIBUTE**

**EDWARD "CHAMP" HALL INTRODUCED**

The SPEAKER. If I could have the members' attention. I would appreciate if the members would take their seats.

As the lady from Philadelphia, Ms. Brown, just mentioned, we have a guest here – who is actually a guest of Representative Brown and Representative Sturla – that we wanted to recognize in conjunction with Martin Luther King Day. So I would appreciate the members' attention.

In honor of Martin Luther King Day, we have a special guest with us this afternoon. Some of you may remember Edward "Champ" Hall when he was with us to commemorate this day last year. He has been here a few times, actually. Mr. Hall, as I mentioned, is a guest of Representative Brown and Representative Sturla, and he lives in Lancaster County. He is the founder of and instructor at Champ's Barber School. He owns and operates barbershops in Lancaster and Neffsville. This afternoon Mr. Hall will recite Dr. Martin Luther King's "I've Been to the Mountaintop" speech.

It is my pleasure, and I hope the House will give a warm welcome to Mr. Champ Hall.

Welcome to the hall of the House, and you may proceed

Mr. HALL. Speaker of the House, and to Representative Brown, and to State Representative Sturla, and to the entire body, we pay tribute and commemoration and salutation to the life and legacy of the Honorable Dr. Martin Luther King, Jr.

Go with me now to the year 1968.

**REENACTMENT OF  
MARTIN LUTHER KING, JR.'S  
"I'VE BEEN TO THE MOUNTAINTOP"  
SPEECH**

Mr. HALL. "As I listened to Ralph Abernathy and his eloquent and generous introduction and then thought about myself, I wondered who he was talking about. It's always good to have your closest friend and associate to say something good about you. And Ralph Abernathy is the best friend that I have in the world. I'm delighted to see each of you here tonight in spite of a storm..." watch. "You reveal that you are determined to go on anyhow.

"Something is happening in Memphis; something is happening in our world. And you know, if I were standing at the beginning of time, with...a kind of general and panoramic view of the whole of human history up to now, and the Almighty said to me, 'Martin Luther King, which age would you like to live in?' I would take my mental flight by Egypt and I would watch God's children in their magnificent trek from the dark dungeons of Egypt...across the Red Sea, through the wilderness on toward the promised land. And in spite of its magnificence, I wouldn't stop there.

"I would move on by Greece and take my mind to Mount Olympus. And" there "I would see Plato, Aristotle, Socrates, Euripides and Aristophanes assembled around the Parthenon. And I would watch them around the Parthenon as they discussed the great and eternal issues of reality. But I wouldn't stop there."

Oh, "I would go...to the great heyday of the Roman Empire. And I would see developments...there, through various emperors and leaders. But I wouldn't stop there."

Oh, "I would...go by the way..." to whom "the man...I am named had his habitat. And I would watch Martin Luther as he tacked his ninety-five theses on the door at the church of Wittenberg. But I wouldn't stop there."

Oh, "I would come on up...to 1863, and watch a vacillating President by the name of Abraham Lincoln finally come to the conclusion that he had to sign the Emancipation Proclamation. But I wouldn't stop there."

Oh, "I would...come up to the early thirties, and see a man grappling with the problems of the bankruptcy of his nation," saying "...that we have nothing to fear but 'fear itself.' But I wouldn't stop there.

"Strangely enough, I would turn to the Almighty, and say, 'If you allow me to live just a few years' " longer " 'in the second half of the 20th century, I will be happy.'

"Now that's a strange statement to make, because the world is all messed up. The nation is sick. Trouble is in the land; confusion all around. That's a strange statement. But I know, somehow, that only when it is dark enough can you see the stars. And I see God working in this period of the twentieth century in a way that men, in some strange way, are responding.

"Something is happening in our world. The masses of people are rising up. And wherever they are assembled today, whether they are in Johannesburg, South Africa; Nairobi, Kenya; Accra, Ghana; New York City; Atlanta, Georgia; Jackson, Mississippi; or Memphis, Tennessee – the cry is always the same: 'We want to be free.'

"And another reason that I'm happy to live in this period is that we have been forced to a point where we are going to have to grapple with the problems that men" and women "have been trying to grapple with through history, but the demands didn't force them to do it. Survival demands that we grapple with them. Men, for years now, have been talking about war and peace. But now, no longer can they just talk about it. It is no longer a choice between violence and nonviolence in this world; it's nonviolence or nonexistence." And "that is where we are today.

"And also in the human rights revolution, if something isn't done, and" isn't "done in a hurry, to bring the colored peoples of the world out of their long years of poverty, their long years of hurt and neglect, the whole world is doomed...."

Oh, I can remember, "I remember when Mrs. King and I were first in Jerusalem. We rented a car and drove from Jerusalem down to Jericho." And when "...we got on that road, I said to my wife, 'I can see why Jesus used this as the setting for his parable.' It's a winding, meandering road...really conducive for ambushing. You start out in Jerusalem, which is about...1200 feet above sea level. And by the time you get down to Jericho, fifteen or twenty minutes later, you're about 2200 feet below sea level. That's a dangerous road. In the days of Jesus it came to be known as the 'Bloody Pass.' And you know, it's possible that the priest and the Levite looked over that man on the ground and wondered if the robbers were still around." Or, you know, it is possible they looked at that man on the ground and wondered if he "...was merely faking. And he was acting like he had been robbed and hurt, in order to seize them over there.... And so the first question that the priest asked – the first question that the Levite asked... 'If I stop to help this man,' " on the ground, " 'what will happen to me?' But then the Good Samaritan came..." along. "And he reversed the question:" He said, " 'If I do not stop to help this man,' " on the ground, " 'what will happen to him?'

"That's the question before you tonight. Not, 'If I stop to help the sanitation workers, what will happen to...' " me, but, " 'If I do not stop to help the sanitation workers, what will happen to them?' That's the question" before you tonight.

"...Several years ago, I was in New York City autographing the first book that I had" ever "written. And while sitting there autographing..., a...black woman came up" to me. And all "...I heard from her was, 'Are you Martin Luther King?' And I was looking down writing, and I said, 'Yes.' ...Before I knew it I had been stabbed by this demented woman. I was rushed to Harlem Hospital. It was a dark Saturday afternoon. And that blade," that blade "had gone through, and the X-rays revealed that the tip of the blade was on the edge of my aorta, the main artery. And once that's punctured, you're drowned in your own blood – that's the end of you."

Well, "it came out in the *New York Times* the next morning, that if I had merely sneezed, I would have died. Well, about four days later,...after my chest had been opened, and the blade had been..." removed, they allowed me "to move around" in the hospital "in the wheel chair..." and "...to read some of the mail that came in, and from all over the states and the world, kind letters.... I had received..." a letter "from the President and the Vice-President. I've forgotten what those telegrams said. I'd received a visit and a letter from the Governor of New York"



City, "but I've forgotten what that letter said. But there was another letter..." that I will never forget. "It said simply," Dr. Martin Luther King, "I am a ninth-grade student at the White Plains High School. While it should not matter, I would" just "like to mention that I'm a white girl. I read in the paper of your..." suffering and of your misfortune. "And I read that if you had sneezed, you would have died." Well, "...I'm simply writing you to say that I'm so happy that you didn't sneeze."

"And I want to say tonight...that I too am happy that I didn't sneeze. Because if I had sneezed, I wouldn't have been around here in 1960, when students all over the South... were "sitting-in.... And I knew that as they were sitting in, they were really standing up for the best in the American dream, and taking the whole nation back to those great wells of democracy which were dug deep by the Founding Fathers in the Declaration of Independence and the Constitution.

"If I had sneezed, I wouldn't have been around here in 1961, when we decided to take a ride for freedom and ended segregation in inter-state travel.

"If I had sneezed, I wouldn't have been around here in 1962, when Negroes in Albany, Georgia, decided to straighten their backs up. And whenever men and women straighten their backs up, they are going somewhere, because a man can't ride your back unless it is bent.

"If I had sneezed... I wouldn't have been" around "here in 1963, when the black people of Birmingham, Alabama, aroused the conscience of this nation, and brought into being the Civil Rights Bill.

"If I had sneezed, I wouldn't have had a chance later that year, in August, to...tell America about a dream that I had had.

"...I wouldn't have been down in Selma, Alabama, to see the great Movement there.

"...I wouldn't have been in Memphis to see a community rally around those brothers and sisters who are suffering."

Oh, "I'm so happy that I didn't sneeze."

But it doesn't matter with me now. "I left Atlanta this morning, and as we got started on the plane, there were six of us. The pilot said over the public address system, 'We are sorry for the delay, but we have Dr. Martin Luther King on the plane. And to be sure that all of the bags were checked,...' " carefully, to be sure there would be nothing wrong with the plane, "...we've had the plane protected and guarded all night.

"And then I got into Memphis. And some began to...talk about the threats that were out. What would happen to me from some of our sick white brothers?

"Well, I don't know...now. We've got some difficult days ahead....

"Like anybody, I would like to live a long life. Longevity has its place. But I'm not concerned about that now. I just want to do God's will. And He's allowed me to go up to the mountain. And I've looked over. And I've seen the Promised Land. I may not get there with you. But I want you to know tonight, that we, as a people, will get to the promised land!"

And so tonight, "I'm not worried about anything.

"I'm not fearing any man!"

Because "mine eyes have seen the glory of the coming of the Lord!!"

And with this faith, we will wish you out of the mountain of despair, a stone of hope. And with this faith, we will transform dark yesterdays into bright tomorrows. And with this faith, "...all of God's children – black men and white men, Jews and Gentiles, Protestants and Catholics – will be able to join hands

and sing..." in the words of the Negro spiritual of old: " 'Free at last! Free at last! Thank God Almighty, we are free at last!' "

Thank you. God bless you, and God bless these United States of America.

The SPEAKER. Thank you very much, Mr. Hall, for that wonderful rendition of one of the great Martin Luther King speeches. We appreciate your bringing him to us, and we appreciate your enthusiasm and commitment.

### STATEMENT BY MAJORITY LEADER

The SPEAKER. The Speaker recognizes the gentleman from Allegheny County, Mr. Turzai.

Mr. TURZAI. Thank you very much, Mr. Speaker. Briefly on unanimous consent.

Mr. Hall, thank you so much for your outstanding rendition of the great speech by Martin Luther King. Martin Luther King positively changed the lives of every single American and made it clear that each of us has the opportunity to fulfill our promise and responsibilities as citizens of this great nation.

I think it fitting just to briefly cite President Obama's second inaugural address, because in that tradition, I thought that he said some very, very important words, and I thought it was outstanding that America came together with respect to that particular date yesterday with the inauguration for President Obama for his second term. And he spoke in the opening paragraph, "...We affirm the promise of our democracy. We recall that what binds this nation together is not the colors of our skin or the tenets of our faith or the origins of our names. What makes us exceptional – what makes us..." special in America "...is our allegiance to an idea articulated in a declaration made more than two centuries ago: " 'We hold these truths to be self-evident, that all men are created equal;' ..."

Later in his speech – and I think this speaks true to all of our children and grandchildren and the children and grandchildren for the citizens of Pennsylvania – he stated, "We are true to our creed when a little girl born into the bleakest poverty knows that she has the same chance to succeed as anybody else, because she is an American; she is free, and she is equal, not just in the eyes of God but also in our own."

Thank you again, Mr. Hall, and again, upon the celebration of the Martin Luther King Day yesterday, I think they are great lessons for all Americans. Thank you.

Prior to making that announcement, I just felt compelled to share with the members of the House that 45 years ago, I was an 18-year-old freshman in college, living about a half a mile from where Dr. Martin Luther King was assassinated. When I heard that speech there, it brought back probably the worst day in my life – the scariest day in my life – how the city of Memphis almost burned down to the ground and literally thousands and thousands of folks were protesting. The city of Memphis was under martial law, and really, the first time in my life that I ever

witnessed something like that so close. I was probably less than a half a mile away. You know, back in those days you did not have that type of communications where you could get on a cell phone or call home or anything. You know, you actually used pay phones back in those days to call your parents and your friends to say that you are all right.

But we could not get out of Memphis, could not get home. It was riots all over America, and hearing this speech here today brought back those memories. I just wanted to share that with you because, boy, as an 18-year-old, long-haired guy from the Philadelphia area – okay? – to be 1100 miles away from home in Memphis, Tennessee, which back in those days was a lot different than it is today, and boy, we have come a long way and we still need to go further.

I just wanted to share that with you. I hope it was not inappropriate. Every once in a while – I do not even think my kids know I was a half a mile away from Martin Luther King's assassination back in 1968.

So thank you for sharing that with me, Mr. Speaker.
