PRAYER

Let my heart, therefore, Gracious God, be so affected with the glory and majesty of it, that I may not do mine own works, but wait on thee, and discharge those weighty duties thou requirest of me, and since thou art a God of pure eyes, and wilt be sanctified in all who draw near unto thee, who doest not regard the sacrifice of fools, nor hear sinners who tread in thy courts, pardon, I beseech thee, my sins, remove them from thy presence, as far as the east is from the west, and accept of me for the merits of thy son Jesus Christ, that when I come into thy

temple, and compass thine altar, my prayers may come before thee as incense; and as thou wouldst hear me calling upon thee in my prayers, so give me grace to hear thee calling on me in thy word, that it may be wisdom, righteousness, reconciliation and peace to the saving of the soul in the day of the Lord Jesus. Grant that I may hear it with reverence, receive it with meekness, mingle it with faith, and that it may accomplish in me, Gracious God, the good work for which thou has sent it. Bless my family, kindred, friends and country, be our God and guide this day and for ever for his sake, who lay down in the Grave and arose again for us, Jesus Christ our Lord, Amen."

STATEMENT BY MS. MUNDY

The SPEAKER. The Speaker recognizes the lady from Luzerne County, Ms. Mundy, under unanimous consent relative to one of the resolutions just adopted.

Ms. MUNDY. Thank you, Mr. Speaker.

Mr. Speaker, could I have a little order, please?

The SPEAKER. How is that?

Ms. MUNDY. Very nice, thank you.

Mr. Speaker, HR 120 designates March as "Deep Vein Thrombosis Awareness Month" in Pennsylvania. Deep vein thrombosis, or DVT, is a serious but preventable medical condition whereby a blood clot forms in a large vein, usually in the lower limbs, leading to either partially or completely blocked circulation. It may be caused by a variety of factors and triggering events, including cancer, obesity or restricted mobility due to major surgery, acute medical illness, or respiratory failure.

DVT symptoms may include tenderness or pain in the leg, along with swelling and discoloration or redness. The condition may ultimately result in a pulmonary embolism, which occurs when a blood clot breaks loose from the wall of the vein and moves to the lungs, where it blocks the pulmonary artery or one of its branches. Signs and symptoms of pulmonary embolism include shortness of breath, chest pain, coughing or coughing up blood, and fainting.

DVT occurs in approximately 2 million Americans each year, and complications from DVT take up to 300,000 lives annually, which is more than breast cancer and AIDS (acquired immune deficiency syndrome) combined. These conditions account for about 55,000 deaths annually. Yet according to a national survey sponsored by the American Public Health Association, 74 percent of Americans have little or no awareness of DVT, and that is why I have introduced this resolution, to promote awareness of this dangerous, yet preventable, condition.

Deep vein thrombosis is among the leading causes of preventable hospital death. Fifty-eight percent of patients who developed a DVT while in the hospital received no preventive treatment despite the presence of multiple risk factors and extensive data on DVT preventive treatments, such as getting bedridden patients up and around, using compression devices to promote blood flow, and prescribing anticoagulant medications.

My guest on the House floor today, my friend and the mayor of Exeter Borough in my district, Cassandra Coleman, suffered from DVT exactly 1 year ago today after undergoing two knee surgeries. Over five blood clots reached her lungs and arteries, and she was hospitalized for over 32 days. Exactly 1 year ago today her blood clots first shot to her lungs. Luckily for Cassandra, for her mother, who is here today, and for all of us who love her, her condition was eventually successfully treated, and at age 24, she is alive and well and with us today.

But it was Cassandra's experience that led me to introduce this resolution in the hope that it will raise awareness among consumers, health-care professionals, and policymakers as to the seriousness and the preventable nature of DVT.

So I thank all of you for your support for this important resolution. Thank you, Mr. Speaker.

HR 151 designates March 3-9, 2013, as "Problem Gambling Awareness Week" in Pennsylvania. This designation mirrors the "National Problem Gambling Awareness Week" that is recognized across our country. Mr. Speaker, the goal of this resolution is to educate the general public, along with health-care professionals, about the warning signs of problem gambling, and to raise awareness about the help that is available at the local, the State, and the national levels.

While thousands of our residents enjoy recreational gaming and gambling – either at our horse racing tracks, the standalone casinos, or our resorts – for some individuals and families, gambling can become an issue affecting and disrupting their lives. The news stories can be too numerous of people who have

gone to desperate measures to feed their gambling addiction; and as such, problem gaming has become a public health issue that crosses all ages, all races, and all ethnic backgrounds.

As chairman of the House Gaming Oversight Committee, I believe it is important for us to acknowledge the addiction, this addiction that can be caused by gambling, along with its societal and economic costs, and to make sure that resources are available to those who are in desperate need of treatment. Sadly, those who seek treatment are limited, even though there are countless organizations dedicated to providing this very assistance.

So I would ask, through this resolution today, that we urge the Pennsylvania Gaming Control Board to continue its outreach efforts and to work with the gaming industry to develop and implement problem gambling programs and promote community-based initiatives. I also ask that the Department of Health and Drug and Alcohol Programs and the Gaming Control Board work with individuals, with professionals, and with organizations to jointly create, develop, and promote public awareness campaigns regarding the recognition and the prevention of problem gambling.

He was 34 years old at the time of his death. He is survived by his parents, Donald and Jean; brothers Mark and Kyle; and his sister, Lauren.

Today I simply ask that we honor this young man and pay him the respect he earned. I have circulated a cosponsor resolution seeking recognition of him on the House floor. Mrs. KULA. Mr. Speaker, I just want to thank once again all the members for their unanimous vote on this legislation, and I would like to submit the rest of my remarks for the record.

The SPEAKER. The Speaker thanks the lady. Deliver them to the clerk and they will be noted in the record.

Mrs. KULA submitted the following remarks for the Legislative Journal:

I would like to take this opportunity to thank the members for their votes on HB 286. This bill amends Title 23 (Domestic Relations) of the Pennsylvania Consolidated Statutes to enact the Uniform Child Abduction Prevention Act. The act would allow the courts to order abduction prevention measures when children – typically during a custody battle – are at risk for being kidnapped.

Nationwide, most child abductions are perpetrated by a family member, often during the course of custody proceedings. While Pennsylvania currently has laws on the books providing for initial custody determinations as well as consequences for abduction or attempted abduction of children, our laws, like most States, lack measures on the front end to prevent the abduction of children. This bill attempts to fill that void.

The bill would allow abduction prevention measures to be ordered by the court – by its own motion or by motion of one of the parties to a child custody determination – where there is evidence that establishes a credible risk of abduction of the child. There are 13 factors enumerated in the bill that go to risk, including whether or not the respondent has previously attempted to abduct the child, has threatened to abduct the child, or has engaged in activities that may indicate a planned abduction.

If an order for abduction prevention measures is warranted, the court must enter an order which may include travel restrictions such that the party against whom the order is entered must notify the moving party of his or her travel itinerary, a prohibition on moving the child out of the State, or restrictions on the child's passport. Additionally, conditions may be put on custody and visitation to serve as abduction prevention measures.

This bill has been given the stamp of approval by the National Conference of Commissioners on Uniform State Laws. Ten States have adopted similar acts so far.

I am extremely pleased with the bipartisan support that this bill has received. If this bill prevents the heartache and trauma of so much as one child abduction, our work here will have been for the good of Pennsylvania's children.
