Michael Robert Goodwin, Sr. While we attempt to comfort his family, no words are great enough for this hero and all those that have fallen before him protecting our families.

For every firefighter that falls, a community of loved ones, friends, and fellow firefighters mourn. That is why the National Fallen Firefighters Foundation started their nationwide initiative to remember America's fallen heroes and their loved ones and to honor them for their sacrifice.

Firefighters' families are a part of a community of heroes. Their willingness to sacrifice for our neighborhoods is reason enough to honor them and support them whenever possible. The families we are honoring today in the resolution have made the ultimate sacrifice to our cities and towns throughout and should never be taken for granted.

Mr. MARKOSEK. Thank you, Mr. Speaker.

Mr. Speaker, I am joined up here at the podium with two of our colleagues from Westmoreland County, Representative Dunbar and Representative Harhai. We are here to talk about HR 94, and I always think when we do these resolutions, that they are a unique way that the House of Representatives can honor and show accolade and in a way pray for fallen comrades, fallen citizens of the Commonwealth of Pennsylvania.

Today I rise with a heavy heart to ask my colleagues to join me in honoring the life and supreme sacrifice of United States CPO Nicolas D. Checque, who tragically died of combat-related injuries suffered on December 8, 2012, while supporting Operation Enduring Freedom near Kabul, Afghanistan.

Chief Petty Officer Checque was raised in western Pennsylvania and graduated from Norwin High School in Westmoreland County, where he lettered in wrestling. Classmates described him as "an extraordinary, driven young man." A coach described him as "one of those guys you want to have on your team."

After graduating from Norwin High School in 2002, Chief Petty Officer Checque joined the Navy. A year later he was accepted into the highly competitive SEAL (Sea, Air, and Land) program. He not only attained his long-standing goal of becoming a SEAL, he also became a member of the elite SEAL Team Six, the Naval Special Warfare Development Group. I am sure many of you will remember that SEAL Team Six also participated in the successful operation that resulted in the death of Osama bin Laden. Over his 10-year career in the Navy, Chief Petty Officer Checque was a highly decorated, tenured Navy veteran, earned several awards, including a Bronze Star Medal with Valor. He served in both Iraq and Afghanistan.

Chief Petty Officer Checque died on December 8, 2012, at the young age of 28 of combat-related injuries. He sustained his fatal injuries while participating in SEAL Team Six's successful rescue of Dr. Dilip Joseph, an American physician who worked for a nongovernmental organization, who was being held captive in Afghanistan. Dr. Joseph had been kidnapped by the Taliban, and American officials believed he was in imminent danger.

According to NBC News, SEAL Team Six's rescue team set out under cover of darkness aboard assault helicopters to rescue Dr. Joseph, who was being held in an enemy compound. As they approached on foot, they came under intense enemy fire. In the course of the firefight, Chief Petty Officer Checque paid the ultimate sacrifice. During the firefight, the SEALs killed seven Taliban fighters and captured two others, in addition to securing the safety of Dr. Joseph.

I join all Pennsylvanians in extending our condolences to Chief Petty Officer Checque's mother, a new Gold Star Mother, Sandra Strom of McCormick, South Carolina; his two sisters, who live in Greensburg, Pennsylvania; and the rest of the family and friends. Our service men and women put their lives on the line, and Chief Petty Officer Checque's ultimate sacrifice reminds us again that we must at all times honor our troops and their families. I never knew Chief Petty Officer Checque, but I wish I did.

I ask the House for a unanimous vote in support of HR 94 in honor of the life and memory of CPO Nicolas D. Checque, a great American and a great Pennsylvanian.

WHEREAS, The House of Representatives of Pennsylvania wishes to honor the memory of the Honorable George Michael Leader, who served with honor and distinction as Governor of Pennsylvania from 1955 to 1959, and passed away at the age of ninety-five on May 9, 2013; and

WHEREAS, Mr. Leader was born in York County on January 17, 1918. He attended Gettysburg College and earned a degree from the University of Pennsylvania in 1939. Following his dedicated military service, Mr. Leader became the seventh generation of his family to become a Pennsylvania Dutch farmer when he purchased a poultry farm in York County. the age of thirty-six, making him the second-youngest person to be elected to this position. Under his leadership, the State overhauled its mental health system and made special education a requirement in schools. In 1962 Mr. Leader and his wife founded a company which provided skilled nursing care in this Commonwealth. He later established Country Meadows Retirement Communities, and in 1980 he launched Providence Place, where he served as Chairman, Chief Executive Officer and President until his passing. Active in professional organizations throughout his life, Mr. Leader served as National Crusade Chairman of the American Cancer Society and on the Board of the Philadelphia Home Loan Bank. In later years, he focused his attention on prison reform, on local charities that supported students in the Harrisburg School District and on international organizations serving Africa; now therefore be it

#### REMARKS BY MAJORITY LEADER

The SPEAKER. The Speaker recognizes the majority leader, Mr. Turzai.

Mr. TURZAI. Thank you very much, Mr. Speaker.

I just wanted to say a few brief remarks in remembrance of Governor Leader.

We had the opportunity, many of us here in this august chamber, to meet the Governor at the invitation of the Speaker of the House in the swearing-in ceremonies of 2011, and Governor Leader was such an affable, strong individual and, as the Speaker just recalled when we were talking about when he had Governor Leader here, knew the operations of State government on the back of his hand, even though he had served back, I believe, in the late 1950s as Governor.

He was also, as you know, a successful businessperson, a successful community leader, giving much of his time to charity. And for me it was an honor and I know for many of the members, because I remember them remarking on it when the Governor was here, to have the Speaker invite him so that we

could meet him, and we certainly extend our heartfelt condolences to his family upon his passing.

He and his wife, the former Mary Jane Strickler, they were married in 1939 and she passed away in March 2011, and they were both living at Country Meadows.

This good York County product, and my good friend, Stan Saylor, and the other members from York County here in our body I know feel a special kinship with the former Governor. Thank you.

# REMARKS BY DEMOCRATIC LEADER

The SPEAKER. The Speaker recognizes the Democratic leader, Mr. Dermody.

Mr. DERMODY. Thank you, Mr. Speaker.

As we have heard, Governor Leader was a remarkable person. He made his mark in government and in business, and most importantly, in doing good works.

While we recall him as being Governor, we should not forget that he also was a member of the Greatest Generation. He served his country. He volunteered. He enlisted at the beginning of World War II and served in the Navy, I believe, on an aircraft carrier. He returned back to York County, as we have heard, and became a State Senator. We are very happy to say that he was probably the second Governor, I believe, Democratic Governor elected in the 20th century. He won in 1954 with a 900,000 Republican voter registration edge. So it was quite an upset victory for Governor Leader, and he took office and started his Governor's tenure in hard times. He had difficult financial times, much like we face today, and he continued to work hard and invest in the future of Pennsylvanians.

And as we have heard, he started several programs that are in place today. He started PIDA, the Pennsylvania Industrial Development Authority, which is still at work helping businesses grow in Pennsylvania. He did sign the law that made the provision for special education a requirement in all school districts, and he really took an interest in mental health and mental illness. He greatly reduced the number of patients in our State's mental hospitals because he invested in community facilities and treatment for people with mental illness.

He also appointed Pennsylvania's first African-American Cabinet member, and he set up an office to protect people's rights that later evolved into the Human Relations Commission that we have today. George Leader's administration sparked growth in our State parks and our State forests, and he preserved some of Pennsylvania's most endangered natural areas.

He was the Governor for just 4 years because that is what the limit was in those days. It has been 54 years since he has been in office, and despite the passage of all that time, these countless legacies of his term as Governor still exist with us today. It goes to show the impact that he had on all Pennsylvanians.

I had the opportunity over the last several years to meet Governor Leader several times, and if you knew him at all, you knew that he always kept his political chapter of his life in perspective. He was proud of his record. He did not dwell on it and he was always looking forward.

He was just 41 years old when he left this office, but he knew he had a great future ahead of him. He had years to work and he had much left to accomplish. As it turned out, he was a natural businessman, and as we have heard, he started the

centers for seniors, the residential areas for seniors, and countless and hundreds of thousands of Pennsylvanians, senior citizens, have lived in his senior centers that he has developed.

And he really became an elder statesman, as we have heard also. I believe he helped the Speaker with our swearing-in ceremonies. He has worked closely with us on important issues. He served on boards and commissions. He really was interested in prison reform. He spent his whole life trying to make Pennsylvania better.

And we also join in sending our condolences to the family but really saluting a true Pennsylvanian for all the great work he has done for all of us. Thank you, Mr. Speaker.

# REMARKS BY SPEAKER

The SPEAKER. I would like to add a couple comments as well to emphasize the accolades expressed by the two floor leaders.

I met Governor Leader a couple times kind of in passing through this place, but 2 1/2 years ago when he agreed and he honored us by lending his name to the Legislative Swearing-in Committee, I was simply honored that he was willing to do it, a man of his stature, a former Governor, and after all, it is the House, it is the legislative branch, and he was the Governor, but I was truly honored that he did. You know, there are a lot of different adjectives that can describe Governor Leader: a reformer, a humanitarian, a statesman, entrepreneur. The two floor leaders have talked more in depth about some of those characteristics.

And let me just simply conclude our recognition in honor of former Governor Leader that Pennsylvania is a better place because of Governor Leader, and we should all be very proud to have been a part of this with him over the course of these years in the institutional sense of this place. He was just a very, very decent, kind gentleman on top of all those smart things he was.

# REMARKS SUBMITTED FOR THE RECORD

The SPEAKER. The Speaker recognizes the gentleman from Delaware County, Mr. Adolph, who requested to submit remarks for the record relative to HB 770, which was just previously adopted. The gentleman's remarks will be noted in the record.

Mr. ADOLPH submitted the following remarks for the Legislative Journal:

Pennsylvania is home to 229 miles of the Appalachian Trail. Much of this great Commonwealth's natural resource is cared for and maintained by the Appalachian Trail Conservancy.

The Appalachian Trail Conservancy's mission is to preserve and manage the Appalachian Trail, ensuring that its vast natural beauty and priceless cultural heritage can be shared and enjoyed today, tomorrow, and for centuries to come.

This legislation establishes a new section to create an Appalachian Trail Conservancy special vehicle registration plate. The new section mandates that PENNDOT shall design the plate in consultation with the ATC and that the design shall be of the full-canvas variety as opposed to the now-uniform design standard for PENNDOT-issued special organization plates.

This legislation also allows the Appalachian Trail Conservancy to charge a fee to an individual for the authorization to request the registration plate and that proceeds received by the ATC must be used exclusively for trail maintenance and improvement.

HB 770 allows for personalization or vanity plates for a set fee of \$100.

My bill also makes some amendments to the Vehicle Code that expands what types of vehicles can apply for special plates.

I would appreciate your support for this legislation that helps the Appalachian Trail Conservancy maintain the trail that serves as a great option for outdoor recreation for Pennsylvania and also recognizes the great history of the Appalachian Trail in Pennsylvania.

# BILLS ON THIRD CONSIDERATION

HB 391, it is an important piece of legislation. Right now throughout the entire State of Pennsylvania, you can – if you are a jurisdiction, a school district – you can, you have the authority, you have the power to allow for installment payments with respect to property taxes. The only jurisdiction that does not have this option is the first city of Pennsylvania, Philadelphia, that was founded by William Penn with a population of 1.5 million people. HB 391 should be available, the relief of installment payments of property taxes should be allowable to Philadelphia along with every other jurisdiction in the State. It does not change the amount of tax due, but empirical research has shown that delinquency rates decline when residents are able to spread out the payments. This option, this authority, is available to every jurisdiction in the State but one, and I would ask you to vote "yes." Thank you.

The SPEAKER. The question is, shall the bill pass finally? On that question, the Speaker recognizes the gentleman from Philadelphia County, Mr. McGeehan.

Mr. McGEEHAN. Thank you, Mr. Speaker.

And I appreciate the strong support of the majority leader and his caucus on this bill. We had a tremendous problem in Philadelphia. We have one of the highest poverty rates, not only in the Commonwealth but in the country, and by allowing people to pay their property tax in installments will greatly alleviate the one-time burden on property tax payers in Philadelphia. It sounds like a simple bill, but it is our belief that it will have profound influence on delinquency property tax payments in Philadelphia, and I appreciate the support of the members.

It is a way to make sure that you can responsibly have your revenues come into your jurisdiction. It is just allowing that the taxing jurisdiction can take those delinquent property tax claims reduced to judgment, and without disturbing the original lien, to file those judgments against the taxpayer.
