### **RIVERSIDE ELEMENTARY WEST STUDENTS PRESENTED**

The SPEAKER. I would like to invite Representative Kavulich to the rostrum for the purpose of presenting a citation to the national winners of the Siemens We Can Change the World Challenge from Riverside Elementary School.

The gentleman, Mr. Kavulich, may proceed.

Mr. KAVULICH. Thank you, Mr. Speaker.

Mr. Speaker, 2 weeks ago I received a letter, and it was not your typical constituent letter asking for a vote on a House bill or looking for help with a problem. It was from Dominick DeAngelo, a first grade student at Riverside West Elementary School in Taylor, in Lackawanna County. Well, Dominick was all excited because he and three of his classmates entered a competition and they came home in first place, and he wanted to come to where I work and tell me all about it.

Well, I found out that this was no ordinary contest. This was the Siemens We Can Change the World Challenge sponsored by Siemens, Discovery Education, and the National Science Teachers Association. There were entries from all over the United States, and I stand in this hallowed hall today proud to say that these four young students, who attend Riverside West Elementary School in my hometown of Taylor, Pennsylvania, beat out all the others and they are now national champions.

To all of you, my distinguished colleagues here today, may I introduce to you three of the Aqua Busters who are here with us today. First we have Gavin Hartman – Gavin, wave to everybody; Trevor Balcerzak; and Dominick Deangelo. Now, the fourth team member, Gary Mrozinski, could not be here with us today, but I would like to take a moment just to tell you all about their winning entry.

The Aqua Busters decided that they were going to prove that the quality of tap water was as good as or even better than bottled water. They understood that there was a stigma around tap water that said it was worse than bottled water, and their goal was not only to erase that stigma but to educate students, parents, the community, the world, and maybe even the universe that tap water tastes fine and is actually better for you. And in

the end, the Aqua Busters proved that, showing that tap water was just as good as two of the leading brands of bottled water and better than the third. And they also showed that it was cheaper for you to buy a filter for your tap at home than to purchase bottled water.

Now, as if all that was not enough, I would like to add that these four fine young men have decided to use the money that they won in the competition to build an outdoor classroom at their school for this generation and for generations at that elementary school to come.

I would now like to acknowledge, also, the parents of the Aqua Busters. They are in the back. Please stand up so we can give you a hand.

And finally, the principal of Riverside West Elementary School, Mr. Paul Brennan, who under his guidance, Riverside West is also the two-time defending champion of Recycle-Bowl, a competition with 1500 schools and over 900,000 students participating.

So once again, to my fellow colleagues here in this chamber, these are the kinds of efforts that show, despite all of the bad news we hear about our younger generation, we are leaving this world in some pretty capable hands. So again to the Aqua Busters – Gavin, Trevor, Dominick, and Gary – their parents, and Mr. Paul Brennan, my heartfelt congratulations.

### **DAVID BRICKER PRESENTED**

The SPEAKER. I invite Representative Helm and Representative Hennessey to the rostrum for the purpose of presenting a citation to David Bricker, State champion in the Class AA boys 400-meter dash.

Ms. HELM. Thank you, Mr. Speaker.

This morning I rise with great pride to speak about the achievements of an outstanding athlete from Dauphin County. David G. Bricker of Susquehanna Township has joined me here on the rostrum, along with Representative Tim Hennessey. To the left of the rostrum are David's mother, Carol Turner, who is Representative Tim Hennessey's administrative assistant; also, David's father, David L. Bricker; his stepfather, Steven Turner; his grandmother, Brenda Kauffman; and his aunt, Jackie Trently-Deitrich, who is my Elizabethtown district office manager.

David will be starting his senior year at Trinity High School and deserves special recognition for capturing a gold medal in the Class AA boys 400-meter dash event during the 2013 PIAA State Track and Field Championships held last month at Shippensburg University. His time was 49.77 seconds. David is a dedicated and committed athlete whose hard work paid off and took him to the top of the victory stand.

Making his State title even more noteworthy is the fact that David was the only Class AA individual champion from the Mid Penn Conference. David also distinguished himself by capturing a silver medal in the 400-meter relay and 1600-meter relay events.

I heartily congratulate David Bricker for his stellar season and State championship victory. I offer my best wishes for success in all your future endeavors.

Representative Hennessey would like to say a few words, and afterwards please join me in giving David a warm House round of applause to celebrate his outstanding athletic accomplishments.

It is a pleasure for me to be here today to recognize what David has accomplished, especially since his mother has told me so many times what he has accomplished as he continuously recorded victory after victory in his track career.

As you know, I like to do a little background on these kinds of presentations before I do them, and as Representative Helm has told you, David won the 400-meter dash in 49.77 seconds as a high school junior. I was sort of intrigued about that, and I went to the track myself and tried to find out how fast I could run the 400-meter dash. So I got out my – it was right before dinner one day – I got out my stopwatch and ran the 400 meters. I cannot give you an official time for me because the sun had set by that time, by the time I crossed the finish line, and I do not know how fast I made it. But I know 49.77 seconds for a high school junior is a pretty amazing accomplishment.

In addition to that, David won silver medals that same day in the PIAA Championships for a 400-meter relay and 1600-meter relay; a rather skilled athlete and we look for a lot of good things from him in the future.

So we have, on behalf of Representative Helm and myself, and on behalf of all the members of the House of Representatives, we have a citation to commemorate David's victory in the PIAA Class AA Championships. Thank you.

**STATEMENT BY MS. PICKETT**

The SPEAKER. The Speaker recognizes the lady from Bradford County, Ms. Pickett, under unanimous consent relative to one of the resolutions just adopted.

Ms. PICKETT. Thank you, Mr. Speaker.

I would like to thank my colleagues for their unanimous support on HR 114. This resolution designates July 21 of this year, 2013, as "Veterans Appreciation Day" in the Commonwealth.

While I know that we all appreciate our veterans every single day, this date marks a very special event in my Bradford County. This year the annual Veterans Appreciation Day picnic will be held in Wysox in Bradford County in honor of all veterans and as a way to show appreciation for their courageous sacrifices. At this year's picnic, we will be honoring the four individuals who started the Veterans Appreciation Day picnic in Bradford County, as well as the 60th anniversary of the end of the Korean war.

The four founders were the late Joe Larnard, the late Merle Young, and the late Steve Fasset, along with the only living member of the group, Don McNeal. The four men not only agreed that something needed to be done to show the community's appreciation for our veterans, but they stayed up late cooking the meat, gathering supplies and other refreshments, and solicited donations from community groups and businesses, along with their veterans from the Veterans of Foreign Wars Post 44. These men exemplified what it means to be a veteran. They all served in the Vietnam war. And while their service to our country is noble, it is what they and their supportive families did when they returned home that speaks volumes of their dedication to our country and to our community.

This Veterans Appreciation Day not only reaches out to the veterans who live in our community but those who may be homebound, and of course, to the families who give their love and support every day for our men and women in uniform.

I think it is also fitting that this year's celebration of our Bradford County veterans is just a few days shy of the 60th anniversary of the Korean War Armistice Agreement, which was signed on July 27 of 1953. By marking this anniversary at this year's picnic, we seek to remember all the men and women from Bradford County – and in fact, all of Pennsylvania – who were part of the Korean war and any conflict in which America sent her sons and daughters. Through the time-honored and unselfish commitment of these veterans, our country is and continues to be a beacon for democracy around the world. The valor they have shown can never be adequately measured.

Whether our nation's heroes fought in the 18th, 19th, 20th, or 21st centuries, we honor them all; we honor them all the same and we honor their memory. And the best way that we can honor them is to never forget them and to never forget that for which they fought. That is why this Veterans Appreciation Day is so very important for Bradford County and for all of Pennsylvania.

**STATEMENT BY MR. MATZIE**

The SPEAKER. The Speaker recognizes the gentleman from Beaver County, Mr. Matzie, under unanimous consent relative to one of the resolutions just adopted.

Mr. MATZIE. Thank you, Mr. Speaker.

I rise today to thank the members for their vote in support of HR 376, and also to speak about the plight of Pennsylvania's pollinator population. It is easy to overlook the essential role pollination and beekeepers play, but the pollination process is imperative for the health and well-being of our national forests and grasslands. Pollinators are also essential to our agricultural industry.

Bees are responsible directly or indirectly for every third bite of food Americans eat, and I ask a couple of questions to you: Do you like apples? What about almonds or blueberries or cherries? None of these would be available on grocery store shelves without bees. Bees and the pollination process are indispensable parts of growing any flowering fruit, and the result of this is \$15 billion worth of food each year. Bees also produce food for your food: Alfalfa and clover, both cattle feed, need to be pollinated to produce seeds for the next year's crop.

A few decades ago farmers could rely on wild bees and other insects to pollinate their crops, but with the rise of colony collapse disorder and the increased use of harmful pesticides, wild bee populations are down and professional beekeepers have come to play an increasingly important role in putting food on our tables. The low number of professional beekeepers is just as troubling. There are about 125,000 beekeepers in the United States, but most of them only keep hives as a hobby. Only 600 are commercial beekeepers with 1,000 hives or more. Without these 600 beekeepers, the agriculture industry would only be able to produce a fraction of what it does now. That is why the Pennsylvania Beekeepers Association should be commended for working cooperatively with the Pennsylvania Department of Agriculture, the Pennsylvania State University Cooperative Extension, and Delaware Valley College to promote pollination and beekeeping.

Beekeepers and their pollinators do not get the recognition they deserve for their important work, which is why I am proud to support this resolution and thank the members for their vote in designating the week of June 20 to June 26 as "Pollinator Week" in Pennsylvania.

Mr. WATERS. Thank you, Mr. Speaker.

Mr. Speaker, I rise today to recognize a tradition originating in Galveston, Texas, in 1865, marking the ending of slavery and was coined "Juneteenth." On June 19, 1865, 148 years ago as of today, Maj. Gen. Gordon Granger and 1800 troops of the Union Army arrived in Galveston, Texas, and announced that the Civil War had ended and all slaves were free.

Even though President Abraham Lincoln's Emancipation Proclamation had gone into effect on January 1, 1863, freeing all slaves in those States in rebellion against the United States, for various reasons the decree had not yet taken effect in Texas. Since that time the observance of Juneteenth has spread across the United States and beyond. Juneteenth is the oldest nationally observed commemoration of the ending of slavery in the United States.

Today Juneteenth commemorates African-American freedom and emphasizes education and achievement. Juneteenth is also a time to also celebrate the positive contributions of African-Americans nationally and locally, and to promote a cultural connection of the observance as an opportunity to build strong communities through access to health services and education resources. It is recognized as a State holiday in approximately 37 States nationwide.

"Juneteenth is a day of reflection, a day of renewal, a pride-filled day. It is a moment in time taken to appreciate the African American experience. It is inclusive of all races, ethnicities and nationalities – as nothing is more comforting than the hand of a friend."

Mr. Speaker, on this occasion it is my distinct pleasure to recognize Juneteenth in Pennsylvania in celebration of our momentous victory. I ask for the support of HR 378. And I thank you, Mr. Speaker, and I thank all the cosponsors of this resolution. It has great bipartisan support, and I look and ask for an affirmative vote on HR 378.

Instead, we need to look at opportunities to use already existing revenue and be creative in how we find additional funding sources for the Philadelphia School District, and really, for all school districts across this great Commonwealth, to help stop the educational cuts that are happening across the Commonwealth. We must never lose sight of what is really at stake here: maintaining a chance for a quality education for tens of thousands of children, not only in the great city of Philadelphia, but across every county in the Commonwealth of Pennsylvania.

The SPEAKER. On that question, the Speaker recognizes the gentleman from Philadelphia County, Mr. Brendan Boyle.

Mr. B. BOYLE. Thank you, Mr. Speaker.

Mr. Speaker, very briefly, this amendment is in the spirit of the bill that I offered last session, as well as again this session, that would require education about the Holocaust and other genocides in our schools. This idea is modeled off of a similar law that exists in five different States: New York, New Jersey, Florida, Illinois, and California. In those States, in an effort to say never again and to make sure our young people are taught about what can happen when hatred is left unchecked, they require that the Holocaust, as well as other genocides, be taught in their schools.

Now, Mr. Speaker, I am disappointed that my bill has not moved through this House the last two sessions. I appreciate the gentleman who has offered a bill to attempt to address this matter; however, it does not include this mandate. The underlying legislation could be stronger. It could require that this subject matter, this important subject material, is taught in our schools. This is the way it is done in those five other States. It has very minimal cost, and I certainly think that it is the best approach.

It is strongly supported by the Holocaust Awareness Museum that is in my legislative district, and I would certainly appreciate an affirmative vote. Thank you.

The SPEAKER. The question is, will the House adopt the amendment?

On that question, the Speaker recognizes the gentleman from Bucks County, Mr. O'Neill.

Mr. O'NEILL. Thank you, Mr. Speaker.

Mr. Speaker, while I agree with the gentleman from Philadelphia and his amendment, the Republican Education members met with several groups who were of the Jewish faith who were pushing this legislation, and through the conversations of trying to get this through and bring it to the House, we had a discussion about mandates on the school districts and being realistic about what we can get through both the House and the Senate. While we were all in agreement that we think that every school district should be supporting this and should be teaching about the Holocaust, they reluctantly did agree with us that maybe what we should do to get this through is not make it a mandate.

So therefore, I would ask the members, since the group that is pushing this bill agreed with us that maybe we should move forward at this time without a mandate attached to it, that I ask the members to oppose the amendment. Thank you.

The SPEAKER. The question is, will the House agree to the amendment?

On that question, the Speaker recognizes the gentleman from Bucks County, Mr. Clymer.

Mr. CLYMER. Thank you, Mr. Speaker.

Mr. Speaker, while the amendment that is before us is well-intended, it is an unfunded mandate. And as my colleague

from Bucks County just mentioned, that the Pennsylvania School Boards Association will oppose this bill if this mandate is included. Also, you heard him mention, that is my colleague from Bucks County, mention that the Jewish Coalition that we worked with over a number of weeks was supportive of the "may" provision, the bill as it is presently structured.

Mr. Speaker, the Holocaust itself is such a horrific issue, trust me, many of the school boards will support this and many of the school districts will write into their curriculum the Holocaust issue because of what it is. It will draw its own support within the school district and many – all administrators, I would think, all teachers would want their students to learn about this issue, this horrific issue that occurred some 70, 80 years ago. We cannot forget what occurred in Germany and throughout Europe during World War II to the Jewish people.

I ask members not to support this amendment. Thank you.

The SPEAKER. The question is, will the House agree to the amendment?

On that question, the Speaker recognizes the gentleman from Philadelphia County, Mr. Roebuck.

Mr. ROEBUCK. Thank you, Mr. Speaker.

I think it is important that we understand what this bill is about. It is about incorporating into the instruction an essential element that we all need to understand.

Now, what just occurred in the comments of my good colleague from Bucks County is exactly the same thing that happened when we talked about this bill in committee. This is not solely about the Holocaust; it is about the Holocaust and genocide. Do not separate one from the other. To say that we are going to teach about Holocaust and not teach about other manifestations of what happened to other people in the same manner is to distort history and is wrong.

The amendment that we proposed, that is proposed here, is a good amendment and makes us understand what this is about. It gives the issue paramount importance that helps to get it incorporated into the curriculum.

Let us understand, I am by training a historian. I could not teach about the period of the 1920s, 1930s, 1940s, without teaching about the Holocaust, nor could I teach about the period up to 1865 without teaching about slavery. I could not teach about the period after the Civil War without teaching about immigration. They are essential elements of history that need to be said or mandated in that they are essential to what you are teaching. If you do not do that, if you do not do that, you might as well not teach it at all.

So I would urge you to adopt this amendment which ensures the integrity of the subject we are talking about. To do less is to create an illusion that we are doing something and not doing that which is right.

Thank you, Mr. Speaker.

The SPEAKER. The question is, will the House agree to the amendment?

On that question, the Speaker recognizes the gentleman from Lehigh County, Mr. Schlossberg.

Mr. SCHLOSSBERG. Thank you, Mr. Speaker.

Mr. Speaker, let me start by admitting a very personal bias on this issue. It was not one that I was planning on speaking on, but sitting here, I felt obligated to.

I am the grandson and grandnephew and related to many who survived the Holocaust, and more to the point, I am related to many who did not. The purpose of education and the reason that we have an educational system is obviously to teach, but it

is also to teach history's lessons. The purpose of a mandate is to guarantee that something is taught, and I would put before this body that there are some issues that, without fail, we need to ensure, we need to mandate are taught.

Mr. Speaker, my relatives and 12 million others and millions upon millions in history have been eliminated through genocide, including through the Holocaust. There are some issues that I think we as a legislative body have an obligation to say we must teach to others. And while I certainly commend the gentlemen from Bucks County, Mr. Clymer and Mr. O'Neill, I would respectfully argue that there are some things that we as human beings have an obligation to say, you must know about this, because how many times in the course of history have we said never again, yet here we stand as genocide after genocide after genocide is perpetrated throughout the world?

Mr. Speaker, I would urge passage of this amendment to give this legislation real teeth and to say that we as legislators and as a Commonwealth believe there are some issues that are so important that yes, we mandate that they be taught to others.

Ms. HAHN submitted the following remarks for the Legislative Journal:

Thank you, Mr. Speaker.

I rise to ask for your support of HB 1439, which is part of a very important package of agriculture bills we are considering today on final passage.

Agriculture is big business in Pennsylvania, which has more than 63,000 farms covering a bit more than 7.5 million acres. Farmers, however, are not immune to economic difficulty, and my bill would save them money by exempting them from being penalized under current tax law.

HB 1439 addresses the use of high tunnels, which are buildings similar to greenhouses. These portable structures are currently assessed as real estate and subject to building codes. My bill exempts from assessment high tunnels in second-class-A through eighth-class counties. High tunnels would be exempt from assessment in all Pennsylvania counties, as well as the Pennsylvania Construction Code, through additional legislation we are taking up today. These buildings offer farmers tremendous energy and business benefits, which translate into savings at the dinner table for consumers. The agriculture industry should be commended for using this new technology.

I ask for your support of Pennsylvania's family farms through an affirmative vote on HB 1439.
