STATEMENT BY MS. RAPP

The SPEAKER. The Speaker recognizes the lady from Warren County, Ms. Rapp, under unanimous consent relative to one of the resolutions just adopted.

Could I have the members' attention.

Ms. RAPP. Thank you, Mr. Speaker.

The SPEAKER. If the lady could hold on; if the lady could just suspend one minute; I apologize.

If I could have the members' attention, please. I appreciate holding the conversations down. Just hold them down just a little bit, please. I appreciate your courtesy.

Ms. RAPP. Thank you, Mr. Speaker.

Mr. Speaker, I am greatly honored to rise and ask for your support of HR 363, which recognizes the tremendous life and achievements of one of Warren County's most notable public servants on the 170th anniversary of his birth.

Born on June 29, 1843, Charles Warren Stone accepted the position as principal of the Union School in Warren in 1863 and was elected superintendent for all Warren County schools in 1865. Soon after, he was chosen to serve as principal of the Erie Academy, and while teaching school, Mr. Stone studied law and was admitted to the Warren County bar in 1866.

Due largely to his exceptional performance on the board of school directors, he was nominated as a candidate for the Pennsylvania House of Representatives and was elected to serve the people of Warren County in 1869. In 1876 he was elected to the Senate of this Commonwealth, where he served as chair of the Judiciary General Committee.

As a lasting tribute to his accomplishments in the State legislature, Mr. Stone's portrait still hangs in the Rules Room of the State Senate.

He next moved on to the executive branch to serve as Pennsylvania's Lieutenant Governor during the term of Gov. Henry M. Hoyt from 1879 to 1883. In 1887 Mr. Stone was appointed as Secretary of the Commonwealth and served in this post until his resignation to accept a nomination for Congress. Mr. Stone was elected to the U.S. Congress in 1890 and proudly represented his constituents on the national stage until 1899.

After his retirement from the political arena, Mr. Stone returned to the practice of law and remained very active in his community, serving as a director, officer, or board member for several corporations and nonprofit organizations, such as the Warren Savings Bank, Cumberland Railroad Company, Union Lumber Company, Warren County Public Library, and as the first president of the Warren County Historical Society.

In honor of this extraordinary man who truly dedicated his entire life to serving his community, his Commonwealth, and his country, I respectfully ask for unanimous passage of HR 363.

STATEMENT BY MR. GODSHALL

The SPEAKER. Is the gentleman from Montgomery County, Mr. Godshall, seeking recognition under unanimous consent? The gentleman, Mr. Godshall, is in order.

Mr. GODSHALL. Thank you, Mr. Speaker.

Mr. Speaker, so often in this chamber we recognize the achievements of student athletes, and North Penn High School, in my district, has a proud athletic tradition. In fact, this has been a particularly good year for both student athletes and academics at North Penn.

State championships are coveted by each of Pennsylvania's nearly 500 school districts. North Penn has the good fortune to have claimed about 50 State championships over the course of 3 years – including these three this year; excuse me.

Today we honor the State Champion North Penn High School Baseball Team, AAAA. After losing three regular season games to Representative Paul Clymer's Pennridge High School, North Penn faced them again in the district finals and beat them in a 3-run shutout. That sent them to the State finals, where they took on Representative John Payne's Lower Dauphin High School. There they battled their way to a hard-fought 6-5 victory to claim the State title. At the beginning of the season, few would have expected to see North Penn in the State finals.

Under the direction of Coach Kevin Manero, the team fought hard, grew stronger, and more cohesive as the season progressed. In the end it was solid pitching, timely hitting, and sheer determination that led to team victory.

Just a couple of weeks ago, we welcomed the State Champion North Penn Academic Decathlon Team to this chamber and congratulated them on their State title and for their impressive showing in the U.S. Academic Decathlon in Minneapolis in April.

After outperforming 24 State Pennsylvania teams to claim the State title, North Penn went on to face the sharpest young minds from all over the country and, in fact, internationally.

North Penn placed 11th out of a field of 53 competitors that included teams from several foreign countries. What makes this team's accomplishments more impressive is the fact that most of their challengers have year-round classes that groom them for the competition. North Penn does not. At North Penn, academic decathlon is much more like a club sport – just one of the more than 100 clubs and activities in which students may choose to participate.

I want to take this opportunity to express my sincere congratulations, along with Representative Harper, Representative Bradford, and Representative Stephens, to the team and its academic adviser, Dr. Kathryn Daughton, on their outstanding performance this year. I am proud to say that North Penn is home to many gifted young people, including a number of national merit scholars.

Finally, I want to recognize a team that has consistently ranked among the best in the State, North Penn High School Women's Water Polo, which was also recognized in this chamber 2 weeks ago.

This year's State championship water polo team, which is comprised of All-State and All-Americans, has claimed three of the last four State championship titles and four of the last six. In fact, to come to the championship round this year, they defeated my high school of Souderton.

Under the direction of assistant head coach Kathryn Grunmeier, the Maidens went undefeated in 28 games before beating Souderton 9 to 3 in the State final.

Please join me in congratulating these superior student athletes and scholars from North Penn High School.

Amend Bill, page 2, lines 22 and 23, by striking out "<u>Definition.</u>-<u>As used in this section, the term "secondary metal" means wire,</u>" and inserting

<u>Definitions.-As used in this section, the following words and</u> phrases shall have the meanings given to them in this subsection unless the context clearly indicates otherwise:

"Secondary metal." Wire,

Amend Bill, page 2, by inserting between lines 27 and 28

"Value." The market value of a secondary metal as determined by a buyer of secondary metals plus the replacement value of any property damaged by the theft of the secondary metal.

On the question,

Will the House agree to the amendment?

The SPEAKER pro tempore. On that question, the Chair recognizes the gentleman from Washington County, Representative Neuman.

The gentleman may proceed.

Mr. NEUMAN. Thank you, Mr. Speaker.

This amendment is pretty simple. It would redefine what "value" is within this bill. It would include, for the grading purposes, it would include the value of the secondary metal stolen but also the damage that was done to property while that metal was being stolen. So this would effectively, hopefully, deter people from destroying property to get to secondary metal. Without this amendment, this bill would only cover what the cost of the secondary metal would be upon scrap, and if you do not have this amendment, the property damage that was done to your property to get the metal will not be covered under this grading.

So this amendment is really a friendly amendment for people that are victimized by thieves to steal secondary metal for scrap. Thank you, Mr. Speaker.

The SPEAKER pro tempore. The Chair thanks the gentleman.

On the question of the amendment, the Chair recognizes the gentleman from Butler County, Representative Metcalfe.

Mr. METCALFE. Thank you, Mr. Speaker.

Mr. Speaker, I would ask for the members to vote "nay" on this amendment. This amendment is not needed, Mr. Speaker; it is unnecessary. The existing law with respect to theft offenses provides that the value is market value, and if that cannot be ascertained, then replacement value, Mr. Speaker.

Further, with respect to replacement of property, Pennsylvania law requires mandatory restitution for losses as a result of a crime, Mr. Speaker.

So, Mr. Speaker, this amendment is not necessary, and I would ask for a "no" vote.

The SPEAKER pro tempore. The Chair thanks the gentleman.

On the amendment, the gentleman from Washington County, Representative Neuman, is recognized for a second time on the amendment.

Mr. NEUMAN. Thank you, Mr. Speaker.

This amendment is absolutely necessary. To say that somebody that is coming into your house to steal copper is then going to restore you whole by giving you money is ridiculous.

This is a way to punish somebody that damages your property to get to secondary metal. To think that after they go into your house and steal copper and do damage to your home and then they are going to turn around and have the money to restore the damage that was done to your house is absurd. We need to make sure that we send a message from the legislature to deter people from stealing secondary metal from the beginning, and the message is, do not damage property, because you are going to be held liable not only for the copper that you stole but the property that you damaged.

Thank you, Mr. Speaker.

The SPEAKER pro tempore. On the question of the amendment, the Chair recognizes the gentleman from Montgomery County, Representative Stephens.

Mr. STEPHENS. Thank you, Mr. Speaker.

Mr. Speaker, I certainly appreciate the maker of this amendment's intentions and certainly agree with the underlying premise that he presents, but as my colleague from Butler pointed out, this is covered already in the Crimes Code, in the theft section, and certainly restitution would be made available to those victims of crime in the event that some item were damaged during the theft of the secondary metals and the victim would certainly be able to be made whole.

So I would join with my colleague from Butler in asking the members to oppose this particular amendment. Thank you, Mr. Speaker.

Amend Bill, page 2, by inserting between lines 21 and 22 (d) Impoundment of motor vehicles.-Upon the conviction of an offense graded as a felony under this section, the court shall order the impoundment of any motor vehicle used in the commission of the offense for not less than 30 days. The person convicted shall be responsible for any fees associated with or related to the impoundment

of the vehicle.

Amend Bill, page 2, line 22, by striking out "(d)" and inserting (e)

On the question, Will the House agree to the amendment?

The SPEAKER pro tempore. On the question of the amendment, the Chair recognizes the gentlelady from Bucks County, Representative Davis.

Mrs. DAVIS. Thank you, Mr. Speaker.

This is a simple amendment. It will require courts to order a motor vehicle impounded for at least 30 days only if the motor vehicle was used in the theft of secondary metal and was graded a felony. The person convicted of theft of secondary metal would be responsible for any costs related to the impoundment.

Mr. Speaker, I believe we need to punish the most serious and repeat offenders. Thank you.

The SPEAKER pro tempore. The Chair thanks the gentlelady.

On the question of the amendment, the Chair recognizes the gentleman from Butler County, Representative Metcalfe.

Mr. METCALFE. Thank you, Mr. Speaker.

Mr. Speaker, this amendment I also rise in opposition to. While this amendment, like the previous one, is well-intentioned, there are practical problems with this policy. If the offender who stole a vehicle to commit the crime was apprehended by the police, the true owner will not be able to get his car back. It ties the hands of the judge. If the offender is placed on probation or work release, the offender will not be able to get to work. Work is needed to fulfill the court's order of mandatory restitution to pay the fine that was associated with the crime. If the offender uses his wife or girlfriend's car, for example, the offender will not be hurt by the impoundment but innocent people might be.

Mr. Speaker, this amendment is also not drafted properly. Under the Vehicle Code with respect to impoundment, there are provisions regarding where to store the vehicle, notice being provided to the person who owns the vehicle, assessment of costs against the owner regarding the work of the constable, police officer, impoundment official, and how to recover the vehicle, Mr. Speaker.

Mr. Speaker, because of all these problems, I would ask the members to vote "no" on this amendment.

The SPEAKER pro tempore. The Chair thanks the gentleman.

On the question of the amendment, the Chair recognizes the gentlelady, Representative Davis, for a second time.

Mrs. DAVIS. Thank you, Mr. Speaker.

I appreciate what the gentleman from Butler County said. I offered a second amendment that would address this particular issue, and I would like to make a motion to suspend the rules to address that amendment, 2533.

The SPEAKER pro tempore. Would the gentlelady suspend, please.

Mrs. DAVIS. Sure.

The SPEAKER pro tempore. We are still under considering your amendment, A2450. Are you withdrawing that amendment, or do you wish that we proceed with amendment A2450?

An Act amending Title 23 (Domestic Relations) of the Pennsylvania Consolidated Statutes, in child protective services, further providing for definitions and for persons required to report suspected child abuse; providing for specific persons required to report and for required posting of signs; and further providing for penalties for failure to report or to refer.

On the question, Will the House agree to the bill on third consideration? Bill was agreed to.

(Bill analysis was read.)

The SPEAKER pro tempore. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

The Chair recognizes the gentleman from Westmoreland County, Representative Krieger.

Mr. KRIEGER. Thank you, Mr. Speaker.

Again, I want to continue some of the remarks I made last week on Thursday and some of the other bills that were considered.

And again, I understand fully the desire here to do something about child abuse and certainly particularly about the Sandusky matter. I understand that these were very well-intentioned bills, and I just think we need to be careful about unintended consequences of bills we pass. I think it is very important to take a look at this bill, and again, I have a couple concerns. I will not mention all of them. I am going to mention a couple for the members' consideration.

This bill increases, expands the definition of "mandated reporters" under the law, which, again, may not be a bad thing, but we need to consider what that does. It lists several people. It lists the school employee, makes sense; an employee of a child-care center; an employee of a social services agency; and an attorney.

Now, the definition of a school employee is carefully crafted to make sure that it does not include parties that do not have contact with children. However, for social service agencies, for child-care services, I assume since that provision is not included in that definition, it may well include a janitor that does not have contact with children; same way with an attorney. It appears to include a corporate attorney that perhaps practices in a big firm or a family law attorney that would have regular contact with families. When you consider that in conjunction with on page 7 of the bill, it lists the basis to report.

Mr. Speaker?

The SPEAKER pro tempore. The members of the House and staff present, would you please reduce the level of your conversation? The conferences in the aisles, please break up.

The gentleman may proceed.

Mr. KRIEGER. Thank you, Mr. Speaker.

I was saying, on page 7 it lists the basis to report and it lists a couple things that I think make perfect sense. If a mandated reporter comes in contact with a child through the course of employment, again, that makes sense to me. If a mandated reporter is directly responsible for the care or supervision of a child, again, I think that makes perfect sense.

The concern I have is in subparagraphs (3) and (4), if that person receives a specific disclosure that an identifiable child is a victim of abuse or if an individual age 14 or older makes a specific disclosure to that mandated reporter. Now, as I read the bill, that would mean if that mandated reporter receives that report either in his scope of employment or outside his scope of employment. So I could envision a possibility where a mandated reporter, say a health-care worker, an attorney, is in his backyard with an engineer and the neighbor across the street indicates, they specifically disclose, hey, the kid up the street may have been abused. In that particular case, that health-care worker or that attorney would be mandated to report, while that engineer who is standing beside him, as I understand the bill, would not be required to report. I wonder when reports are received outside the scope of employment, why one class of person is treated differently than another.

One last thing I want to leave for the House to consider, on page 8 of the bill, it mentions confidential communications received by a clergyman, and again, I think the provision is designed to make sure that confidential communications to a clergyman are protected. However, it continues, "BUT ONLY TO THE EXTENT THAT THE MEMBER OF THE CLERGY IS AUTHORIZED TO HEAR THE COMMUNICATIONS UNDER THE DISCIPLINES, TENETS OR TRADITIONS OF THE RELIGION OF THE MEMBER OF THE CLERGY," and I wonder what that means. I think it is clearly designed, for example, if a Catholic priest has received a confession. Does that apply to the Catholic priest if he is in his office, not in the confession booth? Does it apply to a Baptist minister? Does it apply to a Presbyterian? And do we want the courts determining those questions?

Again, I applaud the maker of the bill. I think his intent is very good. I am always concerned about the unintended consequences, particularly whenever we are talking about trapping people in a system that is very, very damaging to their reputation. And we want to make sure that we capture those people that are abusing children, but we do not want to capture anyone that is not abusing a child. I think we need to craft this bill to capture the people that need to be captured and protect those that need to be protected, and I, for one, am not willing to give up the rights of some of our citizens to protect other citizens. I think we need to do this better. I think we can do it better, and I would ask that if we cannot stop this bill here, that the Senate would consider these arguments and perhaps make this bill a better bill. Thank you, Mr. Speaker.

The SPEAKER pro tempore. The Chair thanks the gentleman.

On the question of final passage, the Chair recognizes the gentleman from Montgomery County, Representative Stephens.

Mr. STEPHENS. Thank you, Mr. Speaker.

And I certainly want to thank my colleague; he does raise some terrific questions. And what we tried to do, I think it is important to understand, last session this legislature impaneled a task force to go to work and tell us what was wrong with our child protection laws. That task force went to work. They spent darn near a year coming up with a very comprehensive report about suggested changes for our child protection laws, and this legislation is borne of that report. That report detailed problems with the mandated reporters section of our current law and made recommended changes, which this bill does.

The pieces that the gentleman mentioned regarding the clergy are actually carried over from current law. We have those current carveouts in the law, in our current child protection laws. So this bill does try to contemplate many of the same protections that we have but then at the same time incorporates the suggested changes that the task force recommended as it relates to protecting our children.

I think probably the best way to put this, Mr. Speaker, is in the words of our chairwoman of the Children and Youth Committee from Bucks County, she put it best I think when she said it this way: On a lot of these bills, there may be some adults that are inconvenienced, but the point of these bills is to protect children, Mr. Speaker, and that is what we are here to do. When we are looking at these types of bills, it is about protecting children. There may be an adult that is inconvenienced because they need to take an extra step to protect the Commonwealth's children. I, for one, think that that is okay and that is a duty we all share, and I am proud to sponsor this bill and urge the members' support.

The House proceeded to third consideration of **HB** 726, **PN 2012**, entitled:

An Act amending Title 23 (Domestic Relations) of the Pennsylvania Consolidated Statutes, in child protective services, further providing for definitions; providing for exclusions from child abuse; and further providing for disposition of founded and indicated reports, for release of information in confidential reports and for investigation of reports.

On the question, Will the House agree to the bill on third consideration? Bill was agreed to.

(Bill analysis was read.)

The SPEAKER pro tempore. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

On that question, the Chair recognizes the gentleman from Westmoreland County, Representative Krieger.

Mr. KRIEGER. Thank you, Mr. Speaker.

And again, I am not going to belabor this. I think I understand what the vote will be.

Again, my intention is not to question anybody's integrity or intent here; really, just to alert the Senate, if we could, that there are some things that I think we need to be careful of. Particularly in this bill, we are expanding the definition of child abuse, and I understand that is the intent of the maker. Two issues I would raise, however: We are lowering the standard to bodily injury from serious bodily injury. Again, I think most of the time that is probably a good thing. But again, there was a testifier before the committee that raised the issue that in an assault case that his partner was litigating, bodily injury was included to be a scratch. In conjunction with another change that does – previously, as I understand the law, accidents were excluded. As I understand this definition, accidents would not, by themselves, be excluded. So I could envision perhaps where a parent is tired and makes a reckless decision where a child is injured – certainly no intent. Certainly it was an accident in the normal sense of that word but would be brought into this definition. Again, I understand that might be an outlier, but it can happen and probably will happen. I am concerned about that parent's rights. I would just ask the Senate to be careful and perhaps look at this section, and with that, I would thank the Speaker for the opportunity.

The SPEAKER pro tempore. The Chair thanks the gentleman.

On the question of final passage, the Chair recognizes the gentleman from Bucks County, Representative Petri.

Mr. PETRI. Thank you, Mr. Speaker.

And while I understand some of the comments of the previous speaker, I must cite for the record some demographics and numbers to put a framework on this. Pennsylvania's threshold for substantiating a case of child abuse is so high that many children who are subjected to abuse by a caregiver are found to be an unsubstantiated case. Let me give you an example of cases that have been found to be unsubstantiated: burning, breaking of bones.

Pennsylvania statistics are well under even the national average. The national average for a child under 1, as per thousand – there are 21 per thousand children in 2011 where there was child abuse found. In Pennsylvania, it is less than one per thousand, and the reason for this is simply this, that the threshold is so high that pediatricians see things that occur not from normal corporal punishment, but from severe beatings, and they get frustrated and so they fail to report them, or they find that even though they reported those incidents, the courts or the administrative law judge cannot find the level that is required in Pennsylvania because Pennsylvania, by definition, requires imminent harm of substantial bodily functions, and that is a very, very high standard.

So what this bill does is try to protect children by placing a definition which most people would understand to be child abuse, so that those children who are subjected not only to one but two and three incidents can be protected. Child services can be provided to the family; oversight can be given.

I believe this is a very reasonable standard, and for the members, an accidental circumstance, an injury occurring from accident, is in fact excluded obviously from child abuse. So I would ask for your support. Thank you.

On the question recurring,

Shall the bill pass finally?

REMARKS SUBMITTED FOR THE RECORD

The SPEAKER pro tempore. For what purpose does the gentleman from Bucks County seek recognition?

Mr. PETRI. Mr. Speaker, on the passage of that bill, comments for the record.

The SPEAKER pro tempore. The gentleman is in order; present them to the staff. Thank you.

Mr. PETRI submitted the following remarks for the Legislative Journal:

Mr. Speaker, today is a historic and important day for children in Pennsylvania and for changing parent's and society's role in protecting children from abuse. A package of bills is being considered which create a standard and framework for defining what is and what is not child abuse and beginning what will be law in Pennsylvania.

For too long Pennsylvania has had such a high threshold for child abuse that few acts against children become founded cases of child abuse. This has meant that children have been repeatedly subjected to ill treatment; the type of treatment which most would recognize as child abuse. The statistics are telling.

In 2011 the reports show that the national average for child abuse by age as compared to Pennsylvania is as follows:

The national average in 2011 for rate of investigations was 41.2 – Pennsylvania was only 7.8 percent per thousand. No other State is close to Pennsylvania in either category. At first blush, it would appear that there is a small problem with child abuse in Pennsylvania. In actuality, the problem is significant and capable of being repeated even with the same child. The above statistics are as a result of the definition of child abuse in Pennsylvania. Substantiated cases nationally are 9.1 per thousand children, while in Pennsylvania, it is only 1.2.

Current law requires establishing severe pain or significant impairments of a child's functioning to substantiate child abuse. As a result of this high threshold to establish substantiated child abuse, many cases, including repeated abuses to the same child, go unreported and are unfounded. Pediatricians testified before the task force and the Children and Youth Committee that they were frustrated by the signs of repeated abuse among their patients and ultimately became frustrated that nothing happened after they filed reports. Furthermore, it seems critical to reinforce that unfounded cases of child abuse, particularly for children who later die or nearly die from child abuse, are not equivalent to the child not having been abused, or a false report. Consider these few recent examples from Bucks, Indiana, and Philadelphia Counties:

- 1. An 11-month-old girl nearly died in 2012 after her father "hit her in the head and jaw" 9 months earlier, so when she was 2 months old, Children and Youth investigated a report about burns on her feet that were unfounded.
- 2. In 2012, in Bucks County, a year old died after being brutally abused by her mother's paramour. The coroner found "various scars" over her body, a human adult bite mark on the upper left arm, which also was broken. The girl had old burns on the back of her legs that appeared to be inflicted by a cigarette lighter and a healing spiral fracture of the right leg, which she was treated for at St. Mary Medical Center on January 7. Those injuries were reported to Children and Youth, but the report was unfounded. By the way, DPW (Department of Public Welfare) describes the call to the hotline about the

healed burns and broken leg as "general concerns" that the county investigated.

- 3. A 2-month-old died from malnutrition while living in a shelter with his mother and twin sibling. The family had been reported several times for child abuse, including sexual abuse, that were all unfounded. Within months of the child's death there was another referral, but the case was closed the day before the child died.
- 4. A 3-month-old died in 2008. Prior to the child's death, there were reports of physical abuse by the mother against other children in the family. Those reports were "unfounded" and a newer report had the family "being assessed" at the time of this child's death.
- 5. A 2-year-old died suffering a skull fracture and brain swelling. "A few months prior," injuries the child experienced were investigated, but the report was "unfounded."

The question I often ask myself is why this issue was not sooner addressed. My interest in the child protective system arises from the 2003 death of Porchia Bennett, a 3-year-old girl who was found dead in a corner under a mattress of her home. The facts of the case reveal that the entire system, school system, police, and child protective services failed to protect Porchia and her siblings from abuse. I enter her name into the record so she and approximately 500 other children who have died, or nearly died, since Porchia's passing will not have died in vain.

Now that legislation is moving toward final passage, let me give thanks to: Chairperson Watson for her leadership and diligence to make sure the issue is addressed in a proper manner, utilizing her talents of being professional and determined, and her grace to successfully garner the necessary votes in the House; the task force members for being steadfast in insisting that we maintain a high standard; all of the groups that provide child advocacy for the willingness to wordsmith through numerous drafts of HB 726 and to meet, discuss, and debate the legislation – words really do matter; to the members of the Children and Youth Committee, my bill has been appropriately placed under a microscope and represents some compromise between somewhat divergent opinions; I also thank the members who have drafted other provisions – as this is a package of bills, each is as important as the other in defining and reporting child abuse.

Much has been made of the horrible acts of Jerry Sandusky. It was his profile as a former assistant coach at Penn State University which has caused the issue regarding the appropriate standard for child abuse in Pennsylvania to be undertaken. Along the way, he sullied the reputation of a number of individuals and that of Penn State University, but the acts of abuse he committed are the real harm. What the Sandusky case teaches us is that child abuse knows no social or socioeconomic boundaries and that all of us play a role in ensuring that child abuse occurs at a far lesser amount and is reported more often so that appropriate social services can be provided to and for a family.

Early signs of abuse may enable society to stop the cycle of learned inappropriate behavior. Much of what is learned about parenting, I learned from my parents. Thankfully, I was never exposed to physical or mental abuse by my parents. HB 726 will provide appropriate protections from child abuse against those perpetrators who are in the third degree of consanguinity.

Thank you for your favorable vote.
