WHEREAS, A member of the PENNVEST Board of Directors, Representative Hess was a member of the University of Pittsburgh Medical Center Bedford Memorial Hospital Board of Trustees, the University of Pittsburgh-Johnstown Advisory Board and the Broad Top Home Nursing Advisory Board. A life member of the Saxton Volunteer Fire Company, he was active with the Bedford American Legion, the Everett Area Republican Club, the Bedford Elks Lodge, the Federation of Sportsmen and the Rocky Mountain Elk Foundation. Representative Hess was also an active supporter of high school sports teams in his district. A beloved family member, dedicated legislator and avowed community steward, he generously gave of his heart and time to enhance the quality of life of his family and community; now therefore be it

#### REMARKS BY SPEAKER

The SPEAKER. In the election of 1986 and then on swearing-in day of 1987, Tom Corrigan, Scott Dietterick, Elaine Farmer, Dick Hayden, Dave Heckler, Dick Hess, Ken Jadlowiec, Shirley Kitchen, Frank LaGrotta, Dennis Leh, Connie Maine, Anthony Melio, Karen Ritter, and myself were all sworn in to this legislative body.

Dick came here as a guy who had been active in local politics; as the resolution noted, he was in the county row office arena. He came here like all of us come here, you know, with a certain amount of interest in what we are doing but a certain amount of uncertainty. And it was back in the days when as freshmen, you definitely kind of did a lot of listening and not very much talking. Dick was pretty good at that. He used to keep a few of us around. He shared an apartment with Ken Jadlowiec for I think practically their entire legislative careers when they were both here. And I kind of think Dick hung out with Ken Jadlowiec and myself and Scott Dietterick mostly because we were loud and obnoxious and entertaining for him, because he was a fairly quiet man.

As I said at the funeral, he was not one to feel like he had to speak on every issue. He was one of those guys that kind of did a lot of listening, but when he did talk to you, you knew he was serious about it. Dick also was pretty good at pulling you aside and telling you what he thought, sometimes good or bad. But he always kind of worked under the old school rules of respect, and certainly understood each of our positions in this legislature and respected each of our views and our positions.

It is a sad day for us as a body to recognize him and to reflect on his tenure here, and as I read through that class of legislators who were sworn in – you know, we all have a little bit of a tie to those members we came to the legislature with, even if we are from wildly different districts, Republicans and Democrats. It is an extra sad day for me, as the last member of the class from which I arrived here has now departed this body.

The thing that I find the most noteworthy about Dick, though, was his love for his family – and I told Shirley and Jeff this at the funeral – his love for his wife, his love for his son and family on that side. But more importantly with Jeff was his respect and just pride in all that you have accomplished as his son was so noteworthy in Dick's private life, to the degree that we all have a private life, and something that I hope gives you comfort in this time of mourning and this time of adjustment and loss, that you know that he loved you and he was so proud of you and everything that you have done.

#### REMARKS BY MAJORITY LEADER

The SPEAKER. The Speaker recognizes the gentleman from Allegheny County, Mr. Turzai.

Mr. TURZAI. Thank you very much, Mr. Speaker.

It is with real sadness that we stand today to honor such a good friend and colleague, Chairman Dick Hess. To his wife, Shirley; to his son, Jeff; to his daughter-in-law, Lizette; and his grandchildren, Erika, Zachary, and Haden, we express our sadness, but we also want to tell you that each of us here has a warm and gracious memory of your husband, father, father-in-law, grandfather. And each and every member of this body who has served with him thought of him and continues to think of him as a statesmen and a leader and a member who served his constituents so well, but also served all the citizens of Pennsylvania well in the important roles that he held.

Three personal memories with respect to the chairman. He was prayerful, something that I am not always so mindful of myself, but on the times when I had the opportunity to have lunch with the chairman, with a small group or even alone, he always started it off with a silent prayer.

Second, he was truly respectful of the House of Representatives as an institution; proud of it but humble, but a man who understood that public service was being part of a great body and trying to move issues forward, both on a State level and a local level, truly considerate of making sure that everybody had an opportunity to be the best that they could be in his life. His work, which I dealt with personally but I know it preceded my tenure by years, but his work on behalf of making sure that the local community college had a presence in his district so that people could have an affordable education, have an opportunity to become the best that they could be or follow a career path. He was very headstrong about it and dedicated about it and passionate about it.

And finally, I know the Speaker touched on this in really a wonderful approach both today and at the funeral service: what a truly dedicated family man. I did not come in with the chairman, but I can honestly say on so many occasions he would talk about his wife, Shirley; about his son, Jeff, and his wife, Lizette; and their three grandchildren. And it is certainly true, as the Speaker said at the service, with respect to the time that they spent out hunting and outside and being part of the community, and also being part of the outdoors and a part of everyday life.

He did great things, great things as chairman of House Aging and Older Adult Services Committee, as chairman of the Commerce Committee, and recently as chair of the Transportation Committee. Great pieces of legislation and bringing together Republicans and Democrats to get them over the goal line, through the Senate, and onto the Governor's desk. He was a real leader.

Oftentimes people spoke about him being somewhat quiet, but let me tell you this: He was tough, he was persistent, he was dogged. He knew how to make the legislative process work. This was not a shy person in terms of getting items accomplished. Dick was a real leader. He was not quiet in that regard. He may not have said a lot in caucus or on the floor, but let me tell you, he was exceptionally effective in meetings, exceptionally effective. And I think when he spoke in caucus people definitely listened because he picked his battles and made sure his point was succinct.

I have great respect for him, will always have great respect for him, and I know that each and every one of you feels the same. I am honored, I am truly honored to be able to say these kind words about our departed chair. Thank you.

The SPEAKER. The Speaker thanks the gentleman.

#### **GUESTS INTRODUCED**

The SPEAKER. The Speaker made a mistake. I was intending to introduce the family before I went to the floor leaders, and I apologize. But I think it is better I do it now and make up for it and we will come back to the other members that want to speak.

With us in the hall of the House are members of the Hess family and staff. They are seated here to the left: Dick Hess's wife, Shirley Hess; his son, Jeff, and his wife, Lizette. Will our guests please rise.

Members of his district staff, Tammie Hess, Karen Novak, and Sue Yeager; and members of his Harrisburg staff, Eric Bugaile, Greg Grasa, Beth Sickler, and Barb Ramsey are also with us; along with a former colleague of ours here on the House floor and now the Governor's Secretary for Legislative Affairs, Katie True; as well as from the Pennsylvania Turnpike Commission, we would like to welcome chief executive officer Mark Compton. Will those guests also please rise and be recognized.

### REMARKS BY MINORITY LEADER

The SPEAKER. The Speaker recognizes the gentleman, Mr. Dermody, from Allegheny County.

Mr. DERMODY. Thank you, Mr. Speaker.

Mr. Speaker, I met Dick Hess on swearing-in day, January 1, I believe it was 1991. Is that right, Mike? It is getting to be a while, almost 23 years ago. And I have enjoyed knowing him and working with him ever since. I think everyone in this room knows, if you have known Dick just a little bit, that he was friendly, he was a gentleman, he was a genuine person at all times.

Now, he came from a proud Republican background and from the middle of our State, and believe me, he always held true to his principles, but he also understood that this House of Representatives is a place where all views are heard. For more than a quarter century, Dick Hess was a patient listener to people with views different than his. He respected those differences even while he worked to find common ground.

For many years Dick was chairman of the Commerce Committee, and in this session, he took over as chairman of the Transportation Committee. And as we all know, not an easy task, but he did a great job. He did a great job under difficult circumstances, treating everyone, both the majority party and the minority party, fairly, and as he always has done, he treated us with dignity and respect.

If the majority in any of the committees he was chair of had the votes easily to pass a bill, he made sure the minority had a chance to be heard. And as you all know, sometimes things get testy in a committee meeting, tempers flare. Dick Hess always maintained control while always treating every member and every person in that room fairly. He was good at his job and he made the members that he worked with, he made them better at their jobs. He could keep everyone focused on the task at hand. That is the kind of service Dick gave this House every year.

As you have already heard, he was a tremendous champion for this House of Representatives. He cared deeply for the House, but he cared deeply also for the people of the 78th Legislative District, and they were very lucky to have Dick as their legislator. We were very lucky and are very lucky to have had the opportunity to serve with him as our friend and our colleague. He made this House of Representatives a better place, a more civil place.

So, Mr. Speaker, I join with all my colleagues in extending our heartfelt condolences to Dick's wife, Shirley; his son, Jeff; and his daughter-in-law, Lizette; and the whole family. I had the opportunity to meet Shirley at the viewing and expressed just how great of a friend he was and what a great job he has done over the years and what a great job he has done treating all of us fairly in this House. I also can attest that he liked nothing better, in the conversations I had with him, than speaking of all of you, but really about his three grandchildren. He was so proud of his family, and he loved you and his grandchildren deeply.

The members of this House share your sorrow. He left us too soon, but we have all been fortunate and lucky to have had the opportunity to know him and to work with him.

### REMARKS BY MR. STERN

The SPEAKER. The Speaker recognizes the gentleman from Blair County, Mr. Stern.

Mr. STERN. Thank you, Mr. Speaker.

When Dick first arrived here 26 years ago, he came with the same emphasis and the same enthusiasm that each and every one of us came with. He never lost that enthusiasm, never, not even up to the last day. He was planning on coming back another term. He was committed to passing a transportation bill yet this fall. He had his heart set on that.

And we all come here and sometimes, it has been mentioned previously by the Speaker, been mentioned here by the leader, but Dick truly did love this institution, and he loved the members from both sides of the aisle. I remember so many of our colleagues on the other side would come over and they would come back to what they referred to as "Chairman's Row" back here, the last four chairs in on the end. And prior to me sitting back there, I am sitting in Dick's old chair right now, but

prior to that, it was guys like Merle Phillips; it was guys like Russ Fairchild, who was sitting where the gentleman from Tioga is sitting; gentlemen like Rick Geist; and Dick, of course. And those four guys would bring people in, they would be talking about hunting, fishing, you name it. They had an opinion on it no matter what.

And I remember the gentleman from Cambria County, Ed Wojnaroski, would come over, and he and Dick would get into it because Dick liked to play pranks, too, on people, and he pulled pranks all the time to probably a lot of us.

But stories he told, the laughter that came out of this section back there; I thought we would get thrown out of the House more than once by the Speaker because there was a lot of laughter going on back in the back here, because Dick understood that this is a job. He took it very seriously, he took the legislation very seriously, but he also took each and every one of you very seriously. And he wanted that personal relationship, so he tried to get to know you, and he did. He reached out to many.

And that is the institution that I remember whenever I came in, and it seems that we have lost some of that, and I think we need to get that back. And if Dick had a message here today for all of you, I would think that message would be that we need to get back to the collegiality of this House, get back to doing the people's business, what is good for Pennsylvania.

And I remember when I first came in, I did not know who to talk to, get advice, whether I should run for the House. At the time I was Blair County prothonotary and clerk of court. So I went to Bedford County and I talked to a former prothonotary, clerk of court in Bedford County, Representative Hess. I went to his district office. Between Dick and all the animals he had in his office, I got in. But Dick was quite an avid hunter, as most of you know, and Shirley would not let any of those animals come back home, so they stayed in the office. I am sure that they were quite interesting topics of conversation, because our district, our area is quite a hunting district, fishing district. And Dick had fish, he had everything imaginable mounted. He was quite an avid outdoorsman, and he was serious whenever it got to be turkey season or bear season or deer season. He was ready to get on the turnpike and get back home, go hunting with Jeff.

Gentlemen like him, and he was a gentleman, and it was a pleasure to sit next to him. But I remember when I came in there were five prothonotaries. It was Ruth Rudy from Centre County, and it was Curt Schroder, Tom Dempsey, Dick Hess, myself. With Dick's passing, we are down to one prothonotary. And Dick was quite proud of that, he would always say about the prothonotaries in the House, and every year when one would retire, one would step aside, he would comment about it.

But I want to especially give tribute, gratitude, and appreciation to his wife, Shirley, today. Shirley put up with Dick's public service – and he served the public diligently for 48 years, 48 years – served as chief clerk, prothonotary, and as a State legislator. But Shirley had the patience to give him to Bedford County and to the 78th District. Shirley has a tremendous amount of patience. She is a great woman. I have known her for many years. Dick loved her beyond all conditions. He loved Jeff, and especially – loved Lizette as well – but the grandchildren were always the apple of his eye, and he would always be telling stories back there about his grandchildren. It was always family first.

We will miss him here in the House of Representatives, but let us not forget some of the things he stood for. Let us not forget respect for not only the institution, but respect for one another.

The SPEAKER. The Speaker thanks the gentleman.

#### REMARKS BY MR. FLECK

The SPEAKER. The Speaker recognizes the gentleman from Huntingdon County, Mr. Fleck.

Mr. FLECK. Thank you, Mr. Speaker.

To the family and to my colleagues: We are all colleagues here, no doubt, but there is that small group of us that are a posse of friends, true friends, the ones that you call when we are not on the floor, the ones that are in our delegation that you ask to cover your back if you cannot be there.

Dick had the eighth largest district; I had the ninth. We both had three counties. That is a very small delegation between central Pennsylvania. I know Jerry and I share Blair County. Jerry and Dick shared Bedford County at one point.

I do disagree with the gentleman from Blair County about it being a pleasure to sit beside him. When I came in as a freshman and sat in front of him, the harassment that I had to endure as the new guy— As a freshman, I was told I keep my mouth shut and just listen and do what is told. We had some great times. We had especially some fun times after the House would shut down for the day and we would all, a group of us, hang out in the office and tell stories.

Dick was very territorial, of the old school: You do not come into my district uninvited. And being the fact that we split some areas – my mother is actually from the little town of Coalmont and is a couple years older, and Dick actually graduated with my aunt. I have known of Dick Hess for decades. Actually, one of the first campaigns I worked on as a Huntingdon County Republican Committeeperson in my early twenties was in college, was working the polls that election day for Dick. People in our area did not have tough campaigns – Sam Hayes and Dick Hess – and I really wasted my day. People would not even take the literature because, "I know Dick, I don't need that."

But I would harass him. I mean, when you are a politician in a rural area, you are a local celebrity. You do not have to share the limelight with a huge delegation. You are in the paper constantly. But when you just want to go out to eat with your family, as we all know, you will get a dozen people coming over with a tax question or something. Since I live so close to the Fulton and Bedford County line, I found it much easier to slip over to Bedford Springs. And oftentimes I would call Dick and say, "Hey, Dick, I'm at a dinner in your district. They're wondering where you are." And then I would not answer the phone when he would call back. So those are some of the things that we would do. I certainly will miss him.

My hat is off to Shirley who as well was a representative of that district and took that post seriously and with dignity. And to Jeff and the family and the grandchildren: I had only met the grandchildren a couple of times, but I think I knew just about as much of them as anyone else just from the stories, from the late-night sessions. And to the staff, you know, he had a long-term staff. Our staffs worked together, and I know truly there is a hole in their hearts.

So rest in peace, my friend, Dick.

### REMARKS BY MR. MARKOSEK

Dick was one of those members, and I think as a member of that club myself – in fact, I could actually qualify for the 30-year club – I thought I ought to say something about Dick and how shocked I was when we learned that he was not well and that he had finally passed on.

You know, the thing, couple of things about Dick real quick. I had the opportunity to serve as the Democratic chair of the Commerce and Economic Development Committee, and when I moved on from that, Dick took that, was the minority chair of that committee. And he came to me and he said, "Partner" – he liked to use the word "partner" – he said, "Partner, any advice you could give me, I'm open." And I said thanks, and he really did not need any advice, but I think he was just being friendly.

And then later on I had the opportunity to serve as the majority chair of the House Transportation Committee, and Dick was on my committee. He was on the committee and he was a great member of that committee, and later on he became the chairman. And I remember the day that he was named chairman of that committee, how happy I was that we had somebody on that committee who not only had the time here, who had paid his dues, who had earned his way, but he knew what it was. He got it. He got it. Whatever "it" is, he got it. He knew what had to be done here. And he came to me that day and he said, "Partner," he said, "any advice you can give me, I would appreciate."

And I looked in the dictionary to get the definition of the word "partner," and it is very simple. It is a person who takes part in an undertaking with another or with others; a person who takes part in an undertaking with another or with others. I think that really sums up Dick's career here. He was happy to be here and be part of this and work with people, both sides of the aisle, to take on an undertaking, knowing that he was not necessarily going to get everything that he wanted. But he was willing to work with us, with you, with all of us here, for the betterment of not only the people in his district, but the people of the entire Commonwealth of Pennsylvania.

So it is with that I just summarize by saying, Dick, we miss you, partner.
