Mr. Speaker, one of my constituents is one of the 12 million people who have been identified as having an even more unique disease, and that is postural orthostatic tachycardia syndrome. There is currently no cure, and today we are recognizing awareness of this debilitating disease.

Mr. Speaker, it has been said that in the next 10 years we will have more discoveries related to medical cures than we have had in the last 100 years. So our medical research in Pennsylvania is top-notch, but it starts with awareness, and I want to thank the members for making me aware and making each other aware of this rare disease. Thank you.

At home that night Mr. Ruddy and Mr. Bonavoglia's families were sleeping – an 8-year-old child, a 9-year-old, and a 2-year-old child.

These officers went above and beyond the call of duty, and I would like all of the State Representatives here today who served in law enforcement – to say thank you to you for everything you have done, and for the more than 100 cosponsors that you gave to Officer Gene Ruddy and Officer Bill Bonavoglia for their call above and beyond. Thank you so much.

I wanted to thank, with respect to passage of SB 379, in the first instance, my good friend and colleague from York County, who had introduced a comparable piece of legislation both last session and this session. In fact, last session HB 495 passed by a vote of 171-27, but was not acted upon last session. This session, along with a good Senator from Cumberland County and our good friends and colleagues, leaders in the Senate, we reached compromise language that was passed over here to the House in the form of SB 379.

I want to congratulate all parties for working together to address this benevolent gesture or omission by health-care provider legislation, or as it is now known, the Benevolent Gesture Medical Professional Liability Act. The goal there is to be able to allow health-care providers to speak openly with their patients without there being consequence in a court of law. And significant stakeholders came together to reach this compromise, and we applaud both the good Senator from Cumberland County, but in addition, our good friend and colleague from York County who led with health-care providers across the State in this very, very significant legislation.

I did not want that to go unsaid, and I congratulate on the unanimous vote in both chambers for the Benevolent Gesture Medical Professional Liability Act now going to the Governor's desk. Congratulations.
