STATEMENT BY MS. DONATUCCI

The SPEAKER. The Speaker recognizes the lady from Philadelphia County, Ms. Donatucci, under unanimous consent relative to one of the resolutions just adopted.

Ms. DONATUCCI. Thank you, Mr. Speaker.

Mr. Speaker, on December 19, 2011, the United Nations General Assembly adopted a resolution declaring October 11 as "International Day of the Girl Child" each year. The day is to be set aside as a day to recognize girls' rights and the unique challenges girls face around the world. The United States and 97 other countries supported and cosponsored this resolution.

Mr. Speaker, we live in a world today where the welfare and safety of young girls is constantly threatened. Around the globe human trafficking, prostitution, and forced arranged marriages are major threats to young women. The Day of the Girl campaign focuses attention on the need to address the challenges girls face and to promote girls' empowerment and the fulfillment of their human rights.

This resolution will also honor all those involved in the Day of the Girl in Pennsylvania, including Girls on the Run, the Girl Scouts, the Women and Girls Foundation, the Girls Coalition of Southwestern Pennsylvania, and other organizations throughout the State that celebrated the second annual Day of the Girl, which included the second Day of the Girl summit in Pittsburgh.

As we all know, Monday, November 11, is Veterans Day. Many schools will hold programs to teach children about the importance of thanking our veterans for the sacrifices that they have made and to remember those who made the ultimate sacrifice.

The resolution that we just passed, however, establishes Friday, November 8, as Pennsylvania Veterans Day of Caring. The goal is to encourage our fellow Pennsylvanians to go beyond the celebrations and to back up our thanks to our veterans with action. This idea was brought to me by one of my constituents, Dave Kobe, who was helping a veteran in the Wounded Warrior Project when he noticed that the veteran's own yard was in need of a little help. Dave volunteered to help the veteran clean up the yard, and the veteran was grateful. Dave believes that a simple act of kindness that meant a great deal to one veteran could be repeated across the Commonwealth.

Pennsylvania is home to nearly 1 million veterans. These men and women have served our country and have sacrificed for us. Pennsylvania Veterans Day of Caring encourages us to back up our thanks with actions by doing an act of kindness to a veteran on Friday, November 8, in honor of their service.

STATEMENT BY MR. SABATINA

The SPEAKER. The Speaker recognizes the gentleman from Philadelphia County, Mr. Sabatina, under unanimous consent relative to one of the resolutions just adopted.

Mr. SABATINA. Thank you, Mr. Speaker.

I was trying to get everybody's attention.

Thirty years ago today, on the morning of Sunday, October 23, 1983, shortly after 6 a.m., a 19-ton yellow Mercedes-Benz truck drove to the Beirut International Airport where the United States 24th Marine Amphibious Unit was deployed.

After circling the parking lot, the driver accelerated and crashed through a 5-foot-high barrier, passed several sentry posts, and smashed into the lobby of the building serving as the barracks for the 1st Battalion 8th Marines. The truck exploded, detonating a bomb that was later believed to be the equivalent of approximately 21,000 pounds of TNT (trinitrotoluene). The powerful explosion leveled the four-story Marine Barracks, killing 241 American servicemen and wounding 128 more brave Americans. This terrorist attack was the deadliest single-day death toll for the United States Marine Corps since World War II's Battle of Iwo Jima and the deadliest single-day death toll for the United States military since the first day of the Vietnam war's Tet Offensive.

Thirty years after the horrific bombing, terrorism continues to be a threat to the international community. Our young men and women in the Armed Forces continue to preserve freedom by fighting terrorism around the world. They face the daily threat of suicide bombers who wish to destroy the good our service men and women are trying to accomplish. On this tragic day 30 years ago, we lost hundreds of brave men and women, including many of our own Pennsylvanians. With that in mind, I ask you all to join me in commemorating the 30th anniversary of the terrorist bombing of the United States Marine Corps Barracks in Beirut. The sacrifice of those soldiers must not be forgotten.

I am going to read a list of the servicemen who were from Pennsylvania: Moses Arnold, Philadelphia; John J. Bonk, Jr., Philadelphia; Curtis J. Cooper, North Wales, Pennsylvania; William D. Elliot, Lancaster, Pennsylvania; Richard A. Fluegel, Erie, Pennsylvania; Robert B. Greaser, Lansdale, Pennsylvania; Thomas A. Hairston from Philadelphia; Keith J. Laise from East Stroudsburg; James McDonough from New Castle; Richard Morrow from Clairton; John Muffler from Philadelphia; Rafael Pomalestorres from Philadelphia; Rui A. Relvas, Philadelphia; Louis J. Rotondo, Philadelphia; John W. Spearing, Lancaster; Steven B. Wentworth, Reading; Allen D. Wesley, Philadelphia; and Capt. Walter E. Wint from Wilkes-Barre, Pennsylvania, who graduated with Representative Kortz from IUP (Indiana University of Pennsylvania).

The SPEAKER. On that question, the Speaker recognizes the gentleman from Allegheny County, Mr. DeLuca.

Mr. DeLUCA. Thank you, Mr. Speaker.

Mr. Speaker, I want to thank the House for voting for HR 516. Myself, Representative Micozzie, and Representative Dermody, we are proud to honor this resolution today to honor Plum Borough on being recognized as the sixth safest city in the United States. Please make note of what I just said. I did not say the sixth safest city in Pennsylvania, but I said the sixth safest city in the entire United States.

Mr. Speaker, we cannot turn on our TV or read the newspapers without headlines announcing violent crimes in our cities almost every day. Today it is refreshing to see that in this day and age, when crime is at an all-time high, we can honor one of our own communities for being one of the safest.

They now have 5 years to apply after they have separated from the service. I thank the gentleman from Philadelphia, Mr. McGeehan, for offering the amendment in committee to set the 5-year provision.

BILL ON SECOND CONSIDERATION

The House proceeded to second consideration of **HB 397**, **PN 1942**, entitled:

An Act providing for limited immunity for persons that sponsor farm-related tourism activities.

On the question,

Will the House agree to the bill on second consideration?

Mr. **NEUMAN** offered the following amendment No. **A04048**:

Amend Bill, page 3, by inserting between lines 17 and 18 Section 4. Exceptions.

This act shall not apply to injury to or death of a person under 18 years of age.

On the question,

Will the House agree to the amendment?

The SPEAKER. On that question, the Speaker recognizes the gentleman from Washington County, Mr. Neuman.

Mr. NEUMAN. Thank you, Mr. Speaker.

HB 397 has some major fatal flaws in it, and my amendment will address one of those flaws. Essentially, HB 397 would give immunity to any agritourism – anybody that is injured on a farm if it is considered agritourism.

My amendment would make an exception for minors. So anyone under the age of 18, if they are injured based on the negligence of the farm operator, they would be able to recover for those injuries. It is important that you recognize that the exception is only if it is on the negligence on behalf of the farm operator. This means that the child is being injured at no fault of his own but at the negligence of the farm operator.

So I would ask for support on amendment 04048 to protect our children from dangers that may occur or negligence that may occur that cause injury or even death while they are on a farm doing farm agritourism activities. So I ask for support on this amendment. Thank you, Mr. Speaker.

The SPEAKER. The question is, will the House agree to the amendment?

On that question, the Speaker recognizes the gentleman from Perry County, Mr. Mark Keller.

Mr. M. KELLER. Thank you, Mr. Speaker.

Amendment A04048, it will necessarily strike a line because the bill only applies to those who are capable of voluntary and intelligent participation, thus excluding those too young or incapable to give the voluntary consent.

Also, back in 1966 under the recreation and land use management, this was fully addressed.

I would ask a "no" vote on amendment A04048. Thank you.

The SPEAKER. The question is, will the House agree to the amendment?

On that question, the Speaker recognizes the gentleman from Chester County, Mr. Hennessey.

Mr. HENNESSEY. Thank you, Mr. Speaker.

I rise to speak in favor of the amendment, A4048, I believe it is. My eyes are failing me here.

The express purpose of this bill, the underlying bill, is to create immunity for an operator of an attraction for which the operator is generally making a profit. These are attractions that, frankly, appeal to our children. We should not be creating immunities for situations where our children may be hurt. On the other hand, on the contrary; we ought to be making sure that our children are properly protected, and it would seem to me the amendment accomplishes that to an extent, whereas the bill itself fails in that regard.

I would suggest that we vote in favor of the amendment, 4048. Thank you.

The SPEAKER. The question is, will the House agree to the amendment?

On that question, the Speaker recognizes the gentleman, Mr. Keller, for the second time.

Mr. M. KELLER. Thank you, Mr. Speaker.

Just to make things perfectly clear here to the members, it is the fact that this does not exempt you totally from a lawsuit. The operator still has to have liability insurance. They have to have that, and it is only on – one second, please – it is only negligence from personal lawsuits.

I still encourage the members to vote "no" on amendment A04048. Thank you.

The SPEAKER. The question is, will the House agree to the amendment?

On that question, the Speaker recognizes the gentleman, Mr. Neuman, for the second time.

Mr. NEUMAN. Thank you, Mr. Speaker.

The subjective standard that the maker of the bill made is just that, it is subjective. We need to protect all minors. We cannot leave this to the discretion. We need to make sure that anybody under the age of 18 is protected. You have to understand that negligence is a serious accusation. Negligence harms and injures and sometimes kills people and kills people under the age of 18. The gentleman, the good chairman of the Aging Committee, is exactly right. We need to make sure that we are protecting our children in every way, especially from activities that are attracting children.

So I encourage a "yes" vote, immunity from negligence. This means that this child, it is not the fault of the child. The child was not injured or the child does not die at the fault of the child. It is the fault of whomever they are seeking damages from. So I would encourage a "yes" vote to protect our children from this immunity and make sure that we hold our children to the – hold anybody to the highest standards whenever we are dealing with children. Thank you, Mr. Speaker.

Will the House agree to the bill on second consideration as amended?

Mr. **NEUMAN** offered the following amendment No. **A04036**:

Amend Bill, page 3, by inserting between lines 17 and 18 Section 4. Exceptions.

This act may not apply to injury to or death of a person with a mental health condition, intellectual disability or physical disability.

On the question,

Will the House agree to the amendment?

The SPEAKER. On that question, the Speaker recognizes the gentleman from Washington County, Mr. Neuman.

Mr. NEUMAN. Thank you, Mr. Speaker.

Just as important as it is to protect our children, we also need to protect persons that have a physical or mental disability. It is imperative that we understand that whenever, in any activity that we do, if negligence happens and it injures somebody, you cannot have immunity, especially whenever you are dealing with persons of mental or physical disabilities.

So, Mr. Speaker, I ask, just like the last bill how we protected children, that we also protect persons in our society that we always protect and we try to protect, and I encourage a "yes" vote on amendment 04036. Thank you, Mr. Speaker.

The SPEAKER. The question is, will the House agree to the amendment?

On that question, the Speaker recognizes the gentleman from Chester County, Mr. Hennessey.

Mr. HENNESSEY. Thank you, Mr. Speaker.

I rise again in support of this amendment.

In the last vote we were taking a step toward protecting children. Here we are protecting the mentally disabled, the physically disabled. We have an obligation to protect them from this kind of situation, especially when we are dealing with attractions that are run for profit and trying— If somebody is trying to make a buck, we should not be subjecting these people with mental or physical disabilities to this kind of danger.

So I would support the immunity offered by amendment 4036 and ask for a vote of approval. Thank you.

The SPEAKER. The question is, will the House agree to the amendment?

Is the gentleman from Perry County, Mr. Mark Keller, seeking recognition on the amendment?

Mr. M. KELLER. Thank you, Mr. Speaker.

The SPEAKER. The gentleman is in order on the amendment.

Mr. M. KELLER. All right; this unnecessarily strikes a line, because the bill only applies to those who are capable of voluntarily and intelligently participating, thus excluding those too incapacitated to give such voluntary notice. So I do not know how you draw a line between whether you are capable or not capable.

Again, I would encourage a "no" vote on this amendment.

The SPEAKER. The question is, will the House agree to the amendment?

On that question, the Speaker recognizes the gentleman from Lancaster County, Mr. Cutler.

Mr. CUTLER. Thank you, Mr. Speaker.

Very briefly, I rise in opposition to this amendment offered by the gentleman from Washington County because I believe that within the context of the bill, that this is already covered.

As the prime sponsor of the bill has already explained, in order for this bill to apply and this defense to be used, you have to be an individual that could not in fact be able to consent to this activity in the first place. If you are an individual that is mentally incapacitated in some manner, as this gentleman's amendment would apply, you would not by definition be a person that is defined on page 3, line 14, "THE PARTICIPANT" who "VOLUNTARILY AND intelligently undertakes participation in the agritourism activity." By definition, Mr. Speaker, this group of individuals is already included.

I believe that his amendment unnecessarily complicates the bill. I believe that the protections are already afforded in the bill, and I would encourage a "no" vote. Thank you, Mr. Speaker.

The SPEAKER. The question is, will the House agree to the amendment?

On that question, the Speaker recognizes the gentleman from Philadelphia County, Mr. Jordan Harris.

Mr. J. HARRIS. Thank you, Mr. Speaker.

Mr. Speaker, today I rise to support amendment 04036.

Mr. Speaker, there are different levels to mental disability, and I think, quite honestly, there could be folks who have mental disabilities who still have the cognizant ability to make a decision on whether they are getting on a hayride or whether they are picking pumpkins from a pumpkin patch.

So I would have to support this amendment, because I believe the legislation as it is would not protect these individuals because there is a wide spectrum when you are

talking about mental disabilities that we are not taking into consideration in this legislation unless we accept the Neuman amendment. Thank you, Mr. Speaker.

The SPEAKER. The question is, will the House agree to the amendment?

On that question, the Speaker recognizes the gentleman from Washington County, Mr. Neuman, for the second time.

Mr. NEUMAN. Thank you, Mr. Speaker.

Once again we are dealing with a subjective standard. My amendment takes it out of the discretion of persons that are legally able to make decisions and ones that are not legally able to make decisions. This allows for mental and physical, people with physical disabilities an exemption from this immunity bill. So it is important that we recognize that just because legally you can or cannot make a decision on your own does not mean you do or do not have the mental or physical disability. There is a clear distinction.

This amendment actually makes the bill a lot stronger and clears up a lot of discrepancies, and I encourage that the body stand up for persons with disabilities and vote "yes" on my amendment. Thank you, Mr. Speaker.

The SPEAKER. The question is, will the House agree to the amendment?

Is the gentleman, Mr. Keller, seeking recognition for the second time?

Mr. M. KELLER. Thank you, Mr. Speaker.

The SPEAKER. The gentleman is in order.

Mr. M. KELLER. If you read the amendment as it is written, it says about "...mental health condition." Mental health condition? I am depressed. Now I cannot make a decision? Vote "no."

The SPEAKER. The question is, will the House agree to the amendment?

On that question, the Speaker recognizes the gentleman from Allegheny County, Mr. Kortz.

Mr. KORTZ. Thank you, Mr. Speaker.

I rise in support of the Neuman amendment, because it also states in there you could have a physical disability. So, I mean, part of the argument we have heard here is that they cannot make an intelligent decision. Well, someone that is physically disabled can make that intelligent decision, yes, I want to go on that hayride or I want to go on that tractor pull, but maybe they are missing some limbs and maybe this is not set up quite right to protect them and they can fall off that hayride or fall off that tractor. So they can still make a cognizant decision, yes, I want to participate, but they are still injured; that person would have no recourse.

So I would say, let us vote for the Neuman amendment and put the protection in that is necessary to protect people that are disabled, whether it is mental or physical. Thank you, Mr. Speaker.

We use negligence a lot in normal terms, but in legal terms "negligence" is a very serious thing, and I think that we need to protect our senior citizens from negligence. We need to protect, just like we protect our children, just like we protected persons with disabilities, we also need to protect our senior citizens from any negligence that may happen while they are on a farm doing farm agritourism activities. Thank you, Mr. Speaker.

Ch. 57 (relating to food protection) or any other law or regulation providing for food or beverage safety.

Mr. BRADFORD. Thank you, Mr. Speaker.

I rise to put forward amendment 4032. The gentleman from Washington County has rightfully protected certain classes of people – children, our seniors, and those with an intellectual disability – but the next logical step is if we are going to start providing these immunities, that there are certain classes of business that, frankly, have nothing to do with farming but have everything to do with profitmaking industries and businesses. In this case, in this particular amendment we have de facto restaurants, bakeries, apple cider donut stands. While they are all valuable parts of our community and our economy, they are not in any way worthy of stripping those who are injured or fallen ill from the ability to get recourse for their injuries.

This has everything to do with protecting victims and nothing to do with promoting agritourism. This is simply an end run around civil justice laws. This amendment would make sure that we provide access to the courts for those injured by those who purvey these products.

The SPEAKER. The question is, will the House agree to the amendment?

Is the gentleman, Mr. Keller, seeking recognition on the amendment?

Mr. M. KELLER. Yes.

The SPEAKER. The gentleman, Mr. Keller, from Perry County is recognized on the amendment.

Mr. M. KELLER. All right; I am going to give you a scenario, Mr. Speaker, and this is how it is. I am visiting an apple orchard and I have just toured how this farming operation takes place here. As the orchard grower, I am not allowed to offer you a free apple? That is basically what this amendment says

So, you know, I would encourage a "no" vote on amendment A04032.

The SPEAKER. The question is, will the House agree to the amendment?

On that question, the Speaker recognizes the gentleman from Washington County, Mr. Neuman.

Mr. NEUMAN. Thank you, Mr. Speaker.

The only way that scenario works is if in some way that apple is negligent. This is about negligence. This is not about stopping frivolous lawsuits, because frivolous lawsuits are frivolous. They get filed. They are frivolous lawsuits. We need

to stop those, but this does not do it. This is about negligence. This is about a potential huge profitmaking industry performing an act that causes injuries due to negligence and a person cannot recover.

I urge support of the Bradford amendment, because unless I am giving an apple that a wicked witch is giving that causes negligence, then that person is not – it is not covered and the suit will be thrown out of court.

So, Mr. Speaker, I urge support of the Bradford amendment. Thank you.

The SPEAKER. The question is, will the House agree to the amendment?

Mr. HENNESSEY. Thank you, Mr. Speaker.

Will the House agree to the amendment?

The SPEAKER. For the information of the members, that amendment had been filed by the gentleman from Cambria County, Mr. Barbin, who is on leave, and so it is being offered by Representative Dean.

The question is, will the House agree to the amendment?

On that question, the Speaker recognizes the lady from Montgomery County, Mrs. Dean.

Mrs. DEAN. Thank you, Mr. Speaker.

I rise in support of and to offer amendment A04045.

I think this is a commonsense improvement to the underlying bill, and it will be protecting – it will offer protection to the operator who does not charge a fee. If you take a look at the underlying bill, this immunity would be offered to any operator whether or not they charge a fee, but I think for those who charge a fee, I think we can all agree that they ought to owe a duty of care to those whom they charge. So this amendment simply says that for those who do not charge a fee, they would be offered protection, not immunity, but protection from liability.

And it also is clearer on the notion of someone voluntarily or intelligently. I think we saw in some of the earlier discussion that that is pretty muddied. So what this amendment does is it adds the words "knowingly," "voluntarily," "intelligently," or "unreasonably" offering their approval.

I ask for a "yes" vote on this commonsense improvement to the underlying bill.

The SPEAKER. The question is, will the House agree to the amendment?

On that question, the Speaker recognizes the gentleman from Lancaster County, Mr. Cutler.

Mr. CUTLER. Thank you, Mr. Speaker.

I rise in opposition to the gentlelady's proposed amendment for the following reason, Mr. Speaker: If it were to be accepted, it would effectively gut the bill as drafted, Mr. Speaker, and it hinges on one word. It is the "unreasonable" word; "unreasonably" that it is hinged on at the end of the proposed amendment.

Mr. Speaker, if we would go back to the knowingly, voluntarily, intelligently, and unreasonably articulated standard, it is a general standard of negligence. In that case, Mr. Speaker, there would be no need for this bill, because that is already existing case law. Therefore, there would be no need for an exemption or a protection as provided by this proposed bill that the gentleman from Perry County is working on, and therefore I would urge opposition to the gentlelady's amendment. Thank you, Mr. Speaker.

The SPEAKER. The question is, will the House agree to the amendment?

On that question, the Speaker recognizes the lady, Mrs. Dean, for a second time.

Mrs. DEAN. I appreciate my colleague's comments regarding the definition, but I think, actually, this clarifies the definition. Instead of just simply saying knowingly and intelligently, we can see how unreasonable it will be for somebody standing at a pumpkin patch or a hayride to figure out the intelligently.

So I ask for a "yes" vote on my amendment. Thank you, Mr. Speaker.

Mrs. **DEAN** offered the following amendment No. **A04047**:

Amend Bill, page 3, by inserting between lines 17 and 18 (c) Exceptions.—This chapter does not preclude or limit the liability of an agritourism operator who:

(1) (i) Has actual knowledge or reasonably should have known of:

(A) a dangerous condition on the land, facilities or equipment used in the agritourism activity; or

(B) the dangerous propensity of a particular animal used in the agritourism activity; and

(ii) does not make the danger known to the participant and the danger proximately causes injury, damage or death to the participant.

(2) Fails to properly train, or improperly or inadequately trains, employees or unpaid workers who are actively involved in agritourism activities and an act or omission of the employee proximately causes injury, damage or death to the participant.

(3) Commits an act or omission that:

(i) constitutes gross negligence for the safety of the participant; and

(ii) caused the injury or death of the participant.

(4) Intentionally injures the participant.

On the question,

Will the House agree to the amendment?

The SPEAKER. On that question, the Speaker recognizes the lady from Montgomery County, Mrs. Dean.

Mrs. DEAN. Thank you, Mr. Speaker.

I offer amendment A04047. Again, I hope that everyone will see that this is a very important commonsense cleanup of the underlying bill because it offers one exception. I do not think we should be offering immunity or protection from liability or for protection from owing a duty of care to people who come to your agritourism event when you have knowledge, if the operator, only if the operator has knowledge or should have known of a dangerous condition, whether it is a danger that the person could see or not. If the underlying operator does not have liability for known dangers or failure to train his own folks, then we would really be putting people at grave risk.

So I ask for a "yes" vote for knowing or should have known dangerous condition or failure to train. Thank you.

The SPEAKER. The question is, will the House agree to the amendment?

On that question, the Speaker recognizes the gentleman from Luzerne County, Mr. Mullery.

Mr. MULLERY. Thank you, Mr. Speaker.

I rise in support of amendment A04047 as this amendment seeks to exclude language that under current law we provide protection to trespassers on private land for. So if we do that under current law for trespassers, certainly this is a provision that we should provide protection for business invitees to our agritourism facilities. Thank you, Mr. Speaker.

The SPEAKER. The question is, will the House agree to the amendment?

On that question, the Speaker recognizes the gentleman from Lancaster County, Mr. Cutler.

Mr. CUTLER. Thank you, Mr. Speaker.

Again, I rise in opposition to the gentlelady's proposed amendment.

Mr. Speaker, this is almost verbatim existing law regarding negligence, Mr. Speaker. "Reasonably should have known" is the standard when it comes to the idea of the duty of care that is owed to individuals, as the gentleman previously articulated, Mr. Speaker, but I would like to offer a scenario where this would become problematic. Mr. Speaker, as a farmer, if I plow my field, I would reasonably know or should know that it would leave a furrow at the edge of the field. Mr. Speaker, however, if you are walking along the edge of that field, the entire question involving the case would then become, do I have a duty to fill in that furrow or otherwise block off that furrow if you are going to be walking along that field to pick those pumpkins? Mr. Speaker, it is those items like rocks in the field and uneven ground and those other things that are oftentimes the points of those frivolous suits. Mr. Speaker, while it is often pictures that are painted of open machinery or open pits that are often problematic, it is often issues that are much more mundane that often get included in those suits that the gentleman's bill is seeking to protect the farmers from.

Mr. Speaker, I would offer that this is existing law. If it were to be included, the bill would essentially have no effect. Therefore, I respectfully urge opposition of the gentlelady's proposed amendment. Thank you.

The SPEAKER. The question is, will the House agree to the amendment?

On that question, the Speaker recognizes the lady from Montgomery County, Ms. Harper.

Ms. HARPER. Thank you, Mr. Speaker.

I rise in support of the gentlelady's amendment.

To the extent that this is existing law, we do not want to change it. We want to leave it in the law where it belongs.

I have to say the amendment speaks in terms of people who know the propensity of an animal to be dangerous or vicious and they are not given immunity under this bill. We actually had that situation at a farm in my district that was an agritainment farm. A dog mauled a little child, 3 years old, and it was the second 3-year-old child that had been mauled and had facial injuries from the dog. The farmer knew that the dog had those propensities, and for reasons known only to him, even though he invited all these people and their children onto his property to pick pumpkins and all the rest of it, he did not tie the dog up. I do not believe he should be immune in that situation. The little girl was terribly injured, and the courts exist to provide recompense and to remind people to keep the dog tied up so that they do not have situations.

So I support the gentlelady's amendment because it keeps in the law a very important provision in the law. Thank you.

The SPEAKER. The question is, will the House agree to the amendment?

On that question, the Speaker recognizes the gentleman from Washington County, Mr. Neuman.

Mr. NEUMAN. Thank you, Mr. Speaker.

I rise in support of the Dean amendment.

It is imperative that we understand, frivolous lawsuits are not negligence. Negligence injures people. Frivolous lawsuits get thrown out of court. This does not stop frivolous lawsuits from being filed and thrown out of court. We are talking about negligence. So I would ask that you support this amendment to protect people from negligence. Thank you, Mr. Speaker.

The SPEAKER. The question is, will the House agree to the amendment?

On that question, the Speaker recognizes the gentleman from Chester County, Mr. Hennessey.

Mr. HENNESSEY. Thank you, Mr. Speaker.

I rise in support of the amendment.

Frankly, extending immunity or offering immunity where negligence is apparent, really, it is something we should do only very selectively.

This still makes sense. If somebody knows of a dangerous condition or a dangerous predilection of an animal to be violent or act up and be cantankerous and it could cause harm, we should not be immunizing them. This amendment to the extent that it in fact restates the existing law, there is no harm in that. We should not create a new statute which might mislead people when the existing law drawn from elsewhere would tell them they still had a claim. This clarifies the law.

We ought to vote for it because it makes sense not to immunize people who know of dangerous situations and allow them to occur. Thank you.

REMARKS SUBMITTED FOR THE RECORD

The SPEAKER. The Speaker recognizes the gentleman from Centre County, Mr. Benninghoff, under unanimous consent.

Mr. BENNINGHOFF. Very briefly, Mr. Speaker. I just wanted to take a moment to thank the members for their support on HB 162.

And on behalf of myself and many other adoptees of Pennsylvania, you came here to change some lives, and I have to tell you the message I have received, they are very grateful.

I will submit my other comments for the record.

Thank you, Mr. Speaker, and to all the members and the two chairwomen that made this happen. Thank you.

Mr. BENNINGHOFF submitted the following remarks for the Legislative Journal:

Mr. Speaker, I would like to submit comments for the record on HB 162. I rise to support this legislation not only as the prime sponsor but as an adoptee myself. HB 162 would allow all Pennsylvanians the same access to their original birth certificate.

In 1984 our Commonwealth sealed the adoptees' records prohibiting them from obtaining their original birth certificate. The Internet, along with other Web sites like ancestry.com, gives adoptees the ability to research their families and most often locate their living parents.

HB 162 is not just about finding one's family but about answering the age-old question of "who am I?" Most people want to know their origin or ethnic background as well as those who want to learn of their parents. For some, it is simply about being able to see their name along with their parents on the one legal document that legitimize their existence, just like all other Pennsylvanians.

Natural born and foster children, regardless of how many sets of foster parents they may have had, are legally allowed access to their original birth certificate. Pennsylvania's adoptees should be granted no less. HB 162 will give adoptees that basic right upon their 19th birthday, and I rise to ask my colleagues on the House floor for their support.

In closing, I want to thank the majority and minority chairs, Kathy Watson and Louise Bishop, respectively, for all their support and the committee's bipartisan unanimous votes to move HB 162 out of committee. Thank you Mr. Speaker.
