STATEMENT BY MS. TOOHIL

The SPEAKER. Is the lady from Luzerne County, Ms. Toohil, seeking recognition under unanimous consent relative to one of the resolutions just adopted? The lady is in order and may proceed.

Ms. TOOHIL. Thank you, Mr. Speaker.

Mr. Speaker, today I rise to honor and acknowledge those with intellectual disabilities and to help raise public awareness about their special needs.

Joining us on the House floor this morning is my very special guest, Curtis Michael Reznick, sitting left of the rostrum. Curtis is the son of my staffer, Debi, and her husband, Jason. Curtis's story is one of a child born with a rare debilitating syndrome and also the story of a mother who never stopped believing in him.

When Curtis was born on June 4, 1999, doctors immediately noticed his distinct, high-pitched cry, which sounded like a cat. They whisked Curtis away for testing and observation before his parents were even able to see or hold him. Three days later Curtis was diagnosed with a rare genetic disorder called cri du chat syndrome, which is a French term for "call of the cat." It is a condition which results from the deletion of chromosome 5 and affects an estimated 1 in 50,000 live births, strikes children of all ethnic backgrounds, and is more common in females.

There was much uncertainty during the time of Curtis's diagnosis, and as parents, Debi and Jason were filled with fear about the type of life they would be able to provide for their son. Doctors were unsure what Curtis's life expectancy would

be. Some said he would never walk, never talk, never be able to understand what was said to him.

Mr. Speaker, had Curtis been born in another decade where there was less acceptance and understanding for special needs, his outcome would have been different. Surely had he been born into a different family, he may have been placed in a State facility, but because of their determination to be the parents that Curtis needed them to be, Debi and Jason chose to keep him, love him, and give him the best life possible, even with all of the unanswered medical questions and the knowledge that their child was severely intellectually disabled.

Curtis has endured numerous surgeries, but look at him now. He is 14 years old and he is a very big boy. His mother, Debi, I might add, has had two hernia surgeries herself because she lifts Curtis from his wheelchair, from the bathtub, and out of the car. And one time I had said to Debi, I said, "Debi, why don't you just stop lifting him? You have hurt yourself so many times lifting him," and Debi replied, "That is my baby boy, and I will do whatever I need to do for him until my body gives out." Yes; thank you. Give her a round of applause because she deserves that recognition. She represents many mothers and many parents that have this love for their children.

And Debi also had dreams of Curtis walking, talking, signing, and communicating, and these dreams were dismissed by others, people in our community; they were dismissed by doctors, but all of those dreams have come true. Curtis lives a full life. He plays baseball with the Hazleton Little League. He is on the Challenger Team; he loves to swim; he does horseback riding therapy, which he enjoys very much; and he is now able to walk on his own. Curtis is full of life and has lots of love to give to anyone who is willing to accept it from him.

Mr. Speaker, during the last fiscal year, more than 55,000 Pennsylvanians with intellectual disabilities received services and support which ensure them the opportunity to participate in the range-of-life experiences which we all enjoy in our homes and communities. Public awareness and education improve the understanding of intellectual disabilities and the programs that are required to meet these special needs. To assist in this regard, we have introduced a resolution recognizing March as "Intellectual Disabilities Awareness Month" in Pennsylvania.

We would like to express our appreciation to all of those Pennsylvanians who conduct special outreach, education, and services, and urge the citizens of the Commonwealth to give year-round support to efforts which enable persons with intellectual disabilities to live full and productive lives. Their lives are worth living and they are people worthy of love.

Mr. Speaker, I ask the members of this House for an affirmative vote on HR 664. Thank you.

STATEMENT BY MR. SCAVELLO

Mr. SCAVELLO. Thank you, Mr. Speaker.

Today I rise in support of HR 684. This resolution designates the month of March as "American Red Cross Month" in Pennsylvania. Few organizations have had the impact of the American Red Cross, not only here in Pennsylvania but also across the entire nation. When folks are in their darkest hour, whether that is due to a fire, flood, or any number of disasters, the Red Cross is there. Countless people across the Commonwealth volunteer their time to serve their neighbors throughout this wonderful organization.

It is especially important that we recognize the work of the American Red Cross now, after the harsh winter this State has experienced. STATEMENT BY MRS. GINGRICH

The SPEAKER. The Speaker recognizes the lady from Lebanon County, Mrs. Gingrich, under unanimous consent relative to one of the resolutions just adopted.

Mrs. GINGRICH. Thank you, Mr. Speaker.

I want to thank my fellow members for their affirmative vote on the resolution that was just passed recognizing March as "Problem Gambling Awareness Month." The resolution recognizes the importance of encouraging all of us to learn more about the signs of problem gambling and to be aware of the treatment options that are available and how to access such treatment.

While gambling is, for most people, entertainment and recreational, data indicates that some 6 to 8 million people across America experience some type of problem gaming throughout their lifetime. We know in fact here in Pennsylvania that over 300,000 people have been identified as being affected by problem gaming and we know that it has no boundaries. It crosses all societal levels, in all communities, and in many families. We know the risks of gambling and we know that it is essential to be educated to the warning signs and prepared with essential information that will give people the direction they need to access the resources that are out there, and they can do that with the combined efforts and hard work of our Pennsylvania Gaming Control Board and their Office of Compulsive and Problem Gambling, the Pennsylvania Council on Compulsive Gambling as well, and our Department of Drug and Alcohol programs. Together they are prepared to educate us, work with the casinos, help people before a problem becomes overwhelming for them.

The help line is available. I want to mention that number. It is 1-800-GAMBLER, and if you contact that number or know anyone who needs that information, call them and you will get the direction you need and access to the resources that will maybe save you, your family, and all your investments.

So thank you to all for voting affirmatively to recognize this month as awareness month for problem gaming. Thank you, Mr. Speaker.

STATEMENT BY MR. STEVENSON

The SPEAKER. The Speaker recognizes the gentleman from Mercer County, Mr. Stevenson, under unanimous consent as well.

Mr. STEVENSON. Thank you, Mr. Speaker.

I would like to also thank my colleagues this morning for their affirmative vote on HR 689 designating March as "Brain Injury Awareness Month," and I certainly appreciate their support for this very important effort to make more Pennsylvanians aware of brain injuries and the devastation they can cause.

I would like to submit the rest of my remarks, extended remarks for the record. Thank you, Mr. Speaker.

The SPEAKER. The Speaker thanks the gentleman.

Mr. STEVENSON submitted the following remarks for the Legislative Journal:

Thank you, Mr. Speaker.

Mr. Speaker, I rise today to offer HR 689 as a way to encourage awareness of brain injuries and to offer our support to Pennsylvanians who struggle with brain injuries.

Representative Tim Briggs and I cochair the Brain Injury Caucus, and in this role we have the opportunity to come together to discuss various issues that may affect brain injuries, research, education, awareness, funding, et cetera. Some of us may have personal experience relating to traumatic or acquired brain injuries, while many of us have constituents who have suffered. Sadly, we may also know someone whose life has been devastated by an injury or a family who has lost a loved one from brain trauma or stroke.

Acquired Brain Injury, ABI, is any brain injury that occurs after birth, and generally speaking, they are thought of according to their cause as either traumatic or nontraumatic. Some examples include stroke, postsurgical complications, aneurysm, high fever, infection, near drowning, and other conditions that interfere with delivery of blood or oxygen to the brain.

Traumatic Brain Injury, TBI, occurs when the brain is injured by any traumatic action, such as a variety of accidents, fall, striking by or against any object, shaken baby syndrome, or an assault. Nontraumatic brain injuries often occur from events such as cerebral vascular accidents, CVA; anoxia; ingestion of toxic substances; brain tumors; et cetera.

It is estimated that 75 percent of all brain injuries are concussions from trauma, affecting more than 47,000 Pennsylvanians. In studying emergency department visits, hospitalization, and death data, the Centers for Disease Control and Prevention, CDC, found that at least 1.4 million TBIs occur in the United States each year. Of these, 50,000 result in death; 235,000 require hospitalization; and 1,111,000 have emergency room visits. There are countless more who receive other medical care or no care. Of these, approximately 28 percent are from falls, 20 percent from motor vehicle accidents, 19 percent from being struck by or against an object, 13 percent other, and 11 percent from assaults.

In fact, the signs and symptoms of traumatic brain injury can be subtle and may not appear until days or weeks after the injury or may even be missed. In some cases, mild traumatic brain injury is often underdiagnosed or misdiagnosed, with symptoms not always immediately apparent.

Statistically, traumatic brain injury is the leading cause of disability and death from birth to 40 years of age, and the cost of treating, rehabilitating, and caring for the victims of traumatic brain injury in the United States is approximately \$30 billion each year.

And many of those who have suffered or are suffering from traumatic brain injury are our heroes, the men and women who dedicate their lives to protecting us, our democracy, and our freedoms. A 2009 report by USA Today indicated that officials from the Pentagon have estimated that up to 360,000 Iraq and Afghanistan veterans may have suffered brain injuries, and because Pennsylvania has sent more than 34,000 members of our National Guard to Iraq and Afghanistan, not including full-time members of our nation's military, over the past decade, it is logical that many of our newest veterans have suffered from TBI. Many of these men and women have recovered, and that is because of the scientists who are working hard to understand the severity and extent of brain injury caused by exposure to a blast that likely caused the injuries.

We are fortunate here in Pennsylvania, as we have a number of dedicated men and women devoted to this type of medical science. Our Commonwealth is home to the leading research centers for brain injury, including the Penn Center for Brain Injury and Repair at the University of Pennsylvania, the Moss Rehabilitation Research Institute, the Brain Trauma Research Center at the University of Pittsburgh, and the Center for Injury Research and Prevention at the Children's Hospital of Philadelphia. In addition, three organizations in this Commonwealth are specifically devoted to brain injury and include the Brain Injury Association of Pennsylvania, Inc., the Acquired Brain Injury Network of Pennsylvania, and the Pennsylvania Brain Injury Coalition, and two organizations that maintain a strong focus on brain injury include the Disability Rights Network of Pennsylvania and the Pennsylvania Association of Rehabilitation Facilities.

Mr. Speaker, the best approach to the silent epidemic of brain injury is to promote the awareness, prevention, and treatment of brain injuries, and I am hopeful that the successful passage of this resolution will help play a small part.

Again, Mr. Speaker, thank you for the opportunity to present HR 689, and I ask the membership to vote in the affirmative.

REMARKS BY SPEAKER

The SPEAKER. We have a couple of people that want to be recognized as part of the remembrance of Merle Phillips. Before I recognize them, I just wanted to make an observation or two of my own.

Merle was old school, and in these fast-changing and tumultuous times, sometimes some people might not recognize that as a compliment. They may think it is not a good thing to be one who has vested themselves in the institution of life as well as the institution that we all work in. Merle always had his priorities in order, though - God, country, and family. He was a quiet man. Frankly, he mumbled a lot. When you talked to Merle, it sounded like, "What did you say, Merle?" He was a quiet man, but he was a leader, and when I say old school, I mean that in the most complimentary way, because he was a man that you could respect. If he said he was going to do something, he did it. If he said he was not going to do something, he did not do it. Maybe stubborn in some ways, but he was everything good about the institution, and he was someone who certainly made his mark here and has been missed, and I hope that that, in a short sense, encapsulates what I think is the essence of Merle Phillips.

REMARKS BY MS. CULVER

The SPEAKER. With that, I will recognize the lady from Northumberland County, Ms. Culver.

Ms. CULVER. Thank you, Mr. Speaker.

And thank you to all of my colleagues for allowing me a few minutes during session today to pay tribute to one of the finest men to have sat in this House chamber, my predecessor, Merle H. Phillips.

In December after a number of courageous health struggles, Merle left this earth to go to a place where he could finally rest, where he could be at peace. We gather here today for a few moments at least to honor him by sharing our memories and acknowledging his lasting legacy to the 108th District, this institution, and to the Commonwealth of Pennsylvania.

For more than 30 continuous years Representative Phillips spent his time working hard on the issues the people of Northumberland and Snyder Counties cared about. In fact, during his farewell remarks to this House just 3 1/2 years ago, he said that the greatest joy of public service is being able to help someone, and that is why he continued to do what he did.

Merle's passion for people was evident by the way he lived his everyday life. He believed everyone deserved a second chance, a third chance, and sometimes even just a little bit more. Because he often said to me, "Lynda, no one is perfect; and if someone is willing to try and make themselves a little better, then we need to help them."

During his tenure in the House, he is probably known best here at the Capitol for serving as Republican Caucus Administrator and being part of the leadership team, something he was so proud to have accomplished. He also served as chairman and vice chairman of the Game and Fisheries Committee, as secretary of Agriculture and Rural Affairs Committee, and as a member of the Transportation and Appropriations Committees. He was an avid outdoorsman who loved to hunt and fish, so much so that just a few short weeks before his passing, he went out and got his last deer.

Mr. Speaker, I have had the privilege of working with him for more than 23 years, watching him in action like many of you have over the years, except I got to watch him from the district. There was so much I learned from him, and I am going to impart a few pearls of his wisdom to you.

He always said, "Stay true to your word because if you do not, you have nothing." He said, "Do more listening than talking, fight for what you believe in, but know when to compromise. Do not get up to speak on the House floor unless you truly have something to say." And his biggest lesson to me was, "Never, ever accept no as an answer."

You can see why he quickly became a mentor to me, a friend - a very, very dear friend. You always knew when Merle was around because when he left your office, it was as though a tornado had run through it. He was good at pushing you when you needed to be pushed. He was good at pushing you when you did not want to be pushed, but it was all because he wanted you to be a better person.

And any of you who knew him knew he had a bit of a Dutch accent. He always said it was one of his greatest strengths because people underestimated him and what he was capable of. And anybody who ever negotiated anything with him, when he really wanted something, had to notice his Dutch accent got just a little bit thicker.

He believed in teamwork and he believed that to be one of his greatest accomplishments, working together for the common good. He may not always have agreed with everyone on every issue, but he was able to put aside his differences so that his district and the Commonwealth would be better for it.

I can tell you that he cherished his time here in the House of Representatives and the friends that he made. He always said that the friends that I would make here would be some of the best friends that I would ever have. Until the very end, he would watch PCN (Pennsylvania Cable Network), and if he saw anybody that was a friend of his on leave on the board, he would call down to check and see if they were okay. There are many of you here today that he spoke so fondly of and he was so proud to be associated with you.

GUESTS INTRODUCED

Ms. CULVER. Much of what guided him legislatively were his faith and his family, and as I say their names, I ask if they stand today - his wife of more than 61 years, Helen Phillips. There are some others I am going to ask to stand so you might want to hold off and let me finish this. His children who are here: Sandra, Jane, Michael, Michael's wife, Missy, Christine, and Lorrie. He had 12 grandchildren. Some are here with us today: Rebecca Kalmbach and her husband, Michael - you guys want to stand as I go – Joshua Phillips, Michael Reiley, Bevin Reiley; two of his former staffers, Jeannine Markowski and Jason Weiser; and some of his dearest friends, Representative Rick Geist, Representative Russ Fairchild, Representative Bob Allen and his wife, Peggy, Senator John Gordner, Senator Dave Argall; and two people that he mentored and they thought the world of him, Ryan Boop and Josh Funk. If you could all give them a round of applause, please.

I hope you all know how much that you meant to him, how important that you were in his life, and that you were his first priority. We extend our heartfelt sympathies to you and wish you much peace and comfort, and we honor him with a resolution cosponsored by myself, Garth Everett, Dave Millard, Adam Harris, Kurt Masser, and Fred Keller.

Merle knew his time on this earth was coming to an end and was very cleverly saying goodbye to those closest to him his last few months. He made sure that he left instructions for everyone and that everyone he was leaving behind would be taken care of. A lesser man would have been bedridden those last few months.

The 108th District meant so much to Merle that he chose his final resting place at a cemetery on top of a hill that overlooked the 108th District, which he served for so many years.

I know that he would want me to impart this message to each of you because he repeated it to me almost every time I spoke with him. "Keep your family close, protect them, cherish them, spend time with them, and enjoy them. Stay true to your faith. Time goes by so fast and in the end the important thing is that you have your faith and you have your family."

And I also know that Merle and his good friend, Dick Hess, are all smiling down upon us. And Merle is doing his famous chortle, and if anybody has ever heard it, you know what I am talking about because he would have been truly delighted for this resolution and for all of this attention. He would have been sincerely touched. He loved this place. He was proud to serve the 108th District back home and here in the House of Representatives.

And, Lynda, I have to say, I always got a sense that you were a part of that family too, I must tell you, because he often talked about you in particular, but your staff as his family. Section 1. Short title.

This act shall be known and may be cited as the Pertussis Education Act.

Section 2. Purpose of act.

The purpose of this act is to educate parents of newborn infants regarding pertussis disease and the availability of vaccination to protect newborn children against pertussis disease.

Section 3. Findings.

The General Assembly finds as follows:

(1) Commonly known as whooping cough, pertussis is a highly contagious disease that can be prevented by vaccination.

(2) During 2012, the Centers for Disease Control and Prevention (CDC) reported an increase in pertussis in the majority of states.

(3) Pennsylvania ranked 13th in the country in the incidence of reported cases of pertussis.

(4) Pennsylvania's incidence of pertussis is higher than the national incidence of cases of pertussis.

(5) Recommended vaccination for children is at 2, 4 and 6 months of age, followed by vaccination at 15 to 18 months of age, followed by vaccination when the child enters school with the final vaccination when the child is between 11 and 12 years of age.

(6) Pertussis can cause very serious illness which can be potentially life threatening in infants too young to be vaccinated.

(7) More than half of infants who contract pertussis must be hospitalized.

(8) Of those infants who are hospitalized with pertussis, about 1 in 5 will get pneumonia and 1 in 100 will die.

(9) The CDC recommends that families and caregivers of newborns be vaccinated at least two weeks prior to coming into close contact with a newborn.

Section 4. Definitions.

The following words and phrases when used in this act shall have the meanings given to them in this section unless the context clearly indicates otherwise:

"Department." The Department of Health of the Commonwealth. "Health care facility." As defined in section 802.1 of the act of

July 19, 1979 (P.L.130, No.48), known as the Health Care Facilities Act.

Section 5. Dissemination of pertussis information by health care facilities.

(a) Options.–A health care facility that provides health care services to a pregnant woman, which services are directly related to her pregnancy, may provide the woman, and any other adult family member present, with educational information on pertussis disease and the availability of a vaccine to protect against pertussis. The educational information may be provided before the woman's discharge after giving birth. Provision in a timely manner of publications prepared by the department under section 6 shall constitute compliance with this subsection.

(b) Construction.–Nothing in this section shall be construed as requiring:

(1) A health care facility to provide or pay for vaccination against pertussis.

(2) A pregnant woman to receive vaccination against pertussis.

Section 6. Informational publications by department.

The department shall, on the department's publicly accessible Internet website, make available to health care facilities printable publications that include information on the Centers for Disease Control and Prevention's recommendations that pregnant women, family members and caregivers of infants receive vaccination against pertussis to protect their newborns from the transmission of pertussis. Section 7. Effective date.

This act shall take effect in 60 days.

On the question, Will the House agree to the amendment?

The SPEAKER. On that question, the Speaker recognizes the gentleman, Mr. Scavello.

Mr. SCAVELLO. Thank you, Mr. Speaker.

I offer this amendment that is basically – it is a gut-and-replace, but it is agreed upon, and it changes the entity and the responsible designated educational information on pertussis from health-care providers to health-care facilities, and this means that the information will be given out at a health-care facility, such as a hospital or a birth center, after birth before discharge.

Instead of the educational information given to an expectant mother at a first prenatal appointment, the information will be given to the parents and any other adult present after birth before discharge, and it changes the bill from a "shall" to a "may," so we are not imposing a mandate on a health-care facility.

And I urge the members for a unanimous vote. Thank you, Mr. Speaker.

The SPEAKER. The question is, will the House agree to the amendment?

Ms. DeLISSIO. Thank you, Mr. Speaker.

Mr. Speaker, I do sit on the Health Committee. I remember when this went through, and I just want to understand that this amendment basically puts us where we are at today without HB 1567. Hospitals in particular are already doing this on a voluntary basis, so then as a result of the amendment, the law is really not meaningful in any way. Is that accurate, Mr. Speaker, or have I missed something?

Mr. SCAVELLO. Mr. Speaker, this is a growing problem and, you know, it is continuously growing, and the whooping cough disease – if you read the numbers, since you are on the committee, you are pretty much familiar with it. We are trying to let people basically be aware, and I think putting this into legislation makes all these hospitals and these health-care facilities realize that, yes, although right now it is the way you say, it will give them an opportunity to maybe do a better job of handing them out personally and letting that information out.

Mr. R. MILLER. Thank you, Mr. Speaker.

Right now the crimes of harassment, stalking, and the threats to use weapons of mass destruction each contain a section exempting from prosecution any conduct by a party to a labor dispute as defined in the Labor Anti-Injunction Act or to any constitutionally protected activity. HB 1154 deletes those special exemptions completely. But in working with some in the law enforcement community and the labor community, some of them have expressed fears of seeing legitimate picketing, for example, misconstrued as harassment or stalking.

So, Mr. Speaker, my amendment strikes a compromise by reinserting an exemption into the offense of harassment and stalking, but only for constitutionally protected activity. Mr. Speaker, I believe that constitutionally protected activity is just that and it really is protected, but by offering this amendment, I hope to assuage the fears of those that have that concern. What this means is that peaceful picketing or distribution of handbills and other peaceful labor activity cannot be prosecuted as harassment or stalking, but if activity strays into illegitimate contact, then those criminal offenses will apply uniformly to everyone.

In the end, both labor and management should live by the same rules, the same criminal law that everyone else lives by in Pennsylvania.

I ask for the members' support for this amendment. Thank you, Mr. Speaker.

Her legislation was changed to an amendment, was incorporated into this in the House Judiciary Committee, and I just want to applaud the efforts of somebody this young looking out to correct a piece of public policy that was not in place, needed to be in place, so that what happened to her cannot happen to any other minor in Pennsylvania again.

So I applaud Sarah's courage. I hope she is watching at the moment, and if not, I would like to congratulate her in advance for what I hope is an affirmative vote on this legislation.

I just wanted to take a minute or two to thank all of you for your support on HB 1972, which names a bridge over Fish Creek in Greene County after Lt. Col. Cephus Lee Roupe, an Iraqi war veteran and much, much more.

It would be easy to say that Colonel Roupe's story is a sad one. However, that would not do justice to the man or the spirit of devotion and service that he so exemplified. Colonel Roupe's story is one that should elicit great pride in each of us.

Colonel Roupe passed away 2 years ago after proudly and courageously serving his country in the United States Army for 36 years. His untimely death at age 54 came just after he submitted his retirement papers to the Army. But what a career. What service to our country.

The Waynesburg native began his Army career as an enlisted man and worked his way to the top. After receiving his aviation wings at Fort Rucker, Alabama, Colonel Roupe received a direct commission to the Medical Service Corps and became qualified on more military aircrafts than I can list. Colonel Roupe was a Master Army Aviator and was considered perhaps the most experienced Medical Service Corps aviator in the Army.

During his 36 years in the Army, Colonel Roupe saw combat duty in both the first and second Iraq war. He also flew multiple missions in war-torn Bosnia and Afghanistan.

Simply put, where danger lurked, Colonel Roupe served, expertly and proudly.

We lost a good, selfless patriot and soldier 2 years ago in Colonel Roupe. But his sacrifices and service live on, and thanks to you, countless generations will be reminded of what he did for each and every one of us in service to our nation.

Again, thank you very much. Thank you, Mr. Speaker.
