ST. PATRICK'S DAY PROGRAM

The SPEAKER. I invite Representative Hennessey, chairman of the House Irish Caucus, to the rostrum.

Mr. HENNESSEY. Thank you, Mr. Speaker.

On behalf of the Pennsylvania House of Representatives Irish Legislative Caucus, I want to welcome everyone to what has become our traditional short St. Paddy's Day celebration on the House floor here in Harrisburg. Almost 20 percent of Americans claim some degree of Irish heritage. By far the largest impetus to that was the Irish potato famine from 1845 to 1849, but it has gone on for generations. That percentage of people, Americans claiming Irish heritage, is second only to Americans who claim German or Pennsylvania Dutch heritage. But whereas the Germans celebrate Oktoberfest and it takes them the whole month of October, the Irish have managed to distill, at least in America, our celebration into St. Paddy's Day or St. Paddy's weekend, which we just celebrated, and we celebrate St. Patrick's Day, as I like to call it, the holiest feast of the Christian calendar.

To kick off our celebration, we have our own Representative Eddie Day, Eddie "O'Day" Pashinski, and he is going to lead us in a rendition of "Danny Boy" and "When Irish Eyes Are Smiling." We ask that you all join in. The words are in front of you on your desks. And once we do that, hopefully you will all join in and you will energize our dancers. We will have some colorful Irish dancers here on the House floor for you in just a few minutes, once we hear from Representative Pashinski.

("Danny Boy" was sung by Representative Pashinski.)

Mr. HENNESSEY. A standing ovation.

Here we go. And now please join us in "When Irish Eyes Are Smiling."

("When Irish Eyes Are Smiling" was sung by Representative Pashinski.)

Mr. HENNESSEY. Thank you. Representative Eddie Day Pashinski. Thank you, Eddie.

REBEL HEART IRISH DANCERS PRESENTED

Mr. HENNESSEY. And now we are about to be treated to some Irish dance by the Rebel Heart Irish Dancers, who are nice and colorful here in their red and black costumes. The first dance is called the "Drums of Belfast." Now, the Irish are known for their rhythmic dancing called hard-shoe. In this type of movement, the dancers' feet create sounds similar to that of a beating drum. The first dance, as I said, is called the "Drums of Belfast." Take it away, kids.

("Drums of Belfast" was performed by Rebel Heart Irish Dancers.)

Mr. HENNESSEY. Now, while some of the kids change into soft-shoe for the next dance, let me tell you about the Rebel Heart Irish Dancers. They were formed in 2007 when Stephanie St. James created an Irish Dance School in Camp Hill and teaches today in Camp Hill and also in several other locations. In the past 7 years, the Rebel Heart Irish Dancers have performed hundreds of times. Actually, this Saturday, I believe, will be their 500th performance. And they have traveled in Pennsylvania, New Jersey, Maryland, Georgia, Montana, and California. They mix certain styles. They use traditional Irish music and also mix in some modern Celtic music rather than just the standard Irish songs. The group designs and makes their

own costumes and have created a variety of beautiful show costumes and unique solo dresses.

Unlike most Irish dance groups, they do not compete. They focus their energy on bringing their love of dance to audiences everywhere. They are thrilled to share their passion for Irish dance and invite you all to join in the celebration. And please feel free to clap as we go along. I suppose the only one that I know of who can actually dance with these kids would be perhaps Representative Marguerite Quinn, who was an Irish step dancer herself. And in answer to the question that I know is bothering all of you, I cannot do that kind of thing, step dancing anymore. Thirty years and maybe a hundred pounds ago I could do that kind of thing, but not anymore.

It looks like the kids are back, so they are going to treat us to "Lannigan's Ball." This is a single-jig that is performed entirely while the dancers maintain the ring or circle formation. The dancers are wearing soft-shoes. So the focus of this dance is movement and grace. Please enjoy "Lannigan's Ball."

Kids, take it away.

Mr. HENNESSEY. Wait, kids. Before you leave, I forgot to introduce the little leprechaun here, with the blond hair in the front. Madelyn, come on out here, please. This is Madelyn Weeter, the daughter, the 6-year-old daughter of Jenn and Tom Weeter of our House Republican Caucus. This is her first performance in any kind of a theater or surroundings like this. Great job, Madelyn.

Okay. The Rebel Heart Irish dancers, what set them apart in the last eight seasons that they have been performing is their idea of breaking the rules. Now, here in the House, we are much more polite about it. We suspend the rules to the chagrin of some but to the delight of many on frequent occasions. They break the rules. Rebel is in their name because it is a big part of what they do. They merge traditional elements of Irish dance with contemporary flair and upbeat music. Their final tune and newest dance in their repertoire is called "Jack Dempsey."

Kids, take it away.

Mr. HENNESSEY. I was— Over the weekend. Over the weekend, yes.

Happy St. Patrick's Day to all of you, and thank you very much for being such a wonderful audience.
