(2) An offense under subsection (a)(4), (5), (6) or (7) or (b) shall constitute a misdemeanor of the third degree.

Amend Bill, page 2, line 30; page 3, lines 1 through 9, by striking out all of said lines on said pages and inserting

"Emotional distress." A temporary or permanent state of mental anguish.

Amend Bill, page 3, by inserting between lines 12 and 13

"Seriously disparaging statement or opinion." A statement or opinion which is intended to and under the circumstances is reasonably likely to cause serious emotional distress to a child of the victim's age.

# BILL ON CONCURRENCE IN SENATE AMENDMENTS

An Act amending the act of April 9, 1929 (P.L.177, No.175), known as The Administrative Code of 1929, in Commonwealth agency fees, further providing for the Department of Health; and providing for children's advocacy centers.

It also creates an advisory committee within the PCCD (Pennsylvania Commission on Crime and Delinquency) called the Child Advocacy Advisory Committee in order to make recommendations to PCCD regarding how to administer the grant program with this respect to CACs and the MDITs.

And I would appreciate your support on this very important piece of legislation, HB 316. It passed the House in February of 2013 by a vote of 198 to 0. Thank you for your support.
