REMARKS SUBMITTED FOR THE RECORD

The SPEAKER. The Speaker recognizes the gentleman, Mr. Turzai.

Mr. TURZAI. Thank you, Mr. Speaker.

I would just like to submit some remarks for the record on HB 2234.

The SPEAKER. The Speaker thanks the gentleman.

Mr. TURZAI submitted the following remarks for the Legislative Journal:

The bill is based on the Model Entity Transactions Act, proposed by the Uniform Law Commission. The Title 15 Committee of the PA Bar Association's Business Law Section adapted the model act for Pennsylvania.

This bill is a collaborative effort with Minority Leader Dermody, who is the lead cosponsor of the bill. The bill streamlines Title 15 by consolidating a number of provisions (which were contained in the individual entity laws) into the preliminary chapters (which apply to all types of business entities).

The bill also provides for five fundamental entity transactions – merger, division, interest exchange, conversion, and domestication – which will be available to all types of business entities.

The PA Bar Association, the Rural Electric Association, and the Department of State support the bill.

The House proceeded to third consideration of **HB 1769, PN 3747**, entitled:

An Act amending the act of April 12, 1951 (P.L.90, No.21), known as the Liquor Code, further providing for responsible alcohol management.

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

On that question, the Speaker recognizes the gentleman from Westmoreland County, Mr. Dunbar.

Mr. DUNBAR. Thank you, Mr. Speaker.

I was wondering if the maker of the bill will stand for a brief interrogation.

The SPEAKER. The gentleman, Mr. Hickernell, indicates he will stand for interrogation.

If I could have the members kindly hold the conversations down a little bit. Especially during interrogation, it is sometimes hard to hear. If the members would please hold the conversations down. Thank you.

The gentleman, Mr. Dunbar, may proceed.

Mr. DUNBAR. Thank you, Mr. Speaker.

A couple days ago we passed an amendment which added on some other training programs, and I was curious if you know if those training programs have any fees associated with them.

Mr. HICKERNELL. Mr. Speaker, yes, I do believe they do. My understanding is that the fees for these programs typically run around \$25 and take about 2 hours to complete online. That can vary a little bit depending on how the questions go, but that is my understanding, sir.

Mr. DUNBAR. Thank you, Mr. Speaker.

That concludes my interrogation. On the bill?

The SPEAKER. The gentleman is in order on the bill.

Mr. DUNBAR. Mr. Speaker, this bill is pretty much a government mandate on those that can afford it least. Asking waiters and waitresses and servers of alcohol to undertake training at their own expense – these are minimum-wage employees – this is going to be an impediment to their employment, and I would respectfully ask for a "no" vote.

The SPEAKER. The question is, shall the bill pass finally?

Agreeable to the provisions of the Constitution— Does the gentleman, Mr. Hickernell, want to be recognized on the bill? The gentleman is in order.

Mr. HICKERNELL. Thank you, Mr. Speaker.

Mr. Speaker, I certainly understand the gentleman's objection. As someone who is probably as pro-business as anybody in this room, I, too, never want to place restrictions on business or individuals who are working, you know, for private businesses. In this particular case, sir, we are attempting to make sure that individuals who are serving alcohol at least have basic training in how to recognize someone who is drunk and also how to manage people who are intoxicated. I think \$25 and 2 hours of time to do that is reasonable. We found out, in investigating this situation, that about 80 percent of taverns in Pennsylvania currently require all of their people to be trained,

and actually, the taverns have come on board as supporting this legislation at this point in time. So I really do not think it is a major ask to require this to potentially save lives.

And I will not take the time of the House this afternoon to get into the details, but I have introduced this bill at the request of a constituent who had a loss of a daughter several years ago at the hands of a drunk driver, and upon investigation, it was revealed that the server that night in that bar had no kind of training and said that she did not know that the individual was drunk when she left the establishment that night. So maybe, just maybe, if that person had received this type of training for \$25 and 2 hours of time, perhaps Susan's daughter would be alive today.

So I would encourage the members to please support this legislation. Thank you.

Mr. Speaker, HB 1429 passed the House back last year unanimously at 198 votes. The Senate added an amendment which was largely technical in nature. The two changes made that are substantive have to do with the form of a power of attorney and the commingling of funds. The Senate amended the bill to provide that neither the principal nor the notary public can be witness when executing a POA. The bill requires that the POA be witnessed by two individuals.

The other change has to do with the commingling of funds. The Senate amendment will allow the commingling of funds if the principal commingles the fund and the agent is the husband or wife of the principal. As the bill left the House, it allowed the commingling of funds if the funds were commingled before the execution of the power of attorney. The intent of the language is to make it easier when an agent and a principal are married or a father and son, mother and daughter, for an example.

I would appreciate an affirmative vote. Thank you.
