STATEMENT BY MR. BIZZARRO

The SPEAKER. The Speaker recognizes the gentleman from Erie County, Mr. Bizzarro, under unanimous consent relative to one of the resolutions just adopted.

Mr. BIZZARRO. Thank you, Mr. Speaker.

I would like to thank my colleagues for their support of HR 972, designating November 2014 as "Childhood Brain Stem Glioma Awareness Month" and November 11 as "Jax Stone Day" in our State.

Nothing can prepare you to hear the words, "Your child has cancer," but a diagnosis of brain stem glioma can be additionally scary because there is little to no awareness about it. This particular disease causes tumors to grow on the brain stem, affecting the area of the brain that controls the body's breathing, heart rate, and muscles involving seeing, hearing, walking, talking, and eating. Surgery is not an option for many patients, who instead have to undergo chemotherapy and radiation. Unfortunately, a majority of brain stem glioma patients are young adults or children, many between the ages of 5 and 10 years old. The prognosis is not optimistic, and most children do not live more than a year after they have been diagnosed.

However grim the disease may sound, one little boy from Erie was able to cope with his diagnosis while keeping a smile on his face and helping others who were fighting cancer too. Jax Stone was just 8 years old when he was diagnosed with malignant brain stem glioma. He sadly passed away July 27, just a few months shy of his 10th birthday.

Jax Stone left quite an impression on the entire community during a life that was all too brief. Though he was suffering, he never let cancer ruin his mood or enthusiasm for helping others. As a childhood leukemia survivor myself, I was in awe of his determination, courage, and zest for life, even at a time when life could not have been more difficult for him.

By honoring Jax's birthday, November 11, as a special day, we ensure his memory of kindness lives on. We also recognize the need for greater awareness of childhood brain stem glioma, and we stand with those children facing tough cancer battles. We will continue to do whatever we can to let all families facing cancer diagnoses know that they are not alone.

STATEMENT BY MRS. DAVIS

The SPEAKER. The Speaker recognizes the lady from Bucks County, Mrs. Davis, under unanimous consent relative to one of the resolutions just adopted.

Mrs. DAVIS. Thank you, Mr. Speaker.

I want to thank everyone for their support of HR 1048, designating tomorrow, Thursday, October 9, as "PANDAS Awareness Day" in Pennsylvania. PANDAS stands for Pediatric Autoimmune Neuropsychiatric Disorders Associated with Streptococcal Infections. They were not even diagnosed until 1998, and there is a great need to increase awareness of the disorders among parents, medical professionals, and the general public.

They are associated with strep infections and hit kids, mostly between ages 3 to puberty, with issues that mimic obsessive compulsive disorders like tics, intense anxiety, personality

changes, and regression in development. PANDAS affects at least 162,000 children in the United States. They are as common as pediatric cancer and pediatric diabetes and can seriously affect the healthy outcome of a child's life. Sadly, once the symptoms strike, the formerly normally functioning child is gone. The change is dramatic: ADHD (attention deficit hyperactivity disorder) symptoms; severe mood changes; inappropriate age behaviors, such as bedtime fears or loss of impulse control; decrease in handwriting or math skills, and much more.

The big problem is that there are no conclusive tests to determine PANDAS in a child, and the disorders are often misdiagnosed and mistreated. This could go on for years and can literally destroy families because of the dramatic ups and downs the disease brings with it.

I would like to thank two women from my district, Nicole Harper and Lauren Kradoska, for sharing their stories with me. "PANDAS Awareness Day" will help increase awareness of this new and unfamiliar disorder. I encourage everyone to learn more about it.

Again, thank you, and thank you, Mr. Speaker.

STATEMENT BY MS. MUNDY

The SPEAKER. The Speaker recognizes the lady from Luzerne County, Ms. Mundy, under unanimous consent relative to one of the resolutions just adopted.

Ms. MUNDY. Thank you, Mr. Speaker.

This is Pennsylvania's Promise for Children Month, and on behalf of the 130 members of the Early Childhood Education Caucus, House and Senate, Democrats and Republicans, we want to emphasize the fact that early childhood education is the best investment this Commonwealth can make in the futures of our families, our children, and our Commonwealth. We had a press conference this morning, and many of the members here spoke about the importance of making this investment. This has been a lifelong work of mine for 24 years in this General Assembly. I have pushed the notion that an ounce of prevention is worth a pound of cure, and the longer we delay in making these important investments – investing in our children and their future, investing in universal pre-K, investing in high-quality nurse home visiting programs, investing in high-quality child day care – the longer it will take us to reap the benefits of lower costs of incarceration, lower welfare costs, lower education costs as we try to remediate children.

We need to put our money where our mouth is, make these investments in the State budget, find new money if that is what is necessary. And I commend the members of the House and Senate Early Childhood Education Caucus for their work and their focus, and I certainly hope that it will continue long after my retirement. Thank you.

Mr. Speaker, this is an important recognition. Pennsylvanians with disabilities operate thriving businesses, teach our children, and serve our nation and our Commonwealth. They are innovators and pioneers of technology. They demonstrate what is so fundamental to the American character – the legacy of hard work, responsibility, and sacrifice. This resolution is a recognition of their importance to our economy, and it reminds us that Americans deserve the opportunity to participate fully in society.

Mr. Speaker, during National Disability Employment Awareness Month we celebrate the Americans living with disabilities, including significant disabilities, who enrich our country, and we reaffirm the simple truth that each of us has something to give to the American story. We must remind ourselves that every American has a right to dignity, respect, and a fair opportunity at success in the workplace. Not long ago, workers with disabilities were measured by what people thought they could do, not what they could do. That deprived us of their full talents and contributions.

The Americans with Disabilities Act codified the promise of an equal opportunity for everyone who worked hard, and in the years since, Americans with disabilities have reached extraordinary heights. But when employees with disabilities are passed over in the workplace or denied fair accommodations, it limits their potential and threatens our democracy. When disproportionate numbers of Americans with disabilities remain unemployed or underemployed, more work must be done to achieve the spirit of what is one of the most comprehensive civil rights bills in the history of our country.

This resolution is a recommitment by this legislature to tear down the barriers that prevent those with special needs from living fully independent and integrated lives. Mr. Speaker, this month we renew our commitment to cultivate a more inclusive workplace, and we continue our efforts to build a society where everyone who works hard has a chance to get ahead.

STATEMENT BY MR. GROVE

The SPEAKER. The Speaker recognizes the gentleman from York County, Mr. Grove, under unanimous consent. I appreciate the members' attention. Please hold the conversations down. I would appreciate if the members clear the aisles. The gentleman, Mr. Grove, may proceed.

Mr. GROVE. Thank you, Mr. Speaker.

Today I rise to thank my colleagues for their support for HR 1009, which honors the veterans of the war in Vietnam and the 50th anniversary of the Gulf of Tonkin Resolution. Conflict and instability in Southeast Asia began long before American involvement in the Vietnam war and continued for nearly a decade afterwards. Escalation of this Cold War-era conflict directly related to the August 2, 1964, attack on an American warship in the Gulf of Tonkin.

In August 1964 the destroyer *USS Maddox* reported being fired upon in the Gulf of Tonkin by North Vietnamese torpedo boats. August 7, 2014, marked the 50th anniversary of the passage of the Gulf of Tonkin Resolution, which led to the escalation of America's full-scale involvement in one of the most divisive and costly wars in our nation's history.

Working under the domino effect theory, which feared that if one Southeast Asian country fell to Communism, many would follow, the United States increased aid to South Vietnam but stopped short of committing to a large-scale military intervention until 1964.

More than 58,000 brave Americans lost their lives in the service of freedom, and more than 300,000 Americans were wounded, including 75,000 who became severely disabled by their wounds. In addition to those large numbers of casualties, 2,000 of our brave soldiers still remain missing today. In total, 3 million American men and women selflessly gave themselves on foreign battlefields and are among our nation's truest heroes.

This resolution honors the courage of those who served in the Vietnam war and remembers those who gave the ultimate sacrifice as we approach the 50th anniversary of the Gulf of Tonkin Resolution.

Today I would like you to join me in welcoming several veterans from York County, in the district, to the House floor today: Judy and Paul VanBrunt; Bob Myers; James Bean – not Jim Beam, James Bean; William Schultz; Philip Palandro, our Veterans Affairs director; Harold Redding; Michael Robinson; Donald Crumble; Robert Klinedinst; and Robert Zeigler.

Thank you for your service, gentlemen, and welcome home.

To these veterans here today and those across the Commonwealth of Pennsylvania, please accept our heartfelt and lasting gratitude for putting your lives on the line and serving in Vietnam. Your service can never be fully appreciated, but please know that I, along with my colleagues in the Pennsylvania House of Representatives, recognize your service and are proud to have you as citizens of this great Commonwealth.

Thank you, Mr. Speaker, and again, gentlemen, welcome home.

The SPEAKER. On that question, the Speaker recognizes the lady from Cumberland County, Ms. Delozier.

Ms. DELOZIER. Thank you, Mr. Speaker.

As we stand here today, there is someone somewhere in Pennsylvania who is being abused physically, emotionally, or sexually. It is a sad but startling fact that 158 domestic violence-related fatalities occurred here in Pennsylvania in 2013. The personal stories behind these statistics are just as shocking as the numbers. October is recognized nationally as "Domestic Violence Awareness Month," a time when every person should be considering what he or she can do to help end the epidemic of domestic violence in our communities. The harsh reality is that domestic violence brutalizes women, men, and children, both physically and mentally, and destroys families.

HR 1035 officially designates October 2014 as "Domestic Violence Awareness Month" here in Pennsylvania. In recognition of domestic violence awareness, Domestic Services of Cumberland and Perry Counties have many of the Red Ladies around our county as well as a press conference next Tuesday to bring awareness to a unique program called the Silent Witness. The Silent Witness is a national initiative that has made a powerful and global impact against domestic violence homicides. The mission of Silent Witness is to promote peace, healing, and responsibility in adult relationships in order to eliminate domestic murders.

The display in the rotunda will include a life-size red figure of a woman who was murdered in the act of domestic violence, with a shield telling her name and her story. They call this figure a Red Lady, and I would encourage all of my colleagues to stop by the display next week as it sends a very powerful message about domestic violence's devastating effects on all of us in our community.

I thank you for your support in the past, and I ask you for that continued support for HR 1035, as we raise awareness of this serious issue within our Commonwealth and to help victims gain the strength and the ability to break the cycle of violence and get the help that they need.

**FAREWELL ADDRESS
BY MR. HALUSKA**

The SPEAKER. I would like to take a few minutes now and offer the dais to Representative Gary Haluska, who would like to make some parting remarks to the members of the House.

Gary, welcome to the podium.

Mr. HALUSKA. Thanks, everybody.

Okay. I will quit. Thank you, Mr. Speaker.

Sam and I have a couple of things in common. Our districts almost border each other, and we followed our fathers here. Your father is always full of knowledge, so I will tell you a little story about my dad. Back in the early sixties, you know, on Sunday night, the big thing was you sat with your brother or sister – my two brothers, my sister and I, and my mother and my dad – you watched TV because Sunday night was the TV night. There were no recorders. There was not even colored television. And you only had one television, believe it or not. So this is the early sixties.

So we are watching Ed Sullivan, and the Beatles were going to be on that night. Of course we all heard the Beatles songs, but we never got to see them because this is the first time they were coming to America. So we watched "The Ed Sullivan Show." We listened to the Beatles, and my two brothers and my sister, we were really engaged. My dad looked over at me; he says, "Yeah," he says, "a year from now, you will never remember those four guys' names." I think that was John, Paul, George, and Ringo, if I am not mistaken. But that tells you that your parents do not always know everything, but that was a good try.

Being a teenager in the sixties was probably about the best time in this nation to grow up. I mean, it was really neat. It was "American Graffiti" and it was "Happy Days" all rolled into one. It was the muscle car era, you know. So basically we had a

young President Kennedy, who challenged us to do things that we never did before, and when you are a young teenager, that really meant something to you. So he wanted to get us to the moon, and everybody sort of looked at each other and said, how in the heck are we going to do that? But I guess we went out and we got an RCAP or something like that. We borrowed the money, and we invested in our future. We spent that money, but for generations, what we spent will really come back to us tenfold. The technology that we got from that space program is just unbelievable, and it is the gift that keeps giving and giving and giving.

I have got to have some notes so I do not go all over the board here. Okay.

And then, like I said, it was the muscle car era. Obviously I have raced since I have been 16 years old. I met a lot of good people racing. It is one of my passions that I like. And I guess that is why John Payne and I have chaired the Motorsports Caucus all these years, because John has a love for racing, racecars, antique cars, and classic cars and so do I, and it has been a joy to work with John on that committee that we cochaired, and we have had a lot of fun with it over the years.

Then in 1995 I came to the House, and before I got here, then-Speaker DeWeese created the Tourism and Recreational Development Committee. In the first term it really did not do too much, and then we came along in the class of '95 and I landed in that committee and I stayed there for 18 years. Bob Godshall, Tom Michlovic, took the chairmanship of that committee, and boy, did we travel. And Chris Sainato came in with me, and one of the first trips, we were going to go to the Grand Canyon. Chris got all excited, and he ran over to Bobby, and he said, "Bob, I just got elected." He said, "I don't think I can go out of the State." Chris did not know that we were going to go to Matt Baker's district; we were going to go to the Little Grand Canyon in Pennsylvania. So that sort of quelled Chris.

Bob and Tom were great, great chairmen. We traveled this State upside down, inside out. We went to New Jersey, Maryland, West Virginia, Ohio. We saw a lot of things that needed to be done. We needed to market Pennsylvania. We needed to get that word out because we have so much to see in Pennsylvania. So we came back and the Ridge administration listened to Bob, and they put a lot of money into marketing. The Schweiker administration, the Rendell administration, all marketed Pennsylvania, and it is our second largest industry now. So unfortunately, the current administration does not seem to want to market Pennsylvania, but hopefully we will pick that back up in the future.

A couple of the stories that we have in the Tourism Committee, because when we traveled, Republicans and Democrats, we ate together, we stayed together, we played together, and we built a lot of good relationships back and forth across the aisle, and it is too bad that we cannot do that today with all the committees. It is not a waste of money. It is really bonding this body together and making each other a lot more familiar with each other.

And I remember we were in Philadelphia one day, and E.J. Lucyk became the chairman after Tom Michlovic left, and he and Bob did a great job also. We went to the ballet to watch one of their practices, so after the practice, we went to the local pub and E.J. was going to arm wrestle one of the male dancers, and we said, "E.J., you have got to think this through. If you beat a ballerina, it doesn't count. If a ballerina beats you, it's really

going to be bad." So we kind of talked E.J. out of arm wrestling the male dancer. We called him a ballerina, but I guess they just called him a male dancer.

But we had so many trips, and we looked at a lot of things in tourism, and obviously, it is our second largest industry and it creates a lot of jobs, and I hope someday we come to our realization, two things: Bob Godshall has had a bill to start school after Labor Day, which all these tourism places desperately need. They lose their employees one of the biggest weekends of the year, on Labor Day. And, Bob, I still think our State parks – we have got 117 of them – we still need a couple lodges in a few of them.

And I sat down and I did a little bit of research. I looked through my book. If my estimations are correct, and they are pretty close, there have been 263 smiling faces come through this place since I came here. That is unbelievable. And after this retiring class, Sam and the rest of us leave, the day that I got sworn in, 20 years ago, there are going to be 22 people sitting in these seats that were here that day. So that really tells you a lot about the turnover in this place and how it changes. I have had some great friendships, met some real characters here.

I mentioned former Speaker DeWeese. When he took the microphone and he teased us with his King's English, I do not know if there will be anybody that will ever step to a microphone in this building again that did what he did. And it would be so hilarious that he would be on a roll and then he would stop for a minute and go, "Is that a word?" You know, because he created these words, and it was very entertaining to say the least.

But like I said, it is, you know, there have been a lot of people come through the place, and we have lost a lot of good friends, obviously. It does not seem like 20 years is a lot, but it is a big chunk of your life when you think about it. When I came in, there were 11 Democrats, 11 Republicans. My classmates that are left, on the Republican side, are Julie, Sandy, and Gene, and over here on the Democratic side: Chris, Joe, and Harry. I have been here so long that I knew when Tony DeLuca had jet-black hair and Harry Readshaw actually had hair.

I would like to thank my staff, obviously, for all the hard work that they do. They have been great people to work with, and I have to – Marilyn and Steve and Chuck here in Harrisburg, they have been great to work with. And my wife, Amy, obviously will be happy because I will be home more. At least I will be home to roost. I will not be there during the day too much.

But I have to say, wife Amy and office Amy, because my one assistant in my Patton office is named Amy. So when people call and she answers the phone, "Representative Haluska's office, this is Amy. Can I help you?" they go, "That's pretty nice that your husband can get you a job there." You know, she goes, "No, I'm not wife Amy. I'm office Amy." So I have an office Amy and a wife Amy.

My staff in the home office obviously are Amy – she has been with me the whole 20 years – Trudy, Sherry, and Agnes. I just commend them for a job well done. They have gone out of their way when we have kids' fairs, senior fairs. They go out of their way to make them the best they possibly can, and they were great people to work with, great people to work with.

And then everybody asks me, "Well, what are you going to do?" Well, when I took this job, I was 44, and I figured when

I am 64, that is pretty much it. My father came here when he was 64 and stayed for 14 years, and I just cannot imagine doing that. Today that would be really tough. But I do have a lot of interests, obviously. Through the help of DCNR (Department of Conservation and Natural Resources), we were able to create the Rock Run Recreation Area, and Kurt Masser is doing the same in his area now. He is creating the anthracite area up there. I chair the board there, and that is a 6,000-acre piece of ground that we have open for ATVs, side-by-sides, dirt bikes, and Jeeps. We are in our eighth year, and it has been a really successful venture, and it is a nonprofit. So that has worked out really well. That is a great project that we were able to do. I obviously have raced all my life, so I have some classic cars to fix for people when I get back there. So I have lined that up. That is no problem.

And my son and his daughter live down the street, and I have three grandkids. I have Brennan, who is 14; Ryan is 11; and Ava is 6. They hunt. They fish. They ride quads. They are in basketball, football, baseball. So I will have plenty to do besides hunting, golfing, and whatever else I do. But I am going to miss the people, like everybody said. It is something that you build relationships with a lot of people over the years. There are trying times here, that is for sure, but after it is all said and done, there are a lot of things to do and talk to and go out to dinner and have a sandwich with people. It has been very entertaining.

And again, Bob, I thank you because you made the Tourism Committee what it is today, and you have done some great things. As we went around the countryside, the winemakers had issues. We came back and got legislation done so they could do sampling and everything at their wineries. We saw some amazing things, and this State is amazing. I just hope that we continue to market Pennsylvania.

And as I leave you, I will just borrow a line from a John Denver song. Take me home, country road, back to a place where I belong, Patton, Pennsylvania.

The only thing I could think of when you said that is at least he never co-opted you into going and buying shirts and ties wherever Tony gets his stuff.

But I congratulate you on your years of service and present you with this gavel to commemorate your time here. God bless you.

The SPEAKER. For what purpose does the gentleman from Delaware County, Mr. Barrar, rise?

Mr. BARRAR. Mr. Speaker, I would like to thank the members for their unanimous support of this resolution. I wanted to inform them that this resolution deals with the Chair of Honor for POW (prisoner of war) and missing in action. There will be a formal dedication of this Chair of Honor Wednesday at 9:30 in the rotunda, and I would ask as many members to attend as possible. We will have members, about 15 members from the Rolling Thunder group will be here on that session day to do the formal dedication of this Chair of Honor.

FAREWELL ADDRESS BY MR. STERN

The SPEAKER. I would like to invite Representative Stern to the dais.

Jerry has served the 80th Legislative District of Blair County for 22 years, having been elected in 1992. He currently serves as chairman of the House Tourism and Recreational Development Committee. Jerry served as the House Republican caucus secretary and is a member of the House Appropriations, Agriculture and Rural Affairs, Children and Youth, Health, and State Government Committees. Prior to his election of the House, Jerry was Blair County's prothonotary and clerk of courts. He and his wife, Susan, reside in the Martinsburg area. They have two children and two grandchildren.

If I could please have the members' attention.

Representative Stern.

Mr. STERN. Thank you very much, everyone. I promise that I will not be any longer than caucus today.

I just wanted to let you know my mother always watches these proceedings. She is watching today, so hi, Mom. She is 88 years old, still living back at home, and I just wanted to say hello to her this day.

Psalm 118:24 said, "This is the day that the Lord has made; we will rejoice and be glad in it." So just remember that whenever we are voting here later on.

In 22 years there are so many stories that I could tell, and time does not allow me to do that today+

. So I will tell them when I go home and lecture to college and high school students. And I am sure that the stories will become more interesting with the length of time from my departure from the chamber.

I would first like to acknowledge my wife of 36 years, Susan. And if you would stand please, Susan. Without her support, I would not be standing before you at this moment. Honey, thank you for all your patience, your understanding, and your love.

Next, our daughter, Gretchen, is here with me today and her husband, Joe, and our two granddaughters, Evalyn and Ella. If you would not mind standing at this time. And she always steals the show no matter where we go. Our son just got married over the weekend, and he is in St. Thomas, so he unfortunately could not be here today. So we wish him well also.

Our staff, they work for us. They work very hard each day to answer the complaints and solve the problems that occur within State government, and I am very blessed and fortunate to have loyal and professional individuals that set a high level of excellence in serving the public.

With me today is my district staff. I will have them all stand and I will acknowledge them: Jody Gahagan; Meghin Kerila; and former staff members Ray Nycum and J.E.B., Joan Barr. Also, Susan and Carol Peterman could not be here today, but I thank them for their service. And I would like to thank them for their work in helping others, the good times we shared, the many fond memories that we have treasured within our hearts.

Also, my executive director on the House Tourism Committee is here today, and that is Allen Taylor, and I appreciate the job Allen has done for tourism. Representative Haluska took my remarks earlier for tourism, so we will not go over them again. But also in Harrisburg serving with me – if my Harrisburg staff would please stand – are Laura Wagner-Miller, Nancy Cole, and Tricia Lehman is also part of the staff. I would like to thank them for their support, and I am very grateful for their talent. They made each day memorable, and I appreciate their friendship, their loving friendship.

In this chamber, this institution is only as strong as its weakest member. Never forget that. While we may disagree on many issues, I urge each member to consider what we do because it reflects on the whole body. The media only paints a broad brush when reflecting on members of the House and Senate, so always remember, like the gold sheathe that you see surrounding us throughout the Capitol, polish and keep clean the title that you have been given, which is the honorable so-and-so.

When I first arrived, I was amazed at the beauty of this building and over the years began to study it in greater detail. I always kid everyone that I do not want to come back to the Capitol as a lobbyist; I want to come back as a tour guide.

Penn's vision for Pennsylvania still holds true to this day. He said, and it is inscribed on the interior of the dome out here, "There may be room there for such a Holy Experiment. For the

Nations want a precedent and my God will Make it the Seed of a Nation. That an example may be set up to the Nations. That we may do the thing that is truly wise and just."

When I would take tours and the guides would tell me that the dome weighed 52 million pounds and stands 272 feet high, I often wondered, who weighed it? And was there a tape measure that long? But if you think about how this Capitol was built without the modern equipment that we have today and the scaffolding and so forth, this building is an amazing, beautiful structure. Treasure it.

Many an evening we spent here all night in this chamber debating legislative issues or budgets, I would count "The Hours" as we look up here, representing the circular passage of day and night in Edwin Austin Abbey's mural above us. Then I would fix my eyes behind us here on the 28 prominent State figures that are behind me, William Penn in the center with Benjamin Franklin and Representative Robert Morris behind him, and the 29th figure, of course, at the top named the Genius of State. These murals tell a story in this chamber. There are 43 murals that are located in the Governor's reception room, the Supreme Court chamber, and the Senate, and they tell another story about the gifts and the talents of a wonderful woman by the name of Violet Oakley. She spent 25 years of her life painting these murals, from 1902 to 1927. This was before women had the right to vote. The Assembly was all male. She was a woman of faith and believed all were created equally and supported the cause of the 19th Amendment to our Constitution, the right of women to vote, which was ratified on August 18, 1920. She is an exemplary model to demonstrate what someone can do when the world tells them they cannot.

We sometimes ask ourselves, and everyone does, what is our true purpose in life? Who am I? What am I meant to do here? What am I trying to do with my life? These are powerful questions that can be difficult to answer at times. They sometimes surface during major life transitions, such as family strife, job losses, spiritual awakenings, or even the death of a loved one.

I feel fortunate to have found my purpose in life. I have that reason to get up in the morning, and it fuels my passion, to encourage others into realizing that everyone is unique, there is only one of you. You have many precious gifts, talents, and skills that no other person possesses. God gave unique characteristics to each and every one of us.

Albert Schweitzer said it well, "I don't know what your destiny will be, but one thing I know: the only ones among you who will really be happy are those who will have sought and found how to serve."

This sums up why just about every one of us ran for public office, to serve.

Our days pass by too quickly, but we remember moments. I read recently in a book about success that we race to be better or best; we sometimes lose sight of just being. And just being, just soaking it in and savoring a beautiful moment, can provide life's greatest pleasures: a crackling fire on a cold, winter night; a good book; a love letter from your spouse – hint, hint, Honey – or a timeless moment with your child or a friend. These moments, if we stop long enough to enjoy, are the true essence of life.

Success is a very personal thing, but I think most people would agree that true success is about being fulfilled in life. It is that feeling of deep satisfaction that starts in your soul and radiates through your being. The end result is true happiness

and peace of mind. There is no greater feeling than to look back at your life with a smile in your heart, knowing that many of your dreams came true and that you made a positive difference in someone else's life.

"Do not save your loving speeches"— There is a poem by Anna Cummins, and it goes like this: "Do not save your loving speeches for your friends till they are dead; do not write them on their tombstones, speak them rather now instead."

A constituent of mine back home, Tom Kunkle, a former music teacher in the Hollidaysburg Area School District, shared a gospel track that I listen to when I come to Harrisburg during my trips. The lyrics for the one chorus of the one song go like this. It says, "Loving God, loving each other, making music with my friends; Loving God, loving each other, and the story never ends."

This chapter for me ends as a new chapter begins for me. I want to thank my friends in this chamber and those that I have been privileged to work with over the years, and I want to thank you for the music and the many songs that we wrote together. God bless each and every one of you.

In the context of your job, you have always exemplified and demonstrated your love and your respect for this institution, that no matter what the issues were that we were dealing with, that first and foremost was the House, the legislative body of government, and the importance that it has in our governing system, and that keeping it in high respect, in high regard, was always first and foremost in your mind, even beyond your own personal legislative agenda or the issues that you would normally want to advocate or advance.

And I think that that is a bold and needed element of one's approach to this job, that it is bigger than any of us as individuals, and you have demonstrated that over the years. I hope that as your next chapter begins, that it will be a pleasant and exciting one just like this one has been.

I also want to present you with the commemorative gavel to mark your service to the legislature. God bless you and good luck.

And just to refresh our colleagues' memories and the people back home, on any given day we combat nearly 3,000 of these deviants exchanging the most vile child pornography one can imagine on the Internet, and every child in those pictures has been in some way sexually exploited and may be in continuous or imminent danger.

This bill passed unanimously in the House. The Senate amended it. They changed one small part. In the bill under the House version, my version, the Internet service provider could disclose to the subscriber that a subpoena had been issued unless a court order prohibited it, and the Senate just changed that to automatically prohibit disclosure for 90 days unless the court permits it.

Mr. Speaker, the child sex predator arena is fluid and growing. This is a big win for our children and a huge setback to sexual predators. With this extra tool in our law enforcement's toolbox, if we get this on the Governor's desk, we can let the word go out from here that if you are a child sex predator preying on our youth on the Internet, we are coming after you.

I ask my colleagues to support this bill on concurrence. Thank you, Mr. Speaker.

It does not remove the original designation of "qualified tax collector" throughout the bill but removes the exemption for county treasurers that fill in for a vacancy in office. This deletion causes some confusion because only treasurers are exempt from the bill based on the definition of "tax collector." They would also be exempt from having to receive the training if the vacancy is less than a year.

It changes the appropriation language to make a line item in the budget – originally the program was to be paid for by the Governor's Office – and deleted the section that requires checks being used to pay for taxes to be made out to an office, title, or position, not in the name of an individual, along with the

requirement that tax bills come with a notification of how to make out your payment. Having the checks being made out to the individual has been identified as the biggest source of fraud by tax collectors.

And I will tell you this, that we are planning— Myself and another Representative will be working together on this bill to make it happen next year, to make that correction, but I urge the members for an affirmative vote.
