TEAMS PRESENTED**

The SPEAKER. At this time it is now my pleasure to present citations to the North Allegheny Girls Tennis Team and the Boys Cross Country Team. Having not one but two championship teams from the North Allegheny School District is a distinct honor and a source of great pride for the community I personally represent.

With us today we first have the North Allegheny Girls Tennis Team, who finished a perfect, undefeated season by winning the PIAA Class AAA State Championship in October. In the State championship final, the Lady Tigers defeated Shady Side Academy's team by a score of 3 to 1. The victory capped a second straight undefeated season and State championship for the North Allegheny girls.

Along with us today are also members of the North Allegheny Boys Cross Country Team, who captured their 12th overall PIAA title in November, with a dominating 47-point victory in the State championship meet. This season also marks an incredible 10th straight WPIAL District 7 Championship for the Tigers, and the victory in the State championship meet was a team effort with 7 runners finishing in the top 60, including 2 of the top 5.

And while we have many of the members of the boys cross country team, on the rostrum here with me are Matt McGoey, Scott Seel, Hunter Wharrey, Jacob Stupak, and Zack Deible – the head coach being John Neff. I also have from the tennis team, coach Michelle Weniger. Both of these coaches are outstanding mentors and role models for their respective teams.

I also have with us the assistant coach, E.J. Robertson, and the rest of the teammates in the back. If all those individuals – I see you are standing. Thank you very much.

In recognition of the outstanding achievements of these two State championship teams from North Allegheny School District, I am honored to present them with these citations, and I invite the full House to congratulate them with me. Thank you.

**STATEMENT BY MR. ROZZI**

The SPEAKER. I would like to recognize Representative Rozzi on HR 59, National Girls and Women in Sports Day. Representative Rozzi, the floor is yours.

Mr. ROZZI. Thank you, Mr. Speaker.

Today is National Girls and Women in Sports Day. I felt compelled to introduce this resolution because I have a daughter, and she is my only child—

The SPEAKER. Sir, hold on just for a second.

If we could, please clear the aisles and give the good gentleman full opportunity to present his remarks. Please clear the aisles, take your seats. Representative Rozzi, just give us a second.

Mr. ROZZI. Thank you, Mr. Speaker.

The SPEAKER. We have a very short day today. Thank you. Representative Rozzi, please, the floor is yours.

Mr. ROZZI. Thank you, Mr. Speaker.

Very quickly, today is National Girls and Women in Sports Day, and as a father of my only child, McKenna, who has played many sports – and I really say this to my wife. My wife was an incredible fast-pitch softball player. She also coached basketball. She coached, I think, two of her teams to county championships. She coached one of her fast-pitch softball teams to a State championship that my daughter played on.

The reason I am bringing this up is that, yes, we have women who are great athletes in our State like the Betsy Kings who have won six major championships; Allison Schmitt from Pittsburgh, who was a six-time Olympic medalist; Dawn Staley from Philadelphia, who won the basketball summer gold in '96, 2000, and 2004, was asked by the Olympic team to carry the United States flag in 2004, which is quite an accomplishment; and then we also have somebody like Mo'ne Davis, who really is a role model for our young girls that are coming up. And we also have—

And every one of us in our district have girls that do not go on to the WNBA (Women's National Basketball Association), who do not go on to be professional athletes, who go on to maybe bigger and better things, and I just wanted to point out one of those girls in my district. Her name is Jarra Rusnock, who was born and raised in the 126th, went to Albright College, and when she left Albright College in 1998, she was the leading point scorer with 1,642 points. She was an Academic All-American and she decided to go into teaching. She is a teacher in one of our public schools, teaching chemistry, and is teaching our kids everything that she learned coming up about success, about teamwork.

And bringing it back to Mo'ne Davis, why is it so important for our girls to have this opportunity growing up? Because it is really, it is teaching them about leadership, it is building confidence in them, and that is what we need for these girls moving forward.

We often talk about Title IX and that we should be giving them every opportunity, and you know, we are looking at the school districts to make sure that they are doing that. I do not think that is the right approach because I know all our schools, public or private, understand that we are offering the girls these programs in our schools, but a lot of the problems that I am seeing are with the coaching. A lot of times, you know, I have calls from my parents in my district that maybe the coaches are verbally abusing the girls and that girls are quitting. I think we need to take a look at that a little bit more than Title IX and making sure that we are offering them everything; that what we have in place, let us make it better for them.

So congrats to all the women in this hall today, the tennis team. Thank you for playing sports and being a role model for all our girls in the future. Thank you, Mr. Speaker.
