### ARCHBISHOP WOOD HIGH SCHOOL FOOTBALL TEAM PRESENTED

The SPEAKER. We are going to move to citation presentations first today, members. Representative Bernie O'Neill of Bucks County and Representative Murt, Tom Murt, of Montgomery County are invited to the rostrum for the purpose of presenting a citation to the Archbishop Wood High School Football Team. Thank you.

Mr. MURT. Thank you, Mr. Speaker.

Mr. Speaker, I am very pleased and proud to join my colleague, Representative Bernie O'Neill, and fellow Archbishop Wood graduate, Representative Marguerite Quinn, in recognizing the football team from Archbishop Wood High School this morning—

The SPEAKER. Members, please take your seats. We do have players from Archbishop Wood High School Football Team here, and I would like everybody to please take your seats before I turn the rostrum over to Chairman O'Neill.

Chairman O'Neill, the floor is yours.

Mr. O'NEILL. Thank you, Mr. Speaker.

Mr. Speaker, it is my true honor and pleasure to stand before you for the third time in 4 years to honor the champion Archbishop Wood PIAA 2014 Champions. This is the third year out of 4 straight years that they have been here as champions. I might also add that they were in the championship game the one year that they did not make it. So 4 years in a row, the seniors who are graduating this year played in the State championship 4 consecutive years.

Before I turn it over to Representative Murt – and I am going to let Representative Murt, who is an alumni of Archbishop Wood, do the honors of introducing the team – I just want to note that on stage with me today is Jake Cooper. Wave, Jake. Jake is going to be continuing the Linebacker U tradition at Penn State. Ryan Bates. Ryan is going to go fill in— There you go. Ryan is going to fill in the much-needed offensive linemen that they need at Penn State. And Jarrett McClenton, who will be attending the champion team in Villanova. Raise your hand there.

We have a very special coach with us today. The coach with us is John Shulby, who is assistant coach with Archbishop Wood. John had a unique honor at this past Saturday's Blue-White Game at Penn State. He led the Penn State team out of the dugout, or not dugout, out of the runway there – tunnel. There you go. I got it right. Thank you. Out of the tunnel with Coach Franklin.

With that, I am going to turn it over. I will say one thing. There is a young man on this team, David McDonald, back there. David, raise your hand. David's father played football for me at William Tennent High School and was one of my former students. So it is nice to see David here.

Representative Murt is now going to introduce the team, but I want to point out that Representative Murt has a young gentleman who is special to him on this team, and that is Nolan Murt, his nephew. Raise your hand, Nolan.

Representative Murt.

The SPEAKER. Representative Murt, you are recognized. If you could please also introduce your fellow colleagues.

Mr. MURT. Before I commence with my remarks, I also want to introduce the head coach of the varsity football program at Archbishop Wood and a teacher in the business education department, a man who has brought great honor to the Archbishop Wood community, head coach Steve Devlin.

I also want to mention that my nephew, Nolan Murt, will be attending and playing football at the University of Massachusetts Amherst in the fall.

Mr. Speaker, the seal of the Archbishop Wood Catholic School is a shield bearing a cross with green ivy and a gold crown superimposed. When translated, the motto beneath the seal reads, "Faithfulness Merits the Crown." The students at Archbishop Wood learn early that faithfulness means not only fidelity to one's faith and religious convictions but to the principles of excellence, whether in the classroom or on the field of competition. That is how Archbishop Wood became renowned for its academic excellence and respected in the athletic arena, where it often dominates its competition. Its student athletes display a commitment to achievement and its coaches a dedication to their players' physical and emotional maturity.

This was never more clear than in December when the Archbishop Wood Vikings won their third PIAA State Football Championship in 4 years by decisively defeating the Central Valley Warriors at Hersheypark Stadium.

While Central Valley kept the game close, they could not stop Archbishop Wood's rushing offensive machine. Senior Jarrett McClenton moved for 230 yards and four touchdowns to beat Central Valley 33-14 to the exhilaration of Archbishop Wood alumni like myself and Representative Marguerite Quinn.

As a loyal Archbishop Wood graduate, I can say that the players who leave the school this year will do so with more than a championship. These students have learned lessons that will see them through their lives. They set ambitious goals for themselves and experienced the thrill and satisfaction of achieving them. They each set personal bests and gained confidence in their abilities, which are all critical lessons needed for successful achievement as parents, teachers, workers, and entrepreneurs.

To reach this level, these young men have overcome adversity and failure, yet stayed loyal to their brothers on the field. In the face of great challenge, these young men struggled on, worked as a team, illuminated each other's strengths, and compensated for each other's weaknesses. They have remained faithful to their coaches, to their teammates, and to their school. And as their motto suggests, that faithfulness merited each of them the crown of excellence.

I speak for all my colleagues when I say congratulations for a job well done.

### NEW HOPE-SOLEBURY GOLF TEAM PRESENTED

The SPEAKER. Representative Scott Petri of Bucks County, as soon as we exit our championship football team, Representative Petri will be inviting to the rostrum the New Hope-Solebury Golf Team. He will be presenting a citation.

Members, if you will please take your seats, we are going to have a citation presentation.

I would like to turn the rostrum over to Representative Scott Petri.

Mr. PETRI. Good afternoon, ladies and gentlemen, and welcome with my Bucks County colleagues, the New Hope-Solebury Golf Team, the Lions, who are the Class II golf champions in golf.

I want to tell you a little bit about the game of golf. I am sure we all saw Jordan Spieth and his masterful win at the Masters, where he showed an intellect, a confidence, and a maturity that we do not expect. But the truth is, Jordan Spieth has been competing at that level for a long time and so have the members of the New Hope-Solebury Golf Team.

These are athletes who can block out almost any condition, almost any circumstance, walk away from a bad shot and make the next shot good. Their games are so honed that we are envious of them. I have seen some of these players from 185 yards be disappointed with a shot that lands a mere 10 yards from the pin. I wish I could play golf at that level.

This particular team won at the Heritage Hills Golf Club in York under extremely poor conditions, heavy winds and heavy rains. This is the third title for New Hope-Solebury in any sport, so we are particularly proud of their accomplishments. They were underdogs going into this final, being ranked five out of six teams, and yet the team score demonstrated that not just one, two, three, or four players but the entire team came in.

Now, to tell you how close this final match was, the score was New Hope-Solebury 333, Sewickley Academy, 334 – just one stroke behind – and York Catholic, 336. Three strokes, the difference between first and third.

Amongst the individuals behind me is senior Roland Massimino. He led the team with a 1-over 72 on a par-71. It was the best round among AA boy golfers by 10 strokes. Senior Andrew Bove had an 83, and given the conditions, that was a phenomenal score. Freshman Nina Kouchi, the only girl on the team, had an 84. Third straight District I Golf Championship win for New Hope-Solebury.

Roland Massimino won the District I Individual Boys Golf Championship. He finished second in States among boys. He has received a Division I golf scholarship and will play for Kansas State next year. He is also Intelligencer Golfer of the Year for the second year in a row.

Nina Kouchi won the District I Individual Girls Golf Championship. She finished sixth in the State.

This is a team sport, make no mistake, and so the members in the back and those up front stand and give a wave as I call out your name. There are 13 players, 5 seniors: Andrew Bove, Jacob Cimbalista, Avery Jones, Max Masino, Roland Massimino. We have four sophomores and four freshmen and head coach Brian Demby. The athletic director is also with us, Ted Harrington. Vickie Behlert could not be with us.

If the members would kindly give a round of applause for the State champion AA golf team as I present the citation to the coach, and congratulations to all the members of the team. Thank you.

### BETH ANNE GALLAGHER PRESENTED

The SPEAKER. Representative Santora, Representative Adolph, and Representative Barrar, you are invited to the rostrum for the purpose of presenting a citation to Beth Anne Gallagher.

Mr. SANTORA. Thank you, Mr. Speaker.

I rise today to honor an educator who has been nationally recognized as one of the best in her profession. Mrs. Beth Anne Gallagher teaches sixth grade English, language arts, and religion at St. Dorothy—

The SPEAKER. Please suspend for just a second.

Members, members, if we could, please let us give Representative Santora our full attention.

His guest and the guest of Representative Adolph and Representative Barrar has been recognized for a very distinguished award, and we would like to pay her homage here today. So thank you very much, Representative Santora.

Mr. SANTORA. Thank you, Mr. Speaker.

Mrs. Beth Anne Gallagher teaches sixth grade English, language arts, and religion at St. Dorothy Roman Catholic Church and School in Drexel Hill, my alma mater. The National Catholic Educational Association recently presented Mrs. Gallagher with the Distinguished Teacher Award, an award given to a teacher in nine geographic regions across the United States who demonstrates outstanding dedication to learning and improving their students' educational experience.

Mr. Speaker, this is one of the highest honors bestowed upon Catholic school educators nationally. Those who know Mrs. Gallagher are not at all surprised that she received this honor. Mrs. Gallagher's peers describe her as a tireless worker who constantly thinks of fun and creative ways to engage her students. She is always looking for new and exciting ways to help her students succeed.

Two examples come to mind that really exemplify Mrs. Gallagher's skill at encouraging her students to grow in the classroom and in the community. One example is her Pay It Forward project, which is modeled after a book of the same name. Mrs. Gallagher reads a modified version of the book to her students, then asks the students to perform three service projects so that they can go out and make their own mark on the world. The students are tasked with researching service organizations, writing essays, maintaining journals, and ultimately going out into the community and performing their service activity. Some students volunteered at soup kitchens. Others did yard work for seniors, and some spent time weekly visiting veterans. Some students even made dresses out of pillowcases to send to girls in Africa.

Another example occurred just several weeks ago when Mrs. Gallagher heard about a pizza shop in Philadelphia that was running its own Pay It Forward promotion. The pizza shop was encouraging customers to contribute a dollar toward a pizza for individuals in need of food. After paying the extra dollar,

customers stick a Post-it note on the shop's window. A person in need of a meal could then come in and exchange a Post-it note for a piece of pizza. Mrs. Gallagher took her class into the shop so that they could see firsthand this happening.

Mr. Speaker, it has been said that "the mediocre teacher tells, the good teacher explains, the superior teacher demonstrates, and the great teacher inspires." Mrs. Gallagher is not only a world-class educator and a role model, but she is an inspiration to her students and everyone in her community.

Mr. Speaker, on behalf of my colleagues, it is my distinct pleasure to present Mrs. Beth Anne Gallagher with a citation from the Pennsylvania House of Representatives recognizing her outstanding work and influence on the lives of so many students.

So I want to thank my colleague, Representative Lewis, for bringing to our attention and having Mr. Williams here with us this afternoon. Thank you, Mr. Williams.

**STATEMENT BY MRS. HARHART**

The SPEAKER. Representative Julie Harhart is recognized to speak on HR 216. Chairman Julie Harhart.

Mrs. HARHART. Thank you, Mr. Speaker.

I would like to thank you all for your affirmative vote on HR 216, designating May 9, 2015, as National Association of Letter Carriers Stamp Out Hunger Food Drive Day in Pennsylvania.

This remarkable event is the nation's largest single-day food drive. Our local carriers, our citizens, and the countless food banks throughout the Commonwealth have been so successful in providing food to those in need. We are very thankful for their efforts.

Before I get to the next resolution speaker, Representative Wheatley, Representative Kim, Representative Kinsey, if you want to bring your guests down to the front, please feel free to bring your guests down to the front.

**STATEMENT BY MR. MURT**

The SPEAKER. Representative Tom Murt is recognized to speak on HR 137. Representative Murt, the floor is yours.

Mr. MURT. Thank you, Mr. Speaker.

Mr. Speaker, in 2006 Pennsylvania became an example to the rest of the nation when it became the first State to provide hospital-based education on shaken baby syndrome in 100 percent of all birthing and children's hospitals. In the United

States every year, as many as 3,750 infants and young children are diagnosed with shaken baby syndrome. Tragically, one-third of those victims die as a result of direct brain injuries. That is why it is so important that we acknowledge April 19 to 25 as Shaken Baby Syndrome Week in the Commonwealth of Pennsylvania as a way to educate our parents, other extended families, and babysitters on how delicate young children are.

Shaken baby syndrome is caused by a vigorous shaking of an infant or young child by the arms, legs, chest, or shoulders. Forceful shaking can result in brain damage leading to intellectual or developmental disabilities, speech and learning disabilities, paralysis, seizures, hearing loss, and even death. It may cause bleeding around the brain and eyes, resulting in blindness. A baby's head and neck are especially vulnerable to injury because the head is so large and the neck muscles are still weak. In addition, the baby's brain and blood vessels are very fragile and easily damaged by whiplash motions such as shaking, jerking, and jolting. Shaken baby syndrome is difficult to diagnose, unless someone accurately describes what happened.

Dr. John Caffey, who first described shaken baby syndrome in 1972, called for a massive public education program to describe the dangers of shaking infants. Some experts believe that the shaking is primarily the result of an angry adult who loses self-control and that the perpetrator is aware of the potential harm to the child. Others believe a lack of knowledge about the dangers of shaking is a contributing factor and that most people do not intend to harm or kill children by shaking them. But, Mr. Speaker, that is why physicians, social workers, attorneys, educators, families, and others should collaborate to educate the public about preventing shaken baby syndrome. Other proposed strategies to reduce the problem include identifying families at high risk for abuse, and providing supports to reduce stress, and funding and monitoring high-quality child care so that parents leave their children with safe caregivers.

In conclusion, Mr. Speaker, my hope is that by recognizing shaken baby syndrome, we as legislators and policymakers will draw attention to the hundreds of children hurt or killed by thoughtless parents and guardians. This is an injury that can be avoided.

I thank my colleagues for their support. Thank you, Mr. Speaker.

Mrs. WARD. Thank you, Mr. Speaker.

Each year my fellow nurses and I celebrate Nurses Week, which is always May 6 through May 12 and is held in conjunction with Florence Nightingale's birthday. Florence Nightingale was the founder of modern-day nursing. She was a woman of faith and a deep belief that she could make a difference. At a time when no woman was working in the field of nursing, she was a trailblazer and a woman of action. She was also quoted as saying, "I think one's feelings waste themselves in words; they ought all to be distilled into actions which bring results." The Pennsylvania State Nurses

Association and other nursing organizations help nurses of this Commonwealth in achieving this laudable goal of Florence Nightingale.

Gallup polling has annually announced their most trusted and ethical professional poll, and for the past 13 years, the public has voted nurses as the most honest and ethical profession in America. This year 80 percent of Americans rated nurses' honesty and ethical standards as very high or high, 15 percentage points above any other profession.

Pennsylvania hosts the fifth largest population of nurses with over 218,000 registered nurses, 55,000 licensed practical nurses, and 12,000 advanced practice registered nurses, which makes nursing the largest licensed health-care profession in the Commonwealth.

As a registered nurse myself, I am acutely aware of the vital role nurses play in our constituents' lives. Nurses are the backbone of this system and the catalyst to ensuring that Pennsylvania has the best health-care delivery system in all of the United States.

Thank you to my colleagues in the State House of Representatives for joining me and Representative Ravenstahl in recognizing the selfless service of Pennsylvania nurses, the associations that represent nurses, and the overall importance of quality nursing care. Thank you so much.

Today is Pennsylvania Freight Rail Day, and I thought it was apropos to bring this resolution up today.

The freight rail industry is the backbone of America's economic vitality and growth, and it is instrumental in bringing American goods to market both nationally and internationally. This undervalued industry has been serving the American people since 1830 and was essential in helping the country achieve the ideal of manifest destiny, but it has never been more important than it is today.

Each year freight rail moves approximately 40 tons of goods over 140,000 miles of track for every person in the United States. The food we eat, the cars we drive, the raw material we use to build our homes and operate our businesses undoubtedly have all been moved across the country on freight rails.

Freight rail also serves an important role in exporting quality-made American goods across the globe, and in an age where the environmental impact of any product may concern consumers, freight rail offers many benefits. Over the years freight rail has evolved to become one of the most fuel-efficient means of transporting goods. One gallon of diesel fuel is able to transport one ton of freight close to 500 miles, a feat no

long-haul truck can even come close to matching. Due to the fuel efficiency improvements that the industry championed, freight rail has consumed 69.8 billion fewer gallons of fuel and emitted 781 fewer tons of carbon dioxide since 1980.

In addition to the freight rail's environmental benefits, it also keeps our citizens working. The industry employs almost 200,000 people nationwide with 13,000 of those good-paying jobs located in the Commonwealth, many of which in my legislative district.

Additionally, this economic steam engine has reinvested over \$500 billion, that is "B," billion dollars in revenues towards equipment, maintenance, and rail expansion since 1980. Pennsylvania has the distinction of having more operating railroads than any other State. So I believe this resolution, honoring the industry's achievements and future, is appropriate.

Once again, I thank you for your support on this issue. And thank you, Mr. Speaker.

### MOTION TO SUSPEND RULES

The SPEAKER. The gentleman, Mr. Carroll, offers—I apologize; I see a motion.

Members, if we could have your attention, please.

The gentleman, Mr. Carroll, is called upon to make a motion to suspend, I believe.

Mr. CARROLL. Thank you, Mr. Speaker.

Mr. Speaker, I move that the rules of the House be suspended to consider my amendment to HB 160.

The SPEAKER. Sir, what is the number of the amendment that you want to— Amendment 623 is the amendment that Representative Carroll would like to offer, but it does require a suspension of the rules. He is moving to suspend the rules to allow for a vote on amendment 623.

On the question,  
Will the House agree to the motion?

The SPEAKER. At this time I would call upon Representative Mackenzie.

Mr. MACKENZIE. Thank you, Mr. Speaker.

I appreciate my colleague's amendment that he is offering here today. I have discussed it with him and many stakeholders who were involved in this process at length. Unfortunately, there is not an agreed-to way to approach the issue that he is trying to deal with in this amendment, and in speaking to the stakeholders involved, I think a lot more discussion needs to go on around this specific topic.

And also, specifically, this bill, the bill that is before us, deals with fraud prevention measures, measures which should be taken to protect our taxpayers across the Commonwealth, and the amendment that is before us deals with the continuing education requirement for tax collectors, something – a different topic.

So I would ask for a "no" vote on the suspension of the rules. Thank you, Mr. Speaker.

The SPEAKER. The good gentleman from Lancaster County, the majority whip, Representative Cutler, is called upon.

Mr. CUTLER. Thank you, Mr. Speaker.

Mr. Speaker, I, too, would urge a "no" vote on the suspension of the rules for the consideration of this amendment. As the good gentleman has already outlined, there has been an extensive amount of work put into this product. I think that product should carry forth, and given the fact that there are continued discussions and dialogues regarding this very topic, where it is better suited, I would urge the members for a "no" vote. Thank you, Mr. Speaker.

The SPEAKER. The Speaker recognizes the minority leader, Representative Dermody, on the motion to suspend.

Mr. DERMODY. Thank you, Mr. Speaker.

Mr. Speaker, I would urge the members to support the motion to suspend the rules to consider this amendment.

This is just a simple commonsense amendment. It requires continuing education but requires 6 hours per term, per term for the elected tax collector. That means these tax collectors that are not getting reimbursed for this continuing education will get continuing education, will help them do their job better in a commonsense way that requires them to do it for every term for which they have been elected. It makes sense. We can suspend the rules. Let us consider this amendment right now and still provide a commonsense answer to a problem I think many of us have heard from our local tax collectors regarding the burdensome rules that are in effect right now.

Thank you, Mr. Speaker.

The SPEAKER. The maker of the motion, the motion to suspend, Mr. Carroll.

Mr. CARROLL. Thank you, Mr. Speaker.

Mr. Speaker, before us now we have a motion to suspend, and the motion really is a motion to suspend a mandate. You know, for those in this room that abhor mandates, here is your chance. This is a mandate that is imposed on our tax collectors that requires them to perform and obtain 6 credit hours of continuing education every year forever at a cost measured in the hundreds of dollars.

Mr. CUTLER. Mr. Speaker?

The SPEAKER. Yes, sir.

Mr. CUTLER. I believe the motion that we have before us is the suspension of the rules and not the body of the underlying amendment. If the gentleman could stay on task.

The SPEAKER. Yes; Mr. Carroll, please. The motion to suspend, depending on what the vote is on that, you would have more opportunity, but right now we are, please, please, limited to the motion to suspend.

Mr. CARROLL. Thank you, Mr. Speaker.

So the motion to suspend will give us the opportunity to unwind this mandate. Mr. Speaker, 6 credit hours per year forever—

Mr. CUTLER. Mr. Speaker?

Mr. CARROLL. —this bill gives us the opportunity to solve that today.

The SPEAKER. Representative Carroll, with all due respect, you are urging folks to vote "yes" on the motion to suspend. Is that my understanding?

Mr. CARROLL. Well, I have not quite completed the thought yet.

The SPEAKER. If we could, please, the motion to suspend. We will get to the underlying merits at the time if and when the suspension is addressed. Please, I would like to just narrow this discussion. We can take the vote and then we can proceed from there.

Mr. CARROLL. Okay, Mr. Speaker. Thank you.

So, Mr. Speaker, this motion to suspend will give this body a chance to vote on the underlying amendment that I offered. Mr. Speaker, absent this suspension, we will not have the chance to unwind this mandate. So this vote, Mr. Speaker, is the opportunity to consider the amendment that dials back this mandate, this continuing education requirement that was inadvertently approved by this chamber last session. This suspension—

## POINT OF ORDER

Mr. CUTLER. Point of order, Mr. Speaker.

The SPEAKER. Thank you very much. It is the second time. I think with all due respect to all the folks that may want to speak, we ought to proceed to this motion. Do you want to give just one last sentence on this, please. Thank you, and let us get to the vote.

Mr. CARROLL. Mr. Speaker, a motion to suspend is an opportunity to fix a flaw. This motion to suspend gives us the opportunity today to fix a problem that has been identified by the tax collectors of this Commonwealth. Please vote in favor of the motion to suspend if you are interested in solving a problem for your local tax collectors.

The SPEAKER. The prime sponsor of the legislation, Representative Mackenzie.

Mr. MACKENZIE. Thank you, Mr. Speaker.

Again, I would recommend a "no" vote on this suspension of the rules, and the reasons have been stated. But specifically to address the last speaker, my good friend, in his statements, the fact is that there is a bill, another bill, HB 823, which will be coming up – it is on the calendar in just a couple of weeks – that deals with this specific section of the Tax Collection Law. That is the appropriate place to address something like this.

And also, it should be noted again that tax collectors are divided on this specific issue. Some would prefer no continuing hours. Your suggestion is for 6 hours. Right now it is at 24. It is all over the map.

So again, unfortunately, there is not a resolution. I want to work with you to find a resolution that we can move forward, and I look forward to doing that in the future. Thank you.

The SPEAKER. The good gentleman from Dauphin County, Chairman John Payne, is recognized on the floor.

Mr. PAYNE. Thank you, Mr. Speaker.

Mr. Speaker, on the last vote I was trying to press "no." My button malfunctioned. I would like to be recorded in the "no."

The SPEAKER. Yes, sir. Representative Payne will be marked in the "no" on the vote for the motion to suspend.

#### MOTION TO RECONSIDER SECOND CONSIDERATION OF HB 160

The SPEAKER. Members, I have in front of me a reconsideration motion, signed by Representative Brandon Neuman of Washington County and the minority leader, Frank Dermody, of Allegheny County. It indicates that they move to reconsider the vote by which HB 160 was agreed to on second consideration. So it is moved by the gentleman, Mr. Neuman, seconded by the minority leader, that the vote by which HB 160 was agreed to on second consideration be reconsidered.

On the question,  
Will the House agree to the motion?

The SPEAKER. The parameters of this debate on this motion to reconsider are very narrow. I say that to all members on both sides of the aisle. This is not to get to the substance of the underlying legislation. It is a very narrow argument in terms of permission to discuss on the floor and remarks with respect to this particular motion to reconsider a vote.

At this time I will turn it over to Representative Neuman.

Mr. NEUMAN. Thank you, Mr. Speaker.

I think that this is an important opportunity for the House, for the members of the House that just voted in the affirmative on the last motion. This is an important opportunity for us to send the bill back to second consideration, which will then allow us to debate the amendment.

There is no rush on this bill. I do not see anybody standing up and saying that we need this bill tomorrow. I have not heard the Senate saying they need this bill by the end of the week. Let us try to do this properly. Let us try to do this correctly. Send it back to consideration. Allow us to have a full substantive debate on the Carroll amendment. This would send the bill back to second consideration, allow the House to do this, and be able to vote on the bill tomorrow or Wednesday, and then, still in a timely fashion, get it over to the Senate so that it can be finally passed in a corrected fashion. Thank you, Mr. Speaker.

The SPEAKER. The Chair recognizes Representative Mackenzie on the motion to reconsider HB 160.

Mr. MACKENZIE. Thank you, Mr. Speaker.

I would ask that we do not take up this motion to reconsider. The last speaker suggested that there is no rush on this legislation, and I would very politely disagree with that statement. Last session this same language was offered and it was taken out in the Senate. It passed the House unanimously, the underlying bill. It was taken out in the Senate, and in the intervening time period, it was found that over \$300,000 was stolen by a Spring Garden Township tax collector, and the Federal authorities found that the reason that the money was stolen was because checks were made out in her individual name. So the statement that we are in no rush is completely inaccurate. Tax moneys are being diverted, and if we do not take this up in a timely fashion and pass this bill, the possibility continues that more tax money will be stolen.

So, Mr. Speaker, I would ask for a "no" vote to protect taxpayers and eliminate fraud loopholes.

The SPEAKER. Representative Carroll is called upon on the motion to reconsider by Representative Neuman.

Mr. CARROLL. Thank you, Mr. Speaker.

Mr. Speaker, we have a second opportunity here with this motion to reconsider, and this opportunity again gives us the chance to dial back this mandate on our tax collectors. This motion would allow us to amend this bill without having to suspend the rules. So for those that voted because there is an objection to suspending the rules, this motion, which is a normal everyday transaction, gives us a chance to put this bill back on second and amend it without a suspension of the rules. So, Mr. Speaker, for those that are averse to suspending the rules that want an opportunity to help our local tax collectors avoid the pain of this unfunded mandate, a "yes" vote on the Neuman motion is the best way to proceed to allow us to solve this problem for our tax collectors. Thank you, Mr. Speaker.

The SPEAKER. At this time the majority leader, Dave Reed, of Indiana County is called upon on the motion to reconsider.

Mr. REED. Thank you very much, Mr. Speaker.

We would ask the members to oppose the motion to reconsider second consideration. We have a legislative process for a reason. Amendments are properly filed on second consideration. The gentleman had the opportunity to file his amendment on second consideration. Given the importance to him, he should have taken that opportunity instead of on third consideration.

We will and we are intending on running a bill out of the Local Government Committee within the next 2 weeks to rectify this issue anyway, so there is no reason to hold up the passage of HB 160.

And again, we would ask the members to oppose the motion for reconsideration. Thank you.

The SPEAKER. Thank you.

Representative Carroll, for the second time on the motion to reconsider.

Mr. CARROLL. I do appreciate the majority leader's observation about the second consideration amendment process. The reality is that not a single person in this chamber offered an amendment on second consideration for this bill that would have provided the relief that tax collectors throughout Luzerne County and the rest of the counties in this Commonwealth that have tax collectors had the opportunity to exercise. So he is exactly on point, but we have the chance today to fix that error.

We can support the Neuman motion, then we can run it on second and amend the bill without having to suspend the rules, and by doing so we overcome the shortsighted decision with respect to an amendment on second consideration.

Thank you, Mr. Speaker.

The SPEAKER. I think just two other individuals have asked to be recognized. I am going to let the maker of the bill go last.

So, Representative Neuman, if you want to speak for the second time on your motion, and then I am going to call on Representative Mackenzie and then I think we will proceed to a vote.

Mr. NEUMAN. Thank you, Mr. Speaker.

As we listened to this debate, and it is a good debate, we passed this bill unanimously out of the House, I believe so, with maybe one or two negative votes.

It is an important piece of legislation. It is important to catch any type of fraud that is happening with taxpayer dollars, but as an admission from the majority leader, there is a problem with the bill. We can fix the problem with the bill, only delaying it 1 day, and we can do that by supporting my motion, send it back to second. The Carroll amendment makes this a better bill before we send it over to the Senate.

So I am requesting a "yes" vote just to fix a portion of this bill that was inadvertently put in and is going to be an unfunded mandate on your tax collectors that cannot bear the burden of a lot of these credits and to pay for these credits—

The SPEAKER. Representative Neuman, if you might, just on this motion for now, please. Thank you, sir.

Mr. NEUMAN. Thank you for your indulgence, Mr. Speaker.

I request a "yes" vote on this motion. Let us do the right thing – send it back to second, get it out of the House this week, send it over to the Senate as a better bill. Thank you, Mr. Speaker.

The SPEAKER. Representative Mackenzie, on the motion.

Mr. MACKENZIE. Thank you, Mr. Speaker.

Again, I would ask for a "no" vote on this motion.

And I would like to correct the last speaker, my friend who made a statement that there was a problem with this bill. The problem is not with this bill. This is not something that is being addressed in my language or this bill that is here before us. The proposal is to make an additional change to correct language from last session with their suggested solution. However, after talking with all the different stakeholders, this is not the only solution to make this change. There are solutions of no credits of continuing hours of education, there are some for 3 hours, some for 6 hours. Some could change the price on the cost of the continuing education credits. So while this is one possible solution, it has not been agreed to by the different stakeholders who have been consulted on my bill, and at the same time, again, I am not sure that it is the best solution or the solution that is going to win out at the end of the day.

So I would ask for a "no" vote at this time to, again, move forward legislation which is suggesting and closing fraud loopholes, does have strong bipartisan support and agreement, and we can protect taxpayers across our Commonwealth. Thank you, Mr. Speaker.
