In our caucus we discussed this, and the word "traverse" seemed to cause a ruckus. I got the F.O.P.s (Fraternal Order of Police) involved, and currently the F.O.P.s and the lawyers here in the House are in agreement with the wording of this bill.

But just for the record, the legislative intent is this: This legislation is in response to a court case decided by the Superior Court in October 2014 that held that a police officer with Slippery Rock University did not have the authority to arrest a driver who was traveling through campus with a blood alcohol content of 0.11.

According to the court, the campus police from the State System of Higher Education only have primary jurisdiction over property that is directly owned, leased, or managed by the university. This means that campus police do not have the authority to patrol the roads through campuses or even public sidewalks.

This legislation is very simple. It would restore the ability of campus police to secure public roads, sidewalks, and trails through or alongside campuses. This legislation is very precise in outlining this. It only includes the portions of those public roads, sidewalks, and trails that touch university property. This does not mean that they have primary jurisdiction on the roads between buildings owned by the university, just on the portion of the roads that touch the campus.
