STATEMENT BY MR. EVERETT

The SPEAKER. Representative Everett will be recognized under unanimous consent.

You will be recognized again with respect to the resolution, but if these great heroes could stand for us, we would certainly appreciate it. Representative Gillen, we will be hearing from you shortly.

Located in the rear of the House, the Chair is honored to welcome, as guests of Representative Mark Keller, crewmembers of the USS Raby – right? – R-A-B-Y, Raby. And these distinguished World War II veterans are here today with their wives celebrating their 36-year reunion. Representative Keller, I presume you will be introducing them later with respect to a resolution, but at this time if those guests could please rise with Representative Keller, we would love to honor you. Thank you so much for being with us today. Representative Mark Keller told us that the USS Raby was a Buckley-class destroyer escort for the U.S. Navy, the United States Navy, and was named for Rear Adm. James Joseph Raby. It is just an honor to have these outstanding World War II veterans here today with us.

In the gallery, we welcome guests of Representative Schreiber, members of the National Auxiliary to the Veterans of Foreign Wars, and in particular, their president, Francisca Guilford. If you would please rise. If we could all give them a standing ovation as well. Thank you so much for being with us today.

RESOLUTIONS PURSUANT TO RULE 35

Mr. GILLEN called up HR 436, PN 2085, entitled:

A Resolution commemorating September 2, 2015, as "V-J Day" in Pennsylvania.

On the question, Will the House adopt the resolution?

The SPEAKER. At this time I am going to recognize Representative Gillen. If we could give him our undivided attention, please. He will be introducing some of our World War II heroes today.

Mr. GILLEN. Thank you, Mr. Speaker.

Seventy years ago this month the Second World War ended with the signing of the instrument of surrender on the USS *Missouri* in Tokyo Bay on September 2, 1945. The signatories of that document – for a brief word of background before we introduce our guests – were the United States, Japan, the Dominion of Canada, the United Kingdom of Great Britain and Northern Ireland, the Kingdom of the Netherlands, the Union of Soviet Socialist Republics, the Provisional Government of the Republic of France, the Republic of China, the Dominion of New Zealand, and the Commonwealth of Australia.

This generation has been called, and rightfully so, the Greatest Generation, and one could argue that singularly their victory over tyranny and fascism and imperialism and Nazism would have been sufficient to call them great. I believe that greatness was manifest during World War II, but it existed prior to World War II, and as closely as I have known this group through the years, it has been manifest in the years after World War II.

John Fleming – and if you will hold your seats just for a moment, I will have them stand as a group – John Fleming and I were together last week, and I suspect there might be some that think that this story could be embellished and that John

Fleming was doing what he has always done over 90 years of age: serving in our community. Throughout the crowd they were wearing John Fleming buttons with his picture on it, and it was not because he was a World War II vet, and it was not because of his exploits of World War II. He was involved in a community event restoring Joanna Furnace. He has done it for decades, and John was driving a fire truck during this event. That would have been sufficient enough to leave the story there, but John built the fire truck from parts. I know some of you are like, yeah; we are going to talk to this guy afterwards. I was back at John's machine shop. He put it together with parts brought in from all over the country. That is just something that John does. He serves in his community.

George Moore, Battle of the Bulge, one of the bloodiest conflicts in American history; December of '44 to January of '45, the Ardennes Forest, the last place in the world you would want to be, likely to be killed by frostbite or Nazi machine-gun fire. Nineteen thousand Americans died. There were nearly 100,000 casualties. George has never stopped serving. George is part of a group that not only honors veterans but brings that history to young people in our community, and for years has headed up the Berks chapter of the Battle of the Bulge.

In between these gentlemen is Irene, looking ever radiant, who is the wife of Everett. Everett and I just talked this morning. I asked Everett, had he ever told his wife this story? She remarked, Irene Keffer, that she had not heard the story before. Everett thought that he had told her. When Everett told me that he was on PC-1261 in Normandy on June 6, 1944, at Utah Beach, I needed to hear a little bit more of the story. Everett's PC-1261 - you are welcome to look it up on Wikipedia – was the first ship that was sunk during D-day, 58 minutes before H-hour. It was hit by a Nazi shore battery. Everett was blown out of the ship and landed in the English Channel without a life preserver and was seriously, seriously wounded. Nearby him, as he related the story to me, was floating, unfortunately, a dead comrade who had a life jacket on, which he clung to for several hours. A few minutes after Everett's ship was hit, he watched it sink into the waters off Normandy.

Mr. Speaker, these are heroes. The Commonwealth is in their debt. Whether in the front of the room or the back of the room; whether you fought on the beaches, in the air, in the towns, you are American treasures. We have a responsibility today, with heavy hearts for those 400,000, 400,000-plus that did not come home, for those 60 million to 80 million human beings that died during the Second World War. We have heavy hearts, but because of the heroism of these men in this room, the Dachaus, the Auschwitz, the Bergen-Belsens were shuttered, and those that were responsible were brought to justice, and the Bataan Death March ended and the POW (prisoner of war) camps were evacuated because of the heroism of these men. When duty called, they answered and they answered valiantly, which is why patriotism defeated Nazism and heroism defeated imperialism.

And, Mr. Speaker, I do not know what more could be said. Fifteen million of their comrades have gone on to their reward and their "Well done, thou good and faithful servant." So today we simply say to these assembled heroes, as they stand up – please, if you would stand just for a moment, each of you, stand up. Irene, you are welcome to stand with them – today we corporately say, "Well done."

A Resolution commemorating the 250th anniversary of the founding of Linglestown, Dauphin County.

On the question,

The SPEAKER. Representative Marsico is recognized for remarks.

Mr. MARSICO. Thank you, Mr. Speaker.

Mr. Speaker, I ask for your attention as we have the honor of including all of you in celebrating the commemoration of the 250th anniversary of the founding of Linglestown, Lower Paxton Township, in Dauphin County, Pennsylvania.

Pioneer Scot-Irish families, banished from their homeland in Scotland in 1718 because of religious differences, immigrated to America. Many of them traveled down through the Susquehanna River, and soon after German settlers followed. They recognized the beauty and the potential for farming in the rich soil and the plentiful forest land for buildings and chose to settle what is now known as Linglestown.

Mr. Thomas Lingle arrived in the area from Berks County in 1765 and decided to establish a new town. After purchasing the land and laying out the 80 lots, he named it "The Town of St. Thomas," and because Mr. Lingle founded the town, many people there referred to it as "Lingle's town." After Mr. Lingle died in 1811, the former name of the town was dropped, and the name was unofficially changed to Linglestown.

Since then the town has continued to thrive by farming, opening schools, and hosting fairs. Linglestown is a small village with a big past, and there is much to celebrate for their 250th anniversary this year. Actually, if you are in the area, you can join me in celebrating the great history we have in Pennsylvania with the development of historic towns such as Linglestown at their celebratory events scheduled for October 9-11. Friday begins with a church service at 7 p.m. Saturday's highlights include a parade at 10 a.m., craft vendors, community groups, kids activities, and living history exhibits in Koon's Park all afternoon. Saturday evening will feature live music and dinner specials at Linglestown's great cafes and restaurants. Sunday concludes the celebration in Koon's Park with a concert all afternoon and a huge fireworks display at 7:30 p.m. St. Thomas Church is hosting a country fair all day Saturday and Sunday, and more details on these events are available at linglestown250.com.

Ms. DONATUCCI called up HR 486, PN 2195, entitled:

A Resolution honoring female veterans who heroically served our country as members of the United States Armed Forces.

On the question,

Will the House adopt the resolution?

The SPEAKER. Representative Donatucci will be recognized to speak on HR 486.

Ms. DONATUCCI. Thank you, Mr. Speaker.

I want to thank my colleagues for their support of HR 486 honoring female veterans who have been serving our country for as far back as the Revolutionary War. Women have played increasingly greater roles in our military over the years. Since they were permitted to begin serving in the military in the 20th century, more than 600,000 women have served in armed conflicts overseas. Right now women account for 15 percent of active duty and Reserve personnel in the United States, and the number of female veterans continues to climb.

In addition, two women also recently made history as the first female soldiers to graduate from the harrowing Army Ranger School. Capt. Kristen Griest and 1st Lt. Shaye Haver both completed the grueling training with dignity and grace, inspiring women and girls everywhere.

We are also in the middle of a watershed moment as the military gets ready to open all jobs to women in January. Two years ago the Defense Secretary at the time, Leon Panetta, announced he was getting rid of the rule banning women from direct ground combat. What is more, recent news reports show the commander of the Naval Special Warfare units is advocating for women to be permitted to test for all combat roles, meaning women could become Navy SEALs. It is a special time for our women in the military, and we civilians could not be more proud of their achievements. But our female veterans' accomplishments remind us that we as legislators need to do more to better provide for these women who have given so much for us. There is a resolution facing our House Veterans Affairs and Emergency Preparedness Committee that would establish the Task Force on Women Veterans' Health Care, and I am proud to cosponsor HR 324, as it seeks to study the health issues facing women veterans and make recommendations to the Governor about how best to address them. We know that illnesses like PTSD (post-traumatic stress disorder) can present themselves differently in women than in men, and we need to better understand how we can serve our women veterans here at home.

Just as the fight for women's rights is not over, the fight for women's equal treatment in the military has just begun. We have come a long way, but still have a ways to go. We stand in solidarity with our female veterans and sincerely thank them for their courage, sacrifice, and dedication.

And again, I thank you for your support with an affirmative vote, and thank you, Mr. Speaker.

I am returning herewith, without my approval, House Bill 224 Printer's Number 2180.

This bill is the Public School Code bill, which implements aspects of the temporary General Appropriations bill that I recently received as well. As I will veto the General Appropriations bill, I will also veto its implementation.

This bill contains many laudable items that I support. Unfortunately, however, this bill does not restore the harmful education cuts imposed on each school district over the last four years, nor does it provide adequate funding to ensure Pennsylvanians have schools that teach our children. Simply stated, it fails to meet our constitutionally required obligation of providing a thorough and efficient system of education.

For the foregoing reasons, I must withhold my signature from House Bill 224 Printer's Number 2180.

Ms. DeLISSIO. So the only change this does is removes the additional step of the requirement for documentation by a licensed health-care practitioner?
