STATEMENT BY MS. ACOSTA

Ms. ACOSTA. Thank you, Mr. Speaker.

I would like to thank my colleagues for their support of HR 482, recognizing National Hispanic Heritage Month in Pennsylvania from September 15 through October 15. Many people might wonder why we celebrate Hispanic heritage during this particular time of the year. It is because it marks the period when many Latin American countries asserted their independence, including Guatemala, Honduras, El Salvador, Nicaragua, Costa Rica, Mexico, and Chile.

For those of us whose families immigrated to America from these other countries, it is a special time to trace our roots back to Spain, Mexico, the Caribbean – where I am from – Central America, and South America. Our culture is becoming increasingly diverse, and that is a good thing. According to the United States Census Bureau, there are roughly 54 million Hispanics living in the United States, making up about 17 percent of the total population. I believe our nation is stronger and more unified when we are more accepting of other cultures, traditions, and languages. We should celebrate our differences – that is what makes America great.

Just earlier today I had the pleasure of celebrating some powerful artwork done by Hispanic-Americans from all over our great State. Their diverse perspective and insight add so much to our artistic community, and we are lucky to have these artists in Pennsylvania today. I encourage everyone to take a look at the artwork in the Senate fountain area near the cafeteria today. It is close to the East Wing Rotunda. It is only here today until 5 o'clock, that exhibition of the Hispanic artwork.

I would also like to recognize the Hispanic-Americans right in our own communities that have made enormous contributions, such as former State Representative Ralph Acosta, who is here today, my father, who is here, and those that are making a difference, including Capt. Michael Anthony Bastone, Sr., who is here with us today. Mr. Bastone is the first Hispanic-American to earn the rank of captain in the Philadelphia Sheriff's Office. After joining the Sheriff's Office in 1995 as a deputy sheriff officer, Captain Bastone served honorably with the civil, warrant, and transportation units before advancing to his role as captain. Captain Bastone's dedication, service, and pride for his heritage are inspiring to all of us.

Also joining us today are several of Captain Bastone's Hispanic-American colleagues from the Philadelphia Sheriff's Office, including former State Representative Jewell Williams – he is the sheriff – Staff Inspector Jennifer Algarin-Barnes, and Sgt. Joshua Perez, and I would like to say something about Joshua Perez. We graduated from high school together in 1990. Joshua, it is a pleasure to see you here. And I had no idea he was working for the sheriff's department, so thank you. And Deputy Sheriff Dolores Ramos and Ana Sostre-Ramos, who is also deputy sheriff. We thank them for their service and commitment to Philadelphia and to our Commonwealth.

As the first Hispanic-American woman elected to this great body and the daughter of the first Hispanic-American man to serve in the House, I am proud to be here today to honor National Hispanic Heritage Month. Thank you once again, my colleagues, for the support of HR 482, and may you all have a joyous National Hispanic Heritage Month.

Elected to the House of Representatives of Pennsylvania in 1984, Mr. Distler represented the 75th Legislative District and was reelected in 1986 and 1988. A life member of the American Legion, the Veterans of Foreign Wars and the Benevolent and Protective Order of Elks, he was the recipient of the prestigious Chapel of the Four Chaplains award; and

WHEREAS, A beloved family member and avowed community steward, Mr. Distler gave of his heart and time to enhance the quality of life of his family and community. His inspiring presence and genuine love for his family and friends will live long in the hearts and memories of the many individuals whose lives he touched; now therefore be it

Today we have the opportunity to honor and remember a great man: a veteran of the United States Air Force, a dedicated community and public servant, a longtime leader in the American Legion and the Veterans of Foreign Wars, and a former member of this chamber. Today we have the opportunity to honor Representative James T. Distler, who served the 75th District in Elk and Clearfield Counties from 1985 to 1990. We mourn his loss, as he passed away on March 31 of this year at the age of 80.

I personally knew Jim, and we shared a bond that few people have the opportunity to share. Representing the same communities in the same position during different times provides a unique perspective that is difficult to convey. I remember very fondly the last time I spoke with Jim; we had a long conversation around a campfire in Elk County trading stories about public service. I did much more listening than talking, as I knew how fortunate I was to hear this unique perspective on the history of our community and our Commonwealth.

Jim was elected to the General Assembly in 1984 when I was 1 year old. While I am too young to personally remember, I am told that Jim's service and dedication to the community, and specifically his dedication and support for our military and veterans organizations, was so heartfelt that it was equally strong before, during, and after his tenure as a member of the General Assembly. Certainly his dedication and his fervent patriotic spirit was something that I always observed and admired during the time that I knew him. Even until his very last year with us, he personally spearheaded and coordinated the annual St. Marys Memorial Day ceremonies and parade held at Memorial Park and in the Diamond at the center of town.

Over the years Jim served his community in many capacities. As a young man he served 3 years overseas with the United States Air Force. He worked at Airco-Speer in St. Marys for over 25 years before his retirement. He served as chairman of the Board of Township Supervisors in Benzinger Township, a municipality which has since merged to form a portion of the city of St. Marys. He served 4 years as Elk County Veterans Affairs Director, and he served three terms as State Representative following the elections of 1984, 1986, and 1988. One of his proudest accomplishments was the founding of the Elk County Striders, a running club that remains active in Elk County to this day.

Joining us today is Jim's wife, Joan Gabler Distler, who is also my first cousin once removed. Joan, please rise. Also joining us are two of Jim and Joan's children, Jim Distler and Diane Seelye; and also Jim and Joan's grandson, Anthony, with his girlfriend, Stephanie.

While we mourn that Jim is no longer with us, today we take the opportunity to celebrate the life he shared with us. We celebrate that our community, our Commonwealth, and our nation are all undeniably better because of the contributions Jim made during his lifetime.

I ask that you join me in honoring Representative James T. Distler – a great man, a patriot, and a true public servant. Thank you very much.

- (a) School bus driver requirements.—No person shall be issued an endorsement to operate a school bus unless the person:
 - (1) has successfully completed a course of instruction as provided in subsection (c);
 - (2) has satisfactorily passed [an annual] <u>a</u> physical examination to be given in accordance with rules and regulations promulgated and adopted by the department;
 - (3) is 18 years of age or older; and
 - (4) is qualified to operate school buses in accordance with this title and the rules and regulations promulgated and adopted by the department.
- (b) Proof of [annual] physical and vision examination.—Every school bus driver shall carry a certificate issued by an examining physician or practitioner recognized by the department pursuant to section 1508.1 (relating to physical examinations), indicating that the person has passed the prescribed physical examination, including an examination of the eyes, within the preceding [12] 13 months. The vision examination may be made by an optometrist or ophthalmologist.

Section 2. The definitions of "commercial motor vehicle" and "tank vehicle" in section 1603 of Title 75 are amended to read:

It just gives more bus drivers the ability to get in under the deadline for their insurance companies so that they do not pay out of pocket.

The SPEAKER. Representative Barbin, on the amendment. Mr. BARBIN. Thank you, Mr. Speaker.

I rise in support of the amendment. It has been brought to the attention of the members of Transportation that the testing that needs to be done to keep in compliance is difficult because of the number of available slots in rural areas. What this will do is help keep drivers in compliance. I ask for concurrence in the amendment.

REMARKS SUBMITTED FOR THE RECORD

The SPEAKER. On unanimous consent, Representative Bob Godshall is recognized.

Members, would you please take your seats and give the floor to Representative Godshall.

Mr. GODSHALL. Thank you, Mr. Speaker.

I have about six, seven pages of comments on this bill that I have. I can either read them or I can submit for the record, and I will bow to my constituents which they would prefer. So apparently—

The SPEAKER. All those in favor of submitting for the record say "aye."

Mr. GODSHALL. So I will submit for the record rather than read them.

The SPEAKER. Chairman Godshall, thank you.

Those remarks will be taken for the record. Thank you very much.

But do you have any closing comments with respect to the bill, sir? Thank you very much, Representative Godshall.

Mr. GODSHALL submitted the following remarks for the Legislative Journal:

Mr. Speaker, this body long ago established tax-qualified retirement benefits for State and public school employees through its retirement codes. HB 1332, PN 1814, continues this effort by amending the respective retirement codes to enable our pension systems to conform to Federal statutes and IRS (Internal Revenue Service) regulations and to allow our employees to continue to enjoy the benefits of their retirement accounts remaining tax-deferred until they leave State service and begin receiving a pension.

HB 1332 is part of Pennsylvania's ongoing efforts to maintain the retirement codes' compliance with Federal and State laws, including the Internal Revenue Code. Passage of this legislation will ensure that there are no negative tax implications for nearly 370,000 active State and public school employees statewide.

In 2008 the IRS announced a new enforcement initiative for public pension plans. Most public plans, like Pennsylvania, did not have a formal tax qualification determination previously. Over the past several years, both SERS (State Employees' Retirement System) and PSERS

(Public School Employees' Retirement System) voluntarily self-identified areas of noncompliance and proposed corrective amendments to their respective codes, as well as requested the Internal Revenue Service to determine if those amendments will make the retirement codes compliant with the IRC qualification rules. The IRS issued a favorable determination letter stating that the retirement codes are compliant, but only if certain legislative amendments to the codes are enacted by January 1, 2016. HB 1332 is the result of this work and will bring the retirement code into compliance with IRS requirements.

Many of these technical changes will be transparent to retirement system members, and most of the other changes will affect only a few State employees. These changes include retiree return-to-service rules, allowing annuitants to return to active service in limited circumstances are structured to satisfy Federal requirements; minimum vesting standards are established in the event of plan termination; benefit limits for higher salaried employees and the handling of pickup contributions; maximum contribution and minimum distribution rules and death benefit parameters; and coordination of annuitant benefits between SERS and PSERS to ensure that any combined benefit does not exceed the IRS maximum distribution limit.

It is important that we distinguish this legislation from any type of pension reform effort. This bill must be passed without amendment to comply with Federal regulation. Failure to do so could have serious ramifications for the Commonwealth.

To reiterate, if Pennsylvania does not adopt all of these legislative changes by January 2016, the IRS qualification determination is in jeopardy and the IRS could stop treating PSERS and SERS as if they were qualified retirement plans.

If the IRS no longer treats either system as qualified, then the annual increase in the vested value of their pension benefits for every public school employee and State worker in either plan, including their own contributions and the interest credited on those contributions, will be taxable to the employee every year, regardless of whether or not the employee is working and not receiving a pension. It is incumbent upon this body to ensure that does not happen.

I ask for the members' favorable vote. Thank you, Mr. Speaker.

BILL ON CONCURRENCE IN SENATE AMENDMENTS

The House proceeded to consideration of concurrence in Senate amendments to **HB 823, PN 2181,** entitled:

An Act amending the act of May 25, 1945 (P.L.1050, No.394), known as the Local Tax Collection Law, further providing for bonds of tax collectors, for permanent basic and continuing education programs for tax collectors, for criminal history record information and for deputy tax collectors.

On the question,

Will the House concur in Senate amendments?

The SPEAKER. It is moved by Representative Greiner that the House concur in the amendments inserted by the Senate.

The Chair recognizes Representative Greiner for a brief description of the Senate amendments. Sir.

Mr. GREINER. Thank you, Mr. Speaker.

I just wanted to rise to ask support today for HB 823 on concurrence with the Senate amendments.

Some of the highlights of the Senate changes – there were 2 hours of training over the 4-year term that were made. We did spend a lot of time with the Senate and the tax collectors to try to come up with a compromise. It expands the list of acceptable courses for basic training and continuing education and shifts all the reporting requirements from the individual to DCED (Department of Community and Economic Development). It caps the cost at \$250 per course. Criminal history checks will only be needed when running for office of the tax collector for the first time, so people that are there are grandfathered. It removed a 5-year review for the basic and continuing education programs. It removes a provision that prohibited immediate family members from being named as emergency deputies.

So we spent a lot of time on this with the Senate, and I would ask for concurrence with the Senate, HB 823 on concurrence with the Senate amendments.

Thanks, Mr. Speaker.

The SPEAKER. Thank you, Representative.

At this time Representative Mackenzie, and then I will be calling on Representative Kotik.

Representative Mackenzie, the floor is yours, sir.

Mr. MACKENZIE. Thank you, Mr. Speaker.

I would like to commend Representative Greiner for his hard work on this legislation. It has been a long process of improving this tax collectors act, and I think he has done a fantastic job with the legislation.

I had filed a number of amendments that would have required a suspension of the rules. They were in line with what we previously passed in HB 160. The most pressing issue in that legislation, in my opinion, is the fact that we still allow tax collectors to collect checks in their individual name. This is clearly a way that abuse and fraud are occurring in our system and it is a loophole that needs to be closed. We are going to continue to work with the Senate to advance that legislation.

So I will be withdrawing these amendments today and ask for a "yes" vote on HB 823 on concurrence. Thank you.

The SPEAKER. Thank you, Representative.

Representative Kotik, on the bill.

Mr. KOTIK. Thank you, Mr. Speaker.

Mr. Speaker, this is one of the bills that I have gotten the most comment on from my local tax collectors. There was a lot of controversy about tax collectors that have been in office for a long time and knowing their job and trying to do the best job possible, and I think the Senate has done us a service by kind of eliminating some of the requirements but also making some changes that were making it into a better bill.

So I would support concurrence. Thank you.
