# **GUESTS INTRODUCED**

The SPEAKER. Representative Santarsiero has some very important guests here today, and given that it is Veterans Day tomorrow, it is very appropriate to know that Russell Davidson is past commander of the Yardley-Makefield VFW (Veterans of Foreign Wars) Post 6393, and he is seated to the left of the rostrum. Mr. Davidson, will you stand. It is great to have you here today, and my understanding is your wife, Kathleen; daughter, Perry Benedict; and grandchildren, Donna, Elizabeth, and Ashley are here as well. If you could please rise. We are very glad to have you here today. Thank you so much.

We have been getting a lot of our distinguished alumni in the Capitol Building lately and in our chamber, and we have one of our own and we are so honored and proud to have him here: Pennsylvania State Fire Commissioner and former State Representative and State Senator – but we love the Representative part – Tim Solobay. Tim, thank you so much. Tim, you were a good friend to so many here, and to have you in the Fire Commissioner position, with all the great work that you and Chairman Barrar and others did on behalf of our first responders, including firefighters, that legacy will stand for a long, long time. You are in a perfect position, given the great work that you have done as a legislator in that arena.

And, Tim, you bring with you today, I believe, administrators and staff members from the Fire Academy: Bruce Trego, Patrick Pauly, Tracie Young-Brungard, and Doug Snyder, along with Mark Wineland, Terri Brooks, Bill Hine, Robin Snyder, and Barb Barben. And Representative Farry and Representative Dom Costa, these are your guests. Thank you so much for bringing these individuals. I think you are going to be speaking on that more later, if I understand. Thank you all for being here today with us. Thank you.

#### STATEMENT BY MR. MENTZER

The SPEAKER. In the rear of the House, Representative Mentzer has brought us some guests, and I am going to recognize him under unanimous consent at this time. Representative Mentzer, sir, if you would not mind introducing your guests, and we will have you come to this mike here. Thank you, sir.

Mr. MENTZER. Thank you, Mr. Speaker.

Mr. Speaker, today we have in the hall of the House Beatrice, Marvin, and Steve Hernandez. They are board advisers to a very small nonprofit organization in Lancaster, Pennsylvania.

Now, as the U.S. struggles with immigration and how to deal with immigration, I would like to tell a little story about my friends from one of the poorest countries of the Americas. Yes, it is story time here in the hall of the House. Beatrice and Marvin, a married couple, 20 years ago decided to come to the United States. They came to the United States and they worked and saved and lived with friends and relatives until they had enough money to go back to their home country. They went back to their home country and they opened a restaurant and a catering business, and that restaurant and catering business now employs 5 to 10 people in their country of Honduras. They were even more aggressive. They decided to build a 20-room hotel

that now employs between 10 and 20 people in Honduras, but that was not enough. They decided they wanted to give back to their community.

So I ran into Marvin and Beatrice about 10 years ago, where they joined up with me to try to help people in their community. Their country, where 75 percent of the population lives on below the minimum wage, which is not our minimum wage; in Honduras the minimum wage is \$250 a month. That is right; \$250 a month. So they worked with me to establish self-sustaining pharmacies in these very poor communities. They worked with me to provide school lunch programs for 20 schools, where children, many of them, that is their only meal of the day. They have worked to build schools and they have worked to get 15 medical mission groups to Honduras every year from this area from Pennsylvania. This is the way, this is the path for helping our fellow Americans, our fellow Central Americans and South Americans, by teaming up with responsible citizens from those countries.

So I want to thank Beatrice and Marvin for coming up here for the visit, and good luck on your travels back to Honduras.

#### STATEMENT BY MR. REGAN

The SPEAKER. To the left of the rostrum, Representative Regan has some guests, and he is going to be speaking under unanimous consent.

Mr. REGAN. Thank you, Mr. Speaker.

Mr. Speaker, I rise today to pay special tribute to a series of doctors, nurses, and first responders who literally saved the lives of one of our House staff members and her newborn son. On March 25 Maureen Bereznak, daughter of—

The story you are about to hear I think is just unbelievably telling about our first responders, and Representative Regan will do a great job at that. If we could, I would like to have everybody's attention.

Representative Regan, please proceed.

Mr. REGAN. Thank you, Mr. Speaker.

On March 25 Maureen Bereznak, daughter of Representative John Payne and a member of the research staff for the Republican Caucus, was expecting her second child when a severe, life-threatening issue developed. Due to her suffering from what is called placenta previa, she began hemorrhaging. A call to 911 brought first responders, and because of their efforts, Maureen, who was close to losing her life, managed to survive. The fast response of Officer Daniel Grimme of the Newberry Township Police Department, Fairview Township paramedic Miguel Lopez, and emergency medical technicians Jamie Haugh and Michael McDole, Maureen made it to the Harrisburg Hospital and into the expert hands of my friend, Dr. Robert delRosario. There were more problems, unfortunately. Maureen's son, Easton, was delivered by C-section but suffered collapsed lungs. Once again, due to the skilled hands of doctors and nurses, Easton is alive and healthy today and with us today.

Mr. Speaker, this is the kind of heroism that our first responders, doctors, and nurses exhibit every day, and unfortunately, that often goes unnoticed. Well, today we recognize them, thank and salute them for saving this wonderful mother and son.

Please join me, Representative John Payne, Representative Greg Rothman, and Representative Brett Miller in honoring these outstanding Pennsylvanians.

# STATEMENT BY MR. FARRY

The SPEAKER. Representative Frank Farry is recognized to speak on HR 559.

Mr. FARRY. Thank you, Mr. Speaker.

HR 559 celebrates the 60th anniversary of the Pennsylvania State Fire Academy. The resolution was introduced by myself and Representative Costa, and joining me are Chairman Barrar, Chairman Sainato, and I think Chief Payne was going to come over here too.

As the Speaker earlier mentioned, we have many guests with us, including our former colleague, State Fire Commissioner Tim Solobay, the staff of the State Fire Commissioner's Office, as well as the staff of the State Fire Academy, and I thank you for all the fine work you do for Pennsylvanians and for joining us here today.

In 1950 the General State Authority of Pennsylvania purchased 11 acres of ground for the construction of a State fire school. In 1953 the construction of Pennsylvania's first State fire school started in Lewistown. The first class was held in June of 1955. The school offered 1- and 2-week programs year-round, and these resident programs attracted students from across Pennsylvania and its neighboring States. The courses were State-mandated to be tuition-free, and today continue to remain tuition-free for instate public emergency responders. The State fire school operated under various State agencies and today is part of the Office of the State Fire Commissioner.

Now known as the State Fire Academy, it delivers quality training, education, and professional certifications, which is safe and meets or exceeds national standards. Their curriculum is very comprehensive and is responsive to all the educational needs of Pennsylvania's emergency services. In 2014 the academy processed 8,611 students.

Along with the resident training program conducted at the facility in Lewistown, the academy is also responsible for delivering specialized resident curriculum locally to emergency service organizations throughout the State called the Local Level Training Program. Each year this program delivers over 3,000 programs across the Commonwealth, with the majority of the classes taking place right in the fire department's station. The Local Fire Training Program is the oldest form of organized fire and rescue training conducted by the Commonwealth of Pennsylvania, dating back to the 1930s. This training continues to strive to increase the emergency responder's effectiveness by centering training on local needs and using local equipment and apparatus.

In addition, the academy administers the Pennsylvania Fire Service Certification program, which has certified over 6,000 emergency responders in the Commonwealth. Further, the academy conducts training specifically directed at the Marcellus Shale gas industry and alternative energy for our first responders. Programs like Well Site Emergency First Responder, Firefighting at Shale Gas Emergencies, Responding to Ethanol Incidents, Pipeline Emergencies Operations, and more.

It is challenging for today's firefighters, most of whom are volunteers, to remain informed and up to date as to current fire safety practices. The academy has done an excellent job in promoting and providing safe, effective, and realistic training for all facets of the emergency services, as well as fire and emergency services professional development and lifelong learning that reflects innovation and change in the industry.

So today we are proud to recognize the academy's 60 years of exemplary service and training to our emergency responders, and I thank you for your affirmative vote on HR 559.

#### STATEMENT BY MR. READSHAW

The SPEAKER. Representative Harry Readshaw is recognized to speak on HR 561 on unanimous consent.

Mr. READSHAW. Thank you, Mr. Speaker.

Mr. Speaker, HR 561 is a resolution concerning the 240th birthday of the Marine Corps. I would like to invite my fellow colleagues who served in the Marine Corps to join me in the well.

Mr. Speaker, in accord with HR 561, I am delivering a message from the Commandant of the Marine Corps.

When the Continental Congress raised up two battalions of Marines in 1775, it launched the greatest fighting force the world has ever known – a force revered globally for its uncommon valor, unparalleled adaptability, and ferocious tenacity. Over the past 240 years, the battlefields and equipment have changed, but the spirit of the United States Marine Corps has prevailed in every clime and place.

One hundred years ago, Marine Corps Recruit Depot Parris Island opened its doors as the first base dedicated solely to making Marines. Since then, hundreds of thousands of men and women have been forged into elite warriors at Parris Island, Marine Corps Recruit Depot San Diego, and The Basic School in Quantico. Each recruit had a different reason for stepping onto the yellow footprints, but all are unified by the intangible traits that characterize United States Marines and the remarkable legacy that has carried on across generations.

Whether you served on the hallowed grounds of Belleau Wood, fought on the iconic island battlefields of World War II, navigated the harsh terrain and climate of the Chosin Reservoir or Vietnam, conducted assaults during Desert Storm, marched on Baghdad, fought in close combat in Fallujah, or conducted combat operations in Afghanistan, everyone who wears the Eagle, Globe and Anchor is a member of that storied legacy.

As we celebrate the 240th birthday of our Corps, we pay tribute to all who have served and we remember our fallen heroes. We take great pride in our legacy and in the fine men and women who carry our colors into the future. And we extend heartfelt thanks to our families for their steadfast support.

Our 26th Commandant, General Louis Wilson, once said, "In the last analysis, what the Marine Corps becomes is what we make of it during our respective watches. And that watch of each Marine is not confined to the time he spends on active duty. It lasts as long as he is 'proud to bear the title of United States Marine.' " Thank you all for guarding the legacy of our Corps during your watch.

# STATEMENT BY MR. WHEATLEY

The SPEAKER. Representative Jake Wheatley, on unanimous consent.

Mr. WHEATLEY. Thank you, Mr. Speaker.

I rise today because, just as my fellow Marine, I wanted to recognize a force like no other, one that has personally touched me in my life, a family that was built over 240 years ago that began right here in Pennsylvania in 1775. This organization took a young man like myself from the city of Detroit, Michigan, and it stripped me of all of my arrogance, all of my selfishness, and all of my vanity, and it tried to rebuild me in the image of its core values of honor, courage, and commitment.

Now, I was lucky enough to serve in active duty as a young 17-year-old young man. I did not really appreciate and did not really understand what I was getting involved with, but over my time in active duty and since my time from being released honorably from active duty, I developed a real appreciation and a real value for the institution that we recognized today.

It is an institution that since its inception has established a foundation based on the factor that be you man or woman, be you Black, White, or indifferent, we believe in our country and we sacrifice for the things that we think make our country truly what it is.

I have been proud to be one of the many who wear that eagle, globe, and anchor and look across the years of other men and women who have put that uniform on and can call them my brothers and my sisters. Because anyone who has ever donned that uniform appreciates what our history and legacy, that was forged in battle, that makes us who we are – the finest fighting force ever assembled in this country, in the world.

So today I stand honored to be with my fellow Marines to recognize an organization that, for me, has made me what I am today. So I just want to say thank you all for recognizing a happy birthday to Marines all across the world, and I will say as others have said – I will not sing to you this year. Last year I tried to sing to you. I could not do that, but I will say just the beginning verses of our hymn: "From the Halls of Montezuma to the Shores of Tripoli; we fight our country's battles in the air, on land and sea...."

So I want to thank you all and say happy birthday, semper fidelis, to all the Marines in continued unity. Thank you.

Representative Santarsiero, the floor is yours, sir.

Mr. SANTARSIERO. Thank you, Mr. Speaker.

It is with a high level of honor and not a little pride that I stand before you this morning and ask for your support for HR 576. As the Speaker just said and as you will see in reading the resolution, it is one that honors VFW Post 6393 in Lower Makefield Township, serving the Lower Makefield-Yardley community, and in particular, its former commander, my friend, Russell Davidson.

The post, Mr. Speaker, was awarded a very distinguished honor. It was declared an "All-American Post" for 2014-2015 under Russ's leadership – one of only 136 such posts to receive that honor out of nearly 7,000 posts worldwide. It was one of only two VFW posts in Pennsylvania to receive that honor. Being named an "All-American Post" was based on the post meeting and exceeding all of their mission requirements. They demonstrated leadership in membership, Veteran Service Officer Duty, the Poppy campaign, participation in the VFW's many programs, and an unmatched level of community service.

I want to just read a list of those particular aspects of their service, and then I want to close with a story about something that happened a little less than a year ago.

The post was named "Best Nonprofit Member" by the Pennsbury School District. It was awarded a Certificate of Appreciation and Congratulations for an Outstanding Service Year from the Pennsylvania VFW. It received Membership Excellence Award from Pennsylvania's VFW; the VFW State Commander's Award for the highest numerical increase of members – 40 new members; the Robert Musser Memorial Award for achieving the greatest percentage of increase in members – 116.7 percent; the VFW PA State Van Zandt Award for post recruiting most new and reinstated members – 14.9 percent; VFW PA State Joe Salvo Award for post member recruiting the most new and reinstated members; and VFW Post 6393 Commander Russell Davidson is honored as Citizen of the Year by Fairless Hills Elks 2023. These are just a list of some of the things that this post has done.

As we were discussing this morning, Russ was telling me about the many members who go into our schools, locally, and talk to our students. As a former teacher, I can attest to how important that is, because they are bringing their experiences to the kids in a very real way that really has an impact on young people, and that is critically important.

But I want to talk about something else that is not listed here. It is not in the resolution, but it is a measure of the members of this post and how they care about our community.

Last December, around Christmastime, there was a hate crime in our community. Someone scrawled the words "leave Jew" across a garage door in spray paint. The family who was victimized by this crime was understandably reluctant to come forward for they feared retribution if they did. We were able, ultimately, to get them to come forward to talk to the press because of the importance of shedding a light on this. And what was supposed to have been a press conference of just a few people turned out to be a rally in support of this family, and that rally happened in no small measure because of the local VFW and Russ's leadership.

Members of Post 6393 stood with us that cold December morning – the day after Christmas, in fact – to stand with this family. I remember, Russ, you telling them not to be afraid because our community was standing with them. To me, this was yet another example of the members of the post, who had

already served our country in harm's way, standing up once again for the values that we as Americans hold so dear, and why all too many times young men and women in our history have had to take up arms.

It was one of the proudest moments I have had as a member of the State legislature and as a member of our community. And it is fitting indeed on this day before Veterans Day, when we fittingly pause to remember the sacrifices of our veterans, that we stand here today to honor former commander Russ Davidson and VFW Post 6393.

To my colleagues, I ask that you cast your vote in favor of HR 576, but I also ask right now that you join me in saluting Commander Davidson.

Computer System Augmentation Account to the Judicial Department for the fiscal year July 1, 2015, to June 30, 2016; to provide appropriations from the Motor License Fund for the fiscal year July 1, 2015, to June 30, 2016, for the proper operation of several departments of the Commonwealth and the Pennsylvania State Police authorized to spend Motor License Fund money; to provide for the appropriation of Federal funds to the Executive Department of the Commonwealth and for the payment of bills remaining unpaid at the close of the fiscal year ending June 30, 2015; and to provide for the additional appropriation of Federal and State funds from the General Fund and the State Lottery Fund for the Executive Department of the Commonwealth for the fiscal year July 1, 2014, to June 30, 2015, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 2015.

On the question,

Will the House agree to the bill on second consideration?

The SPEAKER. There were a number of amendments filed and I just want to, for the record, cover these.

Representative DiGirolamo has filed amendments 3180 and 3199, and Representative DiGirolamo, those have been withdrawn.

Representative Boback had filed amendment 3194. Representative Boback, is that amendment withdrawn? That amendment is withdrawn.

Representative Krieger had filed amendments 3211 and 3212. Representative, those amendments are withdrawn? Yes, thank you.

Representative Hickernell had filed amendment 3214; that is withdrawn.

Representative Rozzi had filed 3217; that is withdrawn.

Representative Vitali had filed amendment 3204. That is withdrawn? That is withdrawn.

Representative Parker has amendments 3208 and 3219. The Chair recognizes him now. Representative Parker, the floor is yours.

Mr. PARKER. Thank you, Mr. Speaker.

The SPEAKER. Members, please take your seats. All conversations, we would appreciate if they could go to the anterooms.

Mr. PARKER. Thank you, Mr. Speaker.

On amendment A3208, basically this amendment was designed to take all the moneys that the Governor had budgeted lower than our line items and I put that money into a basic education equity fund and a school district consolidation fund, incentive fund, because I really believe we need to work to get the \$937 million that the 180 school districts are being shortchanged – based on the new basic education funding formula that came out of the commission; bipartisan, bicameral, both Governor's Offices were involved in it – and we really need to focus on getting those districts that money.

As I am learning how the legislature works, I am looking for ways to make that happen more quickly, because my taxpayers in Monroe County pay the highest percentage of their incomes to school property taxes than anyone else in this State. One school district, if they got the money the new formula says they should get, could reduce their taxes by 20 percent, so I am really focused on getting this money to them.

But I understand the political realities, and we want to pass a budget. There are a lot of promising things that are being discussed with leadership and the administration to get property tax reform and to get us on a road to fair funding more quickly, and I am encouraged by that. And to move this process along, I will withdraw that amendment.

On amendment A03219, this amendment is based on similar things to get school funding corrected. I spoke back when we voted on the School Code bill in late June. I voted against that bill because the money was distributed. We acknowledged that 180 districts are not getting the \$937 million they should. We acknowledged 320 are getting \$937 million that the new formula says they should not necessarily be getting under the formula. And yet we are giving the new \$100 million to all the districts. I still really believe new money should be focused on the 180 districts, and my amendment would do just that.

Again, I am encouraged by the process that I have witnessed in this budget negotiation for school property tax relief and fair school funding, and I will withdraw that amendment as well in the hopes that we can amend the School Code and make them more equitably funded going forward.

Thank you, Mr. Speaker.

HB 239 came back over from the Senate. It was just a clarification. The Senate wanted to make sure that any cost-of-living increase index used to calculate a COLA (cost-of-living adjustment) at the county level will be based on the 12 months prior to August 31. And that adjustment, after it is considered, would be in effect for the year that the adjustment is being considered starting the year – January 1 of the following year, is what it would be.

Just as a recollection or to recall for everybody here, what this did was amend the county pension law to clarify any cost-of-living adjustments made by the county retirement boards, require the board to have an actuarial note prepared before considering a cost-of-living adjustment, and require that any county pension plan be at least 80 percent funded.
