HB 1690, PN 2516

By Rep. ROSS

An Act amending the act of April 12, 1951 (P.L.90, No.21), known as the Liquor Code, as follows: In preliminary provisions, further providing for definitions. In Pennsylvania Liquor Control Board, further providing for general powers of board. In licenses and regulations, liquor, alcohol and malt and brewed beverages, further providing for license districts, license period and hearings and for issuance, transfer or extension of hotel, restaurant and club liquor licenses, providing for wholesale permit, for wholesale licenses, for wine or liquor expanded permits, for wine or liquor enhanced permits and for grocery store retail permits; further providing for malt and brewed beverages manufacturers', distributors' and importing distributors' licenses, for malt and brewed beverages retail licenses, for application for distributors', importing distributors' and retail dispensers' licenses, for prohibitions against the grant of licenses, for interlocking business prohibited, for licenses not assignable and transfers, for surrender of restaurant, eating place retail dispenser, hotel, importing distributor and distributor license for benefit of licensee and for unlawful acts relative to malt or brewed beverages and licensees. In miscellaneous provisions, providing for transition assistance committee, for preference in public employment hiring, career training and post-secondary education grant eligibility, for reemployment tax credit and for protection of existing benefits.

The SPEAKER. Representative Harper is recognized to speak on HR 558, and she will also be introducing some guests with her today. Mr. Speaker, HR 572 honors Ed Mann as the longest serving Fire Commissioner in the history of Pennsylvania. He served under four different Governors, covering a continuous 15-year period, from 2000 to 2015. Under his leadership, his office has received numerous national awards for training, for safety and wellness programs for emergency responders. As well, Commissioner Mann has worked hand in hand with the members of the General Assembly to enhance emergency responders programs, such as the fire/EMS (emergency medical services) grant program, the 2 percent volunteer loan program, and our line-of-duty death benefit program.

Ed's passion and devotion to first responders across Pennsylvania has been unsurpassed. His sincere dedication to the safety of his brethren emergency responders is something that will always be remembered by myself and the many members who have had the pleasure to work with him over his 15 years here.

Today we welcome Commissioner Mann to the hall of the House, and we honor him for his tenure as being the longest serving Pennsylvania State Fire Commissioner through HR 572, which is to be considered by the House membership today.

STATEMENT BY SPEAKER

The SPEAKER. For many of you, you may not know, but Commissioner Mann was appointed as the fourth State Fire Commissioner of the Commonwealth by Gov. Tom Ridge in July of 2000. He also served under Governors Mark Schweiker, Ed Rendell, and Tom Corbett.

Under his leadership, the Office of the Fire Commissioner received national awards from the National Fallen Firefighters Foundation and the International Association of Fire Chiefs for his efforts to reduce line-of-duty deaths. His message since the first day of his appointment as Fire Commissioner under Governor Ridge was, "Be safe for your families' sake."

Commissioner Mann, we would be remiss if we did not also make mention of the fact that you are the chief and the financial secretary for the East Derry Fire Company in Mifflin County, represented by Representative Harris. We are all so proud that Chairman Barrar, Chairman Sainato, and Representative Harris brought you and your wife into this august body today after your years of great service. Thank you so much for being with us.

I want to thank the gentleman from Berks County, Mr. Cox, for bringing up this legislation. It expands the applicability of the property tax and rent rebate program and also extends the deadline, but I also want to thank him for including the language of HB 421, legislation that I introduced with 62 sponsors that has passed the House Finance Committee. My bill would expand the life insurance exemption from the current \$5,000 to a new level of \$10,000. That was done, that \$5,000 limit was set many years ago. We did change it for the PACE (Pharmaceutical Assistance Contract for the Elderly) program back in 2004, so it is now up to a \$10,000 exemption in the PACE program. This change would make that effective for the property tax and rent rebate program.

I appreciate that Representative Cox has included the language of HB 421 in HB 406, and I urge a "yes" vote.

An Act amending the act of December 15, 1986 (P.L.1595, No.175), known as the Antihazing Law, further providing for definitions and for enforcement.

Amend Bill, page 1, line 4, by striking out the period after "enforcement" and inserting

; and amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in sexual offenses, prohibiting mutilation of female genitalia.

Amend Bill, page 4, by inserting between lines 3 and 4 Section 2. Title 18 of the Pennsylvania Consolidated Statutes is amended by adding a section to read:

§ 3132. Female mutilation.

- (a) Offense defined.—A person commits the offense of female mutilation if:
 - (1) the person knowingly circumcises, excises or infibulates the whole or any part of the genitalia of a minor;
 - (2) the person is a parent of a minor and the parent knowingly consents or permits the circumcision, excision or infibulation of the whole or any part of the minor's genitalia; or
 - (3) the person knowingly removes or permits the removal of a minor from this Commonwealth for the purpose of circumcising, excising or infibulating, in whole or in part, the genitalia of the minor.
 - (b) Grading.—Female mutilation is a felony of the first degree.
- (c) Exception.—The provisions of subsection (a) shall not apply if the circumcision, excision or infibulation is:
 - (1) necessary to the health of the minor on whom it is performed and either is performed by a physician or is performed in the presence of a physician by a person in training to become a physician in accordance with the act of October 5, 1978 (P.L.1109, No.261), known as the Osteopathic Medical Practice Act, or the act of December 20, 1985 (P.L.457, No.112), known as the Medical Practice Act of 1985; or
 - (2) performed on a minor in labor or who has just given birth and is performed for medical reasons connected with that labor or birth by a physician or in the presence of a physician by a person in training to become a physician in accordance with the Osteopathic Medical Practice Act or the Medical Practice Act of 1985.
- (d) Custom or consent not a defense.—It shall not be a defense to a prosecution under this section that:
 - (1) the actor believed that the procedure was necessary or appropriate as a matter of custom, ritual or standard practice;
 or
 - (2) the minor upon whom the circumcision, excision or infibulation was performed consented to the procedure or that the minor's parent consented to the procedure.
- (e) Definitions.—As used in this section, the following words and phrases shall have the meanings given to them in this subsection unless the context clearly indicates otherwise:
- "Minor." A natural person who is a female under 18 years of age.
- "Parent." The term includes a natural parent, stepparent, adoptive parent, guardian or custodian of the minor.

Amend Bill, page 4, line 4, by striking out "2" and inserting 3
