STATEMENT BY MS. McCLINTON

The SPEAKER. Representative McClinton is recognized to speak on HR 599.

Representative McClinton is recognized to speak on HR 599. Representative McClinton, the floor is yours.

Ms. McCLINTON. Thank you, Mr. Speaker.

Mr. Speaker, I rise today to thank you and my colleagues for recognizing November 25 as "Elimination of Violence Against Women Day" in Pennsylvania. HR 599 allows Pennsylvania to formally recognize November 25 alongside the United Nations' International Day for the Elimination of Violence Against Women.

Worldwide, approximately one in every three women has or will experience some sort of physical or sexual violence in their lifetimes. Those percentages are much higher in some countries. We need to set an example to all that the Commonwealth of Pennsylvania does not condone violence against women, or anyone for that matter. In the United States, the most costly is the cost of violence by a domestic partner. It costs nearly \$6 billion a year, with more than \$4 billion of that cost for medical and other health expenses, with nearly \$2 billion in productivity losses, such as being unable to work while recovering.

Eliminating violence against women is a long-term process. We must ensure that when our children are young, they are taught to value and respect all human lives. We must ensure that those who are convicted of crimes of violence against women are sentenced appropriately and are given any mental health care treatment that is needed.

Unfortunately, I have seen the ugly head of domestic violence, both in my community and in my family. This is a very serious issue that we must address, and I am grateful to my colleagues for joining me in recognizing the need to raise awareness of this pressing global importance.

The U.N.'s recognition of the International Day for the Elimination of Violence against Women is beginning with a 2-week period that they call the 16 Days of Activism, which ends on December 10, Human Rights Day. As we enter into the holiday season, please remember this resolution and ensure that we are protecting women, both at home and abroad.

Once again, thank you for adopting this resolution and recognizing the need to eliminate violence against women.

Mr. **THOMAS** offered the following amendment No. **A03440**:

Amend Bill, page 1, line 3, by inserting after "Philadelphia"; and providing for right to appear pro se

Amend Bill, page 1, line 17, by inserting after "system" which shall guarantee the right of an individual to appear pro se

The SPEAKER. On the question, the Chair recognizes Representative Thomas.

Representative, please suspend. Just please wait.

Members, the bill in front of us is SB 283. The amendment is 3440, offered by Representative Thomas.

He will have the floor momentarily to speak on his amendment. I would ask that all members please take your seats. Representative Thomas is entitled to the opportunity to speak on his amendment. I would like all members to please take your seats. If you have any conversations, please take them to the anterooms. Members, please take your seats. All conversations to the anterooms. Members, please take your seats. Those conversations in the back, please take them to the anterooms.

Representative Curtis Thomas, the floor is yours.

Mr. THOMAS. Thank you, sir.

Good afternoon, Mr. Speaker. You have before you amendment A3440. The amendment very simply asks that we codify the requirement of a defendant's ability to represent him or herself in the traffic court, traffic court division of municipal court. The reason it is necessary is because under current law there is nothing that stops you from representing yourself. But because traffic court division is under municipal court, once this

whole issue is resolved, it is quite possible that municipal court can require the traffic court division to comply with its rules, which require that you be a member of the bar before you can address a municipal court judge.

And we just think that, just in the last year, between '14, which is when this process started, in '13 there were 138,000 traffic court matters. Under this interim transfer of traffic court duties to municipal court, it dropped to 88,000; from 138,000 to 88,000.

The court, between 2013 and 2014, when this transfer took place, dropped from 202,425 cases to 148,192, and I think that is because the rules of municipal court make it a little bit more difficult for you to have access and fairness. And so to that end, I am asking that we codify the requirement of allowing defendants to be able to represent themselves before this traffic court division.

Thank you. I would like your support on that amendment.

The SPEAKER. Chairman Marsico, on the amendment.

Mr. MARSICO. Thank you, Mr. Speaker.

Mr. Speaker, I oppose this amendment as well. You should know that the Senate passed this over. It was unanimous, 49 to 0. Adding this amendment would delay the process to eliminate the Traffic Court of Philadelphia. This is the second session for this bill. As you know, if it is passed, it goes right to the Governor, and then it would go to the voters on a referendum. So with that in mind, this would delay the process.

I ask for a negative vote. Thank you.

The SPEAKER. Representative Thomas, for the second time. Mr. THOMAS. Mr. Speaker, the speaker mentioned that support for this amendment would delay the process. We are talking about access to the courts. We are talking about there are very few opportunities in Pennsylvania or nationwide, where you do not need, where you need a driver's license. Driver's licenses and traffic-related matters are issues that are tied to income, families, and communities. And so while this would be a delay, the delay is not permanent. Delay will not harm the process as it currently exists. And I would like to take this up with the chairman at a later date, because this bill talks about abolishing traffic court.

I just received a memo from Judge Glazer, who oversaw this whole process of cleaning up Philadelphia Traffic Court, and he says that this legislation does not abolish the court as much as it provides an outstanding alternative to traffic court. So if there is a delay, maybe we will clear up that issue during the delay.

But I ask for your affirmative support with this amendment.

Mr. Speaker, it is a similar amendment. The first one dealt with an absolute right to represent yourself with a municipal court. This particular amendment provides an absolute right to be able to represent yourself.

As some of you know, nowadays a pretty good lawyer is going to require you to come up with \$300 to \$500 an hour. Now, these traffic taker red light violations, \$175. Under current rules of municipal court, you could end up spending \$1,000 to defend on \$175 ticket. Municipal court will instruct defendants to not represent yourself; bring a lawyer. This makes access more difficult, because if you need that driver's license in order to work and take care of your family, you might not have that much money in your pocket.

And so, Mr. Speaker, this would provide the same relief. This comes down to access and fairness and not putting people in a difficult situation. So I ask for your affirmative vote.

Let me thank the 75 people that did stand up on the last amendment. We just need a few more from over here and we could go home with a victory today.

The SPEAKER. Thank you, Representative Thomas. Representative Michael O'Brien, on the amendment.

Mr. O'BRIEN. Thank you, Mr. Speaker.

Let us take out Occam's razor for one moment here. All this does is ensures that some schmuck has his day in court and can stand up and plead his case - nothing more, nothing more. While this is wrapped up in a Philadelphia issue, it is not a Philadelphia issue. It is a Commonwealth issue. Philadelphia Traffic Court is Philadelphia's magisterial court, Philadelphia's magisterial court. So what this does, what this amendment does is ensures that in 67 counties, in their magisterial court, any schmuck can go in and plead his case.

I would ask for a "yes" vote.

The SPEAKER. Chairman Marsico, on the amendment.

Mr. MARSICO. Thank you, Mr. Speaker.

For the reasons stated before I oppose this amendment as well. In addition, there is already a constitutional right under the Sixth Amendment to self-representation in criminal cases as well as civil cases. There are already court rules that would, in place throughout the State, guarantee the right to self-representation, and also, there is already a judicial canon in place directing judges to allow for self-representation.

For those reasons I oppose the amendment and ask for a negative vote.

The SPEAKER. Representative Thomas, do you wish to be recognized for a second time?

Mr. THOMAS. Yes, Mr. Speaker.

The speaker was correct that this would allow us to codify that and guarantee that no schmuck is denied access to the courts.

More commonly known as Jerry, Airman Johnson served as a crewmember of the B-29A Superfortress Bomber in the 371st Bomber Squadron of the 307th Bomber Wing during the Korean war.

On October 23, 1951, Jerry's propeller-driven aircraft was shot down by enemy MiG jets over Namsi Airfield in North Korea. These brave airmen were going up in propeller-driven aircraft to take on MiG jets during that time. It is reported that Airmen Johnson survived the crash and was captured as a prisoner of war. As is far too often the case with American POWs and MIAs (missing in action), Jerry's remains were never found and he was officially declared dead on January 28, 1954, at the age of 21.

In addition to having his name forever inscribed on the Courts of the Missing at the Honolulu monument, Jerry was awarded the Air Medal, the Purple Heart, the Prisoner of War Medal, the United Nations Service Medal, the National Defense Service Medal, and the Republic of Korea War Service Medal.

As President Calvin Coolidge aptly stated, "The nation which forgets its defenders will be itself forgotten." It is my hope that the designation of this prominent new bridge in our community will be a lasting reminder of not only in memory of

Jerry's selfless sacrifice, but to the bravery of all American air crews who valiantly took to the skies in those propeller-driven aircraft at the beginning of the Korean war to engage in mortal combat with the far more technologically superior MiG fighter jets.

In conclusion, I want to thank again the members of the House for supporting this resolution. Thank you.
