RESOLUTION PURSUANT TO RULE 35

Mr. FRANKEL called up HR 591, 2548, entitled:

A Resolution honoring the extraordinary life and dedicated service of Elsie Hillman and expressing condolences on her death.

On the question,

Will the House adopt the resolution?

The SPEAKER. On the resolution, Representative Frankel.

Mr. FRANKEL. Thank you, Mr. Speaker.

Mr. Speaker, I rise today to offer HR 591, which honors the extraordinary life and dedicated service of my friend – and the friend of many here today – and my constituent, Elsie Hillman.

Elsie Hillman passed away earlier this year at the age of 89 after a lifetime of philanthropic and civic contributions to western Pennsylvania and the entire Commonwealth of Pennsylvania. Although Elsie was a committed Republican, known nationally for her outspoken views, she was also a champion of bipartisanship who consistently worked with members of both political parties to accomplish great things. Elsie's example of rising above the partisan barriers that often

divide us in this chamber and nationally is an example we should all strive for.

Mr. Speaker, Elsie would have celebrated her 90th birthday yesterday, and I thought that this would be a good time to briefly go over what a remarkable woman she was, a woman I was proud and honored to call my friend.

The SPEAKER. Representative Frankel, if you will please suspend just for a second.

Members, please take your seats, and if you could, take the conversations to the anterooms, please. Please take your seats. Thank you. And we are commemorating an outstanding individual who has passed away.

And, Representative Frankel, the floor is yours.

Mr. FRANKEL. Thank you. Thank you, Mr. Speaker.

Elsie Hillman was born in Pittsburgh in 1925, and her commitment to public service started at a very young age. During World War II Elsie cleaned surgical instruments at a local hospital, sold war bonds, and knitted socks for soldiers.

While studying at Westminster Choir College, Elsie met Henry Hillman, a Navy pilot stationed in Brooklyn. They were married and settled in Pittsburgh after the war. It was not long after that that Elsie began her interest in politics, becoming a Republican committeewoman in the 14th ward of the city of Pittsburgh. In the 1960s Elsie was selected as chairwoman of the Republican Committee of Allegheny County, making her the first female chair of a major political party in an urban area in the country. During the political and social upheaval of those days, Elsie was an outspoken supporter of religious and interracial inclusion in Pittsburgh's cultural and business community. Throughout the 1970s and 1980s, Elsie's interest and involvement in the local, State, and national politics grew as evidenced by her chairing several campaigns and her election to the Republican National Committee. This interest in politics and public service famously continued up until her very last breath.

Elsie and I did not share the same political party, and she and I worked to elect different candidates over many years, and many times – probably most of the time – her candidates won. They included Governors Scranton, Thornburgh, and Ridge, and Senators Specter and Heinz, and she had a very close relationship with former President George H.W. Bush.

But, Mr. Speaker, she did not let politics define or limit her outreach or her hopes for others in the community. Elsie always wanted more women to run for public service and established a nonpartisan political action committee, to recruit women to run for elective office, in 2006.

In 1997 the Elsie Hillman Chair in Women and Politics was established by the Hillman Foundation at Chatham University to bring nationally renowned leaders, scholars, and activists to the school to educate students about the role of women in the political process.

Health care was another issue near and dear to Elsie's heart. During the AIDS (acquired immune deficiency syndrome) crisis in the 1980s, Elsie became heavily involved in the Pittsburgh AIDS Task Force and was one of its founders, and she personally delivered dinners and flowers and all kinds of warmth to folks, people who were actually dying of AIDS, at a time when there was extraordinary fear and stigma surrounding the disease and the LGBT (lesbian, gay, bisexual, and transgender) community.

Two of Elsie's many crowning achievements were the establishment of the Hillman Cancer Center at UPMC (University of Pittsburgh Medical Center), a world-class cancer

treatment center, and the Hillman Pediatric Transplantation institute at Children's Hospital of Pittsburgh, which pioneered America's first pediatric transplant program.

Throughout her nine decades on this earth, Elsie Hillman was a generous philanthropist and activist, strongly advocating for interfaith action, women's rights, and the rights of minorities, including the LGBT community.

In light of her many achievements, Elsie was the recipient of many honors and awards, which are way too numerous to be able to enumerate here.

Elsie loved people. She valued family over anything else. She was married to her husband, Henry Hillman, for over 70 years, and left behind 4 children, 9 grandchildren, 14 great-grandchildren.

Mr. Speaker, Elsie was a fixture in the Squirrel Hill neighborhood of Pittsburgh. I remember she would be driving around. If I was walking the dog, she would stop by and roll down the window and have a conversation. You could see her walking the streets in the commercial district of Squirrel Hill, an extraordinary woman but also a very down-to-earth woman. We will all miss her. I will miss her. Our city, our county, and our Commonwealth will miss this great woman.

As our national dialogue has become so divisive and polarizing, Elsie's example of using politics as a way to gain people's trust and to bring people together is a model we should all emulate as we strive to improve the lives of the people we serve.

I ask all my colleagues for an affirmative vote on HR 591. Thank you.

Elsie Hillman epitomized what was really wonderful in America for a group of people that seldom will roll up their sleeves and get involved in politics to change the country for the better.

Elsie was a groundbreaker in the Republican Party. She was the first to break through the wall to allow a woman to be in the executive decisionmaking of the party. She was also groundbreaking in the fact that she reached out to labor in Pittsburgh to make sure labor was included when policy decisions should be made, and lastly, she was a strong supporter of Senator Heinz, who had the country in mind when he protected Social Security.

For all those reasons Elsie Hillman is one of our great citizens, because she was willing to put aside that wealth and get involved in the difficult days of politics to try to make the country better.

BILLS ON CONCURRENCE IN SENATE AMENDMENTS

The House proceeded to consideration of concurrence in Senate amendments to **HB 857**, **PN 2631**, entitled:

An Act amending the act of May 17, 1921 (P.L.682, No.284), known as The Insurance Company Law of 1921, in casualty insurance, providing for emergency service system billing; in automobile insurance issuance, renewal, cancellation and refusal, providing for coverage obligations of loaner vehicles; and, in children's health care, further providing for expiration.

On the question,

Will the House concur in Senate amendments?

The SPEAKER. Moved by the gentlelady, Ms. Pickett, that the House concur in the amendments inserted by the Senate.

The Chair recognizes Representative Pickett, chair of the Insurance Committee, for a brief description of the Senate amendments and remarks on the bill.

Ms. PICKETT. Thank you, Mr. Speaker.

The Senate did amend HB 857. It now includes a provision for emergency service system billing; that language is from HB 347. It also provides for coverage obligations of loaner vehicles; that language is from SB 861. And it repeals the current CHIP (Children's Health Insurance Program) Article XXIII and creates a new article for the CHIP program with reauthorization until December 31 of 2017. It moves the administration of CHIP from the Pennsylvania Insurance Department to the Pennsylvania Department of Human Services, and that is language from HB 1633.

We are in agreement with this. Thank you, Mr. Speaker.
