LUKE KARAM PRESENTED

Please join me in welcoming to the hall of the House Luke Karam, a senior at Bethlehem Catholic High School, along with his brother, Cole, who has also placed at States, and his father, Jeff, who is Luke's coach at Bethlehem Catholic. Cole and Jeff are seated in the back of the House.

Luke recently capped his high school career by winning his third PIAA wrestling championship. Luke's freshman season ended with a narrow overtime loss in the State finals at 106 pounds. He followed that up by winning the 113-pound AA title as a sophomore and the 126-pound AAA title as a junior and senior. Luke's career record was 156 wins, 10 losses, and he is the school's only four-time district and regional champion and is third-time State champion. Congratulations.

Following graduation, Luke will hit the books and the mat not far from home. He is committed to attend Lehigh University. Please join me in a round of applause for Bethlehem Catholic's Luke Karam.

GREGORY BULSAK AND JAKE WENTZEL PRESENTED

The SPEAKER. Representative Saccone and Representative Kortz, with respect to two champions.

Mr. SACCONE. Mr. Speaker, thank you.

Colleagues, ladies and gentlemen, it gives me great pleasure to introduce a repeat gold-medal wrestler from the South Park Eagles, both of our wrestlers from South Park – Representative Kortz and I share that school district – are here for the second time. You might remember they were here last year.

I am introducing Gregory Bulsak, who won gold at the States on Saturday, March 12. Mr. Speaker, he competed in the 182-pound class and Greg completed his senior season with 44 wins in one season, a new school record, and his second gold medal. Mr. Speaker, Greg was also selected to represent the PA All-Stars versus the USA All-Stars in the Pittsburgh Wrestling Classic, where he defeated the USA All-Star from Minnesota from Jackson County Central High School there also.

His record throughout his high school career is two PIAA State championships, three section championships, three WPIAL championships, three southwest regional championships, and champion PA All-Stars versus USA All-Stars, and he did all this while maintaining a 3.7 GPA (grade point average). Yeah; give it up. Give it up for Greg.

He has accepted a scholarship to wrestle for Clarion University. And it is important to note that both Jake and Greg are the first gold-medal winners for the South Park Eagle Wrestling Team and repeat gold-medal winners, and along the way they have rewritten the record books at South Park High School and in Pennsylvania. They have certainly accomplished something worthy of the recognition of the people in Pennsylvania, and I present to you Greg Bulsak, and Representative Kortz will represent—

Mr. Speaker, colleagues, ladies and gentlemen, it gives me great honor to introduce a champion wrestler, a gold-medal winner, a repeat gold-medal winner from the South Park Eagles, Jake Wentzel. Jake.

He won the PIAA championship gold at the States in the 160-pound weight class on March 12. Jake defeated Eisenhower's challenger 3-nothing in the class AA finals to win the gold. Mr. Speaker, Jake finished his senior season undefeated with a spectacular record of 42 and 0. He can lay claim to an amazing run where he did not allow a single point in the State tournament 3 years in a row. Mr. Speaker, Jake's final record is very impressive – career record 156 wins against 15 losses, two-time PIAA State champion, four-time PIAA State place winner, two-time Powerade tournament finalist, one-time Powerade tournament champion, three-time section champion, three-time WPIAL champion, three-time southwest regional champion, and last week, Mr. Speaker, USA Today named him as second team All-United States.

Greg carries a 4.1 grade point average and is a member of the National Honor Society, while doing all this in wrestling. That is pretty awesome, Mr. Speaker.

Mr. Speaker, Jake and Greg are joined here today by their head coach – if you would please stand up in the back – from the Eagle Wrestling Team, Walt Karrenbauer; the assistant coach, Tyler Nauman. Also seated in the back is Jake's father, Frank Wentzel, and Greg's parents, Greg and Gina Bulsak. Would you all stand, please.

Mr. Speaker, I would ask all my colleagues to join with Representative Saccone and myself in congratulating these two-time State champions, Jake Wentzel and Greg Bulsak. Gentlemen.

STATEMENT BY MRS. WARD

The SPEAKER. Representative Ward, the floor is yours. Mrs. WARD. Thank you, Mr. Speaker.

I would like to thank my colleagues for an affirmative vote on HR 789, which recognizes "Nurses Week" in Pennsylvania from May 6 through May 12, which is Florence Nightingale's birthday.

Florence Nightingale was the English nurse that became known as the founder of professional nursing, especially due to her pioneering work during the Crimean War. Due to her habits of making rounds at night, Nightingale became known as the Lady with the Lamp.

National Nurses Week has been established to recognize the contributions that nurses make to health care in our communities. Pennsylvania has 218,000 registered nurses, including approximately 55,000 licensed practical nurses, and 12,000 advanced practice registered nurses, which makes nursing the largest licensed health-care profession in this Commonwealth.

Please join me in thanking nurses from all over the State for their service and high quality of nursing care to patients in our communities.

STATEMENT BY MR. MARSICO

The SPEAKER. Representative Marsico is recognized on HR 799.

Mr. MARSICO. Thank you, Mr. Speaker.

Every year I like to take the opportunity to honor Arbor Day by introducing a resolution that recognizes Arbor Day, as well as arranging for all of you to receive a seedling to plant to commemorate this occasion.

I would like to thank Fairview Evergreen Nurseries, Inc., in Fairview, Pennsylvania, near Erie, for providing us today with these seedlings. Fairview Evergreen Nurseries is a fourth-generation, family-owned and operated company with over 100 years of service to the green industry.

These seedlings are eastern white pines, and the care instructions are on the tags attached. The containers in which the seedlings are planted were supplied by Henry Molded Products of Lebanon, Pennsylvania. The pots are manufactured using 100 percent pre- and post-consumer newsprint, craft paper, and other selected waste papers; are biodegradable; and can be planted directly into the ground.

Thank you to the officers of the Pennsylvania Future Farmers of America Association for potting these seedlings. Today more than 12,000 students are members of the Pennsylvania FFA association.

I would like to also thank Mr. Gregg Robertson, the government relations liaison for the Pennsylvania Landscape & Nursery Association, for coordinating this effort.

Lastly, thanks to the members as well as leadership for supporting HR 799.

STATEMENT BY MR. HANNA

The SPEAKER. Representative Mike Hanna is recognized to speak on HR 839.

Mr. HANNA. Thank you, Mr. Speaker.

Mr. Speaker, I would like to thank the members for joining me today in passing HR 839, which recognizes "Bronchial Thermoplasty Awareness Day" in Pennsylvania.

Mr. Speaker, today I am joined by my constituents, Phil and Michelle Auman, who were introduced earlier in the back of the House. If they would rise again. If the members would give them a warm welcome.

Mr. Speaker, Michelle suffers from severe persistent asthma and is in need of this innovative procedure. Unfortunately, her insurance company deems this procedure experimental, which prevents her from experiencing the benefits of this procedure due to the financial costs that she and her family would incur.

Dr. Henry Ostman, a board-certified pulmonary, critical care, and internal medicine doctor, is also with us today. If Dr. Ostman could rise. If we would give him a welcome as well, please.

Dr. Ostman has performed bronchial thermoplasty on two patients in Harrisburg, and the results have shown a marked reduction in asthma attacks. Today he joins us as we urge all Pennsylvania-licensed insurance companies to cover this procedure in its entirety.

Mr. Speaker, scientific literature shows evidence that bronchial thermoplasty is an established procedure that improves health outcomes while reducing costs over time. This outpatient procedure becomes cost-effective, because once it is performed in three sessions, the treatment is complete and does not need to be repeated, which helps to offset any costs that can accrue annually.

Mr. Speaker, the fact is, patients can become severely debilitated and those suffering from severe persistent asthma are constantly in and out of the hospital. Every time Michelle is hospitalized, she has to spend days or weeks in the hospital, including in the ICU (intensive care unit), all of which costs her insurance company thousands of dollars.

As noted in the resolution, Mr. Speaker, those treated experienced a 32-percent decrease in severe asthma attacks, an 84-percent reduction in asthma-related emergency room visits, and 66 percent fewer days lost from work, school, and daily activities. You may be interested in knowing that Harrisburg, Philadelphia, Allentown, Pittsburgh, and Scranton are 5 of the top 50 most challenging places to live with asthma, according to the Asthma and Allergy Foundation.

Mr. Speaker, I want to thank you all for voting in favor of recognizing May 2, 2016, as "Bronchial Thermoplasty Awareness Day" in Pennsylvania. Together we can help provide our constituents with better health-care coverage tailored to their individual needs.

STATEMENT BY MR. ZIMMERMAN

The SPEAKER. Representative Zimmerman is recognized to speak on HR 828.

Mr. ZIMMERMAN. Thank you, Mr. Speaker.

I rise today to recognize Pennsylvania's second largest industry, tourism.

HR 828 declares the week of May 1 through 7, 2016, as "National Travel and Tourism Week" in Pennsylvania.

Tourism makes up almost 5 percent of the State's entire GDP (gross domestic product), attracting 190 million tourists a year. These visitors spend \$40 billion at our many attractions, hotels, restaurants, urban areas, historic sites, and amusement parks. Tourism is a major employer, supporting 482,000 jobs, everything from first jobs for young people to good-paying, family-supporting careers.

Thanks to our vibrant tourism industry, \$4.1 billion in tax revenue is generated for State and local government. Tourism has helped many communities, both urban and rural, redevelop and build their economies.

Tourism is not specific to any one region in the State. From Erie to Philadelphia, from the Poconos to the Laurel Highlands, just about every part of Pennsylvania has something great to offer visitors. A recent poll shows how diverse we are. Not only is our beautiful outdoors among the top reasons visitors come here, but our big cities are as well. Whether it is a night of celebration in the big city or a quiet moment among the stars in a rural setting, Pennsylvania has something for every traveler.

And remember, tourism is a homegrown industry. It is unique. You cannot find Hersheypark or Amish country or the Gettysburg Battlefield anywhere else, and they certainly are not going to be outsourced overseas. And while visitors go home, the dollars they spend stay here.

So as May arrives and people begin to plan their summer vacations and weekend trips, we should encourage them to visit the Keystone State, and as our new slogan says, "Pursue Your

Happiness."

STATEMENT BY MS. McCLINTON

The SPEAKER. Representative McClinton is recognized to speak on HR 827.

Ms. McCLINTON. Thank you, Mr. Speaker.

Thank you, fellow House members, for helping me recognize the need to educate our youth in the battle against illegal drugs.

HR 827 declares April 21 as "National D.A.R.E. Day" in Pennsylvania. D.A.R.E. stands for Drug Abuse Resistance Education. I believe that the fourth word in the program's title, "education," is the most important. Teaching young people about the dangers of drugs helps to ensure that our next generation of leaders will grow up healthy and safe. Without drug education programs, many children and teenagers, especially, will remain uninformed about drug abuse. They would also be powerless to take action in the fight against drugs. Everyone must understand the problems associated with drug abuse, how the body deteriorates and how families suffer, and education plays a key role in that.

D.A.R.E. was developed in 1983 as a joint program between the Los Angeles Unified School District and the Los Angeles Police Department and its former police chief, Daryl Gates. It has grown from L.A. into a national program and has also been established abroad in the United Kingdom.

As I said earlier, "education" is the most important word in D.A.R.E. In addition to teaching about the dangers of drugs, it is also imperative that we teach our youth that they do not need to use drugs to be cool, they do not need to use drugs to be popular, or whatever the words are that they are using today. We need to give youth the courage to say no and we need to make sure that they have the self-confidence to make sure that that no sticks with them when their peers try to turn that no into a ves.

I would like to end my comments today with the secondary definition for D.A.R.E., one that anyone who has seen the face of drug addiction can attest to, and that is that "Drugs Are Really Evil."

For those of you who have children, I hope you took advantage of last Thursday and shared your workday with them. And if you do not have children, I hope you took the time with a young person in your district and allowed them to shadow you.

Take Our Daughters And Sons to Work Day started out as Take Our Daughters To Work in the summer of 1992 by the Ms. Foundation for Women, and at that time the day was designed specifically to address self-esteem among girls and to encourage them to consider different careers. But in 2003 the day was expanded to include boys and since then has been

celebrated on the fourth Thursday of April every year in order for the millions of children and parents and schools in over 3.5 million workplaces across this country and in other countries around the world – 200 countries in fact – to plan ahead for this event. It is estimated that over 40 million children, young adults, parents, and mentors participated this year.

On its Web site, the Take Our Daughters And Sons To Work Foundation states that the program is designed to be more than a career day, that it goes beyond the average practice of shadowing an adult. While exposing boys and girls to what a parent or mentor does in their life during the day at work, it is also important to show them the value of their education, help them discover the power and possibilities of a balanced work and life at home, create opportunities for them to network with other adults, and provide them with a real, hands-on experience that is key to them achieving success in their lives.

Each year the Take Our Daughters And Sons to Work Foundation releases a theme for the day, and in previous years it was such as "Grow a Future," "A New Generation at Work," or "Work in Progress." This year's theme: "Sparking Aha Moments." An aha moment: a moment of sudden insight or discovery; a moment that leads that little girl or that little boy to choose a specific career; a moment that motivates them to make a positive change in their life, moves them to be a leader in our communities, and encourages them to dream big and work hard.

So once again, Mr. Speaker, I thank you and thank everyone for their support of this day, and I hope that we all took the time to spark the aha moment for a young person, someone who may become a future doctor, a future teacher, a computer engineer, or even a legislator right here in the House of Representatives.

I look forward to raising awareness for next year's Take Our Daughters And Sons To Work Day.

STATEMENT BY MR. FRANKEL

The SPEAKER. Representative Frankel, the floor is yours. Mr. FRANKEL. Thank you, Mr. Speaker.

I rise today to thank my colleagues for passing HR 833, designating May 2 through May 8, 2016, as the "Days of Remembrance of the Victims of the Holocaust Week" and May 5, 2016, as "Holocaust Remembrance Day" in

Pennsylvania. With our vote today, we reaffirm our recognition of some of the most horrifying moments in mankind's history and our determination that they will never be repeated.

As in years past, HR 833 recognizes that Jews, Gypsies, gay men and women, Jehovah's Witnesses, and many others suffered grievous oppression and death under the Nazi tyranny.

In light of the passage of HR 833 today, I want to briefly report on the results of Act 70 of 2014, which is helping our children learn about the Holocaust, genocide, and bigotry. Act 70 was a result of years of negotiation and compromise, and it declared the General Assembly's belief that we should provide children with an understanding of the importance and magnitude of the Holocaust and to let them know that there are consequences to unchecked ignorance, discrimination, and persecution.

Under Act 70, the General Assembly strongly encouraged school districts and entities across this Commonwealth to offer instruction in the Holocaust, genocide, and other human rights violations. The Pennsylvania Department of Education, in conjunction with its local partners, have been able to provide the tools and the resources to local teachers and school districts to decide on the appropriate Holocaust curriculum. Similar to the resolution before us today in this chamber, the topics covered under Act 70 included the breadth of the history of the Holocaust; the definition, history, response, and actions taken in the face of genocide; human rights violations; and anti-Semitism, racism, and the abridgement of civil rights. As a result of these efforts, thousands of Pennsylvania teachers have received training each year to teach about the Holocaust, genocide, and human rights.

In particular, I would like to thank the Pennsylvania Department of Education, as well as the Pittsburgh Holocaust Center and the Holocaust Awareness Museum and Education Center in Philadelphia, for helping us with this most important endeavor.

We have also been aided in these efforts by Pennsylvanians who were eyewitnesses, such as the survivors of the death camps and the liberators, such as U.S. Army troops who saw the horrors of the Holocaust firsthand. It is also important to thank the intermediate units who have hosted trainings in Pennsylvania, as well as individual teachers, nonprofit groups like the Anti-Defamation League, the Shoah Project, and the U.S. Holocaust Museum, who are also part of these projects.

There is no denying the increased interest in teaching and learning about the Holocaust in the Commonwealth. Teachers are being trained in record numbers across the entire State, and in my hometown of Pittsburgh, the summer program for teachers at the Pittsburgh Holocaust Center had its largest attendance in history last summer, and they will offer an up-to-3-day course again this year.

Mr. Speaker, with HR 833 we express our unity in remembering this horrific period in history, and with the help of Act 70, we will ensure that when school districts want to teach about the Holocaust, they have the tools to do so.

I would like to sincerely thank my colleagues again for passing this resolution.

I am very honored and very sad to offer and cosponsor this resolution with Representative Evans and Representative Wheatley, honoring the memory of Alexis Hendrickes, who passed away at the age of 16 on March 28, 2016.

With us today, to the left of the Speaker's rostrum, are Willie Hendrickes, Alexis' dad – stand up, Willie – Lisa Fuller Hendrickes, Alexis' mother; Willie Hendrickes, Jr., Alexis' grandfather; Donald Fuller, Alexis' uncle; Michele Fuller, Alexis' aunt; Alvin Hendrickes, Alexis' uncle; and Micaiah Hendrickes, Alexis' cousin. Welcome.

Mr. Speaker, Alexis Hendrickes was born June 3, 1999, to her parents, Willie and Lisa. She attended St. Margaret Mary School here in Dauphin County, where she participated in cheerleading, and also as a student at Bishop McDevitt High School in Harrisburg. Lexi was a member of the yearbook staff and excelled in the shot-put event as a member of the track and field team.

She attended the Richie School of Dance, where she participated in ballet, tap, baton, and jazz for many years. She was a volunteer with the East Shore branch of the Dauphin County Library for 6 years and had several books in circulation named in her honor for her dedicated volunteer service.

And at a young age Alexi assisted her mother at the House of Representatives in the Democratic Appropriations Committee Office under the Honorable Dwight Evans.

She was a gifted student, had a passion for biology, and was touring colleges to become a physician's assistant, and enjoyed reading books, cooking, listening to music, and spending time with her family and friends. A beloved daughter, an exemplary student and citizen, Lexi consistently demonstrated outstanding ability, concern, and generosity of spirit, thereby bringing great credit to her school, her family, and her community.

Mr. Speaker, many of us felt great sorrow when we heard the news that the world lost the light of Alexi. It is unimaginable to lose a child before their time and our hearts go out to her many family and friends who are experiencing an unbelievable loss in their lives. The expectation is that you will get over a loss such as this, but the reality is, you will grieve forever in some manner. You will not get over the loss of Alexis; rather, you will learn to live with this loss. You will heal and you will rebuild yourself around the loss that you have suffered.

Psalm 147:3 tells us that God heals the brokenhearted and binds up their wounds. May you rest your faith with God by your side, and may God take care of Alexis now that she is in

His care, and may God bless you, your entire family and friends, and forever hold her memory in your hearts and carry the light of her life with you always.

Mr. EVANS. Thank you, Mr. Speaker.

Good afternoon. Today I would like to speak about a young lady whom I have known since she was born. Alexis Hendrickes was my little buddy. That is what I called her, "my little buddy." I was the first person in the office to hold her when she was 2 weeks old on her first office visit with her mother. I had the privilege of watching her grow. Her mother, Lisa Renee, has worked for me for 24 years. Her father, Will, who works in DIT (Democratic Information Technologies), I have known for 17 years, and they are like family to me. Alexis was their only child.

When she was 6 years old, Lisa Renee asked if she could bring her to work because Alexis was curious about her job. Lisa Renee worked for me on the Appropriations Committee at the time. I naturally said yes because of her request. Alexis became an honorary staff member on the Appropriations Committee, working summers in the office until she was 10 years old. She came to know many of the members, lobbyists, and Capitol staff. Everybody knew Alexis, and they marveled that a kid her age enjoyed coming to work with her mother every day. She helped out in the office with the preparation of the State budget, made copies of documents, attended committee meetings, served guests drinks and snacks, and when she was old enough, even answered the phones. She also worked the same hours that the rest of the staff worked – do not tell the child labor people about that – even taking naps in the office when staff worked around the clock. She was a constant figure in the Capitol Building during her summer school breaks. Everybody knew her name.

She had a love of books from an early age and had a passion for biology. She ventured into different school activities, and even though she aged and did not come into my office as frequently, her mother would always keep me updated on her activities. Her mother made sure to give me new school photos of her, and I proudly displayed them on my desk. She was loved by anybody who met her because she made an impression on you, either by the way she carried herself at such a young age in such a professional setting or by the constant smile she had on her face. Even though she was only a junior in high school, Alexis knew what she wanted to be and what college she wanted to attend. She had a goal to be a physician's assistant and attend the Pennsylvania College of Technology in Williamsport.

Unfortunately, her sudden death leaves us sad and at a loss for words. Word of her death spread throughout the Capitol Building and left many in shock, disbelief, and tears. We mourn for her with her parents, Will and Lisa, and their family. We thank them for sharing their daughter with us. She will be missed. No one can explain the pain that you feel when there is a death of your child. Words will not do it, but we all have to recognize that nobody is above it. So I share with all of you today that in all my years of being here, this is probably the most difficult thing I have ever had to do.

So the family will be in room B-31, Main Capitol, to receive guests, and light refreshments will be served.

I thank you very much, and God bless them.

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

Representative Greg Vitali, on the bill.

Mr. VITALI. I am not suggesting this is necessarily controversial, but I just want to make sure every member understands what is happening here so they can make an informed decision. So I am just going to ask the maker just to kind of explain and maybe— It could be controversial for a couple people.

The SPEAKER. Representative Dush, do you wish to stand for interrogation?

The gentleman has indicated he will so stand for interrogation and will come to the front podium.

Members, please take your seats.

Representative, please hold.

Mr. VITALI. Are we ready? Okay.

The SPEAKER. Representative Vitali, you may proceed with very specific questions pertaining to the bill.

Mr. VITALI. So this is the so-called In God We Trust bill that imposes – well, contains certain provisions with regard to using that expression in public schools, in public buildings. I just wanted you to just go over it one more time just so everyone knows when they are voting what they are voting on. That is all.

Mr. DUSH. Certainly. Actually, if we look over our shoulders here at the portrait and the language here in the House, it has the same purpose. The purpose of the bill is so that our children can have the same opportunity to reflect on God, as is in the preamble of the Pennsylvania Constitution, "We, the people of the Commonwealth of Pennsylvania, grateful to Almighty God for the blessings of civil and religious liberty, and humbly invoking His guidance, do ordain and establish this Constitution." And the purpose of this bill is simply to do what we do here in the House and throughout the State Supreme Court and the State Senate, display things that will cause our students to reflect on why this language was so important in our Constitutions and in our State Houses.

Mr. VITALI. And again, that is an admirable purpose, but I kind of want to get to, what is it going to require whom to do? In other words, it will require what group of entities to do what?

Mr. DUSH. It does not require anything.

Mr. VITALI. Okay. What does it— Okay; so it does not require— It is a bill about nothing? It is very Seinfeld-esque.

The SPEAKER. Please suspend. Representative Vitali, please suspend.

The purpose of interrogation is to elicit information and answers to which the interrogator is not privy and does not know the answer to. With all due respect, a question such as "Is the bill about nothing?" is not an inquiry into what the purpose or underlying – setting forth the details of the bill. I apologize, but that is not an appropriate inquiry.

If you wish to make any commentary on the bill, I will so recognize you, but I think we are beyond interrogation at this point.

Mr. VITALI. Okay. Let me ask you this: Does the bill require entities – well, what group of entities is the bill directed at?

Mr. DUSH. The schools.

Mr. VITALI. Okay. And does it require schools to do anything?

Mr. DUSH. No.

Mr. VITALI. How does it affect schools? Does it permit them to do things they cannot do now?

Mr. DUSH. It gives them the freedom to and it ensures by statute the freedom of our schools to be able to post our national motto in a historical context.

Mr. VITALI. Okay. Got it. So it is totally optional?

The SPEAKER. Yes.

Mr. VITALI. Okay. Thank you. That is all I have.

The SPEAKER. Sir, do you wish to speak on the bill itself?

Mr. VITALI. No, I do not.

The SPEAKER. Does anybody else wish to speak on the bill?

The SPEAKER. Representative Greiner, amendment 6689, the floor is yours, sir.

Mr. GREINER. Thank you, Mr. Speaker.

Mr. Speaker, I rise in support of amendment A06689, which will strengthen and improve SB 290 to expand the use of ignition interlocks across the Commonwealth and ultimately save lives.

Mr. Speaker, before I begin, I want my colleagues to know—The SPEAKER. Sir, please suspend.

Mr. GREINER. Yes, sir.

The SPEAKER. Members, please take your seats. Representative Greiner is offering an amendment, 6689, and would like to explain what the amendment does.

At this time the Chair would like to turn it over to Representative Greiner. Representative, you may proceed.

Mr. GREINER. Thank you, Mr. Speaker.

I want my colleagues to know that these amendments are the result of a collaborative effort of members of both parties of the House Transportation and Judiciary staff, members of the District Attorneys Association, and also PENNDOT.

Many of the changes included in this amendment are technical in nature, but I want to provide my colleagues, as you stated, with a brief summary of this amendment. It was also agreed to with the maker of the bill over from the Senate.

First, it provides further clarification to state that any vehicle operated by someone with an ignition interlock limited license must be equipped with an ignition interlock system. The current printer's number as passed by the Senate only required the vehicle driven most often by the offender be equipped with an

ignition interlock device. This will strengthen the law by ensuring that those with an ignition interlock limited license only use vehicles that are properly equipped.

Second, it streamlines the ignition interlock limited license program. Under the current printer's number, PENNDOT would be required to issue two separate licenses, one for when an offender is carrying a license suspension and another for after their suspension is completed. The original intent of this legislation was to have one licensing program for anyone serving in this program. This amendment removes this duplicate requirement from PENNDOT and streamlines the legislation.

Third, it fixes an issue that could result from an offender refusing to submit to chemical testing who would later go on to be convicted of general impairment. A refusal to submit to testing comes with an automatic license suspension, if later convicted of general impairment for which there is no license suspension, a, quote, "limbo," unquote, is created since they are already serving a license suspension. This amendment would give PENNDOT the option to extend the term of the ignition interlock limited license up to the original term or recall it completely.

Fourth, this amendment carries over the employer exemption that is currently in law and provides when an offender may or may not drive a company vehicle while they have an ignition interlock limited license.

And fifth, this amendment provides clarity to the law to prosecute someone who tampers with an ignition interlock device. Under current law, tampering charges are rarely prosecuted because it is difficult to prove where the tampering took place. This amendment would clarify that for those who choose to tamper with an ignition interlock device, that the district attorney would be able to prosecute them by providing clarification as to where the crime took place.

Mr. Speaker, this amendment improves and strengthens the legislation that came over from the Senate, and I would urge my colleagues to support it. I respectfully ask for a "yes" vote on this amendment.

What we are seeing constantly now from all the Governors has been passing on the cost of the Pennsylvania State Police into our transportation funding legislation, and it is rising at such a fast pace that a lot of the things that we promised our constituents, repairs of highways and new highway construction as well as pothole repairs, are going to be affected if we do not change how we are funding the Pennsylvania State Police.

I hope that the General Assembly members on both sides of the aisle will take it more seriously as we move forward in the budget process to consider how we are spending our highway dollars. Our highways are in dire need of help, not only in expansion and improvements but as well as repairing those roads that need to be repaired due to heavy winters here in Pennsylvania.

As far as I am concerned, and I know a lot of the other members here in the House are concerned, there is no more critical issue, as far as funding goes, than putting more money into drug and alcohol treatment, especially with the heroin and prescription opiate epidemic that we have across the State of Pennsylvania, Mr. Speaker.

The latest coroner's report pointed to almost 3,000 deaths, 3,000 deaths in the State of Pennsylvania from these opiates and heroin. These deaths, Mr. Speaker, are tragic, each and every one of them are heartbreaking, and many of them are preventable. The three amendments that I have offered, Mr. Speaker, would put \$10 million into the most critical area that we need, and that would be residential rehab and also detox for the State of Pennsylvania.

Mr. Speaker, I have introduced a series of amendments to implement the recommendations of the Basic Education Funding Commission. The first recommendation that came out of that commission, if you read the report, is to establish a school district consolidation incentive fund, and my amendments do that.

The second thing that the recommendation talks about is how we deal with hold harmless, and it recommends that the General Assembly establish a way to deal with hold harmless and to eliminate the negative impacts of that in the way we see fit, and the way I would do that is to establish a basic education equity fund. That fund would drive moneys to the 180 underfunded school districts to bring them up to parity with the 320 districts that are overfunded relative to them, who have benefited from hold harmless over the last 25 years.

So my amendments do that. I have assurances that we will draft legislation and have a hearing on it in the Education Committee, and I look forward to having those discussions because we have had these recommendations now from the Basic Education Funding Commission for 10 1/2 months, and all we have done is use the new formula to push out money, \$150 million to all districts, another \$50 million we put through the Ready to Learn Block Grant, which kind of took back some of the gains of my districts. So we really need to deal with this as a body, and I am encouraged by my discussions with the chairman of Appropriations and the chairman of the Education Committee that we will be able to have legislation for these issues very soon.

These kids often fall between the cracks when it comes to any grants for college, yet they are not quite in a household position able to pay for it.

This \$5 million was put into the budget then, and what we found with the success of the program is that nearly 9,000 eligible students did not receive an award.

I am going to withdraw this right now, Mr. Speaker, but I believe it is very important that we in the upcoming months remember to get some more money in here for our students. Thanks.
