I know we have a lot of good friends here, but we need everybody to please take their seats. We are going to be introducing a very special guest here, so I would ask all members to please take their seats. Would all the members please come into the floor, who are coming in, and take their seats. If you have any conversations, just take them to the rooms off the back, and members, if we could, because we have a very special guest here today. I know some more members are coming onto the floor.

2015 BITUMINOUS COAL QUEEN PRESENTED

The SPEAKER. Representative Pam Snyder, the floor is yours.

Mrs. SNYDER. Thank you, Mr. Speaker.

It is an honor for me today to present to you, my colleagues, Katlyn Allison of Carmichaels. She is our reigning Coal Queen. And I just had someone ask me if there is a coal king, so just to be clear, it is the King Coal Association that hosts the pageant in my district that chooses the Coal Queen. These young ladies are so talented and so beautiful and it is so competitive each year, and Katlyn is our reigning Coal Queen.

She is the 18-year-old daughter of Todd and Lisa Allison and the younger sister of Andrew Allison, and her family is here with us today. If they would please rise, and if you would please acknowledge Katlyn's family. Thank you so much.

Katlyn is a senior at Carmichaels Area Senior High School. This fall Katlyn will be attending Slippery Rock University to major in biology, with aspirations of becoming a physical therapist. She is a very busy young lady. She is the vice president of her senior class, a member of SADD (Students Against Destructive Decisions), the ski club, and a member of the National Honor Society, of which she holds the position of secretary. She also sings, dances, plays the piano, and is the drum major for the high school band.

Katlyn's out-of-school activities include being a member of the Greene Valley Presbyterian Church, where she is the teacher for Kindergarten Church. Katlyn's youth group and the Pittsburgh Project combined their resources to help the elderly and less fortunate to make repairs to both the inside and outside of their homes. Also, she traveled this past summer on a mission trip with Meeting God in Missions to the Dominican Republic, where she met and spent a week with some amazing villagers who touched her heart and changed her life forever.

Katlyn's family has been involved in the coal industry for many generations. Her great-grandfather was the general mine foreman at the Robena Mine No. 3; her grandfather worked for U.S. Steel at the Robena Mine in Alicia and the Dilworth Mine in Rices Landing; and her father, Todd, was employed at Hatfield's Ferry Power Station, a coal-fired power plant that unfortunately was shut down. After 21 years of his service, the plant was closed in 2013.

Katlyn feels very strongly about the importance of the coal industry in our area and our country's need for this natural resource, because coal does keep the lights on.

I also want to acknowledge the Coal Queen pageant committee in the rear of the House: Becky Mitchell; Paddy Pratt, who also happens to be the Coal Queen's aunt; and Jean Hockenberry. If you would give them a round of applause. Thank you, committee.

I want to thank you, my colleagues, and it is my honor to present Katlyn this House citation. If you could give her one more round of Harrisburg applause. Thank you.

BECCA LUFT PRESENTED

The SPEAKER. Representative Mike Regan is now invited to the rostrum for the purpose of presenting a citation to one of our State champions, so if members will please take their seats.

Representative Regan, how are you, sir? The rostrum is yours.

Mr. REGAN. Thank you, Speaker Turzai.

It is my great honor today to pay tribute to an amazing athlete of the 92d Legislative District.

For the past several years Becca Luft of Northern High School has been a dominant swimmer in the region and State, and this year has been absolutely no exception to that.

Becca is here with us today, and she is joined by her parents, John and Lisa Luft, over here. If you will please stand up.

Following up on her 2014-15 gold medal performance in the 100-meter butterfly event at the Pennsylvania Interscholastic Athletic Association Class AA State meet at Bucknell University, she added yet another championship in the same event at this year's championship. Becca won this year's gold medal with an incredible time of 55.72 seconds. It is an incredible accomplishment to win a State championship in high school on any level in any sport, but to be a repeat champion is seldom accomplished.

Becca became the first girls State gold medal-winning swimmer in Northern High School history, and obviously now is the first to win back-to-back State championships in that event.

Becca, on behalf of the House of Representatives, it is a privilege to present a House citation to you. My colleagues, please join me in congratulating Becca Luft of Northern High School for her State championship medal. Thank you.

Thanks, Mr. Speaker.

The SPEAKER. Representative Garth Everett, Representative Doyle Heffley, and Representative Rosemary Brown are now invited to the rostrum, and they are going to be presenting citations to three champions as well.

Representative Everett will start us off, followed by Representative Brown, followed by Representative Heffley, and Representative Parker is here as well.

GAVIN HOFFMAN PRESENTED

The SPEAKER. Representative Everett, please start us off. Thank you.

Mr. EVERETT. Thank you, Mr. Speaker.

It is my great pleasure today to welcome Gavin Hoffman here, who won the 2015-16 AA 195-pound State championship. He is from my hometown of Montoursville, Pennsylvania, and he is the first State champion – we have had a lot of great wrestlers in the past few years, but none of them made it to the championship, and it is our first State champ since 2008, so it is a great day to have him here.

His parents, Jim and Marisa, are up in the back. If they would stand up real quickly. There they are. Thank you. I know they are very proud.

And I was talking with the Hoffmans prior to this, and I kind of anticipated that I would be up here presenting a State championship medal – by the way, Gavin is just a sophomore – that I would be presenting a State championship medal to his brother, Garrett. Garrett had a 49-and-3 record this year and came in second in the 182 pounds. And he is a senior and he is not able to be here today because he has finals up home at school, but he amassed 169 wins in his career and is going to be

wrestling at Bucknell. Gavin this year had a record of 46 and 2 and won his last 36 straight matches into the State championship, and he had 41 wins in his freshman year. So I did a little math, and I think that puts him on track to break his brother's record if he holds true to form for the next couple years, and I anticipate that Gavin and I will be back here, putting some more medals on him.

So it is my great pleasure to present this citation to Gavin. And you can tell they are from a wrestling family, and I am sure they had some interesting wrestling matches in their living room over the years as these two guys grew up. I am not sure who still has the upper hand, but they are both great wrestlers, and I congratulate both of them and their family. Thank you.

JAKE JAKOBSEN PRESENTED

The SPEAKER. Representative Rosemary Brown.

Mrs. R. BROWN. Thank you, Mr. Speaker.

Today I would like to welcome to the House and introduce one extremely distinguished athlete, who represents with honor our Stroudsburg School District in Monroe County. Jake Jakobsen is being honored for his great achievement during the 2015-16 PIAA State Class AAA Individual Wrestling Championship in the 195 weight class.

Jake is a senior at Stroudsburg High School who defeated the wrestler from Norwin High School to capture the first-ever State wrestling gold medal in Stroudsburg School District in Monroe County history. His accomplishments do not end there. His 146 career wins are also the most of any wrestler ever in Monroe County. Jake is truly deserving of this recognition, and his hard work, training, and dedication have made him the distinguished athlete he is today, who is well respected by his teammates, his coaches, family, and friends. But I have to add, not only is he a great athlete, but his reputation among the community back home is of a kind, humble, and wonderful young man.

Jake is also joined here today by his parents, who are up in the gallery. If you want to stand up. John and Mary Jakobsen; his sister, Mackenzie, who I just heard is also a tremendous field hockey athlete; and also his coach, Matt Kleinle. Thank you for coming today with him as well.

On behalf of myself, Representative Dave Parker, and also Representative Jack Rader of Monroe County, and the full House, we congratulate Jake and his team for all of their dedication and accomplishments in making Stroudsburg and Monroe County proud.

But, Mr. Speaker, I would be remiss if I also did not verbally acknowledge Mr. Tim Honeywell, who is also here in the gallery, who is the athletic director at Stroudsburg School District and who has received the 2016 Pennsylvania Athletic Director of the Year award. Mr. Honeywell, would you stand up. Thank you.

And as we know, athletics play a tremendous role in developing focus, determination, teamwork, and commitment skills that transfer over into many other aspects of a student's development. So Mr. Honeywell plays a tremendous role in ensuring that the Stroudsburg athletic program continues to be top-notch and maintains its reputation as a high-quality, extremely positive, and productive program for our students.

KEVAN GENTILE PRESENTED

The SPEAKER. Representative Doyle Heffley is recognized. Please proceed, sir.

Mr. HEFFLEY. Thank you. Mr. Speaker.

Mr. Speaker, I rise today to welcome Kevan Gentile, the 2015-2016 PIAA Class AA Individual Wrestling Champion for the 106-pound weight class.

Kevan is a senior at the Jim Thorpe Area High School, and he is the first wrestler from this school to win a State wrestling championship in more than 50 years. He is also the second wrestler from Carbon County to earn that distinction as well.

In addition to his State win, Kevan is a two-time District 11 champion and Southeast Regional champion in the 106-pound weight class. His record for the season is 40 wins and 1 loss, and he will end his high school career with 142 wins and 25 losses. Kevan was named the Morning Call Class AA Wrestler of the Year and the Times News Wrestler of the Year for 2015-2016, and he is ranked third nationally by FloWrestling and fourth in the nation by InterMat wrestling.

I would like to congratulate Kevan on his accomplishments on the mat and for bringing that State championship back to the Jim Thorpe area.

I also want to introduce the guests that he has here with him today. I would like to introduce his mother – if you could please rise – Melissa Levan; his stepfather and coach, Terry Levan; his brother, Kade Levan; his uncle, Edward Hawk; his coach, Shawn Albert, and his girlfriend, Aislinn Galvin. If you could please rise.

Congratulations to Kevan on his incredible accomplishment, and I would like to present him with a House citation. Thank you, Mr. Speaker.

And to these three champions and your outstanding accomplishments, we are so proud to have you in the hall of the House. Thank you very much for being with us today.

Mr. LONGIETTI. Mr. Speaker, I am joined by State Representative Tedd Nesbit, and we are pleased to present the 2015-16 Class A State Championship Boys Basketball Team, the Kennedy Catholic Golden Eagles.

Behind me are the five seniors for the Golden Eagles: Carmen Schuville; Jason Austin, who is a first-team All-State selection; Nickolo Lima; Sagaba Konate, who is Class A "Player of the Year" and a first-team All-State selection; and Jacob Wilson, along with head coach and Class A "Coach of the Year" Rick Mancino. STATEMENT BY MR. MURT

The SPEAKER. Representative Murt, the floor is yours, sir.

Mr. MURT. Thank you, Mr. Speaker.

Mr. Speaker, the American Cancer Society estimates that 81,540 new cases of cancer will be diagnosed in Pennsylvania this year alone, and many of those cancer patients will require support from family members who are critical to the health-care providers.

Mr. Speaker, known as lay caregivers, these unpaid caregivers are, in many cases, a husband or wife, a partner, or an adult child. For many who are single, close friends, coworkers, and neighbors also fill this role. These caregivers provide 80 percent of the home-care services, which are often a complex array of tasks including physical, psychological, spiritual, and emotional support.

Mr. Speaker, while caring for an individual with cancer can be extraordinarily stressful and taxing, many caregivers find satisfaction in providing care for a loved one who is struggling with cancer. Many cancer patients are deeply grateful to their caregivers for their love and dedication, weathering the challenges and setbacks of cancer treatment, and sharing the triumphs with them. That support does not end after treatment concludes.

Mr. Speaker, that is why our caregivers need our help and deserve our support, and why I thank my colleagues for declaring May "Cancer Caregivers Recognition Month" in the Commonwealth of Pennsylvania.

STATEMENT BY MS. DONATUCCI

Ms. DONATUCCI. Thank you, Mr. Speaker.

I would like to thank my colleagues for their support of HR 885 recognizing May 15 through 21 as "National Prevention Week" in Pennsylvania.

Now that spring is underway and summer is just around the corner, we are taking part in so many exciting activities, like sending our kids and grandkids off to prom, hosting graduation parties, and attending weddings. And while most of our friends and family members will be celebrating those milestones reasonably, they can still be breeding grounds for dangerous behaviors like substance abuse and abuse. That is why it is so important to mark National Prevention Week, which is sponsored annually by the Substance Abuse and Mental Health Services Administration.

The goal of National Prevention Week is to increase public awareness about substance abuse and mental health issues, especially among students who are confronted with these issues on a regular basis. This year's theme for National Prevention Week is "Strong As One. Stronger Together." Each day during the week is designated a specific theme, including the prevention of tobacco use, underage drinking and alcohol misuse, prescription and opioid drug misuse, illicit drug use and youth marijuana use, and suicide, and the promotion of mental health and wellness. To help raise awareness about these issues, community organizations across the country hold health fairs, block parties, educational assemblies, town hall meetings, memorial walks, social media campaigns, and outdoor events.

I encourage everyone present today to talk to students in your area about making smart decisions when attending these exciting functions that the spring and summer bring. Unfortunately, an irresponsible choice can sometimes have a lifelong impact, and we want to make sure our children and grandchildren understand this and celebrate reasonably and responsibly.

STATEMENT BY MR. WHEATLEY

The SPEAKER. Representative Jake Wheatley. Mr. WHEATLEY. Thank you, Mr. Speaker.

I truly appreciate my colleagues' support of HR 888. This resolution designates May 17 as "Pennsylvania Sickle Cell Advocacy Day" in Pennsylvania.

Sickle cell is a devastating disease that has killed hundreds of thousands of people around the world. In the United States, sickle cell disease is most common in African-Americans, occurring in 1 in every 500 births, while also occurring in 1 in every 36,000 Hispanic-American births. Approximately 2,000 infants are born in the United States every year with sickle cell disease, and it is estimated that by 2050, more than 400,000 babies around the world will be born with this disease.

Those are frightening statistics, but just what is sickle cell? Sickle cell disease is a blood disorder that affects red blood cells which become sickle-shaped, making it difficult for these cells to pass through small blood vessels. The complications from this serious disease are usually fatal, so the primary goal of the health-care provider is to prevent further complications. Sickle cell disease is not contagious, but there is no known cure.

So again, I want to thank you all in this chamber for your vote. I want to thank you all for joining me, and several of you probably had a chance to meet with some of our visitors today of families around the Commonwealth who are bringing awareness to this very impactful disease as we look forward to moving our Commonwealth in a direction that helps these families and these children to be able to deal with this disease in a better way. So I just wanted to thank you all for your vote in recognizing this advocacy day, and for keeping these families and children in the forefront of our fight for a quality life for those who are struggling with sickle cell disease. Thank you.

STATEMENT BY MS. RAPP

The SPEAKER. Representative Rapp and Representative Briggs are recognized to speak on HR 889.

Ms. RAPP. Thank you, Mr. Speaker.

To my colleagues and the people of Pennsylvania, the majority of us are blessed with the ability to articulate and communicate our thoughts, wants, and needs with our loved ones. However, there are individuals and family members who are impacted daily by childhood apraxia of speech.

Childhood apraxia of speech is a motor speech disorder where children have problems making speech sounds because the brain has difficulty planning the motor and muscle movements needed for speech. And while the cause of childhood apraxia of speech is not well understood, it is a neurological disorder without any apparent brain injury, and most children seem to be born with childhood apraxia of speech.

Children with apraxia do not follow typical patterns of developing sounds and speech. When apraxia is most severe, children struggle to make sounds, and children with a moderate or a milder form struggle with syllables and words. The frequency of apraxia is not well understood, and the American Speech-Language-Hearing Association reports that the number of children diagnosed with apraxia is on the rise.

Childhood apraxia of speech was brought to my attention by a family in my district. I had the pleasure just late Saturday to introduce the Speaker of the House to the father of the family and bring awareness of apraxia to the Speaker's attention.

Thank you, colleagues, for your support and vote for this resolution and support to the families throughout our educational system and speech therapy throughout the State to designate May 14, 2016, as "Apraxia Awareness Day."

STATEMENT BY MR. BRIGGS

Mr. BRIGGS. Thank you, Representative Rapp, and thank you, Mr. Speaker.

Mr. Speaker. I would like to thank Representative Rapp for bringing HR 889, which recognizes May 14 as "Apraxia Awareness Day" to the attention of the House of Representatives.

As some of you may know, I have four terrific children. Two of them, Alex and Morrison, are 6-year-old twins who have been working with determination and persistence to find their voice. Last year, after many years of speech therapy, they were diagnosed with childhood apraxia of speech. When you meet them, you cannot see their apraxia. You see their eyes that light up and are full of life. Alex and Morrison have many wonderful abilities and talents. They are artistic, great dancers, cannot read enough books, and love life. They look like any other children you might see walking around the Capitol, but they have lived with the struggle of silence and a great struggle to communicate.

Childhood apraxia of speech is a motor speech disorder that makes it difficult for children to correctly pronounce syllables and words. Children with apraxia know what they want to say; their words are in their heads, but often the child is not able to produce the words clearly. Can you imagine how frustrating it is for those struggling to overcome apraxia?

For unknown reasons, children with apraxia have great difficulty planning and producing the precise, specific series of movements of the tongue, lips, jaw, and palate that are necessary for intelligible speech. As one expert has said, the problem occurs when the brain tries to tell the muscles what to do. Somehow that message gets scrambled. It is like trying to watch cable TV stations without the right descrambler. There is nothing wrong with the TV station and nothing wrong with your TV set. It is just that your set cannot read the signal that the station is sending out. The child must figure out how to somehow unscramble the mixed messages his or her brain is sending to his or her muscles.

Children with apraxia, however, do understand language and speech, yet others might mistake and misjudge their unclear speech or quietness as a lack of intelligence. Many children with apraxia experience a great sense of failure and frustration in their attempts to communicate. Some children grow even quieter; others may act out their frustration. Each child with apraxia is a unique individual with their own set of abilities and needs and challenges. However, one common theme is that for some period of time, children with apraxia of speech need frequent and intensive speech therapy that is targeted to their

greatest challenge so that they can learn to accurately produce syllables, words, and sentences. All children need the support of teachers and parents, but children with apraxia need extra support and attention if they are ever to overcome the condition.

Children with apraxia truly need the services of the speech-language pathologist, also known as an SLP, who can work with them to help create a way to communicate with their teachers and classmates. An SLP is helping my girls be able to demonstrate what they are learning in class, and has allowed them to continue improving their speech ability and communication. In addition to actual speech skills, at some point of time it is likely that the children will also need to work on expressive language and conversational skills.

With that, thank you again for supporting the House resolution naming apraxia awareness. We are fortunate in Pennsylvania that the Childhood Apraxia of Speech Association is located here in Pittsburgh, and every day they work to raise awareness of apraxia while providing support to families of affected children.

Finally, I want to thank all of the educators and speech therapists who have touched our lives and have worked so hard to help my children find their voices.

On behalf of myself and Representative Joanna McClinton, I would like to thank our colleagues for supporting HR 879 honoring Delta Sigma Theta and recognizing today as Delta Day here in the State Capitol.

It is my pleasure to welcome and recognize illustrious ladies from the Pennsylvania chapters of Delta Sigma Theta who are with us today here in the Capitol and in the House chamber. Established in 1913 when women were advocating for political and social equality, the founding 22 members of Delta Sigma Theta became leading advocates of the women's suffrage movement, setting the stage for the organization's commitment to social activism.

Throughout the years, this sisterhood's mission has been to promote academic excellence, provide scholarships, offer support to the underserved, educate and stimulate participation in establishing positive public policy, and highlight issues and provide solutions to problems in our communities.

Delta Sigma Theta remains one of the largest African-American women's organizations in the world, with 1,000 chapters around the globe and more than 200,000 members from the United States, England, Japan, Germany, the Virgin Islands, Bermuda, the Bahamas, and the Republic of Korea. The uncompromising commitment to the community through its mission continues to be the foundation of Delta Sigma Theta Sorority and the driving force to carry on the mission of Delta Day here at the State Capitol.

STATEMENT BY MS. McCLINTON

Ms. McCLINTON. Thank you, Mr. Speaker, Representative Cook-Artis, and all of our colleagues for supporting this resolution.

The Delta Sigma Theta Sorority has a long and strong history in Pennsylvania going back to 1918, when the University of Pennsylvania first chartered its Ivy League chapter. The chapter was soon followed by the first chapter in Pittsburgh, at Pitt, in 1921 and at Duquesne University in 1946.

The Deltas are truly a statewide, socially active, community-oriented organization of dynamic women. The Deltas have chapters in a number of schools in the State System of Higher Education, including Bloomsburg, Indiana University of Pennsylvania, Kutztown, Millersville, Shippensburg, and West Chester University. That is nearly half of the schools in the State System. Chapters are also active at other schools like Lincoln University and Temple University, our State-relateds. In addition, there are citywide chapters in both Pittsburgh and Philadelphia. There also are 11 alumni chapters throughout the Commonwealth, including right here in Harrisburg. Thank you for all that you do for our communities.

Among the distinguished Pennsylvania women who are alumni of Delta Sigma Theta are Sadie T.M. Alexander, who was the first woman to receive a law degree from the University of Pennsylvania Law School, and also the first woman to pass the Pennsylvania bar exam, the first woman of color. And also, she was the second woman in the United States of African-American ethnicity to earn a Ph.D. Most importantly, she passed the Pennsylvania bar exam. She became the national president of the sorority, and she served from 1913 to 1923. She became a civil rights leader, serving on President Harry Truman's Committee on Civil Rights, which was established in 1946, and later served her home city of Philadelphia, where she was the first African-American woman to be the assistant city solicitor. She was also appointed to the Philadelphia Commission on Human Relations, where she served from 1952 to 1968.

Our former colleague, Council Lady Cherelle Parker, now serves on Philadelphia's City Council for the 9th District, and she is also a member of this elite sorority, along with Philadelphia City Councilwoman Blondell Reynolds Brown. A number of judges are also members, including former State Supreme Court Justice Cynthia Baldwin; Cheryl Allen, who was the first African-American woman elected to the Superior Court; Kim Clark, of the 5th District of the Court of Common Pleas in Allegheny County; my dear mentor, Judge Timika Lane, of the First Judicial District of Philadelphia, where she serves on the Court of Common Pleas; and also retired judge Renee Cardwell Hughes, who is now the CEO (chief executive officer) of the American Red Cross of Eastern Pennsylvania.

These women and thousands more behind the scenes continue to make a difference in our communities. I am so proud to have supported this resolution recognizing your history and all of your contributions.

Representative Marsico, the floor is yours.

Mr. MARSICO. Thank you, Mr. Speaker.

The Senate amended the bill, which requires each secondary school to post a copy of its antihazing policy online and to provide copies to all athletic coaches involved in organizations within the secondary school.

Just a reminder to the members, this bill was passed by this House 197 to 3. The Senate vote was 48 to 0. Members, please take your seats. Members, please take your seats. I would ask any conversations to be taken to the rooms off the floor. This is our last bill of today's session, although we do have caucus sessions yet to—There will be caucus sessions, I understand. But at this time Representative Dush has the floor, and I would ask that everybody please give him their attention.

Mr. DUSH. Thank you.

Speaking as one who has had to be in a position of a trainer with law enforcement and other paramilitary organizations, if I, as a condition of employment, as somebody seeking to be a part of an organization, one of my troops is being compelled to, as I have done, take a ride on the Taser, had to submit to OC (oleoresin capsicum) gas so that we are trained and able to deploy it if we in the military, in the Pennsylvania Air and Army National Guards, put one of our troops on a ruck march and they end up with blistered feet or a twisted ankle or some other injury as a result, and we have someone who basically— The way this training is set up, it is to weed out people who do not have the wherewithal to actually perform the duties in a high-stress environment. And if we have somebody who is going to wave that flag and say, "Wait, this is hazing now. You can't compel me to do this," then as the trainer trying to compel that action or the person be eliminated, I am subject to criminal action, is the broad interpretation of this bill.

And for that reason, I am going to ask the members not to concur, and my hope is that this will go back to conference committee and we could actually get this thing squared away so it has the proper exemptions.
