He is here with his daughters, Karen Walsh and Diane Nagy, and his son, George. Additional family members are seated in the rear of the House. They are the guests of Representative Kavulich. Please rise and be recognized, sir. Thank you very much for your service, kind sir.

STATEMENT BY MR. KAVULICH

The SPEAKER pro tempore. Representative Kavulich would like to be recognized under unanimous consent. You may proceed when you are ready, sir.

Mr. KAVULICH. Thank you, Mr. Speaker.

Mr. Speaker, Monday is Memorial Day. That is the day we pause to remember those who gave their lives fighting for this country so that we might live free today.

I have known George Fricovsky my entire life. He lived across the street from where I lived, which was in the house above my father's tavern. Growing up, I do not think there were many days that I did not see him either coming home from work, if I did not see him doing work outside of his house, or just see him sitting on the front porch of my father's tavern, hanging with the guys.

I knew him as a New York Yankees fan, as one of the quickest outfielders I had ever seen on the baseball or softball diamond, and someone who was and still is quick with a joke. But until I grew a little bit older, I did not know that he was also a hero.

George Fricovsky, or Freachie, as he likes to be called, was drafted into the service in 1944. He was just 18 years old. Soon after that he was headed to Europe on the USS *West Point* under blackout conditions in order to avoid the German U-boats that were hunting the American ships and soldiers aboard. His regiment was one of three that landed in Marseilles, France, on December 15 of 1944 and was sent just south of Bastogne, the Belgian town that would soon be world-famous when American and German troops faced off in the Battle of the Bulge.

While many said that Adolf Hitler threw the last offensive at Bastogne, the last major German offensive of World War II on the western front was really Operation North Wind, and that began December 31 of 1944. Hitler's only objective of that movement was to destroy any and all Allied troops.

At Schlossberg Castle on the German border, George and his unit were guarding two captured enemy soldiers when George came under heavy attack. With only his rifle and not much ammo, he was sitting against a wall preparing to stand with his buddies and repel the attack when a hand grenade was tossed through a window. The explosion killed seven of Freach's buddies. He was badly wounded himself and laid there for 11 hours, his life being saved by a medic who treated him until he was carried by three German POWs (prisoners of war) about a mile and a half to a field hospital. It was there that doctors worked on him and managed to save his left leg, riddled with shrapnel from the explosion.

When he woke up in another hospital, he noticed his wrist was bandaged. Under that bandage was not a wound, but the shrapnel that was removed from his leg and taped to that wrist by the doctor who worked on him. He wanted him to have it as a souvenir of that day, and he still does today. He still has that piece of shrapnel as a reminder of the night when he escaped the unfortunate fate of seven of his brothers.

It was not the only time he escaped death. Once, as the second scout going forward into battle, George and his first scout surprised a group of six German soldiers. George and that first scout were able to kill the German soldiers but not before they were able to kill the first scout.

In March of 1945, George Fricovsky was awarded the Purple Heart Medal, the Bronze Star, and the World War II Victory Medal for his bravery and service to the United States. When you think about it, today we in this country spend millions and millions of dollars to go to the movies to see make-believe figures like Superman, Batman, and The Avengers save the earth from evil. Yet we forget that we have real-life superheroes that still walk among us. They are still here for us to talk with them, to learn from, and to honor, even as their numbers grow fewer and fewer every day.

George Fricovsky is one of those superheroes. He, along with thousands and thousands of others, helped make this country what it is today. His uniform was not made of titanium steel, he did not have any high-tech laser beams, but his uniform was made of cloth, and his weapon was a simple rifle. And yet he and many others were able to save the world. These superheroes defeated the enemy and saved the earth because of their bravery and their dedication to this country.

Please stand and show your appreciation to a true superhero, George Fricovsky.

BILLS ON THIRD CONSIDERATION

The House proceeded to third consideration of **HB 2003**, **PN 3211**, entitled:

An Act authorizing the Department of General Services, with the approval of the Pennsylvania Historical and Museum Commission and the Governor, to grant and convey to the Southern Lancaster County Historical Society certain lands situate in Fulton Township, Lancaster County.

On the question,

Will the House agree to the bill on third consideration? Bill was agreed to.

(Bill analysis was read.)

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

Representative Davidson, you are recognized.

Mrs. DAVIDSON. Thank you, Mr. Speaker.

Is the gentleman available for interrogation?

The SPEAKER. Yes, he is, and he will stand for interrogation.

Representative Davidson, you may proceed.

Mrs. DAVIDSON. The land was appraised at zero dollars. It is \$6 million— I am sorry; I do not have it in front of me, but the parcel is worth how much?

Mr. CUTLER. The parcel is approximately 61 acres, but it is appraised at zero dollars because of all of the restrictive covenants that are on it.

Mrs. DAVIDSON. So we are to believe that 61 acres of land that belongs to the State is appraised at zero dollars?

Mr. CUTLER. Yes. When you look at the underlying land that surrounds the Robert Fulton Birthplace, which is what this tract is known as, DGS (Department of General Services) has had substantial upkeep related to the underlying facilities that are currently in place. They have placed a series of restrictive covenants on the land that the society will provide for the upkeep. However, they are unable to develop it, subdivide it, or in any other way develop it. And DGS actually approached the association about removing that approximately \$30,000 in annual upkeep and investment because DGS did not have the assets or resources to put into it.

It is also worth noting when you look at the farmland, a portion of that is rentable around the current parcel, and DGS for some time has not been getting fair market value because they have failed to update their contracts. So when they looked at it, the Historical Society believes that the rent amounts can offset the required upkeeps, and they already put a substantial amount of time and their own effort and money into it, which is why DGS felt that they would be a good steward of the property.

Mrs. DAVIDSON. So it is your opinion that the Commonwealth does not deserve any money for 61 acres of land. Even if you try to remove those impediments, you are saying zero dollars goes back to the taxpayers and the Commonwealth for this property?

Mr. CUTLER. Respectfully, this is also the position of DGS since they were the one who initiated the transfer, and since I was the local area, at DGS's request we looked at the language that they had contained or offered, I should say, because again, the process started with them, and this was their request.

And in terms of the restrictive covenants, yes, because when you look at that area and that amount, it is prohibited for being used for anything other than its current purpose, and it is a cost avoidance on behalf of the Commonwealth in future years.

Mrs. DAVIDSON. Thank you, Mr. Speaker.

On the bill?

The SPEAKER. Representative Davidson, on the bill.

Mrs. DAVIDSON. I do not think the Commonwealth should be in the business of giving away 61 acres of land for zero dollars. Given the financial state that we are in, I just think this is not a good use of our resources.

And secondly, I am really disturbed that an appraisal would be for zero dollars and zero cents for 61 acres of Commonwealth land. And I will be voting "no." Thank you, Mr. Speaker.

The SPEAKER. Does anybody else wish to be recognized? Representative Cutler, on the bill, please.

Mr. CUTLER. Thank you, Mr. Speaker.

Mr. Speaker, I understand the lady's concerns. However, I would like to read from the documents provided by the Department of General Services in regards to the current tract of land and what is encompassed as well as what the future costs are.

In terms of ongoing maintenance, it is in excess of \$30,000, currently in today's value. Additionally, the grantee will be the Southern Lancaster County Historical Society. And the appraisal of the property done by the Department of General Services, "An appraisal, dated 2/27/2015, was performed on the subject property and fair market value was determined to be \$0.00."

The proposed use of the property is as follows: "Grantee intends to use the property for continued use as a public historical site." That is the only purpose. "The proposed legislation requires the Department of General Services to include a covenant in the deed of conveyance prohibiting the property from being utilized as a licensed gaming facility," which is an item that, as many of the members who have a longer tenure here know, has been a standard upon these kinds of conveyances. And finally, "The proposed legislation requires that the deed of conveyance contain a restrictive historical covenant which includes a provision that if the property is used for any purpose other than a museum or related business and/or curatorial offices, the property shall immediately revert to and revest in the Commonwealth of PA."

Mr. Speaker, it is clear that DGS intends to avoid future costs while ensuring that the historical site itself is maintained, and I would urge a "yes" vote.

On the question recurring,

Shall the bill pass finally?

BILL ON CONCURRENCE IN SENATE AMENDMENTS

The House proceeded to consideration of concurrence in Senate amendments to **HB 1552, PN 3373,** entitled:

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in preliminary provisions, providing for powers and duties of the Secretary of Education; in reimbursements by Commonwealth and between school districts, providing for student-weighted basic education funding and for supplemental payment of basic education funding for 2014-2015 school year; and making an appropriation.

On the question,

Will the House concur in Senate amendments?

The SPEAKER. Moved by the gentleman, Representative Roae, that the House concur in the amendments inserted by the Senate.

The Chair recognizes Representative Roae for a brief description of the Senate amendments.

Mr. ROAE. Thank you, Mr. Speaker.

HB 1552 as passed by the House on October 5, 2015, by a vote of 197 to 0 authorizes and requires the Secretary of Education to enter into and administer membership in a regional compact and an interstate reciprocity agreement for the provision of postsecondary distance education.

In the Senate they amended the bill to have the implementation of the Basic Education Funding Commission formula for the 2016-2017 fiscal year and each year thereafter, and they also amended it to have an appropriation of \$15 million for the 2014-2015 school year, which shall be distributed to a financial watch school district and a financial recovery school district.

The SPEAKER. Now, members, two amendments have been filed to HB 1552, PN 3373. Representative David Parker has filed amendment 7675, and to vote on that particular amendment, it would require a suspension of the rules to be able to vote on this amendment.

The Chair recognizes Representative Parker to see if he wishes to make a motion.

Representative Parker.

Mr. PARKER. Thank you, Mr. Speaker.

Mr. Speaker, with the speed with which this bill came up, I tried to make amendments to it so that we could make some more of the recommendations that the Basic Education Funding Commission made.

I have some legislation I would like to incorporate into this bill, which there will be a hearing on tomorrow, so unfortunately, it is not prepared to be put in this at this moment. These amendments that we have quickly drafted do not function in the way I want them to exactly, and so I will not make that motion, but I would like to speak on the bill.

The SPEAKER. Yes, sir. And you did refer to two amendments. The next amendment that would be called up after a motion to suspend—

Mr. PARKER. Okay. So I will not-

The SPEAKER. —would be 7686. So there are two amendments and you may speak on them. Please, we are going to give you leeway to speak on both amendments, if you so please.

Mr. PARKER. Okay.

So should I just speak on the—

The SPEAKER. You are not going to make a motion to suspend.

Mr. PARKER. I am not; correct.

The SPEAKER. But you just wanted to be able to explain what your amendments were. Is that correct?

Mr. PARKER. I will just speak on the bill so we can withdraw—

The SPEAKER. Okay; I apologize.

Mr. PARKER. I will withdraw both amendments.

The SPEAKER. Then please, you are recognized on the bill. So the amendments are withdrawn—

Mr. PARKER. Yes.

The SPEAKER. —and there is no motion to suspend, but you want to speak on the bill itself.

Mr. PARKER. Yes, please.

The SPEAKER. Yes, sir. The floor is yours; my apologies.

Mr. PARKER. Okay; that is okay. I am not always as clear as I should be.

So, Mr. Speaker, HB 1552 was passed unanimously by this chamber, and I supported it. I certainly want to improve higher education. Now we have the new Basic Education Funding Commission formula in this bill. Of course it is only on new money, so it does not address any of the inequities of the past or current inequities.

And so I would like to point out the Basic Education Funding Commission recommendations. The first one was school consolidation, and they recommend that we should appropriate money to a fund to incentivize school district consolidation. We are not doing that with this bill except for one district. In this bill we are giving one district \$3 million in perpetuity at this point, unless we change it, to facilitate some consolidation for that one school district.

The second recommendation is hold harmless. The commission recognized that hold harmless is problematic, and they said that the General Assembly should come up with a solution for this. I have legislation, again, which we will have a hearing on tomorrow, which tries to address this, and I certainly want that to be considered going forward. So I would really like to consider that before we start appropriating money for basic education.

So I will be voting "no" on this bill for that reason and hope that we can consider my legislation in the future. Thank you, Mr. Speaker.

The SPEAKER. Thank you, Representative Parker.

Does anybody else wish to be recognized on HB 1552, PN 3373?

Representative Kortz, the floor is yours, sir.

Mr. KORTZ. Thank you, Mr. Speaker.

Mr. Speaker, I rise reluctantly to oppose this measure. The bill was amended in the Senate, as the gentleman said, to provide additional money – \$12 million to Chester Upland and

another \$3 million to the Wilkinsburg School District – but I did not hear any money going into the West Mifflin School District, which has taken the kids from Duquesne School back in 2008. They have been struggling for a while. We have been trying to get more money. Incrementally we have gotten some, but they had not been made whole as they should.

So for this reason, sir, I will be voting "no" to this measure. Thank you.

The SPEAKER. Representative Stan Saylor, the House majority chair of Education. Representative Saylor.

Mr. SAYLOR. Thank you, Mr. Speaker.

I rise to explain what the gentleman is talking about in that the bill contains money that was agreed to by the Governor and the courts for Chester Upland to deal with the issues that they have been involved in in that recovery school district and also because Wilkinsburg is now defunct to help take care of that issue as well. So it is something that the Governor and the Education Secretary have agreed to and so that we can move on with last year's budget and move on to this year's budget. Thank you, Mr. Speaker.
