STATEMENT BY MS. BROWN

The SPEAKER. Representative Brown, the floor is yours. All members, please take your seats.

Ms. V. BROWN. Thank you, Mr. Speaker.

Mr. Speaker, I rise today with my colleagues from the Pennsylvania Legislative Black Caucus and other members of our caucus who are standing, who are standing for the families, the families that have experienced such sorrow in the last few days in our nation.

Mr. Speaker, we have asked State Representative Joanna McClinton to speak for us today. If you do not mind, Mr. Speaker, could you recognize her, and she is going to give some remarks on behalf of the Pennsylvania Legislative Black Caucus.

STATEMENT BY MS. McCLINTON

The SPEAKER. Representative McClinton, you are recognized.

Ms. McCLINTON. Thank you, Mr. Speaker.

Thank you to our chairwoman, State Representative Vanessa Brown.

We are standing here today because all of us have been touched by the horrible tragedies that have occurred over the last week in our nation and in our country. And we are standing here today – we do not have any talking points, we do not have any messages, but what I have on this paper in front of me is a list of names of lives that were lost: from Baton Rouge, Louisiana, Alton Sterling; from Falcon Heights, Minnesota, Philando Castile; and then very tragically, also so many officers in Dallas – officers Lorne Ahrens, Michael Krol, Michael Smith, Brent Thompson, and Patrick Zamarripa.

As we stand along and see what is happening all across this country, our hearts are touched, because one thing that we all have in common regardless of our race, of our religion, of our background, of whom we love, is we are all human beings, and that is our commonality. So we are going to ask if this House would take a moment of silence and allow us to pray.

The SPEAKER. We will have a moment of silence for the police officer victims in Dallas and those victims of violence all throughout our great nation.

(Whereupon, a moment of silence was observed.)

The SPEAKER. Representative McClinton, you may proceed.

Members, you may be seated.

Ms. McCLINTON. Thank you, Mr. Speaker.

In times like this it is hymns and songs that get us through these tragic times. So if I just may, Mr. Speaker, before saying a prayer, I would like to sing very briefly.

The SPEAKER. You certainly may.

(Representative McClinton sang refrain from "I Need Thee Every Hour.")

Ms. McCLINTON. Dear Lord, we come to You this afternoon and our hearts are hurting, this country is hurting. And it is so sad, Father, that the ugly racism, ignorance, hatred, violence is not new to this nation. Father, it has been happening here and we are ashamed, God, because You have called us to be leaders in this Commonwealth. And even with all of the things that are occurring across this nation, we are pausing as the Pennsylvania Legislative Black Caucus to indicate that, God, we do not know what to do. We do not know what to say. We do not know how to even respond. But certainly, as we pause this afternoon, it is our prayer that You would be with the families that are mourning, the families that are hurting from Louisiana to Minnesota to Texas, God, all of the awful things occurring. Lord, all of these tragedies, not just these ones, but even the folks in Orlando just last month and in my district last night where a 15-year-old was killed; God, it is just too much, and none of these people deserve to die. All of our lives matter and they are important to You.

So, God, it is our prayer that You would send healing to this nation, that You would send peace in the midst of these storms, that You would send calm. Father, while we do not know what to do, our eyes are watching You today and we are asking for You to lead us, to guide us, for You to give those that are hopeless hope. For those that feel like they can pick up weapons, Lord God, we ask, Lord, that there would be safety for children this summer. that there would be safety for our police officers, God, all across this Commonwealth that get up and go to work every day and they do not know if they are going to go home. So, Lord, it is our prayer that You would protect them. It is our prayer that there not be continued injustices against black and brown men. It is our prayer today, God, that we can live in this nation and we can live at peace.

Father, we ask that You would just hear our prayer and that You would move, that You would send healing to this land. You said if we would humble ourselves and pray, You would hear us, so we are humbling ourselves and we are praying and we are asking for You to move like only You can. All these things we ask in Your name. Amen.

RESOLUTION PURSUANT TO RULE 35

Mr. FRANKEL called up HR 960, PN 3724, entitled:

A Resolution honoring the extraordinary life and indelible legacy of Auschwitz survivor, humanitarian and Nobel Peace Prize winner Elie Wiesel, who passed away on July 2, 2016, at the age of 87.

On the question,

Will the House adopt the resolution?

The SPEAKER. On this resolution, Representative Dan Frankel is recognized.

Mr. FRANKEL. Thank you, Mr. Speaker.

I would like to ask my colleagues for their support for HR 960, which honors the extraordinary life and legacy of Auschwitz survivor, humanitarian, author, and Nobel Peace Prize winner Elie Wiesel. Elie Wiesel passed away on July 2 at the age of 87, but his legacy, his commitment to justice and equality, and his magnificent spirit will live on for generations to come. It is truly remarkable the sheer breadth of the impact Elie Wiesel has had on the world and is evident not only by the many awards and accolades he received throughout his life, but also by the international outpouring of condolences and grief received from locations around the world upon his recent passing.

Elie Wiesel was born in 1928 in present-day Romania, and was just 15 years old when he and his family were deported to Auschwitz by the Nazis.

The SPEAKER. Sir, please suspend for just a second.

Members, I know we have a lot to do today and perhaps tomorrow, but at this time this gentleman that is being honored is truly one of the giants of humanity. Representative Frankel deserves an opportunity to be heard on this resolution. I would ask everybody to please take your seats.

Mr. FRANKEL. Thank you, Mr. Speaker.

Elie Wiesel, like millions of others subjected to Nazi tyranny during this time, was forced to work under harrowing conditions in labor camps, working alongside his father at Buna. While Elie Wiesel was liberated from Buchenwald on April 11, 1945, his parents and two of his sisters perished at the hands of the Nazis. After the war, Elie studied in Paris and later became a journalist. Shortly thereafter, he decided to write about his experiences in the death camps, experiences that are documented in chilling detail in his memoir, "Night." If any of my colleagues have not read "Night," I would recommend that you do so. "Night" has gone on to sell more than 10 million copies worldwide and has left a permanent mark on countless individuals around the world, putting a human face on the millions upon millions who suffered under Nazi oppression. The book garnered renewed interest for a whole new generation in 2006 when Oprah Winfrey selected "Night" as her official selection of her book club.

When his town was rounded up and deported to concentration camps, Elie Wiesel wrote, "One by one, they passed in front of me, teachers, friends, others, all those I had been afraid of, all those I could have laughed at, all those I had lived with over the years. They went by, fallen, dragging their packs, dragging their lives, deserting their homes, the years of their childhood, cringing like beaten dogs."

Prior to the publication of "Night," few people talked about the Holocaust, and they did not talk about it very openly. Elie Wiesel changed that and made us all confront the evil that mankind is capable of.

In 1978 President Jimmy Carter appointed Wiesel chairman to the President's Commission on the Holocaust, and in 1980 Elie Wiesel became the founding chairman of the United States Holocaust Memorial Council, playing a central role in the creation of the United States Holocaust Memorial Museum in Washington.

Around this time, Mr. Wiesel and his wife, Marion, established the Elie Wiesel Foundation for Humanity to combat indifference, intolerance, and injustice through international dialogue and youth-focused programs that promote acceptance, understanding, and equality.

For his efforts to promote human rights and human dignity around the world, Elie Wiesel was awarded the Nobel Prize for Peace in 1986. In awarding Mr. Wiesel this honor, the Norwegian Nobel Committee declared that he, quote, "...has emerged as one of the most important spiritual leaders and guides in an age when violence, repression and racism continue to characterize the world."

Throughout the years, Elie Wiesel was a frequent visitor to the Commonwealth of Pennsylvania, such as speaking to 6,000 Holocaust survivors and their families in Philadelphia in 1985, and to 2,000 people at Carnegie Music Hall in Pittsburgh in 1995, which I was privileged to be at.

Elie Wiesel worked tirelessly with different communities of faith, like his participation in a conference in Pennsylvania and his work with the National Catholic Center for Holocaust Education, which was founded in 1987 on the campus of Seton Hill University in Greensburg. Over the course of his lifetime, Elie Wiesel wrote more than 60 works of fiction and nonfiction, an average of a book a year. For his literary and human rights activities, Elie Wiesel received many numerous awards over the course of his life, including the Presidential Medal of Freedom, the U.S. Congressional Gold Medal, the National Humanities

Medal, the Medal of Liberty, and the rank of Grand-Croix in the French Legion of Honor.

Elie Wiesel passed away on June 2, 2016, at the age of 87, survived by his wife, Marion, son Shlomo Elisha, stepdaughter Jennifer Rose, and two grandchildren.

In 2009 when President Obama visited the Buchenwald concentration camp with Mr. Wiesel, the President called him a "living memorial." Well, the world has lost one of its truly remarkable living memorials, but as I mentioned earlier, Elie Wiesel's work lives on and will be remembered for generations to come. It is through Mr. Wiesel's words and actions that we can hopefully fulfill the promise of "never again."

I leave you with a well-known quote from Elie Wiesel, a quote I believe sums up his life's work quite well, but also is so profoundly relevant today, and I quote: "Sometimes we must interfere. When human lives are endangered, when human dignity is in jeopardy, national borders and sensitivities become irrelevant. Wherever men and women are persecuted because of their race, religion, or political views, that place must – at that moment – become the center of the universe."

Thank you, Mr. Speaker, and I urge my colleagues for their support for this resolution.

HB 2088, PN 3518

An Act amending the act of June 13, 1967 (P.L.31, No.21), known as the Human Services Code, in public assistance, further providing for medical assistance payments for institutional care and providing for comprehensive services and items; in children and youth, further providing for provider submissions; in nursing facility assessments, further providing for definitions and for time periods; in intermediate care facilities for persons with an intellectual disability assessments, further providing for definitions and for time periods; in hospital assessments, further providing for definitions and for time period; in departmental powers and duties as to licensing, further providing for definitions and for regulations; establishing the Pennsylvania eHealth Partnership Program; providing for the Pennsylvania eHealth Partnership Fund; abrogating a related regulation; and making a related repeal.

Reported from Committee on APPROPRIATIONS with request that it be rereferred to Committee on HEALTH.

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

Representative Vitali is recognized.

Mr. VITALI. Too many lawyers. I think many of us feel that in government there are just too many lawyers, and regrettably, what this bill does, regrettably what this bill does is adds another one. Mr. Speaker, what this bill would do would be to require the Department of Environmental Protection to appoint another lawyer to the Environmental Quality Board, and while I am sure we will all survive this, should it go into law, it is simply unnecessary. Requiring our constituents to pay for yet another lawyer on this board is simply not necessary.

I have been on that Environmental Quality Board for 4 years, and every meeting I went to, there was a lawyer there, chief regulatory counsel for the DEP who served as lawyer for this board. And if you look at the composition of the board itself, the 20 members on the board, almost every one of them has access to counsel. The Secretary of Health is on this EQB board; she has a chief counsel. The Secretary of DCED (Department of Community and Economic Development) is on this board; she has chief counsel. Secretary of Transportation is on that board; that person has chief counsel. Agriculture Secretary, chief counsel. L&I (Labor and Industry), they have chief counsel. There is a representative from the Historical and Museum Commission on the EQB, and they have chief counsel. A representative of the Game Commission is on the EQB, and they have chief counsel. A representative of the PUC (Public Utility Commission) is on this, and they have chief counsel. There are four Representatives of the General Assembly on this board, and no offense to staff, but you cannot swing a dead cat around our caucus room without hitting a lawyer. There are simply too many lawyers—

The SPEAKER. Representative Vitali, please.

Mr. VITALI. My point is, my point is, the last thing I think we need is another lawyer assigned to this board. Almost every member of this board has access to multiple counsel. To assign another one is simply not only a waste of tax dollars, but would simply further serve to gum up an already much too slow regulatory process.

I just think that this is not needed, and I would ask for a "no" vote.

The SPEAKER. Representative John Maher.

Mr. MAHER. Thank you, Mr. Speaker.

I believe that the work of the Environmental Quality Board in establishing environmental regulations is a very, very important mission for Pennsylvania, and I believe that the Environmental Quality Board that is dealing with all these legal questions deserves to have an attorney.

Now, I do not know about what the gentleman is doing with dead cats, and I am sad to hear about it, but I would say this is a proposal which is bipartisan, bicameral. This bill before you comes from the Senate, from a Democratic Senator who used to be one of our colleagues in the House, and it is a darn fine idea.

The gentleman is correct that many of those who are on this board hail from constituencies that have attorneys, and that is correct. But something happens when you enter that board meeting - or should - you shed, you shed whatever persona you had outside that board and you become, you have a duty to the board. You are a member of that board, and as a member of that board, you deserve to have impartial, straight-from-the-shoulder legal advice, as opposed to the controversial points of view that any number of other attorneys could offer.

It is a good-government proposal. Environmental regulation is so very important. I am disappointed that the gentleman does not seem to share my commitment to environmental regulation. I would like to see it done right, see it done legally, avoid the dead cat issue altogether, and move forward. Please support this bill.

The SPEAKER. Representative Ryan Mackenzie.

Mr. MACKENZIE. Thank you, Mr. Speaker.

I would like to rise and support Chairman Maher and affirm his comments, and support SB 307 on final passage.

Prior to joining the General Assembly I served as policy director at the Pennsylvania Department of Labor and Industry. In that role I was an alternate appointee for the Secretary of Labor and Industry to the Environmental Quality Board, and as an alternate appointee, I was always looking for and seeking guidance from the Department of Environmental Protection on these issues. Obviously, the staff and general counsel at the Department of Labor and Industry did not have that expertise, but at the same time, it would have been very helpful to rely on counsel who is dedicated to the Environmental Quality Board, or the EOB, and have their best interests and the members' interests at heart.

So again, I would like to support Chairman Maher's comments and also support SB 307, and I ask for an affirmative vote. Thank you.
