The majority having voted in the affirmative, the question was determined in the affirmative and the resolutions were adopted.

The SPEAKER. On the uncontested calendar, we have three members who wish to speak. Representative Heffley will be recognized to speak on HR 999, Representative Murt will be recognized to speak on HR 996, and Representative Benninghoff will be recognized to speak on HR 968. We will have a supplemental House calendar uncontested, and at that time Representative Cruz will be recognized to speak on HR 990.

Representative Heffley, the floor is yours. Okay. We will go over that.

### **STATEMENT BY MR. MURT**

The SPEAKER. At this time Representative Tom Murt is recognized to speak on HR 996.

Mr. MURT. Thank you, Mr. Speaker, and thank you to the members for their support of HR 996.

Mr. Speaker, the statistics are sobering. According to the 2014 National Survey on Drug Use and Health, 27 million people aged 12 or older used an illicit drug in the past 30 days, which corresponds to about 10 percent of Americans. Mr. Speaker, this percentage in 2014 was higher than those in every year from 2002 through 2013.

The illicit drug use estimate for 2014 continues to be driven primarily by the nonmedical use of prescription pain relievers. Consider this, Mr. Speaker: There were 22.2 million marijuana users aged 12 or older, and 4.3 million people aged 12 or older who reported current nonmedical use of prescription pain relievers. These disorders lead to disabilities that result in significant costs to families, employers, and our health systems.

Compounding this, Mr. Speaker, drug and alcohol use can lead to other chronic diseases such as diabetes and heart disease. The cost of treating substance abuse costs Americans more than \$600 billion each year – that is billion, with a "b." Some health officials predict that within 4 years, mental and substance use disorders will surpass all physical diseases as a major cause of disability worldwide. Mr. Speaker, this is why preventing mental illness and substance abuse disorders in children, adolescents, and young adults is so critical to Americans' overall behavioral and physical health.

Mr. Speaker, the truth is, the symptoms that signal the development of a behavioral disorder often appear 2 to 4 years before a disorder is present. This gives families an opportunity to intervene early so behavioral health disorders can be prevented and the symptoms mitigated. This is why we have introduced HR 996 to recognize September as "National Recovery Month" in the Commonwealth of Pennsylvania. Mr. Speaker, the best way to help those with early signs of a mental disorder or a substance abuse problem is to identify the symptoms early and give those with these disorders the support to prevent the problem from growing.

In recovery, we also must help those with these disorders manage their symptoms by helping them abstain from alcohol and illicit drugs, and to make informed, healthy choices for the person's physical support and emotional well-being. Mr. Speaker, we must also give them a stable and safe place to live while they conduct meaningful daily activities, whether on the job or in school. This will give those with disorders independence and empower them to participate fully in society.

And finally, Mr. Speaker, by surrounding those who need our help with love and support, we can guide them down the road to recovery. By showing them that hope exists, they will see that these challenges and conditions can be overcome, and, Mr. Speaker, that is the foundation of recovery.
