And we will take up the special order of business. Without objection, the Speaker hears no objections.

And we have in front of us right now two of our long-standing colleagues and good friends, Representatives-elect John Maher and Tina Davis.

I would ask all members to please take their seats. This is, as you know, a solemn event on behalf of this august body. All members, please take your seats. I would ask all staff members to please be seated or to go into the antechambers off the House floor. All staff members should take their seats or go into the antechambers off the House floor.

OATH OF OFFICE ADMINISTERED TO MEMBERS-ELECT

The SPEAKER. I would like to introduce someone that many of you know well. It is our honor to have one of the Supreme Court Justices, a good friend, an outstanding jurist, Debra Todd, Justice of the Supreme Court of Pennsylvania. Please give her a hand and welcome Supreme Court Justice Debra Todd. She was so kind to accept our invitation today to administer the oath of office, required by Article VI, section 3, of the Constitution of Pennsylvania, and she will now fulfill that duty on behalf of the House of Representatives.

I bring you greetings from the Supreme Court of Pennsylvania. It is indeed my pleasure to be here. I appreciate the invitation from Speaker Turzai.

And again I would like to congratulate Speaker Turzai on his reelection as Speaker of this House, and I would like to congratulate all of you on your elections and reelections as Representatives.

We have before us Representative John Maher and Representative Tina Davis, who will be sworn in at this time.

I ask that you place your left hand on the Bible and raise your right hand, please. I will recite the oath and ask you to say "I do" at the end. First, I – state your names – do solemnly swear that I will support, obey, and defend the Constitution of the United States and the Constitution of this Commonwealth and that I will discharge the duties of my office with fidelity.

(Members asserted oath.)

JUSTICE TODD. Congratulations.

The SPEAKER. All 202 members of the chamber have been sworn in at this time, with 1 vacancy.

GUESTS INTRODUCED

It is with great pleasure I rise today to recognize the Lewisburg Boys Soccer Team. I cannot think of any better way to begin this session than recognizing such a fine group of young Pennsylvanians.

The Lewisburg Boys Soccer Team – and I am going to introduce these guys behind me and the team in the back first so you know whom we are talking about. Here behind me – I have to turn around so I get it right – we have Wilson Fisher, Adam Cole, Joey Bhangdia, and coaches Ben Kettlewell – and I know Skip Kratzer, goodness gracious – Skip Kratzer on the end here. I also want to recognize—

Again, it is just a privilege and a fitting way to begin our session in recognizing such a fine group of individuals. I introduced the gentlemen behind me, but I would like if the balance of the team at the back of the room could please stand and we give them a round of applause in their accomplishments.

Traveling with today's team are the managers, Benjamin Liscum and Jack Host. In addition to that, we have our bus driver today, who is also an integral part of this team, and that is Barry Aucker. Without him, the guys know how important the transportation is. Yes, he does take care of the public transportation for these guys, but it is all part of the team. And I wanted to recognize the bus driver and the managers, because we all know that without good staff and good people behind us, we cannot accomplish the job.

And these young men have done it for the second year in a row. Last year their record was 25 and 0 when they won the 2015 championship. This team, remarkably, repeated the feat again, State champs for Pennsylvania; 24 and 1 is their record.

And I tell you what, I saw these young men play many games, but the best game was down in Hershey for the championship. With less than 3 minutes in the game, they scored the only goal. It just really speaks volumes for how well these young men work together, how well their coaches support them, the community supports them. They are the true example of what we should expect from our future Pennsylvania leaders. They not only excel at soccer. Academically, Lewisburg is No. 16 in the State for academic performance. It is just a great, well-rounded group of individuals that it has been my pleasure to get to know, and I just wanted everybody to say congratulations to the team.

But before I end, I also want to recognize Joey Bhangdia, who has also been named to the High School Boys All-America Team from the National Soccer Coaches Association of America, quite a feat for the second championship in a row.

Our captain up here, Joey; the coaches; the entire team have done an outstanding job, and I just want to say thank you to them, and we wish you all the best in the future. Thank you, Mr. Speaker.

STATEMENT BY MS. QUINN

The SPEAKER. The Chair recognizes Representative Marguerite Quinn to speak on HR 22.

Members, I would ask that you please take your seats. I would ask all conversations to please go to the anterooms.

Representative Quinn, the floor is yours.

Ms. QUINN. Thank you, Mr. Speaker.

I appreciate, as does my colleague, Pam DeLissio, your interest and attention on HR 22, which recognizes January as "Human Trafficking Awareness Month" in Pennsylvania.

It would not surprise me if, when you just heard me mention "human trafficking," you instinctively thought about it as a problem in a country far away, countries in which liberty and freedom are not revered the way they are in our nation. But it is not the case. Sadly, human trafficking is a global epidemic, and it is one of the fastest growing crimes in the world, estimated to be as high as a \$100 billion industry. That makes it second only to the illicit drug industry.

Human trafficking is occurring in our nation, in our Commonwealth, in the counties we serve and the small towns we serve. It is a dark, little-discussed industry, and it is, basically, modern-day slavery. Fifty percent of its victims are children, 80 percent of its victims are female, and the average age is 12 to 14 years old. In the past two decades, this commercial sexual exploitation has grown. The victims are estimated to be in the millions worldwide. In fact, the National Center for Missing and Exploited Children estimates that 325,000 children in the United States and Canada are at risk every year.

Mr. Speaker, the timing for HR 22 is no coincidence. As we look ahead at plans for the upcoming Super Bowl, which will be played within the next 2 weeks, we see an event that is ripe for this type of horrific activity. The large crowd, the partying, the transient customers, and basically an overindulgent atmosphere

will make the upcoming Super Bowl, once again, a target and a magnet for sex trafficking. In fact, leading up to the 2015 Super Bowl in Arizona, the FBI and local law enforcement arrested 68 traffickers and recovered 30 juvenile victims. Despite the efforts of Federal and local law enforcement task forces, despite mandatory training of emergency room workers to ensure that they recognize the victims of this crime, many children are still at risk.

Operation Cross Country, which has now been conducted 10 times, just recently yielded 239 arrests of traffickers and associates and rescued 82 children. Mr. Speaker, of those arrests, at least 15 of those human traffickers came from Pennsylvania. It is our responsibility, morally and constitutionally, to protect the victims of this insidious crime. Raising awareness is a first step that each one of us could take.

I thank you for your support of HR 22, making January Human Trafficking Awareness Month.

Mr. Speaker, thank you.

ANNOUNCEMENT BY MS. DeLISSIO

The SPEAKER. Representative DeLissio, the floor is yours.

Ms. DeLISSIO. I just want to add that this Wednesday at 9:30, I believe in the main rotunda, will be a rally and a session. If you could stop by, you could get some additional information on human trafficking.

The victims are closer than we think, and Pennsylvania has actually, as a result of this legislative body, Pennsylvania has come a long way in the last short couple of years in terms of improving our own laws toward that. We used to rank very low. We have definitely moved up, but we still have work to do. There is funding missing for the victims. So a lot of these children who may have been children when they were first trafficked and are now of majority age need to be treated that way, as victims and as survivors, and we need to have the resources to be able to do that.

So thank you for your support of Wednesday's get-together.

REMARKS SUBMITTED FOR THE RECORD

The SPEAKER. Representative Murt, for what purpose do you rise, sir?

Mr. MURT. Mr. Speaker, I would like to submit some remarks for the record in support of HR 22.

The SPEAKER. Yes, sir. Thank you very much. Thank you.

Mr. MURT submitted the following remarks for the Legislative Journal:

While many of us are aware that human trafficking is a particularly heinous crime, we believe it only happens in other countries when, in fact, it is happening right in our backyards. According to John Ducoff, the executive director of Covenant House Pennsylvania, in 2014 there were 113 cases reported in Pennsylvania, but that is just the number of reported cases. This is a crime hidden in the shadows, where victims are too frightened to seek help or are trapped within malicious cultural norms.

Next to drug dealing, human trafficking is the second largest criminal industry in the world. Make no mistake, human trafficking is modern-day slavery. Unfortunately, too few people are aware that

Pennsylvania has one of the largest human trafficking problems in the country. That is why it is so important that we mark today as "National Human Trafficking Day" in Pennsylvania.

It is imperative that we eliminate human trafficking, including early or forced marriage, commercial sexual exploitation, forced labor, and labor obtained through debt bondage. We in the Commonwealth must be aware of the realities of human trafficking and must dedicate ourselves to stopping this contemporary manifestation of slavery.

Although we have laws to prosecute perpetrators of human trafficking and aid is available to assist the victims of human trafficking, we must educate those who are most likely to come into contact with these victims. They must be made aware of the techniques that traffickers use to keep their victims enslaved.

That is why this resolution is so important and why we raise awareness, since so many lives depend on it.

ORGANIZATION OF STANDING COMMITTEES

The SPEAKER. We are going to move to the organization of committees.

Just a quick comment. I had been elected in a special election, so I missed it in the first session. We went to my first full session, and I will never forget on this day we were calling committees and I missed my first meeting because I was not paying attention. So I would ask everybody to please pay attention to the committee as it is being called that you are serving upon.

I will read the different committees in groups of four or five. If you are a member of that committee, please go to the area that we have designated for that committee to meet upon organization.
