I am excited and proud today to have with us in the hall of the House the Garnet Valley 2016 PIAA Girls Volleyball State Champions. We greatly appreciate that. We are here to welcome, I guess, the first football team this year, a State championship, and I could not be more proud. Gentlemen and ladies, this is the Steel Valley Ironmen, Class AA State Champions of our great Commonwealth. But they are more remarkable than that. The purpose of this day is to raise awareness about heart disease and strokes in women. The fact remains, heart disease is the number one killer of women, causing one in three deaths each year. That is approximately one woman every minute. Nearly two-thirds of the women who die suddenly of coronary heart disease have no previous symptoms. Even if you have no symptoms, you may still be at risk for heart disease. HR 58 serves as a reminder of the keys to prevention, which include knowing your blood pressure, being tested for diabetes, quitting smoking, monitoring your cholesterol, and lowering your stress level. Let us make the reasons for February 3 be something we are mindful of all the time.

Most of the times CHD is serious and requires surgery and/or medications, which often presents an emotional and financial hardship for a family.

I am hoping that by introducing this resolution it will raise awareness across the State for those families who have a child suffering from CHD. Please join me in recognizing February 7 through 14 as "Congenital Heart Defect Awareness Week" in Pennsylvania. Thank you.

STATEMENT BY MR. HARRIS

The SPEAKER. On unanimous consent, the Chair recognizes Representative Jordan Harris on HR 56.

Mr. J. HARRIS. Thank you, Mr. Speaker.

Mr. Speaker, first let me thank my colleagues for the unanimous passage of HR 56.

HR 56 honors City Year Philadelphia. City Year is actually a national organization that was founded in 1988 that does work in urban schools to help students graduate. This year more than 3,100 City Year Corps members will serve in 300 schools, impacting more than 205,000 students in 28 cities across this nation.

In Philadelphia, City Year Philadelphia is celebrating 20 years of service to the students in the Philadelphia School District, which, as we know, is the nation's eighth largest school district, serving a population of 87 percent of students that come from economically disadvantaged homes.

In Philadelphia there are more than 200 City Year Corps members who serve in 18 high-need schools throughout the city of Philadelphia. When we talk about their Corps members, these are young people from the ages of 18 to 25, many of them – more than 80 percent of them are college graduates who spend a year of service in schools across the city. Many of those Corps members have gone on and stayed in the Commonwealth and provided great service as nonprofit leaders, as teachers, as doctors, as lawyers.

Two that I will make mention of, one of our former colleagues and my predecessor, then State Representative Kenyatta Johnson, who is now a member of Philadelphia City Council, he was a Corps member. Also, a young lady that lives

in my district, Miss Keola Harrington, who was a Corps member and now is an assistant city treasurer with the city of Philadelphia.

So these Corps members spend a year providing invaluable service to students in Philadelphia. You may go into a school in Philadelphia, and while teachers are teaching, there are Corps members spending time with young people who need additional support. You may see Corps members pulling out students to do additional math. You may see Corps members pulling out students to help with reading skills. These young people provide a service that should they not be in these schools, many of our young people would not be graduating high school and would be dropping out of the education system and dropping into other systems.

So, Mr. Speaker, I thank my colleagues for their support in recognizing City Year Philadelphia for all of the great work that they do.

Today, in the back, Mr. Speaker, we have with us two folks who represent City Year. We have the executive director and vice president for City Year Philadelphia, Mr. Darryl Bundrige, who is here with us. Also, we have Arthur Block, who is the executive vice president and general counsel for Comcast, who serves as cochair of City Year Philadelphia's local board.

Thank you so much, Mr. Speaker, and I thank all of the young men and women who dedicate their life to service through City Year.

STATEMENT BY MR. STAATS

The SPEAKER. The Chair calls upon Representative Craig Staats on unanimous consent, on HR 66.

Mr. STAATS. Thank you, Mr. Speaker.

It is my honor to present a House resolution commemorating the 106th birthday of our nation's 40th President, Ronald Wilson Reagan. Reagan was born in Illinois in 1911. He graduated from Eureka College with a degree in economics and later served as a second lieutenant in the United States Army Officers Reserve Corps. While working as an announcer for the Chicago Cubs, he landed a contract with Warner Brothers, which led to a brief Hollywood acting career and his election as president of the Screen Actors Guild.

A lifelong Democrat, Reagan became a Republican in 1962. He was elected Governor of California in 1966, and despite imposing a government hiring freeze and raising taxes to balance the State budget, he was reelected in 1970.

After running for our nation's highest office in 1968 and 1976, Reagan finally won in 1980, becoming the oldest to do so at that time, at the age of 69.

President Reagan, who served from 1981 to 1989, is credited with the release of American hostages held by Iran; sparking the fall of the Berlin Wall and the reunification of East and West Germany; negotiating a treaty with the Soviet Union on nuclear

arms reduction; and ending the cold war, which saw the breakdown of the Soviet Union into autonomous democratic republics. He strengthened alliances and supported efforts to stop the spread of communism in this hemisphere and throughout the world.

Here at home, Reagan appointed the first woman, Justice Sandra Day O'Connor, to the United States Supreme Court, extended the Voting Rights Act, and championed the preservation of our nation's civil liberties. He escalated the war on drugs, survived an assassination attempt in which he was shot, and famously fired more than 11,000 air traffic controllers whose illegal strike in 1981 threatened the safety of air passengers.

Reagan was a strong leader and brilliant orator who understood the value of relationships and the power of compromise and used both to advance his own economic, domestic, and international agendas. He had a hearty sense of humor, a quick wit, and enjoyed mutually beneficial relationships with political adversaries and the news media. He strengthened our nation's military, adopting a philosophy of "peace through strength." He later signed arms reduction treaties with the Soviet Union, the world's other superpower, in which each side could verify the cooperation of the other. "Trust, but verify" became Reagan's new motto, putting into perspective the President's caution with regard to the Soviets.

Reagan won a second term with a record 525 electoral votes, winning 49 of 50 States. When he left office after two terms, he had an approval rating of 68 percent.

In 1994 Reagan announced that he was suffering from Alzheimer's disease. He died on June 5, 2004, at the age of 93. Today he is among the most revered and beloved Presidents of all time.

Mr. Speaker, I will leave you with one of my favorite Reagan quotes, one that we should all keep top of mind, and that is, "Government's first duty is to protect the people, not run their lives."

Please join me in honoring the life and service of our 40th President, Ronald Reagan. Thank you, Mr. Speaker.
