McFadden Memorial Bridge; and designating a bridge on that portion of State Route 85 over the north branch of Plum Creek, Plumville Borough, Indiana County, as the Henry Lue Weaver Memorial Bridge.

### STATEMENT BY MRS. BULLOCK

The SPEAKER. Representative Bullock, you may proceed.

Mrs. BULLOCK. Thank you, Mr. Speaker.

And thank you to my colleagues for your support of HR 364, which designates this week as "Men's Health Week" in Pennsylvania. As we prepare for Father's Day this Sunday, the day that we honor the great men in our lives – our husbands, our fathers, grandfathers, pop-pops, uncles, brothers, friends, and neighbors – we also need you to address a very pertinent issue. We have to acknowledge the gender gap that impacts our nation – and no, I am not talking about the pay gap this time. I am talking about the gender gap in life expectancy.

On average, women living in the United States are expected to live about 5 years—

The SPEAKER. Please, please, Representative, just please suspend for just a moment.

Members, if you could please take your seats. I am going to ask the Sergeants at Arms to close the doors of the House. After this resolution, which is very important, we are also going to be taking up a condolence resolution for a past member who is deceased. I would ask everybody to please take your seats so that we can pay attention on HR 364. I am just going to give it a few more moments. If anybody needs to have a conversation, I am going to ask the Sergeants at Arms to let them out at this time. If there are any conversations that have to occur, please just take them out to the antechambers off the House floor.

Thank you. They will still open the doors if anybody needs to have a discussion off the House floor, and as I said, we are going to do Representative Bullock's resolution, and then we are going to go immediately into the condolence resolution. Thank you.

Representative Bullock, the floor is yours.

Mrs. BULLOCK. Thank you, Mr. Speaker.

On average, women living in the United States are expected to live about 5 years longer than our male counterparts. Sorry, Representative Kinsey. In Pennsylvania women are expected to live to 81, while men are only expected to reach the age of 75.

One major contributing factor to the gap in life expectancy between men and women is that men avoid going to the doctor. According to a national survey by the Cleveland Clinic, only three in five men visit the doctor for a yearly checkup. This leaves our men more susceptible to premature death from issues such as cardiovascular disease, lung and prostate cancers, high blood pressure, diabetes, depression, and suicide, just to name a few. But the list goes on, and most of these health issues are preventable, and with early detection, treatable.

That is why I am standing before you today, and I thank you and I thank my colleague, Representative Kinsey, for your support of HR 364. Men's Health Week is an internationally celebrated holiday and seeks to raise awareness of preventable

health issues. It also encourages men and boys to go to the doctor and to talk about their health. As I said, research shows that men are more concerned with their family's well-being or their financial stability than their health. Moreover, they are more likely to report a health issue to their significant other or a parent than to go see a doctor. Nineteen percent of men admit to only going to see a doctor so that their spouse would stop nagging them – and by the way, fellows, it does not work. Often I have to schedule my own husband's doctor visit.

The Centers for Disease Control suggests getting at least 7 hours of sleep a day; to get rid of smoking cigarettes; to exercise regularly; and eat healthy, nutritious meals, as well as effectively managing stress.

So now to my male colleagues, when you come back to work on Monday after enjoying a wonderful Father's Day, maybe at the grill, make sure you schedule an appointment to see your doctor. Make sure you get an annual checkup, if you have not already. We need you here, your families need you, and we hope that you will take care of yourselves – not just this Father's Day, but every day throughout the year.

Have a happy Father's Day. Thank you again, Mr. Speaker.

Mr. READSHAW. Thank you, Mr. Speaker.

Mr. Speaker, as the clerk has read the resolution, I would like to make a few remarks about John.

United States Marine Col. John H. Broujos and State legislator, D-199th District, including Cumberland, Adams, and York, responded to the one last mission on July 8, 2016.

We are here today to honor Representative John H. Broujos. John was a loving husband, father, and doting grandfather. John was a multifaceted man who took great pride in being a family man, an American, a veteran, and an elected official. None of

those were dirty words to John. He had a strong belief in our country and God. His compass was always pointed north and true.

John served 37 years in the United States Marine Corps, retiring with the rank of colonel. John served in both the Korean Conflict and the Vietnam war. In the Korean Conflict, as a rifle platoon commander, Dog Company, 2d Battalion, 1st Marine Regiment, he was awarded the Silver Star, our nation's third highest combat decoration, for his actions in Korea. He was also awarded a Purple Heart. John held a number of positions within the Marines. He was executive officer, 2d Battalion, 3d Marine Regiment; G-2 of the 9th Brigade in 1966, 1967, and 1968; and he was an instructor at the United States Marine Corps Command and State College. He also authored the lesson plan for riverine warfare.

He was a general practice attorney with Broujos and Gilroy in Carlisle. He would frequently encourage young attorneys to public service. He believed in giving back to the community in which we live.

He was a pillar of his community, spending countless hours helping those in the 199th Legislative District. John served five terms in the House of Representatives, 1982-1992. He believed the legislature should make constituents' lives easier. He enjoyed working with members such as Representative Sam Morris on bills that would help others. John's dedication to this institution was second to none, and he spoke with a smile and extreme pride of his time in the legislature.

John was very active in State and local Democratic politics and was well known around political circles. John was a Democratic committeeman for more than 30 years. It was frequently said that John was unstoppable as long as he had Louise, his wife, and a plate of her chocolate chip or her baklava with him. John often credited Louise's cookies for getting him elected.

John truly believed in helping others. He was a supporter of several cooperatives in the 199th District, including the ag co-op and the Korean business owners cooperative. For many years John sponsored the Wider Horizon Program for Catholic and Irish youth education and training.

Today we are here to honor the man, John Horace Broujos. To my left is his wife of 56 years, Louise; together with his children, Melanie, Gregory, and Lisa; and his law partner, Hubert Gilroy. May we acknowledge them, please. In the rear of the House are his former staff: Margaret Tricarico, Alex Makosky, Helen Norton, and Louise Stepanic, who had worked with John for so many years.

It has been my honor and pleasure to present these remarks. The resolution has been read by the clerk, and I will immediately present a copy of that to his wife, Louise. May they be blessed, and may we always remember this fine gentleman, Marine, legislator, and attorney.

The SPEAKER. Thank you, Representative Readshaw.  
Representative John Maher.

Mr. MAHER. It is entirely appropriate that it is Flag Day when we remember John Broujos, a true patriot; a genuine public servant who did so many things for so many people that most of us remain unaware of, as he just made it his life to do good things. He was actually the last of the Broujoses, who are

here today, that I met. You see, the Broujos kids and the Maher kids were all interspersed in the Carlisle School District, and most importantly, Mrs. Broujos was a substitute teacher, and when you entered a classroom and saw Mrs. Broujos, you knew you were going to learn something that day. It did not matter what the subject was. You walked in, and boom, class began. You learned, and you might have learned more – and no disrespect to the other teachers – in that one day than the rest of the marking period.

Now, I came to meet John after meeting all the others. I should mention also that she met John at a debate tournament. He was coaching the Dickinson team, and you were winning on the other side. And he would always say, with a twinkle in his eye, after that that he never won another debate at home. Now, he did win plenty of debates as an attorney and as a legislator, but he was one of those people that had that special quality that he could win the debate without the other person realizing they had lost. He had a special gift.

Precisely 20 years ago today it was Flag Day in 1997. I called him for advice. I was considering whether or not to run for the legislature, and I knew he would be honest with me. He knew me, he knew the legislature, and we had a nice conversation, and he certainly urged anyone who is interested in public service to pursue public service. But he reflected back on being a Marine. Now, he knew a thing or two about giving orders and about taking orders, and he knew a thing or two about being courageous. Something that I do not think was mentioned as yet – he had a Silver Star and a Purple Heart. He would not talk about them. But his advice to me at the end of it was, "If you do this, you've got to have the courage to not take orders. You need to sort out for yourself what you think is right and to do that."

I hope I have met that standard, for which I thank him for his guidance, and, Louise, I thank you for the baklava. The day I was sworn in for the first time, John humbly sat up in the gallery. I did not even know he was here. It was a special election, and afterwards he came down and he brought your baklava, and of course, everybody was happy.

He was a good man, a kind man, the kind of man that makes you proud to be a member of this General Assembly, and we are all fortunate for his service.

Representative Steve Bloom.

Mr. BLOOM. Thank you, Mr. Speaker.

Mr. Speaker, I was just a newlywed, first-year law student when I first moved to Carlisle, and I did not have the honor of meeting Representative Broujos during the time of his service; that was about halfway through his 10 years of being a State Rep that I moved to Carlisle. Although I once went to his office to pick up some maps and some brochures, I never got to meet him during that time. But later, when he chose to end his legislative career and return to his very successful law practice, I had many occasions to interact with then Attorney Broujos in the Carlisle area. And here was a guy who was not only a decorated Marine colonel, a former State Representative, a longtime successful pillar of the community, attorney, who could have treated me in any way he chose to, as a wet-behind-the-ears new attorney, but yet every interaction I had with John over the decades to come, he would always unfailingly treat me with kindness, with courtesy, and most notably, even though

I was a Republican, he would time and time again go out of his way to be especially helpful to make sure that I did not blunder into any mistakes and that the transactions would go smoothly, the interactions would go smoothly. Even though we were often on the opposite sides, just as has already been said, he was a man who cared deeply about others and treated everyone with courtesy.

Today in my district office in Carlisle, there is a wood-carved sign on the wall, a large sign, proclaiming Pennsylvania's 199th District office. That sign was passed to me by my predecessor, Will Gabig. It had been passed to him by his predecessor, Al Masland, who in turn had received it from Representative John Broujos when he left office. And it had been carved for John as a gift by one of his constituents, hand-carved, and I treasure that sign and I will someday pass it along to the next Representative of the district as well, and I hope it continues. But I think of John every day when I walk into my district office, because I know that sign came from him, and I just deeply appreciate the legacy of service and kindness that he has left for our community, and I am glad to be a small part of honoring him today.

Mr. CALTAGIRONE. Thank you, Mr. Speaker.

Today I rise to honor John Broujos. John was a man of integrity and honor. He was a member's member. He loved this chamber. He loved working with all members, young and old, Democrat and Republican. It did not matter.

In an interview not long ago, when asked about his time in the House of Representatives, John said, "I loved the guys in the House and making things happen for all Pennsylvanians." He never forgot that while his constituents sent him here, he had to consider all Pennsylvanians. To John, "compromise" was not a dirty word, but was a way to help citizens in his district and in the Commonwealth. Even today, those of us who served with John still think of him with respect and affection.

Maybe it was his Greek-Italian heritage or his military service, but John was meticulous about the details. He was highly intelligent and approachable by everyone.

John was a Democrat who represented a district spread over three counties, Adams, Cumberland, and York, with a large Republican majority. He served the 199th for 10 years, and if I might take the liberty to say, John probably could have been reelected as long as he wanted, that is how he was loved by his constituents. John was a dedicated servant and believed in doing what was right and not what was always politically expedient. He cared more about taking care of constituents and their issues than anything else.

John was a man of compromise, and in his 10 years in the legislature, he was successful in having 12 laws enacted. He was maybe most proud of his bill to ensure that military personnel and their dependents received in-State tuition for higher education.

John Broujos was my colleague for 10 years, but more importantly, John was my friend. Pennsylvania is a better place because John Broujos was here. To his family, I am sorry for your loss. Please take comfort in knowing that John's memory is forever lasting in this chamber. In keeping with John's example, we, the members of this august chamber, will continue to do the right thing for the citizens of this Commonwealth.

He even found a player for me to present a citation to named "Orlando Roebuck," and he made me a part of that effort.

So I will always value his friendship, his mentoring, and his integrity that reflected well on all of us who serve in this chamber, and his memory will always be sacred to us, and he will indeed be regarded as a person who was someone who set a standard that we all should seek to reach.
