NEWTOWN AMERICAN LEGION JUNIOR PREP BASEBALL TEAM PRESENTED

The SPEAKER pro tempore. Representative Warren and Representative Petri are invited to the rostrum for the purpose of presenting a citation to the Newtown American Legion Junior Prep Baseball Team.

Representative Warren.

Mr. WARREN. Thank you, Mr. Speaker.

I am pleased, along with Representative Petri, to recognize the State champion American Legion Newtown Morell Smith Post 440 Junior Prep Baseball Team.

On August 2, at Berwyn Paoli Area Little League complex, Newtown defeated Plumstead 8 to 5. The team went 32 and 3 overall, with a 22-and-2 regular season mark en route to a first-place finish in the Lower Bucks League. In their county playoff run, they began a run of dramatic come-from-behind wins that would become the trademark of the team's postseason success. In the State tournament, Newtown won two one-run games and came from behind to win twice. In fact, Newtown and Plumstead – from our fellow Bucks County colleague's district – met seven times during the regular season, the county championship tournament, and in the double elimination State tournament.

Newtown was led by State tournament MVP (most valuable player) Bernie Parent, who won two games on the mound and posted a 2.00 ERA (earned run average). On top of that, at the plate he hit for a .667 average. Catcher Chase Coren had four RBIs (runs batted in) in the championship game.

Joining me from the State champion team in the front of the House are Chase Coren, Jack Harar, Bernie Parent, Billy Salvadore, and Austin Stalker. And many of their parents and relatives are seated in the back of the floor as well, joined by other members of the team. If you can stand as I recognize each of you: Dominic Edwards, Nicholas Focella, Joshua Huddy, Andrew Jones, Nathan Rambo, and Zachary Van Arsdale; along with coaches Paul Jones, Duane Van Arsdale, Scott Coren, and Earl Stalker. I have known several of these athletes and their siblings and their parents for years, so it is especially gratifying to welcome them and honor them here today.

Mr. PETRI. Thank you, Representative.

Personal shout-out to the Newtown organization. I want to thank you as a parent for the great work you did when my son was playing and the great work you are doing now. Coaches, believe me, you will remember these days all of your lives and you will look back fondly at the work you have done with these young men, and I do not want to understate the value. You know, my son is 20 now, and he still remembers playing for the Newtown Post, and the coaches that served at that time put a mark on him just as you are putting a mark on these young men.

Lifesharing helps individuals with special needs lead fuller, more independent lives in the communities in which they live.

Mr. Speaker, I would like to submit prepared remarks for the record.

Mrs. HILL submitted the following remarks for the Legislative Journal:

Thank you, Mr. Speaker, and thank you, members, for supporting HR 559, which recognizes the 250th anniversary of the Mason-Dixon line. While often referred to strictly as the border between Pennsylvania and Maryland, the Mason-Dixon line also forms parts of borders with West Virginia and Delaware.

The English team of Charles Mason and Jeremiah Dixon was commissioned in 1763 to end a boundary dispute and survey the newly established boundaries between the Province of Pennsylvania, the Province of Maryland, and Delaware Colony. It took 4 years to complete the process, with the Virginia portion, which later became West Virginia, being added in 1779.

The Mason-Dixon line was originally marked every mile by stones and crownstones with the appropriate coats of arms every 5 miles, using stone shipped from England. Today, while a number of the original stones are missing or buried, many are still visible, resting on public land and protected by iron cages.

STATEMENT BY MRS. WATSON

The SPEAKER. Representative Watson, you may proceed. Mrs. WATSON. Thank you, Mr. Speaker.

Thank you to my colleagues for your attention.

I also want to thank my colleagues for support of HR 556, which designates October 15 to 21 as "National Teen Driver Safety Week." Those of you who have been in the House for a number of years know that this is one of the issues that I devoted actually 8 years to, in trying to, through the Transportation Committee, updating our teen driver laws.

Mr. Speaker, in spite of what we have done, we still know that motor vehicle crashes are the leading cause of death for adolescents and young adults in the United States, and as we also know, many of the deaths are preventable. Yes, we have made important strides in protecting young drivers behind the wheel. Thanks to you and your votes, we limited the number of passengers in a vehicle operated by a new, young driver; we expanded their training to include practice during inclement weather; and we banned texting behind the wheel, which included all drivers.

But sadly, Mr. Speaker, teens are still being seriously injured and some even killed while behind the wheel. Last year in Pennsylvania there were 46 young people killed, including four 16-year-olds, brand-new drivers, and all were young people loved by their families. We always call them the good kids – good kids who are full of dreams and hopes for long and meaningful lives. We all know that too many teen crashes resulting in death have occurred in our own legislative districts, and sadly, if we were to stand up and talk about it, probably each of you has a story that you could tell.

That is why we are here to further raise awareness of teen driver safety. This year's theme for teen driver safety is "U Drive. U Text. U Pay." This theme is all about the consequences of teens' actions, because as we well know, especially those of us who are now parenting a teenager or have grandchildren who are teenagers, they are invincible. They are all-knowing, especially if you are a grandparent, but they are invincible, and they believe that while bad things happen to other people, nothing is ever going to happen to them. But you and I know differently. We know that consequences do happen and, particularly, we know they happen to young drivers. The toughest time for a young driver is the first 2 years that they are

behind the wheel. That is probably the time we need to be the most vigilant, and since that usually occurs from, say, 16 to 18 years, that may be the last and only time that you as a parent, an aunt, an uncle, a grandparent have them around to make comments and to effect change.

I should remind us all, too, ladies and gentlemen, that there are studies that show that young people get some of their driving habits by watching us – their parents, their grandparents, their older brothers and sisters, on how they drive – and they start looking by the time they are 9 years old. Scary thought, is it not, when you go back and think, what did I do in the car when he was sitting back there in that child safety seat?

One of the major factors we know is, of course, impaired driving, and our research has shown that, as I said, most teens are very vulnerable, particularly in the first 2 years. We know that driving and using the phone is dangerous, but for them, they think it is just something that is a part of life, you know, that hand automatically goes up, or they think that texting is important. So therefore, it is up to us to make sure teens know and fully understand what are the risks when they are behind the wheel: certainly, distractions from other passengers; being tired; experiencing strong emotions and taking it out when you are behind the wheel; or being under, we know, the influence of alcohol or drugs.

Mr. Speaker, let us use National Teen Driver Safety Week to engage and empower licensed teen drivers to become skilled drivers and safe drivers, and really, if I could, Mr. Speaker, we would like them to get to be old drivers, just like I am.

Thank you, Mr. Speaker.

The SPEAKER. Thank you, Representative Watson.

The SPEAKER. 2012. I would just advise everybody if you have an opportunity, teen safe driving legislation was undertaken by Representative Watson and became law in 2012 and I know there are efforts that could be used to build upon that. Thank you.

Mr. Speaker, I rise in support of HB 1646, which seeks to add additional protections to Pennsylvania's vulnerable roadway users by increasing penalties for those convicted of careless driving in order to deter as many people as possible from driving in a careless manner.

As we all know, our modern transportation culture operates largely around the use of the automobile. But the motorist driving an automobile is not the only person who is lawfully allowed to use the roadways. Other such users of our roadways include pedestrians, bicyclists, motorcyclists, horseback riders, horse and carriages, farm equipment, and those on wheelchairs. While modern vehicles have the added benefit of decades of research, technological innovations, government regulations, and advanced design engineering in constructing a vehicle to maximize safety, there is a very large segment of roadway users who, by means of their mode of transportation, do not benefit from the added protection of seat belts, air bags, steel cages that crumple in such a way to protect the passengers, and more. Those using these means of transportation on our roadway are obviously far more vulnerable to the physical dangers present on our highways, not only because they lack the extra safety protections in their given mode of travel, but also because they lack deterrent protections in the scope of the law. Since the likelihood of injury is so much greater for vulnerable road users who are involved in an accident, the law ought to offer these individuals far greater protections from careless drivers.

Here are some statistics to demonstrate the gravity of the problem:

In 2016 Pennsylvania experienced a significant increase in pedestrian, bicycle, and motorcycle injuries and fatalities with approximately 4,218 pedestrian injuries and 172 fatalities; 1,298 bicyclist injuries and 16 fatalities; and 3,321 motorcyclist injuries and 192 fatalities. (Bureau of Maintenance and Operations, 2016 Pennsylvania Crash Facts & Statistics, published by PENNDOT.)

Over the last 5 years, total bicycle crashes were 6,637 with 78 fatalities; total accidents involving pedestrians over the last 5 years were 2,116 with 810 fatalities. Within the last 3 weeks in my county, Lancaster County, an Amish family was hit by a careless driver leaving their buggy completely destroyed, their horse traumatized and running away, and the parents and children badly injured. And within the last 2 weeks in my district, a jogger was struck by a car. Sadly, each of us can recount these types of stories from within our own districts and counties.

Over 90 percent of vehicle crashes are attributable to driver error, and many of the above-cited injuries and fatalities were the result of a motor vehicle operator driving in careless disregard for the safety of persons or property, otherwise known as careless driving. Unfortunately, the existing language of the Vehicle Code does not provide fines and penalties for careless driving in a manner proportionate to the physical, financial, and emotional damages

suffered by vulnerable roadway users. For example, the penalties of a person convicted of careless driving are such that they may only be fined \$250 for causing serious bodily injury or \$500 for causing the death of another person. These penalties fail to emphasize the significant life-changing impacts of injuring or killing a vulnerable roadway user. They also, in my opinion, fail to provide sufficient deterrence.

HB 1646 seeks to provide additional protections to PA's vulnerable roadway users by increasing fines and penalties for those convicted of careless driving, and it is hoped that this law will help to educate motorists and provide a greater deterrence to prevent these types of accidents from happening.

Mr. Speaker, I think it is notable that this bill has the support of the Pennsylvania State Police, PENNDOT, AAA (American Automobile Association), and multiple bicycling groups who recognize the need for these additional protections.

I ask that the members join me in recognizing that more than just motorists in automobiles are legally allowed to use our roadways and that those roadway users who are the most vulnerable, such as pedestrians, bicyclists, motorcyclists, those on wheelchairs, or the Amish who use horse and buggies, are deserving of the additional safeguards to protect them from those who drive carelessly.

I ask the members for an affirmative vote on HB 1646. Thank you, Mr. Speaker.

Shall the bill pass finally?

Mr. **PETRARCA** offered the following amendment No. **A03639**:

Amend Bill, page 1, line 18, by inserting after "AMENDED" and subsection (a) is amended by adding a paragraph Amend Bill, page 2, line 1, by striking out all of said line and inserting

(a) General rule.-

* * *

(3) Beginning July 1, 2018, fines, fees or costs which are allocated by law or otherwise directed to the Department of Agriculture under the act of December 7, 1982 (P.L.784, No.225), known as the Dog Law, shall not be affected by this subchapter.

On the question,

Will the House agree to the amendment?

The SPEAKER. On the question, the Chair recognizes Representative Petrarca. Representative Petrarca, on the amendment.

Mr. PETRARCA. Thank you, Mr. Speaker.

As stated, this amendment seeks to remove the cap of moneys that can be used and kept in the Dog Law Restricted Account on a yearly basis. Right now moneys that go into the Dog Law Restricted Account are used for a number of things: shelter reimbursements, kennel inspections, maintenance of the dangerous dog registry, reimbursements for livestock damage from dogs and coyotes, investigating dog bite incidents, also apprehending dogs that run at large, maintenance on vehicles, some equipment, things such as that. Money that goes into the Dog Law Restricted Account comes from three sources: individual license fees, kennel license fees, and also from fines from violations.

In 2008, \$4 million was diverted – or in 2008 we passed a dog law in Pennsylvania which gave enforcement personnel additional responsibilities. In 2009, \$4 million was taken out of that fund to help balance the budget. Still in 2010, in that fund was about \$7 million, and since then, there has been a decline, a steady decline. And how the law works today, the first \$250,000 that goes into that account is retained for Dog Law enforcement actions. All moneys on top of the \$250,000 go to the judicial computer system augmentation fund, and the moneys that have gone to the computer fund average over \$210,000 a year.

So from the late nineties when the Dog Law Restricted Account was enacted, over \$4 million have gone to the judicial computer fund. The problem is that this fund, by next fiscal year '17-'18, is projected to be \$1.6 million in the red. So again, what my amendment does is simply allows all moneys collected to stay in the Dog Law Restricted Account. Unlike the courts, unlike the Pennsylvania courts, from what I mentioned earlier, those are the only areas where money can come into this Dog Law account.

I would like to thank Representative Kathy Watson, who worked on this and introduced legislation last session, and Representative/Chairman Eddie Pashinski, who has introduced legislation that included this provision in this session. We have made great strides with Libre's Law that we passed this session and also the other companion bills along with that. I think by changing this and allowing the money collected in the Dog Law account to remain there to allow enforcement personnel to do what they do is certainly the right thing to do, and I ask for your affirmative support. Thank you.

The SPEAKER. Does anybody else wish to speak on the amendment?

Mr. RABB. Thank you, Mr. Speaker,

I understand that this amendment has been ruled out of order. Is that accurate?

While you confer, I just wanted to—

The SPEAKER. We had not made any ruling, but I can make a ruling.

Mr. RABB. Oh, did I say something?

The SPEAKER. But, sir, you may proceed.

My understanding is, the underlying bill amends the Pennsylvania Election Code to clarify the number of signatures school directors would need to get on their nomination petitions. My understanding is that your amendment repeals the School Reform Commission in Philadelphia, and it is arguable that that is not germane. Now, my understanding is, you were going to withdraw the amendment. If not, I will make a ruling.

Mr. RABB. Oh, well, in that case— I am just a freshman here, Mr. Speaker. I am working on this as best I can. But I brought this up because, while I support the intention of this bill wholeheartedly, I live in the colony known as Philadelphia County, where we do not have an elected school board, and so this reform that I fully support is not germane to the county in which I live and I represent, in the 200th Legislative District, and for all the legislative districts that have any part of

Philadelphia County, and so I thought the easiest thing to do to make this uniform was just to dissolve the School Reform Commission. So I thought it was germane and relevant, but I will defer to you.

The SPEAKER. Sir, if you are withdrawing the amendment – I do think that there is probably a robust debate that needs to occur about the School Reform Commission, by the way.

Mr. RABB. Fair enough. I will have that robust debate at another time, and I will respectfully withdraw the amendment.

The SPEAKER. Okay. Thank you.

Representative Caltagirone has filed two amendments. They are both late-filed. And, Representative Caltagirone, you would have to move to suspend to be able to get consideration of those amendments. There is 3839 and, I believe, 3795, I believe.

Section 908. Manner of Signing Nomination Petitions; Time of Circulating.-Each signer of a nomination petition shall sign but one such petition for each office to be filled, and shall declare therein that he is a registered and enrolled member of the party designated in such petition: Provided, however, That where there are to be elected two or more persons to the same office, each signer may sign petitions for as many candidates for such office as, and no more than, he could vote for at the succeeding election. He shall also declare therein that he is a qualified elector of the county therein named, and in case the nomination is not to be made or candidates are not to be elected by the electors of the State at large, of the political district therein named, in which the nomination is to be made or the election is to be held. He shall add his [residence] address where he is duly registered and enrolled, giving city, borough or township, with street and number, if any, and shall legibly print his name and add the date of signing, expressed in words or numbers: Provided, however, That if the said political district named in the petition lies wholly within any city, borough or township, or is coextensive with same, it shall not be necessary for any signer of a nomination petition to state therein the city, borough or township of his residence. No nomination petition shall be circulated prior to the thirteenth Tuesday before the primary, and no signature shall be counted unless it bears a date affixed not earlier than the thirteenth Tuesday nor later than the tenth Tuesday prior to the primary.

Amend Bill, page 4, by inserting between lines 11 and 12 Section 951. Nominations by Political Bodies.—* * *

(c) Each person signing a nomination paper shall declare therein that he is a qualified elector of the State or district, as the case may be, and shall add to his signature his legibly printed name and [residence] address where he is duly registered and enrolled, giving city, borough or township, with street and number, if any, and shall also add the date of signing, expressed in words or numbers: Provided, however, That if said political district named in the papers lies wholly within any city, borough or township, or is coextensive with same, it shall not be necessary for any signer of a paper to state therein the city, borough or township of his residence. No elector shall sign more than one nomination paper for each office to be filled, unless there are two or more persons to be elected to the same office, in which case he may sign nomination papers for as many candidates for such office as, and no more than, he could vote for at the succeeding election. More than one candidate may be nominated by one nomination paper and candidates for more than one office may be nominated by one nomination paper: Provided, That each political body nominating does not nominate more candidates than there are offices to be voted for at the ensuing election: And provided, That all the signers on each nomination paper are qualified to vote for all the candidates nominated therein.
