#### KIM HILEMAN PRESENTED

The SPEAKER. Everybody, please take your seats. We are going to honor someone who has served our citizens in the House of Representatives for so many years. So I am going to ask all members to please take their seats. This is important. All members, please take your seats. I am going to ask her to please stand, as we have some remarks to honor her service, because she is retiring after 34 years. Kim Hileman. Please stand, Kim. How are you, dear? I am going to say a few words, and then we are going to turn it over to Representative Bradford, who has a resolution, I believe.

But, Kim, we are so honored and want to thank you for your 34 years of distinguished service to the House Democratic Caucus, to the House of Representatives, and to the citizens of Pennsylvania. You always have a smile on whenever I see you, and I know that you have put in so many great years of, really, dedication to this institution – your hard work, your loyalty – always understanding that in the end it was about the citizens of Pennsylvania.

I just want to tell you that Kim began her tenure – Representative Bradford will go through much of this, but think about this – as an executive secretary for then – and I held this job – Majority Leader James Manderino. Kim, I am sure you were busy, and I know you had a great relationship with the leader, an outstanding – as you do with all your members of your caucus.

You know, this good lady earned her bachelor of science degree at Penn State and worked with so many fine legislators: Representative Bowley, Representative Ritter, Representative Josephs, Representative Cohen, and this good man, Representative Bradford.

I just want to introduce your guests, and then I will turn it over to our friend. But, Kim, my understanding is your grandsons, Jacob and Jaxon, are here, right? If they will stand, and because I am going to save him towards the end, your good husband, your gracious husband. I think your daughter, Desiree, is here, right? Desiree, nice to see you, dear. Thank you so much. Her mother, Nancy, is here. Nancy, great to have you. And your brother, Bill. Bill is here; yep, Bill. And son-in-law, David. David, great to see you, my friend. How are you doing?

The SPEAKER. At this time I am going to turn it over to Representative Bradford.

Mr. BRADFORD. Thank you, Mr. Speaker, and thank you for recognizing Kim Hileman, the Democratic Executive Director of the House State Government Committee, who today is retiring after 34 years of service to the Democratic Caucus and the Pennsylvania House of Representatives.

Kim joined the Democratic Caucus on April 16, 1984, 34 years ago, as an executive secretary for then Majority Leader James Manderino. She was asked to assist the leader's office and caucus move from the outdated mag card word processors to a more modern form of word processing using the IBM Display Writers at the time. It tells you a lot, that we have come a long way in 34 years.

In January of 1985 she went on to work for Representative Curtis Bowley as a legislative assistant. Representative Bowley had just been elected to the newly Democratic 65th Legislative District in Warren, Forest, and Venango Counties, where Democrats got elected at that time evidently, and she remained with Representative Bowley for his entire 8 years in office.

While raising her daughter, Kim attended Penn State University, while working here at the Capitol, and graduated in May of 1994.

In December of 1992, Kim had transferred to Representative Karen Ritter's office and stayed with Representative Ritter until December of '94. At that time she transferred to Representative Babette Josephs' office as a research specialist. As chair of the Pennsylvania Women's Legislative Caucus, Representative Josephs asked Kim to help facilitate the creation of Pennsylvania's first Women's Legislative Caucus. Representative Josephs' goal for the caucus was to directly influence the policy process, while offering women legislators a supportive environment from which to challenge the status quo, which has sometimes served to exclude women from full participation in this legislature. Kim was asked to serve as the Executive Director of the bipartisan, bicameral Pennsylvania Women's Legislative Caucus by a unanimous vote of both Democratic and Republican women.

Subsequently, in December 2010, Kim was promoted to the role of Democratic Executive Director of the House State Government Committee, under then Chairwoman Babette Josephs. I would also like to notice, and I think you already have, that Representative Babette Josephs is joining us here today. So thank you, Representative Josephs.

In December of 2012, Kim was assigned, again, to be Executive Director, but now under Chairman Mark Cohen. I know Representative, now Judge Cohen is trying to make it here this morning and is on his way, though he may get himself a little sidetracked. Kim remained with Chairman Cohen until 2016, at which time I took over that position. A true statement is to having worked for Representative Josephs and Representative Cohen and myself, that is not an easy task, Kim, so you have definitely been through it.

On a personal note, as a first-time chairman, I really cannot thank Kim enough. She has been tremendous. I was surprised, actually, how much we got along, because as anyone who has ever watched a State Government Committee hearing, they can be somewhat volatile and a little contentious, but Kim has been a trooper, and I appreciate her for her stick-to-itiveness.

Also, I would be wrong if I did not mention that Kim happens to lead with her heart, and anyone who knows Kim knows that can sometimes be to her detriment, but it is also one of the things that makes her so great. Whether it is 2 o'clock in the morning sending me texts about crazy left-wing Web sites where she finds all kinds of news, the Democratic Caucus will not be losing a staffer when Kim moves on. She will be moving to Florida and be a full-time advocate for every progressive cause there is imaginable. Kim, though, truly does lead with her heart and it is exceptional. One of the things that has amazed me, and again, because of that committee, Kim has often had the opportunity to advocate for women, the LGBT (lesbian, gay, bisexual and transgender) community, immigrants, some of those populations that are not always well represented, and while Kim would have maybe not have done the job for free, her heart would have been every bit as with it, because this is her life's work. It has been her work for 34 years.

And I think something that also needs to be stated, as a single mom for many of those years, for 34 years, it is really tremendous. We often talk a lot about how important it is to support women and single moms and people who are doing the right things: getting an education, advancing themselves, forwarding their own career. Kim's career in the legislature has truly done that, and I want to thank her again personally for everything she has done for me in the last year and thank you on behalf of our caucus, on behalf of this body, and on behalf of the Commonwealth of Pennsylvania. Thank you.

The SPEAKER. The Sergeants at Arms will open the doors of the House.

Kim, we wish you nothing but the best and we are going to take a photo up here with Representative Bradford, if that is okay with you and your family. Please come on up.

The first is going to be Representative Frankel, and this is in remembrance of the victims of the Holocaust, and that is why I ask everybody to please come to the floor and take your seats. All members, please come to the floor and take your seats.

We will be followed by Representative Oberlander on HR 788 – she has guests with us – and Representative White, who will be speaking on HB 2067, and she has guests with us as well, and that is a very solemn bill in and of itself.

I am going to ask one more time any members who are going to come onto the House floor to please do so now because we are going to close the doors of the House. All members, please come to the floor. The Sergeants at Arms are requested to close the doors of the House. All members and guests, staff members, please take your seats.

# STATEMENT BY MR. FRANKEL

The SPEAKER. Representative Frankel, you may proceed. Mr. FRANKEL. Thank you, Mr. Speaker.

I would like to thank my colleagues for their unanimous support of HR 823, which recognizes April 8 through 15, 2018, as the "Days of Remembrance of the Victims of the Holocaust" and on April 12, 2018, as "Holocaust Remembrance Day" in Pennsylvania.

Mr. Speaker, with a 43-percent increase in anti-Semitic incidents in Pennsylvania last year, it is more important than ever to remember and learn from the Holocaust. Today we continue to hear the voices that deny or diminish the Holocaust and we face the reality that those first-person eyewitnesses to this horror are fewer and fewer every year.

While a visit to the Holocaust Center in Pittsburgh or the Holocaust Awareness Museum and Education Center in Philadelphia can provide an important glimpse into one of the most horrible chapters in human history, we also have a connection here in the Capitol.

In 1980 when the Pennsylvania House of Representatives first considered the first resolution about the Holocaust, Representative Russell Kowalyshyn from Monroe and Northampton Counties stood behind one of these microphones to give a firsthand testimony, and I would like to read a few snippets of his remarks, and I quote: "...Mr. Speaker, the date April 28, 1945. On that date, the United States Seventh Army liberated the Dachau concentration camp, which was the first concentration camp established by the Nazi regime, and it was the last one that was liberated. Attached to the United States Seventh Army was a small United States military government unit, composed of one first lieutenant, one second lieutenant, and eight enlisted men. I was that second lieutenant on that military government unit that went into the Dachau concentration camp...."

He continues his remarks by saying, "I am mentioning this to you because I feel that I should bring to your attention, particularly the younger members, the utter human tragedy that occurred under the Nazi regime. Six million Jews were killed. Millions of others whom the Nazis labeled as 'untermeunschen' were also killed in a deliberate extermination program. These things did happen, this great tragedy, which will not be permitted to happen again.

"There was everything there in the extermination camp which was just beyond belief. The gas chamber had above the door the word 'brausakammer,' shower room, and the crematoriums were still operating, and the unfortunate victims there were still dying, some 50 to 70, each day during the week that our unit was there to operate the camp. And one thing among these others that sticks in my mind is, when we went through the barracks and they had the layers of places where the victims were housed, as we went through, these living skeletons raised their arms and cried out, 'America, America.' I am sure they did it not because they were now being liberated by the United States Armed Forces, but they acknowledged that the United States stands for freedom; it stands for human rights."

Mr. Speaker, if you visit the Dachau camp today, just minutes from Munich, you could see the very camp and crematoriums that our former member described, but you would also see two more things. At the entrance at the Dachau camp for the prisoners, you would see the iron gate with the German phrase "Arbeit macht frei," which means "work sets you free," inscribed on top at the place where the Nazis forced labor and medical experiments, worked prisoners to death in so many ways beyond the bullet and the gas chamber. Second, at Dachau you would see a memorial featuring a variety of different brightly colored triangles and stars. Because Dachau was the first concentration camp, these different colored triangles were first sown there on the prisoners' uniforms to represent the different groups of people targeted by Nazi hatred and violence: the yellow triangle, Jewish prisoner; the red triangle, political prisoners or Communists; the black triangle, asocials, nonconformists, vagrants, and the mentally ill; the brown triangle, Roma and Sinti or Gypsies; the pink triangle, gay and lesbians; the purple triangle, Jehovah's Witnesses; the blue triangle, foreign prisoners like the Poles. To this day it is hard to fathom the hatred and destruction visited upon so many groups of people during that time at the hands of the Nazi regime.

In 1980 our colleague surprised this chamber with a firsthand recounting of the death camps. I can report to you today that documents and papers that our colleague collected at Dachau were donated by his family to the United States Holocaust Museum, and like him, nearly 1,000 survivors who have lived in Pennsylvania have also put down their stories for future research and viewing.

As sponsor of the 2018 Holocaust Remembrance resolution, I believe it is worth remembering that while the death camps were thousands of miles away, we have a direct connection to this cruel time right here in the Capitol in this Commonwealth.

Thank you, Mr. Speaker, and thanks again to my colleagues for their unanimous support of this resolution.

The SPEAKER. Members, I think it only fitting given that it is the Days of Remembrance of the Victims of the Holocaust and the Holocaust Remembrance Day that we stand for a moment of silence for all the victims of the Holocaust.

(Whereupon, a moment of silence was observed.)

The SPEAKER. Thank you, members. You may be seated. The Sergeants at Arms will open the doors of the House.

Representative Donna Oberlander is recognized to speak on HR 788. She will be followed by Representative White, who will speak on HB 2067, which we will do a vote and then I will recognize Representative White. We did it on second yesterday, but not on third.

# STATEMENT BY MS. OBERLANDER

The SPEAKER. Representative Oberlander, the floor is yours

Ms. OBERLANDER. Thank you, Mr. Speaker.

And thank you, members, for your unanimous support of HR 788, which names April 2018 as "Esophageal Cancer Awareness and Prevention Month."

This is one of the deadliest cancers, and only one out of five survive for more than 5 years. It is something that simple heartburn – many of which you know someone who suffers from – can be one of the causes. You do not have to chew tobacco or smoke or have excessive alcohol use to have esophageal cancer.

I have had the privilege of two of my constituents who have come over the past 8 years to draw awareness to this very important issue, and they are with me today. We have Rich Horner and his wife, Linda. If you would please rise. Rich is a 9-year survivor of esophageal cancer. Thank you, Rich, for coming. They come each and every year and make the 6-hour round trip because it is so very important to them that we make this awareness to all individuals so that they do not have to suffer through this terrible disease.

Again, thank you for your support; thank you to my constituents, Linda and Rich Horner, for making the trip; and thank you, Mr. Speaker.

# STATEMENT BY MS. WHITE

The SPEAKER. Representative White, you may proceed. Ms. WHITE. Thank you, Mr. Speaker.

Few people go to work every day with the understanding that they may have to put their life in danger to protect the innocent. Every day police men and women leave their homes and families without knowing what they will encounter while on the job. They do so to protect the rest of us, and unfortunately, sometimes they do pay the ultimate price.

Today Representative Taylor and I have the privilege, along with our colleagues throughout the House of Representatives, to honor one such individual who has made that sacrifice. Officer Isabel Santiago Nazario was a Strike Force South C Squad Officer. She worked in the Philadelphia Police Department for 18 years during which she was designated to the Narcotics Strike Force in the 16th District in West Philadelphia.

Nazario grew up in Linwood, New Jersey, before she moved to Philadelphia in 1983. Three years later she graduated from Olney High School. After high school, Nazario joined the Philadelphia Police Academy on January 8, 1990, in order to serve the citizens of her city.

On September 5, 2008, at the young age of 40, Officer Nazario reported for duty for the last time. Shortly after she and her partner learned of a stolen SUV (sport-utility vehicle), they were broadsided by the vehicle on 39th and Wallace Streets in Philadelphia. Nazario tragically lost her life upon impact, and

her partner, Officer Terry Tull, was critically injured. Officer Nazario dedicated her life to public service and keeping her fellow Philadelphians safe.

Here today we honor Officer Nazario's legacy in the company of her daughter, Jazmin Nazario; mother, Patricia Santiago; sister, Maritza Mohamad; and niece, Bryanna Carrasquillo, along with other family members and friends from the Fraternal Order of Police.

HB 2067 will designate a portion of Cottman Avenue, between U.S. Route 13 and U.S. Route 1, as "Police Officer Isabel Nazario Memorial Highway." Each and every day Philadelphians will pass through this portion of the highway and remember Officer Nazario's ultimate sacrifice in the line of duty. It is my hope this memorial will allow her legacy of commitment, honor, and selflessness to live on.

Thank you very much for your support, and thank you, fellow members.

The SPEAKER. Members, if you will please stand in a moment of silence for our fallen police officer, Isabel Nazario.

(Whereupon, the members of the House and all visitors stood in a moment of a silence in solemn respect to the memory of Police Officer Isabel Nazario.)

And to our guests, if you will please rise. I know you were introduced by Representative White. To our guests with the family members and friends, thank you. Our heart goes out to you. Godspeed to each and every one of you.

# STATEMENT BY MR. MEHAFFIE

# STATEMENT BY MR. MURT

The SPEAKER. Representative Murt.

Mr. MURT. Thank you, Mr. Speaker.

Mr. Speaker, I want to thank my colleagues for their support of HR 712, declaring April "The Month of the Young Child."

Mr. Speaker, the evidence is clear. Fifty years of research shows us that children receiving high-quality early education are better prepared for school where they perform better, graduate high school, attend college, learn a trade, and ultimately earn higher salaries. High-quality early learning programs also save taxpayers money by reducing the need for special education and remedial instruction, and it decreases dropout rates, crime, and incarceration.

Unfortunately, there is still far too much unmet need with only one in six children able to access high-quality, publicly funded pre-K, and barely 5 percent of child-care slots for young children are with the highest quality accredited programs. This humble resolution reminds us that we have far to go to make quality child education a reality for the majority of our children.

Thank you, Mr. Speaker, for committing to giving our children the best education they deserve. Our future depends on it. Thank you.

### STATEMENT BY MRS. WATSON

The SPEAKER. Representative Kathy Watson, on HR 757. Mrs. WATSON. Thank you, Mr. Speaker.

It is interesting that I would follow Representative Murt, who talked about this is The Month of the Young Child. I am going to talk to you about this month, April, being declared as "Child Abuse Prevention Month" in Pennsylvania. So it is about children, both young and, sadly, a little older.

Child abuse is something that impacts regardless of your social status, regardless of what county you live in; it is there, sadly, for all of us. In fact, if you were in Harrisburg last week, you saw hundreds of small, bright blue flags outside the Capitol that were placed right near the main staircase coming in. Those hundreds of flags were very small, but they endured some of that rough weather that we all complained about – the snowfall, the harsh winds. These flags were representative of the youngest in our society who have had to overcome life's hardest circumstances. These flags showed the number of victims and the survivors of child abuse and how they have endured. I would suggest to you that we would like a year when there were no flags to be put up.

Tragically, child abuse and neglect threaten the lives and health of thousands of our Commonwealth's children who are subjected to verbal, sexual, emotional, and physical abuse; exploitation and neglect. In order to prevent the maltreatment of our youngest population, it then becomes vital for all our communities to create partnerships among families and organizations to provide supportive resources and reinforce protective measures.

I think it is important for you to remember two words, and those would be "safety" and "permanency." That is what children really need. They need safety to grow up but they need the permanency of consistent care and people who love them, and they will grow to be whatever they are intended to be, whatever their levels of abilities are.

April, as I said, is Child Abuse Prevention Month in Pennsylvania. It is a time, very sad, to remind you that in Pennsylvania in 2016 – please listen to the statistic – there were 4,416 children who were victims of abuse or neglect. And sadly, 46 of that over 4,000 died as a result. One death is too many; 46 spread throughout our Commonwealth, unconscionable. And it is unconscionable to me, too, that we live in an age where people and parents, caregivers, even close friends would seek to harm a child, an innocent child who deserves no less than a chance to live, as I said, in a safe environment.

Mr. Speaker, also this year, in 2016, I should say, reports of child abuse or child neglect hit an all-time high – 44,359 cases reported. This illustrates that the public at large is becoming more vigilant and taking their responsibility to report more seriously. That is a statistic that is not a bad statistic, Mr. Speaker, because we want people to ask, to question, and if it is found that nothing is wrong, that is the best thing that can happen.

No doubt then the increase in the reporting of cases is a result of nearly two dozen laws that you helped enact if you were here just a few years ago to further protect children and ensure justice for child abuse victims. You should feel good about that. Many of those laws will continue to be reexamined, as we have said they should, and revisited so that we know that our laws are among the best in the nation to protect our most vulnerable members in Pennsylvania.

Every year across the nation the month of April is dedicated to building partnerships by raising awareness of the pervasiveness, sadly, of child abuse and to promote the safety and the permanence of all children. That is why I stand today, Mr. Speaker, to thank you for your support of HR 757. You did declare that April is "Child Abuse Prevention Month" in Pennsylvania, just part of our ongoing efforts to ensure that all children have the right to be raised in a safe and secure environment that would prepare them for a future of opportunity and promise.

I thank you for your help in this. I ask for your continued support in protecting children in the Commonwealth. Thank you very much.

#### STATEMENT BY MS. McCLINTON

It is time that we right here in Pennsylvania expand access to clinics and other health-care facilities to ensure that our most vulnerable residents have access to affordable treatment options. We must work toward increasing access to medication that not only treats and reduces the risk of HIV infection, but medicine like PrEP (pre-exposure prophylaxis) that can keep HIV-negative people from becoming infected. Moreover, we must fight the stigma that is associated with HIV and AIDS (acquired immunodeficiency syndrome) that discourages so many young people from even wanting to get tested.

Awareness starts with each and every one of us. That is why I am encouraging each of you to learn the facts about HIV transmission, testing, and prevention. Together through educational initiatives and the utilization of modern medicine, we can achieve an HIV-free generation.

The amendment adds languages on bloodborne pathogens to be included on the written examination, prohibits certain tattooing and body piercing for minors, and deletes references to facial tattoos. The amendment also adds clarifying language, which we have just went through. And the amendment is agreed to, and it is a result of the recommendations from the tattoo and body-piercing industry and, specifically, a resident and constituent of the Lehigh Valley. Thank you.

The SPEAKER. Thank you, sir.

Representative DeLuca, on the amendment, sir.

Mr. DeLUCA. Thank you, Mr. Speaker.
