# SOUTHERN COLUMBIA HIGH SCHOOL FOOTBALL TEAM PRESENTED

The SPEAKER. Representative Millard.

Mr. MILLARD. Thank you, Mr. Speaker.

Today Representative Masser and I recognize the Southern Columbia High School Football Team. They are being honored upon capturing the 2017 PIAA State Class AA Football Championship. They finished an undefeated season with 16 wins. The Tigers won the championship by defeating the team from Wilmington with a score of 48 to 0, and Representative Masser will now offer some more details about that victory.

Representative Masser.

Mr. MASSER. Thank you, Representative Millard. Thank you, Mr. Speaker.

The Southern Columbia Tigers are one of the most successful football programs in Pennsylvania – I would say the most successful – and one of the best small school programs in the country. The PIAA playoff system began in 1988. The Tigers have competed in 16 of the 30 State finals. Over half of the State finals Southern Columbia was there to represent, winning eight of them, including a State record five in a row from 2002 through 2006. They won titles both in A and in AA. Completing his 34th season as head coach of the Tigers in 2017, Jim Roth and his staff have amassed an amazing 86 percent winning percentage.

Their teams have appeared in the playoffs every year, have won 10 or more games in 30 of 34 seasons, and have never had a losing season. Coach Roth became the youngest head coach in Pennsylvania to reach the career milestone of 300 wins, and followed it up in September of last year by becoming 1 of only 3 head coaches in Pennsylvania to reach 400 wins. They hold the PIAA records for consecutive State championships, five; total State championships, eight; State final appearances, 16; consecutive district championships, 16; and total district championships, 25.

It was a fantastic year watching these guys — watching Stone throwing it up to Jules, Garcia just dominating on the field, Cox adding a couple of touchdowns in the State final, just for a little good measure, and being able to do all of this because of an awesome, awesome line on both sides of the ball. On defense, these guys were amazing, with Szuler and Haladay, Tillett, Scicchitano, and Zachman; on top of that, probably the best placekicker in Pennsylvania, if not the country, Elijah Hoffman. All the Southern teams played as a team with heart. And this is how they do it, folks: the day after the State championship,

2 days at the most, the weight room is packed again building for next year. I cannot wait to see you again next year, fellows. Congratulations on a fantastic season.

The SPEAKER. To the Southern Columbia Football Team, congratulations on this championship. We wish you all the best. Up here on the rostrum, do we have seniors and captains? Gentlemen, great job; coaches, great job. We are so honored to have you here today.

At this time the Sergeants at Arms will open the doors of the House. We are going to take some photos. Young men on the floor, you will exit to the left; just go straight back to the chairs, and we are going to take some photos up at the rostrum here. Thank you.

#### JARET LANE PRESENTED

The SPEAKER. Members, please take your seats. We have another young man that has traveled some distance from Southern Columbia High School. He and his coach have come up to the rostrum. So now that we have the football players seated, I would ask all members to please take their seats. Representative Masser is going to be introducing to us a State champion wrestler, Jaret Lane, and I believe father and coach, right? Coach Lane.

Representative Masser, please, the floor is yours.

Mr. MASSER. Thank you, Mr. Speaker.

We are honored here today to have Jaret Lane from Southern Columbia, the 2017-18 PIAA Class AA Individual Wrestling Champion in the 120-pound weight class. He is a senior at Southern Columbia High School. He amassed a season record of 48 wins and 1 loss, and a career record of 182 wins and 9 losses – 182 wins and 9 losses.

The SPEAKER. Yeah, that is amazing.

Mr. MASSER. Under the expert guidance of coach Jerry Marks and assistant – his father – coach Kent Lane, he captured his second consecutive State title with a win over a wrestler from Bishop McDevitt High School.

To his great credit, Jaret has amassed 120 career pins and is the District IV all-time win leader with an undefeated dual meet record of 91 wins. He has captured three district and northeast regional titles and four south sectional titles. He was lauded as the pin leader for this Commonwealth in 2017 and 2018 and recognized with the 2017 Schalles Award, and was selected to Team Pennsylvania to wrestle Team USA in the Pittsburgh Wrestling Classic, where he won by fall over the three-time Iowa State champion.

Jaret, it was a pleasure to watch you as I have watched your father for many years when he wrestled for North Schuylkill, but it certainly has been a great honor to watch you wrestle, and great luck and success at Lycoming and in your future endeavors. Thank you.

The SPEAKER. I am definitely not messing with this young man. Congratulations. Really outstanding career, and I wish you the best. We all wish you the very best in college as well, young man.

The Sergeants at Arms will open the doors of the House. All members, come to the floor, but we are going to close it again because we are going to be honoring more teams. So if any members want to come to the floor, we are going to ask you to please take your seats.

So today I would like to welcome the Constitution High School Generals Boys Basketball Team 2017-18 Class AA State Champions. The SPEAKER. Coach, young men, congratulations. That is outstanding. What a great championship, and thank you for taking the time to be with us today.

Throughout the years, the sisterhood's mission has been to promote academic excellence and to offer support to the underserved, to educate and to stimulate participation in establishing good public policy, and to highlight issues and provide solutions to problems that we face in our communities. Delta Sigma Theta is one of the largest African-American women's organizations in the world, with more than 1,000 chapters around the globe and more than 300,000 members from the United States to England to Japan to Germany to the Virgin Islands, Bermuda, the Bahamas, and the Republic of Korea.

More than 105 years after its foundation, Delta Sigma Theta is continuing to carry on the commitment of the 22 founding members and driving the force to remain in the forefront of social action as a powerful voice for those in need.

# STATEMENT BY MR. KAMPF

The SPEAKER. Representative Warren Kampf, on HR 900. Mr. KAMPF. Thank you, Mr. Speaker.

Mr. Speaker, I am glad to be joined at the podium by my colleagues, Representative Corbin, Representative Longietti, and Representative Briggs. We are the cochairs of the House Life Sciences Caucus and we are here as a part of HR 900, which you voted on earlier today, declaring today as "Cellicon Valley Day." Cellicon, right, is not silicon. It is a play on that word. And Cellicon Valley Day is to celebrate cell and gene therapy technology which was developed right here in Pennsylvania, in southeastern Pennsylvania, actually, in the Great Valley – in the Delaware Valley, sorry, not the Great Valley – the Delaware Valley, and it is extraordinary.

The FDA (Food and Drug Administration) has approved cell and gene therapies that came out of research institutions in Philadelphia, which, among other things, have actually cured relapsed leukemia in children. Let me say that again: cell

therapies developed in our great Commonwealth have cured relapsed leukemia in children. This has happened at the Children's Hospital of Philadelphia, and I am sure is going to happen all over the world as a result of those successes.

So Cellicon Valley is just an extraordinary place. I think something like \$450 million has been invested in cell and gene therapies in our region. One out of every six doctors in the United States today has done some work in the institutions of Cellicon Valley in southeastern Pennsylvania, and my colleagues and I are very proud to have had this day, May 22, 2018, declared "Cellicon Valley Day" here in Pennsylvania.

## STATEMENT BY MR. MURT

The SPEAKER. Representative Tom Murt is recognized to speak on HR 919.

Mr. MURT. Thank you, Mr. Speaker.

Mr. Speaker, the American Cancer Society estimates that this year alone more than 81,000 new cases of cancer will be diagnosed in Pennsylvania, and many of these patients will require support from family members who are critical to the health-care providers. Known as lay caregivers, these unpaid caregivers are, in many cases, Mr. Speaker, a husband or wife, a partner, or an adult child; for many who are single, close friends, coworkers, and neighbors fill in this role. These caregivers provide 80 percent of the home-care services, which are often a complex array of tasks including physical, psychological, spiritual, and emotional support.

While caring for an individual with cancer can be extraordinarily stressful, Mr. Speaker, many caregivers find satisfaction in providing care for a loved one with cancer. Many cancer patients are deeply grateful to their caregivers for their love and dedication, weathering the challenges and setbacks of cancer treatment and sharing the triumphs with them. That support does not end after treatment concludes. This is why our caregivers need our help and support. This is why I am grateful to my colleagues for declaring May "Cancer Caregivers Recognition Month" in Pennsylvania.

The SPEAKER. Thank you, sir, and you may proceed.

Yes, please, we should all clap for his service. Thank you, sir. Yes, absolutely.

## STATEMENT BY MR. MAKO

The SPEAKER. Representative Mako, would you please talk to us about National Guard Day.

Mr. MAKO. Absolutely.

So, Mr. Speaker, I want to thank you for allowing me to rise and speak on HR 935, which we voted on earlier, and I want to thank my colleagues for the unanimous vote declaring tomorrow, May 23, 2018, as "National Guard Day" in Pennsylvania. And as we spoke of just a moment ago, I am a proud member of the Pennsylvania National Guard for the past decade, and it has been an honor to sponsor this resolution. Last year I missed National Guard Day at the Capitol due to serving on military orders, so this will be my first year that I will experience it in person.

The relationship between the Pennsylvania General Assembly and Pennsylvania National Guard dates back more than 260 years. In 1755 the General Assembly passed the Militia Act, laying the legal foundation for the militia, which is our Pennsylvania National Guard. Today the nearly 19,000-member Pennsylvania National Guard is one of the largest and most deployed forces in the nation, and the only National Guard to host a Stryker Brigade. In fact, as you know, one of our colleagues, Representative Matt Gabler, is currently deployed to the Middle East as part of the 28th Infantry Division Headquarters, the oldest division in the U.S. Army. Matt, please know that we think of you each and every day and pray for your safety.

Pennsylvania guardsmen and women have served with honor and engaged in every conflict the nation has faced in our history, from the American Revolution to Operation Enduring Freedom. On the home front, too, the Pennsylvania National Guard shoulders a heavy responsibility, from disaster relief and flood response to security for high-profile events.

While members of the National Guard receive recognition and thanks, I also would like to acknowledge their families. The husbands, wives, parents, and children of National Guard members also sacrifice so that their loved ones can serve. They worry daily about their safety and must take on added responsibilities during deployments and training. We are fortunate to have such a highly trained National Guard and supportive family members in this Commonwealth.

Mr. Speaker, the National Guard always stands ready, whether domestically or internationally. I am honored to have the opportunity to serve my nation and the Commonwealth in this distinguished corps. Thank you to the members of the General Assembly for your commitment to the National Guard. We appreciate the support.

This good man, Representative Mako, joined the Pennsylvania National Guard in January 2008, and as a Chinook helicopter pilot, he was deployed to Afghanistan in December 2012 for 9 months, supporting Operation Enduring Freedom.
