## APPROPRIATIONS COMMITTEE MEETING

The SPEAKER. Representative Cutler, the majority whip, is called upon to make the announcement for the Appropriations Committee. I call upon the majority whip, who will provide us with a committee announcement.

Mr. CUTLER. Thank you, Mr. Speaker.

Mr. Speaker, there will be an immediate meeting of the Appropriations Committee in the majority caucus room at the break. Thank you.

#### REMARKS SUBMITTED FOR THE RECORD

The SPEAKER. Representative Murt, you are recognized. Go ahead.

Mr. MURT. Mr. Speaker, I would like to submit my remarks for the record.

The SPEAKER. Okay. So remarks will be accepted for HR 923, National History Day.

Mr. MURT submitted the following remarks for the Legislative Journal:

Understanding history is critical to a full understanding of the human condition. History helps us understand why we live the way we do as a people and country. Studying history allows us to learn from the mistakes of our past to make sure we do not repeat those errors. History helps us make our world a better place. These are critical lessons we must pass on to our children and why we must support National History Day.

National History Day in Pennsylvania is the Commonwealth's contribution to the national, year-long, classroom-based program that engages students in hands-on historical research and exploration. Each year more than 2,000 students participate in local contests with the support of their school peers, teachers, and parents to celebrate the importance of history and the brightest students of the Commonwealth.

National History Day is a national program to create an understanding and appreciation of history while developing the necessary skills and aptitudes of our diverse student population. It encourages students from the 6th to 12th grades to research, write, and

think critically about our nation's past. After competing successfully in the local and regional contests, more than 100 students, teachers, parents, and family members will gather for the National History Day in Pennsylvania State contest. The winners of the State contest will become the Pennsylvania delegation to the national contest at the University of Maryland at College Park, Maryland, in June. This is also an important community event as volunteers donate their time as judges and staff for the State contest.

National History Day in Pennsylvania is recognized as an innovative education program by the Pennsylvania Department of Education and is represented throughout this Commonwealth by 12 regional affiliates that coordinate activities in 51 counties across this Commonwealth. Students who participate in National History Day in Pennsylvania are better prepared for college and careers.

That is why it is so important that we designate May 14, 2018, as "National History Day in Pennsylvania." It is a way to encourage students, teachers, and other residents of this Commonwealth to appreciate the history of our State and nation.

#### STATEMENT BY MR. HENNESSEY

The SPEAKER. Representative Hennessey, you may proceed. Mr. HENNESSEY. Thank you, Mr. Speaker.

Mr. Speaker, I would like to thank my colleagues for your affirmative votes on HR 931, establishing "Older Pennsylvanians Month" in the Commonwealth of Pennsylvania. I am joined here by the Democratic chair. I serve on the House Aging and Older Adults Services Committee. I serve as the majority chair of that committee. I want to acknowledge and salute our older adults here in the Commonwealth.

Pennsylvania has the sixth highest population of seniors in the nation—

The SPEAKER. Please suspend.

Members, the good gentleman is speaking on HR 931. I would ask everybody to please take their seats. If you have business to conduct, please take it off the House floor. All members, please take your seats.

You may proceed.

Mr. HENNESSEY. Thank you.

As I was saying, Pennsylvania has the sixth highest population of seniors in our nation. In 2011 the first baby boomers began turning age 65. Ten thousand people across the United States turned 65 in Pennsylvania; roughly 400 each day become 65 years old. By 2020 the Pennsylvania senior population is estimated to be 20 percent of our entire population here in Pennsylvania. As these boomers age, we realize we must have adequate services and supports available to them, and we also recognize the knowledge, experience, and value they bring to our local communities.

This year's national theme is "Engage at Every Age." More and more older adults are participating in activities which promote mental and physical wellness, and the resulting increase in their longevity allows them more time to share their wisdom and experience and to mentor others with their life experiences.

The "Engage at Every Age" slogan emphasizes that you are never too old or too young to take part in activities that can enrich your physical, mental, and emotional well-being.

The baby boomer generation remains a dynamic force, taking charge, advocating for themselves and others, striving to live a more independent and healthy lifestyle, and helping to make Pennsylvania an even better Commonwealth. They enrich the fabric of Pennsylvania and the tapestry of our culture.

Today we recognize our older Pennsylvanians as they engage at every age here in the Commonwealth, and we thank them for continuing to share their talents, skills, and stories with us every day.

#### STATEMENT BY MR. SAMUELSON

Mr. SAMUELSON. Thank you.

I would like to join my colleague, Representative Tim Hennessey, in recognizing Older Americans Month. When the first Older Americans Month was celebrated back in 1963, there were 17 million Americans who had reached their 65th birthday. Today there are more than 41 million Americans who are age 65 or older, and Pennsylvania is home to more than 2 million senior citizens.

The theme for Older Americans Month, as Representative Hennessey said, is "Engage at Every Age." It emphasizes that you are never too old or too young to remain active and engaged in your community, and Pennsylvania seniors have found a variety of ways to be engaged in our communities. Many seniors are active in the workforce. According to a Federal report, seniors are responsible for 7 million new jobs since the year 2000. Our State Department of Aging helps seniors remain active and engaged by connecting them with a variety of volunteer opportunities, including the Foster Grandparent Program, APPRISE health insurance counselors, and the Retired Senior Volunteer Program. Many Pennsylvania community colleges allow seniors to attend classes tuition-free. There are some guidelines and restrictions, but this is a program that is worth checking out.

And Pennsylvania has more than 500 senior centers, which are supported by our 52 area agencies on aging, and these senior centers provide information to keep seniors healthy and activities to keep them physically and mentally active, and also many opportunities to socialize.

HR 931 acknowledges the time and talents seniors give back to their local communities. We need to remain committed to ensure that our older Pennsylvanians have the support and resources they need so that they can remain active and engaged.
