May we be protected together. May we be nourished together. May we work together with great vigor. May our study be enlightening. May no obstacle arise between us.

(Prayer in Sanskrit.)

United your resolve, united your hearts, may your spirits be at one, that you may long together dwell in unity and concord.

(Prayer in Sanskrit.)

Peace, peace, peace be unto all.

I apologize, a condolence citation. We are going to close the doors of the House. All members, please come onto the House floor for this condolence citation.

Officers, if you could please come to the well of the House for the condolence citation. Representative Rapp will be up here at the rostrum.

STATEMENT BY MS. RAPP

The SPEAKER. Representative Kathy Rapp is recognized under unanimous consent, and she will be introducing some guests. Thank you.

Ms. RAPP. Thank you, Mr. Speaker.

First, I would like to read the condolence resolution itself:

"Whereas, The House of Representatives of Pennsylvania wishes to honor the memory of K9 Officer Choper, a member of the Conewango Township Police Department, who lost his life in the line of duty during a training exercise at the age of five on June 6, 2018; and

"Whereas, Born in Holland on March 9, 2013, K9 Officer Choper was brought to the United States and received formal training at Shallow Creek Kennels in Sharpsville, where he and his partner, K9 Handler Scott J. Neiswonger, graduated in 2015 with Class No. 121. Nationally certified through the North American Police Work Dog Association, he was sworn in to the Conewango Township Police Department on May 11, 2015, and faithfully served the department for three years as a Dual-Purpose K9, assisting all agencies in Warren County. A member of the Warren County Drug Task Force, K9 Officer Choper provided countless K9 demonstrations in the Warren County area and participated in numerous community service programs and events, including the DARE Program and programs with the Boy Scouts of America and the Girl Scouts of the USA; and

"Whereas, A dedicated member of the Conewango Township Police Department, K9 Officer Choper strove to keep the township and all of Warren County safe and will be greatly

missed by all those who had the pleasure of knowing and working with him; and now therefore be it

"Resolved, That the House of Representatives of the Commonwealth of Pennsylvania proclaim with enduring sorrow the passing of K9 Officer Choper; and extend heartfelt condolences to his partner, K9 Handler Scott J. Neiswonger; caregiver, Alicia Labesky; and many colleagues at the Conewango Township Police Department; and be it further

"Resolved, That a copy of this resolution, sponsored by... myself, Kathy Rapp, "on June 11 2018, be transmitted to K9 Handler Scott J. Neiswonger."

And, Mr. Speaker, if I could, first of all, thank you, Mr. Speaker, for allowing me the time to present this citation and condolence resolution.

But today I rise with sadness but with great pride to honor the memory of K9 Officer Choper, a member of the Conewango Township Police Department, who tragically lost his life in the line of duty during a training exercise on June 6, 2018.

Again, K9 Choper was born in Holland on March 9, 2013, and was brought to the United States and received formal training at Shallow Creek Kennels in Sharpsville, where he and his partner, K9 Handler Scott Neiswonger, graduated in 2015 with Class No. 121. He was nationally certified through the North American Police Work Dog Association, sworn in to the Conewango Township Police Department on May 11, and faithfully served the department for 3 years as the dual-purpose K9 and assisted all Warren County agencies as a member of the Warren County Drug Task Force.

Over the past 3 years, Choper touched the lives of so many and leaves a huge impact on Conewango Township and for keeping all of Warren County safe. He will be greatly missed by all who had the pleasure of knowing and working with him. As a matter of fact, on the day of his passing, the Governor ordered the flag to be flown at half-staff for our police officer.

K9 Choper and his handler, Officer Scott Neiswonger, who is standing in front of me, and his parents are to the left, Ken and Linda, brought nothing but safety and goodwill to our communities. Both were selfless in the exercise of their duties and spent many hours training for whatever situations may have come their way.

Also joining us on the House floor today in remembrance of Choper are members of the Capitol Police K9 force and their handlers: K9 Arty with handler Officer Clark Godusky – if you would raise your hand please and let people know who you and Arty are – K9 Majo with handler Officer Tim Horst; and K9 Brix with handler Sgt. Michael Ferrell, who is in charge of the Capitol K9 Unit. Thank you for being with us today.

Mr. Speaker, I humbly ask that members join with Officer Neiswonger today in honoring this heroic K9 officer. Choper gave his life, proving that it is not only human beings who possess the courage to wear the badge, but also these loyal and brave souls who walk on four legs. Just like any other fallen officer, may his legacy of protecting and serving his community never be forgotten. Thank you.

Thank you, Mr. Speaker.

The SPEAKER. Thank you, Representative Rapp.

Thank you, officers, and thank you to the K9 officers as well. Thank you so much for being with us today.

The Sergeants at Arms will open the doors of the House.

This weeklong program gives high school students the opportunity to learn about municipal, county, and State governments.

We also have a great group called GirlGov program. Would all the GirlGov participants please stand. They are in the gallery, I believe. Thank you so much for being with us, GirlGov. This program provides an opportunity for high school women to shadow, really to intern with State legislators, and we are very honored to have them.

Members, these particular officers and then the K9 officers, those are the folks and animals that we rely on every day with respect to safety in the Capitol. Thank you for giving them a round of applause.

STATEMENT BY MR. KINSEY

The SPEAKER. Representative Kinsey, on HR 871.

Mr. KINSEY. Thank you, Mr. Speaker.

Mr. Speaker, I just want to share a few comments on HR 871 that is sponsored by Representative Vanessa Brown and myself, Mr. Speaker.

Mr. Speaker, today, June 19, 2018, is Juneteenth Independence Day. Juneteenth is known to have begun with the freeing of the last enslaved Africans in America in Galveston, Texas, on June 19, 1865. Juneteenth originated in Philadelphia, Pennsylvania. On June 19, 1863, the Pennsylvania Abolition Society, which was the first abolitionist society in the United States, met to implement President Abraham Lincoln's Emancipation Proclamation. From the meeting, the Pennsylvania Abolition Society established Camp William Penn, the first and largest training camp to exclusively train African soldiers to serve in the Union armed services. Mr. Speaker, on June 19, 1865, in Galveston, Texas, the United States African troops of Camp William Penn guarded Gen. Gordon Granger as he read General Order No. 3, which enforced President Lincoln's Emancipation Proclamation and freed the last enslaved Africans in the last slave State.

We commemorate this day to the freedom of millions of Africans who survived their harrowing journey; to the continued education and achievement of African-Americans and to the challenges that we face today. The Juneteenth celebration is necessary now more than ever. At this time in history it represents an opportunity for everyone, individuals and institutions, to recommit to liberty, justice, equality, so we can move our nation forward, providing opportunities and promoting success for all. Today we have a chance to not only celebrate African-American freedom but to also speak out. I stand here today to honor our past, to celebrate the achievements of our present, and to encourage our work toward a more inclusive society to make sure that we do not repeat the history.

Let us honor our ancestors who survived the inhumane institution of bondage and left us a marvelous legacy of resistance and perseverance. Let us remember, in the words of Dr. Martin Luther King, that none of us are free until all of us are free.

And, Mr. Speaker, with that being said, I would like to have our guests in the rear stand up. These are our guests. They were invited up by Representative Vanessa Brown. They traveled up here in order to celebrate with us Juneteenth, and I want to thank them for being here with us today, Mr. Speaker.

Thank you, Mr. Speaker.

And, Mr. Speaker—

The SPEAKER. Representative Kinsey, if you will, can you read the names for us, please.

Really, such an important historical moment in the Commonwealth of Pennsylvania's history and in our country's, so we are very glad that you would be here. As we all know, the opioid epidemic has been ravaging the Commonwealth and it is not a new issue. One approach is to raise awareness. Construction workers are involved in very physically demanding jobs. They endure many aches, pains, and injuries. The business insurer CNA found more than 15 percent of workers in the construction industry have a substance abuse problem, compared to less than 9 percent of workers in other industries.

HR 981 works in concert with an effort by the Keystone Contractors Association, which has partnered with the National Safety Council, to organize educational resources and promote awareness of the problem and potential solutions. They, along with a number of other industry and labor groups, including the trade unions, plan to focus their efforts on the last full week in July, the height of construction season. These efforts will include an educational toolbox, which encompasses materials to facilitate discussions with workers about the dangers of opioids and prescription drug abuse and a "Warn Me" sticker to place on workers' insurance cards to encourage health-care providers to discuss opioid issues with their patients.

In conclusion, thank you for helping to bring awareness to this issue. By working together, we can help educate and prevent further addiction.

Instead, HB 2477 creates superlicensees who have twice the ability to dispense as our commercial licensees, with absolutely no research restriction upon whom they can dispense to. Additionally, these clinical registrants escape the—

The SPEAKER. Sir, please suspend.

Members, the good gentleman is entitled to be heard. I know we have come back from caucuses and there is lots of discussion, but I ask everybody to please take their seats. Both the good gentleman, Representative Mullery, and the good lady, Representative Watson, are entitled to be heard on this issue. So I am going to ask everybody to please take their seats. Any conversations can go off the House floor. Sergeants at Arms, please let the last members get onto the floor. We are going to close the doors of the House so that we can have members seated to hear this debate.

Members, please come onto the House floor. We are going to close the doors here temporarily. Members, come on in. Please take your seats.

Sergeants at Arms, if you could close the doors of the House. We are going to wait till everybody – please be seated – we are going to wait until everybody is seated. If anybody has any discussions, please take them off the House floor.

Okay. We are going to have Representative Mullery begin. We are going to have him start from the beginning. Members, please take your seats. He is fully entitled to be heard. Representative Watson is fully entitled to be heard. I would ask everybody to please take their seats.

Representative Mullery, you may begin.

Mr. MULLERY. Thank you, Mr. Speaker.

No pressure, now that you have got me all starting over here.

Again, I am not at all opposed to the clinical registrants or the research they anticipate conducting. I am confident their work will create better medicine for Pennsylvanians in need. That said, HB 2477 goes well beyond the scope of medical research. Instead, this bill creates superlicensees who have twice the ability

to dispense as our commercial licensees, with absolutely no research restriction upon whom they can dispense to. Additionally, these clinical registrants escape the ultracompetitive application process our commercial partners were required to navigate. My fear and my resulting opposition to this House bill is that we are too quickly expanding the market to the detriment of our commercial partners by not creating a level playing field. To me, this is fundamentally unfair, and for these reasons I ask for a "no" vote on HB 2477.

Thank you, Mr. Speaker.

The SPEAKER. Thank you, sir.

You may open the doors of the House.

Representative Watson, on the bill, please.

Mrs. WATSON. Thank you, Mr. Speaker.

And as my learned friend said, "One, be quick, and two, are you sure you really want to speak? You know when you speak, that can inspire." All right. I would like you to be somewhat inspired, ladies and gentlemen, but not enough to prolong this.

But really, in a very serious manner, before I ask for your support for HB 2477, please remember it is legislation that was created intended only to provide clarification and legislation that continues to reflect my intent. I was the person here in the House who wanted what became chapter 20, and you will hear I went to some professionals to get some help to how to take what I have in my head as a dream and make it a reality. Please know I am the one with the legislative intent. I did not change legislative intent in this bill. I do not know any other way to say it.

I also think that it is important, ladies and gentlemen, because I know you have gotten e-mails and information and some of the rhetoric that has been tossed around just is not accurate. I do not know why, but remember, I am the ex-teacher so I feel compelled to make sure that the class really understands what is going on. So allow me, class, if you will.

Let me take you back a few years when I was first approached about chapter 20. I had an idea for a concept, but I did not know really where to go with it. Very concerned about the concept of medical marijuana, but how do we make it really work? You have heard, I think, things, that this was done by – I am using quotes now – "out-of-state millionaires who are trying to manipulate Pennsylvania's medical marijuana research-only law." No, I never met with out-of-State millionaires, and you know I am not a millionaire even in State. Who I met with was a Pennsylvania native whom I trusted to help me to get to some of the research facilities, our medical schools, and talk about this idea. Could it work? Could it do it? Because we were, if you remember a few years back, meeting people who sat in our rotunda, who had children who were profoundly disabled and injured because of epilepsy, whatever, and they were saying they had been told that if they could get medical marijuana, their children's quality of life would improve. I am chair of Children and Youth. I work to improve the quality of life for all children in Pennsylvania.

So then I collaborated with that Pennsylvania individual, and in fact, I even got to meet with a president and CEO (chief executive officer) of one of our top medical schools and health systems who explained to me this could work. It could be done. We have fine medical schools across the Commonwealth. We are terribly blessed, and indeed, we could design something that would work, and that is exactly how this all came about.

But you and I both know that research requires more than just someone like me working with medical professionals who have medical expertise. It even requires more than the patients the

research is intended to assist. Let us be honest. What it also requires in research, and you know this, is financial backing. The current constraints on conducting medical marijuana research – we know about them – meant that if we were serious about requiring professional research, we needed to be serious about ensuring the appropriate resources would be available to do so. To suggest that the focus of chapter 20 is, and I will quote, "...on profiteering, not researching cures for patients," Mr. Speaker, I swear to you that is patently false, and quite frankly, it is offensive to me and it should be offensive to many of you who have research facilities with your medical schools in your area, in your immediate area. We worked very hard so that, indeed, real research not only will have the opportunity to occur, but it is going to be required to occur. This is what works.

Please know, and let me end with this since the comment that the Commonwealth Court made was they did not understand legislative intent. Let me explain and go on the record with you, if you would bear with me for a minute more. Here is the legislative intent of this bill and chapter 20: to build an unprecedented collaboration between research institutions in the Commonwealth and medical cannabis organizations in order to develop a research-based, clinically oriented focus that will allow for the development and execution of meaningful, publishable – key word there – research, high-quality products and measurement of public health outcomes, with the goal – very important – of improving patient quality of life.

Mr. Speaker, that is what you will be about if, indeed, you vote for HB 2477; purely a clarification of what you voted for in 2016, which was chapter 20 of the medical marijuana bill.

I have a whole lot more. I will submit it, Mr. Speaker, with your approval, for the record. Please vote for HB 2477.

REMARKS SUBMITTED FOR THE RECORD

Mrs. WATSON submitted the following remarks for the Legislative Journal:

Before I ask for your support of HB 2477, legislation intended only to provide clarification and legislation that continues to reflect my intent when this chamber originally passed chapter 20 with a vote of 187-3, I think it is equally important to clarify some of the rhetoric that has been floating around regarding this legislation.

Let me take you back a few years, when I was first approached with the concept of chapter 20. I met with a Pennsylvania native; not – and I quote – "out-of-state millionaires...trying to manipulate Pennsylvania's medical marijuana research-only law." Additional support for creating the collaboration contained within chapter 20 came directly from the president and CEO of one of the Commonwealth's top medical schools and health systems.

As you all know, Pennsylvania is a wealth of unique and diverse medical expertise that spans across the entire State, and, I believe, the key to the success of the medical marijuana program is the utilization of this vast body of knowledge. However, research requires more than just medical professionals and medical expertise, more than the patients the research is intended to assist; let us be honest, it requires significant financial backing. The current constraints on conducting medical marijuana research meant that if we were serious about requiring research, then we needed to be serious about ensuring the appropriate resources were available to do so. To suggest that the focus of the chapter 20 program is, and I quote, "...on profiteering, not researching cures for patients" is patently false and offensive to me and those that have worked so hard to ensure that real research not only has opportunity to occur but is required to occur.

That said, what sets chapter 20 apart from any other provision is the basis for its development, which was: to build an unprecedented collaboration between research institutions in the Commonwealth and medical cannabis organizations in order to develop a research-based, clinically oriented focus that will allow for the development and execution of meaningful, publishable research, high-quality products, and measurement of public health outcomes with the goal of improving patient quality of life.

For almost the past year, the General Assembly has worked with the department and administration to implement chapter 20. The collaborative efforts of this regulatory workgroup did, in fact, capture my intent and vision: requiring full-time research for potentially eight additional vertically integrated permittees; creating a fair and equitable process for medical schools to play a role in the selection of their clinical registrant, but never diminishing the department's authority, which must ensure those entities are, in fact, qualified to operate in this Commonwealth; and allow a clinical registrant to sell products to anyone who presents a valid identification card, which aligns with current pharmacy practices and provides patients and caregivers with the option to choose. This ensures that a clinical registrant has the means to provide consistent, ongoing financial support for research and eliminates any risk to other research dollars.

I know what was intended then and I know what is intended now. Opponents of this legislation are doing nothing more than protecting their profits, many of which are operating in other States, turning profits and certainly not focused on research. Their recent efforts to engage in research, by conducting surveys for an out-of-State university, is nothing more than an attempt to protect their bottom line and mislead members of the General Assembly and the citizens of this Commonwealth.

The goal of chapter 20 is to ensure that Pennsylvania has a sustainable, clinically oriented, research-driven medical marijuana program that focuses on public health outcomes and patient quality of life.

Therefore, I ask for an affirmative vote on HB 2477. Thank you.

GUESTS INTRODUCED

The SPEAKER. We are going to just suspend for a moment. I want to do an introduction of some students that are with us, because they have to leave shortly.

First of all, to my left and here up at the rostrum, is Emma Arrisher, and she is a senior next year at Pine-Richland High School in my district, the 28th District. Emma, thanks so much for being with us today. She is part of GirlGov – right? – and you were with Chairman Barrar today, Chairman Stephen Barrar. Now, I think some of the other GirlGov students are here that were not here earlier. Please stand and wave to everybody. We are so excited to have you here today. Thanks so much for being here.

Then I think we have a few more – who else is over here to our left with GirlGov? – please stand – everybody who is here. Thanks so much. It is great to have you here. Some great role models out on the floor, by the way.

To the left of the rostrum, because I know they may have to leave, too, Bill Gandy – where is Bill? – and his wife, Kimberley. They are from Pittsburgh. They live on the North Side of Pittsburgh. It is so great to have you here. They are here on Juneteenth Day, you know, which really is a celebration of one of the first, if not the first abolitionist group, and they are guests of Representative Gainey. Representative Gainey, it is great to have you. Come on up and we will get a photo, sir. Just come straight up. Then we are going to begin the debate again.

CONSIDERATION OF HB 2477 CONTINUED

The SPEAKER. Representative Russ Diamond, on the legislation, sir.

Mr. DIAMOND. Thank you, Mr. Speaker.

I rise in support of HB 2477, and let me make it very crystal clear as to why we should support this. Members, those of you who were here in the last session, we stood up here and we had a long, protracted battle over Act 16. One of the proudest parts of that battle was making Pennsylvania not just a leader in this nation, but a leader in the world for research on this medicine.

Here is the problem: Even though we did that, a court ruling has put a stop to the research, dead in its tracks. If you are a patient or if you have a loved one that is a patient who goes to one of these dispensaries today, although the folks there are as helpful as they can be, they cannot be as helpful as they could be because we do not have the research program going to instruct them. So your loved ones and your patients are walking away not as fully informed as they could be about what might work for their serious medical condition. We designed this act with research in it. The court has stopped the research. HB 2477 will put us on a path to getting that research restarted to help all those patients and all our loved ones that we stood here and fought for last session.

Mr. Speaker, I urge a "yes" vote on HB 2477. Thank you.

As a matter of fact, Article 19 of the United Nations Convention on the Rights of Persons with Disabilities has been adopted by 160 nations, that addresses this, and entire nations are trying to relearn what our Commonwealth has learned at Pennhurst, about the success of citizens with disabilities living, working, and being educated in their local communities.

So I would encourage our members, Mr. Speaker, to please go out into the main rotunda and pick up some literature and take a look at the display, because it really does properly depict the struggle with disability rights in the Commonwealth and in our nation.
