GUEST INTRODUCED

The SPEAKER. Located to the left of the rostrum, the Chair welcomes a member of the Irish Parliament, the Honorable Pearse Daniel Doherty, who is the guest of Representative Kevin Boyle. Thank you so much for being with us; how fitting as we approach St. Patrick's Day here in the United States.

Representative Doherty was born in Glasgow, Scotland, but his family returned to native Ireland when he was 3 years old. The Honorable Representative has represented the Donegal constituency in the Irish Parliament since the 2016 general election, and he previously sat as a member of Parliament for Donegal South-West from 2010 to 2016, and was a Senator elected by the Agricultural Panel from 2007 to 2010.

As many of you know, the Republic of Ireland is an island in the British Isles located west of Great Britain. About four-fifths of the area of Ireland are part of the territory of the Republic of Ireland. The Republic of Ireland has a population of nearly 4.6 million people, and of course, the Irish diaspora has many of those with ancestry back in Ireland here in the United States, and in many other countries across the globe as well.

Representative, like many of the members here, on my mom's side, her parents were born in County Galway in the Connemara region; in particular, Oughterard and Maam Cross. So I am sure you have traveled that area because Donegal is not far. Such a beautiful, beautiful country, and we are so honored to have you here today as a guest of this chamber.

We often remark, I often remark that our body here goes back to 1682 when William Penn came over and established Pennsylvania as a colony, and the Provincial Assembly is our direct antecedent. Many believe that we are the oldest functioning democratic body in the New World. So welcome here today. We are so honored to have you.

Representative, if you have time, we are going to do a little bit of business, and then we would love to have you and some others up for a photo, up on the rostrum, if that is okay. Thank you.

REMARKS SUBMITTED FOR THE RECORD

Mr. DRISCOLL submitted the following remarks for the Legislative Journal:

Thank you, Mr. Speaker.

Since this nation's founding, American citizens of Irish descent have made many significant contributions, both within the Commonwealth of Pennsylvania and the United States. And did you know that when America was born the Irish were already here? Their historical contributions include military service, as many soldiers of Irish descent fought under Gen. George Washington in the Continental Army, helping to make independence a reality, and further serving in every major conflict involving the United States. The Irish led union efforts and put on display their inherent power of organizing to add quality to the land they adopted.

Today Pennsylvania hosts some of the longest running and largest St. Patrick's Day parades in the country. These include the city of Philadelphia, where the parade has taken place since 1771, and the city of Scranton, which hosts the second largest St. Patrick's Day parade in the nation.

Thank you to my colleagues for recognizing and celebrating the Pennsylvanians of Irish heritage who continue to thrive and excel in many spheres of human endeavor including, but not limited to, academia, business, literature, science, and politics. As of 2017, 10.1-percent of the U.S. population claims Irish ancestry. Regardless of

your ethnicity or heritage, all Pennsylvanians are urged to be Irish for the day in celebration of St. Patrick's Day, which is observed annually on the date of March 17. We hope that our colleagues and neighbors will join us in one of the many parades and events taking place across the State in 2019.
