REMARKS BY SPEAKER

The SPEAKER. Her niece, Caravel, and nephew, Diesel, please stand. Great to have you here. Now, two other nieces from this outstanding family could not be with us today because they are in summer training at the U.S. Military Academy at West Point. We give them our best. I am sure they are here with you in spirit, Representative.

I also see our good friend who formerly served in the House and then of course he went on to the Senate. We know you loved your time here. Senator and House member Bob Robbins and his lovely wife, Cindy. This good gentleman served in the House from 1983 to 1990.

I know you have many other great friends and family members here today. Thank you for taking the time to be with us on this very special occasion.

REMARKS BY MAJORITY LEADER

BEDFORD HIGH SCHOOL ROSIE THE RIVETER BATTLE BOTS TEAM PRESENTED

The SPEAKER. Representative Topper, you may proceed. Mr. TOPPER. Thank you, Mr. Speaker.

I am not sure what the first thing that pops into anybody's mind when they think about Bedford County might be, but I am not sure that it is the home of the National Robotics Competition Champions, but maybe after today it very well could be.

This impressive group of students competed against a total of 58 high school and college teams with their fighting robot, which won the championship in the battle portion of the robotics tournament, which I just love talking about battle robotics, Mr. Speaker. The title is determined by a composite score of tournament placement, engineering documentation, and an interview score. This team's engineering binder is 120 pages of student-developed information detailing every aspect of the battle bot design, including some detailed engineering drawings of this battle bot. So we have a few engineering majors coming out of this group, I am sure.

STATEMENT BY MS. HANBIDGE

The SPEAKER. Representative Hanbidge, you may proceed. Ms. HANBIDGE. Thank you, Mr. Speaker.

I appreciate the opportunity to recognize a treasured and historic borough of our Commonwealth. I am proud to stand today to thank my fellow members for voting in support of HR 359, which officially commemorates the 150th anniversary of North Wales Borough on August 20, 2019.

North Wales Borough is located in the heart of Montgomery County and is home to approximately 3,250 residents. Incorporated on August 20, 1869, the borough was part of the 1702 William Penn land grant and originally given the name "Gwynedd," in honor of the homeland of its earliest settlers who immigrated from the northwestern part of Wales.

North Wales Borough reflects the deep history not only of my legislative district but of the entire Commonwealth. As the first and oldest borough in the North Penn Valley, North Wales' tightly knit community remains a shining example of the best and most unique values of our Commonwealth.

With a main street lined with shops, restaurants, and homes; a restored and renovated firehouse with one of the highest volunteer rates in the State; a SEPTA (Southeastern Pennsylvania Transportation Authority) train line running through the center of the business district; and a borough hall and area library in the backyards of residents, North Wales Borough is an idyllic, hardworking Pennsylvania town.

Today I am grateful to be joined by leadership from the North Wales Borough. Mr. Speaker, sitting in the rear of the chamber, I would like to recognize and introduce Gregory D'Angelo, mayor of North Wales Borough; Jim Sando, the council president

of North Wales Borough; Jim Schiele, the cochairman of the North Wales Borough's 150th Anniversary Committee; Christine Hart, the North Wales borough manager; and Alan Guzzardo, the North Wales Borough assistant manager.

To each of our guests, thank you for your dedication to the borough's success and for all you do to preserve the history, excellence, and comfort of North Wales. To my colleagues, thank you for your support.

The SPEAKER. Mayor, council president, cochair, and borough manager and assistant manager for North Wales Borough, thank you so much for joining us today. Thank you.

STATEMENT BY MS. TOOHIL

The SPEAKER. Representative Tarah Toohil is recognized upon unanimous consent, and, Representative, you may proceed.

Ms. TOOHIL. Thank you, Mr. Speaker.

It is my pleasure today to introduce Brianna Kubishin to our colleagues here in the House. Brianna is with her mother, Colleen, behind me, and, Brianna, if you would please stand up, I am going to introduce you to the House.

Brianna is a current titleholder. You can hold your applause till the end. We are going to give her a round of applause at the end. Brianna is a current titleholder of Lancaster's Miss Red Rose City 2019. She graduated last month from Misericordia University with a master's degree in occupational therapy. She has a bachelor's degree in health sciences, and she minored in psychology and gerontology.

As an occupational therapist, Brianna strives to help others and she works on putting the ability in their disability. Throughout her year of service, Brianna will promote her personal platform called "The Miracles of Tomorrow Start Today: Overcoming Prematurity Through Early Intervention." And, Brianna, you are an academic and service-oriented inspiration to young people in our community and throughout Pennsylvania. Please keep using your voice to advocate for others. The State of Pennsylvania acknowledges your accomplishments and we wish you continued success. And if the colleagues of this House could give her a round of applause. We welcome you here today and congratulate you. Thank you, Brianna.

The SPEAKER. Thank you so much for being with us today. We are so honored.

Representative Kinsey, Representative Stephen Kinsey, on unanimous consent. You can come down to the Democratic leader's podium.

Members, I understand that upon unanimous consent, Representative Kinsey is going to be speaking with respect to a deceased United States Marine, so I am going to ask everybody to please take your seats.

STATEMENT BY MR. KINSEY

The SPEAKER. Representative Kinsey, you may proceed.

Mr. KINSEY. Thank you, Mr. Speaker.

Mr. Speaker, I want to thank you and my colleagues for the opportunity to share the unfortunate passing of Mr. Earl Guydon. I know that many gathered here do not know Mr. Guydon by name, but I want to share that Mr. Guydon was a Montford Point Marine, and that is, he was a part of the first group of African-

Americans to integrate the United States Marine Corps during World War II.

Mr. Guydon saw combat during World War II when the United States occupied Japan. Mr. Guydon was honorably discharged with the rank of corporal at the end of the war. In 2012 Mr. Guydon along with other Montford Point Marines were awarded the Congressional Gold Medal, the country's highest civilian honor awarded by Congress.

And, Mr. Speaker, I had the distinct pleasure of knowing Mr. Guydon since the 1960s. I actually went to school with his son, Jonathan, and Mr. Guydon was a stalwart in the community. As a young kid growing up, he never talked about his heroics or serving in the United States Marine Corps. What he talked about was focusing on education and keeping our community together. He became sort of like the leader of the "Town Watch," and he would walk with his Doberman pinscher, Rusty, up and down the streets at night just to ensure the safety of all the residents in the Germantown community. He later became very active in our community association, sharing ideas and suggestions, again, to keep our community safe; all this time, Mr. Speaker, many of us not knowing that this gentleman served this country with such honor as a United States Marine.

Mr. Speaker, his memorial is taking place today, and on behalf of all the members here assembled, I am honored to leave the chamber sometime later this afternoon to present to his family a citation recognizing and praising his service not only to Pennsylvania but to our country.

So, Mr. Speaker, I want to thank you for the opportunity to share as I reflect upon the life of Mr. Earl Guydon. Thank you, Mr. Speaker.

REMARKS SUBMITTED FOR THE RECORD

The SPEAKER. Representative Frankel.

Mr. FRANKEL. Thank you, Mr. Speaker.

I will be submitting my remarks for the record.

The SPEAKER. Yes, sir. Thank you very much.

So Representative Frankel is submitting remarks for the record on HR 358, No Place for Hate Week.

Mr. FRANKEL submitted the following remarks for the Legislative Journal:

Thank you, Mr. Speaker.

Mr. Speaker, I rise today to talk about an organization that has for more than 100 years worked to make our State and our nation safer, fairer, and kinder. The Anti-Defamation League was created during a time of open bigotry and intolerance toward Jewish Americans, but from the beginning, the league's mission was larger than the protection of one group of targeted people. Sigmund Livingston created the ADL in his Chicago law office with \$200 and a mission "to stop the defamation of the Jewish people and secure justice and fair treatment to all."

From the beginning, the ADL has fought the dark forces of ethnic, racial, and religious hatred with sunlight. The organization exposed the Ku Klux Klan's methods and developed legislation to give the Federal government the tools to fight the murderous group. As fascism moved across Europe in the 1930s, the ADL called out sympathetic organizations on American soil. While the league was battling violence against Jews and other minorities, it was also speaking out about the casual anti-Semitism and racism that plants the seeds of violence.

The ADL has become a vital source of information about hate groups and hate trends, depended upon by law enforcement and governments here in America and abroad.

The ADL grew out of the Jewish tradition of inclusion, and that value has remained a North Star for the organization. Hatred against one group weakens the whole. Violence against our neighbors makes us all less safe. It is in this spirit that the ADL created the "No Place for Hate" program, which fights bigotry by teaching respect for differences in schools and workplaces.

Hatred and violence have never gone away, never stopped threatening our values, our democracy, and our image of ourselves as a nation. Today the challenges are as formidable as ever, as technology is exploited to spread hateful ideology and its emissaries attempt to push it into the mainstream.

From its beginnings, the ADL has warned us that hatred and prejudice do not fade out when ignored. Because of a century of research by the ADL, we know that the shadows are where this brand of evil grows and flourishes. Never was that more clear to me than on October 27, 2018, when a gunman a couple of blocks from where I was gathering with local activists walked into a synagogue and opened fire on a group of people he had never met. I lost 11 friends and neighbors that day, and my neighborhood will never quite be the same.

We cannot change history or bring back the thousands of Americans who have lost their lives to this kind of destructive ideology, but we can stand with those who insist on equality and demand fairness. Today we thank the ADL for all of its contributions to our nation and our Commonwealth, and we declare May 27 through 31 "No Place For Hate Week" in its honor.

The SPEAKER. Representative Ortitay, if you could use the majority leader's podium since the other podiums are not here. Just give everybody a moment, and then I will call upon you. Members, if you could please take your seats. If you are staying, take your seats. If not, I would ask you to please exit either from the front or the back very quickly so that I can call upon members who wish to speak. And we are asking those that wish to speak to use either the majority leader's podium or the Democratic leader's podium. Either one is fine.

So I am going to ask all members to please clear the well. I am going to first be recognizing Representative Ortitay, and then I will be recognizing Representatives James and Freeman. So if we could, please clear the well. Please exit from the back of the chamber.

Sergeants at Arms, if you would not mind, can you remove the chairs in front of the majority leader's podium. If we could just move them to the side. Thank you so much, Cuppy.

STATEMENT BY MR. ORTITAY

The SPEAKER. Representative Ortitay is recognized to speak on HR 361.

Mr. ORTITAY. Thank you, Mr. Speaker.

I rise today to thank my colleagues for their support in designating the week of July 21, 2019, as "Construction Opioids Awareness Week" in Pennsylvania.

As we all know, the opioid epidemic has been ravaging the Commonwealth. This issue and problem is not new. The construction industry, particularly, has been hard hit. The physical nature of construction work and the aging demographics of the industry's workers mean that injury rates are 77 percent higher than the national average.

Workers often are prescribed opioid pain medications for the pain associated with injuries common in the construction industry, and many workers may return to work before the injury has fully healed, using opioids to manage the pain.

My resolution, HR 361, works in concert with an effort by the Keystone Contractors Association, which has partnered with the National Safety Council, to organize educational resources and promote awareness of the problem and potential solutions. They, along with 12 other industry and labor groups, including the trade unions, plan to again focus their efforts on the last full week in July, the height of construction season. These efforts will include an educational toolbox, which encompasses materials to facilitate discussions with workers about the dangers of opioids and prescription drug abuse, a "Warn Me" sticker to be placed on workers' insurance cards to encourage health-care providers to discuss opioid issues with their patients, and drug take-back events.

Drug abuse by construction workers not only affects the workers themselves but also their coworkers on the job site, their employers, and the public. If work is performed improperly due to a worker's impairment, the errors can cause building failures, which can result in injuries and even death.

In conclusion, thank you for helping to bring awareness to the opioid problem in construction workers. By working together, we can help educate and prevent further addiction.

Mr. Speaker, I rise today with my colleague, Representative Freeman, to draw attention to some unsung heroes here in the Commonwealth.

Our Commonwealth is blessed with a variety of parks, beaches, pools, campsites, marinas, athletic fields, etc., other recreational opportunities. Pennsylvanians take advantage of these opportunities on a regular, daily basis. But these facilities do not run themselves. Behind all these wonderful opportunities in Pennsylvania, there is a workforce of nearly 8,000 park and recreation employees. They are helped by a vast array of volunteers as well.

Mr. Speaker, these men and women ensure Pennsylvanians have access to a wide variety of leisure activities, and the activities keep Pennsylvanians healthy and help them lead happier lives. These local facilities add charm and value to our communities by improving the quality of life for local residents.

Therefore, Mr. Speaker, we introduce HR 370 to recognize the hard work of our park and recreation professionals. Mr. Speaker, on behalf of the grateful Commonwealth, I would like to take this opportunity to thank the men and women who work at the park and recreation facilities. And I would like to thank all of my colleagues for their positive vote.

I am pleased to join with my colleague and good friend, Representative Lee James, in thanking the House for its unanimous vote in favor of HR 370, a resolution that recognizes and celebrates July 19 of this year as "Pennsylvania Park and Recreation Professionals Day."

It is the parks and recreation professionals who maintain the many parks here in Pennsylvania, including 121 State parks and over 6,000 local parks. These individuals work diligently to ensure that our public parks system is clean, safe, and ready to use – parks in all of their various forms, from nature trails to active parks offering venues for sports and other physical fitness options, to passive parks that can offer a place of beauty and repose in a community, allowing that community and its residents to escape from their hectic schedules, at least briefly, for a period of relaxation and contemplation.

Our park and recreation professionals maintain their park systems with increasingly limited budgets and shrinking staff complements. The SPEAKER. Representative Dan Miller, on the amendment.

Mr. D. MILLER. Thank you, Mr. Speaker.

Mr. Speaker, the maker of this bill has a very good idea and I strongly support HB 296 and I believe, as she has always done, she has cared greatly about our foster care system, our foster care kids, and our foster care parents. I applaud her for those efforts and sincerely thank her for her work in that arena. She has a good idea.

What my amendment will do is it triples the size of the tax credits that will be available for foster care and for adoption. And why this is important, Mr. Speaker, is in direct relation to why I believe she has done the bill, is because she knows like I do, like many of us do, that our foster care system is hemorrhaging support and finding difficulty in trying to find enough qualified foster care homes for both foster care – short-term, long-term – and adoption possibilities, and we need to find a greater way to give our counties and nonprofit agencies more support in locating these households who are looking to support our foster care kids in one way or the other.

And now let us keep in mind, too, that in caring for a foster care child or being a preadoptive resource, this is not a simple job, this is not an easy process, and the challenges that come with it can often be immense. And it goes beyond the mere stipends for clothing or the mere support in relation to other household needs and it comes into a massive undertaking where this family is looking to support this new child in their world and to make that new child part of their family, often whether they are foster care, short-term placements, or even adoptive resources. So what my amendment does here is it says that we appreciate the work of not only the agencies in identifying these people and that we appreciate the foster care placements, in the sense of saying that we appreciate their work in stepping forward to care for a child who biologically was not their own, but in particular, what it does is it says we want to make it that we are helping to attract more and more families who care about raising kids from the foster care system.

These kids in foster care are often the most disadvantaged. They are often our most vulnerable. They are not looking for just a home, they are looking for a great home. They are not looking for just a family, they are looking for a great family, and they deserve it, as every child does. And often these kids in the foster care system are left on the side with not enough supports or jumping between too many placements without enough of a feeling of a sense of home or knowing that they have loved ones who care about them.

Well, Mr. Speaker, my belief is that this body cares about foster care kids. My belief is that this body will stand with foster care kids and say, "Look, we care about you. We want you to find more options, we want to support the families who are raising you, and we want this system to work in a better way that leads you to a better tomorrow." Well, in order for that to happen, Mr. Speaker, we need to bring more people into the system. We need to make it a little bit easier for foster care families to be involved. We need to help those preadoptive resources and say, "Look, you're not standing alone when you are taking this child into your home." Well, that is what this amendment does, is it goes and tells those foster care parents, those would-be adoptive resources, "You are not alone. We care about you and we are going to try to make it a little bit easier for you to do the important work that we need you to do."

So that, in short, Mr. Speaker, is what my amendment does. I recognize that the tax credit is a start in a direction and not the end of the process, but I want to applaud the good woman for her work on this bill and her long-term commitment. I believe that in tripling the amount we will make a positive difference in foster care agencies attracting resources for foster care and adoptive resources in Pennsylvania. So I would ask for an affirmative vote on this important amendment.

The SPEAKER. Representative Tarah Toohil, on the amendment.

Ms. TOOHIL. Thank you, Mr. Speaker.

While I appreciate the efforts and motivation of my dear friend and colleague from Allegheny County, I would respectfully ask the members to oppose this amendment. It would provide — I believe that in the bill already that we are providing a reasonable starting point for this credit, and I would like to highlight that there is an annual reporting requirement. So if this credit is not working as intended, once it is established, that we can certainly entertain the idea of increasing the thresholds at a later time, and I am hopeful that this bill would actually be able to be passed and maybe we can include it in the current budget process that we are undergoing. And I think this legislation will get the ball down the field, but I do not want to extend it too far because I would be afraid that it would terminate the bill completely. So I would ask the members for a negative vote on this exact amendment.

(8) A minor ordered to undergo treatment due to a determination under paragraph (7) shall remain and receive inpatient treatment at the treatment setting designated by the court for a period of up to twenty days. The minor shall be discharged whenever the attending physician determines that the minor no longer is in need of treatment, consent to treatment has been revoked under paragraph (4) or at the end of the time period of the order, whichever occurs first. If the attending physician determines continued inpatient treatment will be necessary at the end of the time period of the order and the minor does not consent

- (i) release the minor; or

- (10) Nothing in this subsection shall prevent a nonconsenting parent who has legal custody rights of a minor child to object to the consent given by the other parent to inpatient treatment under paragraph (1) by filing a petition in a court of common pleas in the county where the minor resides. The court shall hold a hearing on the objection within seventy-two hours of the filing of the petition.

Representative Gabler, on his bill, HB 364.

Mr. GABLER. Thank you very much, Mr. Speaker.

Today I rise to ask my colleagues for their support of HB 364, a bill which will improve the safety of our students and our traveling public. This bill adds "school vehicles" to the categories of vehicles that are authorized to display a flashing or revolving yellow light. Unlike school buses, which display the red and amber flashing lights that we are all familiar with, school vehicles are regular passenger vehicles, such as vans or minivans, and they currently are authorized to display only placards that identify them as carrying school students.

Across our Commonwealth school vehicles travel thousands of miles each day to transport children to their places of learning. These vehicles, by nature of the purpose they serve, may behave in ways that other drivers on the road do not expect.

This legislation authorizes, at the discretion of the operator of the school vehicle, the display of temporary or permanent yellow lights on these vehicles to signal their stops. These signals will provide an additional visual cue for other drivers on the road to see what is going on. Especially when one of these vehicles may need to stop or turn near a blind curve or hill or in low-light conditions, the reflections of this yellow light will give advance warning to other approaching drivers.

With the adoption of yesterday's amendment, the official positions of the Pennsylvania State Police and PennDOT are neutral on this bill, meaning that there is no opposition among the stakeholders. The focus of our work this week in the House is to move legislation that strengthens and protects communities. I am proud to offer HB 364 as an important piece of that effort. I ask for your affirmative vote, and I thank you all very much.
