### BILL ON CONCURRENCE IN SENATE AMENDMENTS

The House proceeded to consideration of concurrence in Senate amendments to **HB 1324, PN 2179**, entitled:

An Act amending Title 51 (Military Affairs) of the Pennsylvania Consolidated Statutes, in military educational programs, further providing for definitions, for eligibility, for grants, for amount of grants, for limitations, for recoupment of grant payments, for regulations, for administration and for Educational Assistance Program Fund and providing for a military family education program; and making editorial changes.

On the question,

Will the House concur in Senate amendments?

The SPEAKER. Moved by the gentleman, Representative Barrar, that we concur in those amendments.

Representative Barrar.

Mr. BARRAR. Thank you, Mr. Speaker.

Mr. Speaker, today is a great day for the Pennsylvania National Guard and their families. Pennsylvania is blessed with the best National Guard in the country, and we are so proud of them.

HB 1324 creates the military family education program, which provides college education funding for dependents of National Guard soldiers who reenlist for an additional 6 years in the Pennsylvania National Guard. Currently our National Guard is about 2,000 members short. This is a great program to address the recruitment and reenlistment problems that our National Guard currently faces, but also, it is a way to support the family members of our Guard personnel who endure many hardships and sacrifice on a daily basis.

The Senate inserted an agreed-to amendment clarifying that the members of the National Guard are prohibited from simultaneously accepting dual obligations under the education program for an initial 6 years.

Mr. Speaker, we are about to pass this bill and I am hoping that it passes with a unanimous vote, but if I may, may I take a few seconds to thank some of the people involved in this. I would like to thank Chairman Chris Sainato for his valuable leadership

in this. Chris, you have been great to work with, and I can tell you, this would not be happening without you. Also, I would like to thank Senate Chairman Mike Regan and Senator Lindsey Williams, who also co-prime sponsored a Senate version of this exact bill. Also, I would like to thank the newly appointed Senate Veterans Affairs and Emergency Preparedness Committee minority chairwoman, Pam Iovino. Also, the Adjutant General; this was one of his incentives that he came up with to help with our recruitment problems that we are currently having. And the Pennsylvania National Guard Associations for their tremendous lobbying efforts to get this bill passed. And lastly, I would like to thank all the House and Senate staff that worked on this bill. They did an incredible job at working out the details of this, and this was just introduced in February. We are getting it signed into law; hopefully, at the end of the day, this will be signed into law.

This legislation is also supported by the Governor's Office, the Department of Military and Veterans Affairs, PHEAA (Pennsylvania Higher Education Assistance Agency), and the National Guard Association. I would like to ask today for your affirmative vote, and on behalf of every member of the Pennsylvania National Guard and their families, I thank you for your support today.

I do want to echo my counterpart from Delaware County's words – this truly is a great day here in Pennsylvania for our National Guard. And I really want to thank Chairman Barrar and his staff and my staff for working so hard to get this thing done, and thank Senator Regan and Senator Williams and our new Senator, Iovino, over in the Senate, because you know what? This legislation today is a prime example of what happens when you have bipartisan support and working together. And I thank Governor Wolf for his leadership on this piece of legislation. It all started with him back in February, and we all jumped on board and we all worked together to reach this point where we are today.

So I think everyone should be very proud of the work that was done in this chamber and the work that was done in the Veterans Affairs and Emergency Preparedness Committee, which I have the honor and privilege to cochair with my counterpart from Delaware County.

So, Mr. Speaker, I strongly urge everyone to support this piece of legislation. Nothing would be better than to see a unanimous vote to help our men and women of the Pennsylvania National Guard.

You may have seen in the release that Representative Mako, who represents the 183d Legislative District, is a combat veteran, and a U.S. Army helicopter pilot in the Pennsylvania National Guard, announced today that he is going to be deployed in the Middle East this fall, helping to fight terrorism and secure international peace; attached to Company B, 2d Battalion,

There were a number of Senate amendments on HB 235, and some of them were to bring us into compliance with the Federal Child Care and Development Block Grant reauthorization act, which helps us not incur a penalty of \$6 million. There is also compliance with the Federal Family First Prevention Services Act. The Administration for Children and Families could decide that the reimbursement we received for child-care costs incurred after October 1, 2008, that that would have to be refunded to the Federal government, and this is preventing a loss of almost \$24 million. We also have a compliance with Federal annual user fee for child support services, and this prevents us from losing a Federal match that could be up to \$179 million.

This House voted on a bill from the chairwoman of Children and Youth. It is HB 1633, and the language of that bill is inserted into this House bill as well.

I would ask the members for a positive vote on concurrence. Thank you.

Section 1842. The advisory committee shall advise the area vocational-technical board on such matters as the need for a particular shop, laboratory, occupation, equipment, curriculum, labor management coordination, business and industrial requirements or selection of personnel.

(b) An occupational advisory committee shall be established for each career and technical education program or cluster of related career and technical education programs offered by an area vocational-technical school or school district. The occupational advisory committee shall be appointed by the board of directors of the area vocational-technical school or school district, as applicable. A majority of the members of the occupational advisory committee shall be employees and employers in the occupation for which the career and technical education program is provided. Each occupational advisory committee shall meet at least twice each year to:

(1) advise the board of directors, administrators and staff on curriculum, equipment, instructional materials, safety requirements, program evaluation and other related matters; and

(2) verify that the programs meet industry standards and, if appropriate, licensing board criteria, and that the programs prepare students with occupation-related competencies.

(c) Notwithstanding subsection (b), to increase employer participation in an occupational advisory committee required under this section, the boards of directors of multiple area vocational-technical schools or school districts operating career and technical education programs may agree to establish a shared occupational advisory committee to serve all agreeing area vocational-technical schools or school districts, provided that all agreeing area vocational-technical schools or school districts are located within the same intermediate unit. If a shared occupational advisory committee is formed under this subsection, the occupational advisory committee shall be designed to

provide equal opportunities for all agreeing area vocational-technical schools or school districts to participate, including scheduling meetings at each area vocational-technical school or school district on a rotating basis.

Section 2.2. The act is amended by adding sections to read:  
Section 1842.1. PAsmart Online Career Resource Center.—(a)

The Department of Education and the Department of Labor and Industry, in consultation with the Department of Agriculture, shall establish a central online clearinghouse to be made available on a publicly accessible Internet website maintained by the Department of Labor and Industry. The website, which shall be available no later than the commencement of the 2021-2022 school year, shall at a minimum include an online database of the following:

- (1) Postsecondary pathways and options.
- (2) Career and technical education and workforce opportunities.
- (3) Career pathways.
- (4) Data and statistics on employment opportunities and compensation.

- (5) Statewide and regional articulation agreements.
- (6) Other relevant career resources.

(b) The online database shall be easily accessible by students, parents, educators, school officials and the public. Participating State agencies may utilize existing resources or clearinghouses available from other agencies to compile the clearinghouse information.

(c) Participating State agencies shall explore the possibility of Federal or private funding to support the clearinghouse.

(d) The Department of Labor and Industry, in cooperation with the Department of Education and the Department of Agriculture, shall ensure that the clearinghouse is updated annually.

Section 1842.2. Workforce Development Program

Clearinghouse.—(a) The Pennsylvania Workforce Development Board shall, with assistance from the Department of Education, conduct a survey to determine the number and types of workforce development programs offered at secondary and postsecondary institutions. The Pennsylvania Workforce Development Board may, in consultation with the Department of Education, compile a clearinghouse of model programs discovered during the survey.

(b) The Department of Education and the Department of Labor and Industry shall encourage the use of the model programs, which may include prioritizing available grant funding for applicants seeking funds to establish workforce development programs which are modeled after the programs included in the survey, by secondary career and technical education programs, postsecondary programs and business and industry to:

- (1) expand existing programs into areas of this Commonwealth where there is a need; and
- (2) foster business-education partnerships.

(c) The Pennsylvania Workforce Development Board shall report its findings and actions under this section to the chairman and minority chairman of the Appropriations Committee of the Senate, the chairman and minority chairman of the Appropriations Committee of the House of Representatives, the chairman and minority chairman of the Education Committee of the Senate and the chairman and minority chairman of the Education Committee of the House of Representatives, no later than one year after the effective date of this section.

#### ARTICLE XVIII-A

#### SCHOOLS-TO-WORK PROGRAM

Section 1801-A. Scope of article.

This article relates to the Schools-to-Work Program.

Section 1802-A. Definitions.

The following words and phrases when used in this article shall have the meanings given to them in this section unless the context clearly indicates otherwise:

"Department." The Department of Labor and Industry of the

Commonwealth.

"Program." The Schools-to-Work Program established under section 1803-A.

"School." A school in a school district, charter school, regional charter school, cyber charter school, intermediate unit or career and technical school in this Commonwealth.

"Sponsor." An entity which is or will be registered with the department as a pre-apprenticeship program and which will have the full responsibility for the administration and operation of the program. Section 1803-A. Schools-to-Work Program.

(a) Establishment.—The department shall, in consultation with the Department of Education, establish a Schools-to-Work Program to award grants on a competitive basis to support the establishment or enhancement of workforce development partnerships between schools, employers, organizations or associations to create employment and training pathways.

(b) Grant proposals.—In order to apply for a grant under the program, a sponsor must submit a grant proposal to the department that includes all of the following:

(1) Partnership with at least one school.

(2) Learning opportunities for participating students, including classroom training, workplace visits, internships, apprenticeships, mentorships, employment opportunities, special education transition, Capstone Cooperative Education, job shadowing or externships.

(3) Identification of the qualifications and certifications necessary to fill current and anticipated regional labor market needs.

(4) Description of outcomes from the successful completion of the program, which may include the attainment of industry-recognized qualifications and certifications or college credits, and an explanation of how college credits earned will be transcribed and transferrable.

(5) Pathways for transition to a registered apprenticeship program, post-secondary education program or employment.

(6) Demonstration of existing qualified program personnel, or identification of additional personnel needed, if any, to establish or increase program capacity to meet or contribute toward meeting current and anticipated regional labor market needs.

(7) Description of program curricula.

(8) A program budget, including the amount of grant money being requested and any additional financial resources being used for the program.

(c) Priority of applications.—The department shall give priority to proposals that:

(1) Demonstrate a strong need to build new or existing program capacity to meet or contribute toward meeting current and anticipated regional labor market needs.

(2) Incorporate students from grades nine through twelve.

(3) Prioritize program completion and transition to post-secondary training, education or employment.

(4) Involve a partnership between multiple schools or school districts, employers, organizations or associations.

(5) Demonstrate sustainability by leveraging additional financial or personnel resources that will be used for the program.

(d) Grant distribution.—The department shall, in consultation with the Department of Education, award grants under the program. The department shall consider geographic diversity when selecting grant recipients.

(e) Limitation.—Grant money may be used only for the purposes stated in the grant proposal. Any remaining grant money not used for the program shall be returned to the department.

Section 1804-A. Reporting requirements.

(a) Reports to the department.—A grant recipient shall be required to report to the department annually data related to a program,

including all of the following:

(1) The number of students who entered the program, successfully completed the program or earned industry-recognized qualifications, certifications or college credits, including descriptions and totals of each credential.

(2) The number of students who transitioned to post-secondary training, education or employment.

(3) Other data deemed relevant or necessary by the department in consultation with the Department of Education.

(b) Annual reporting.—The department shall provide an initial report to the General Assembly within two years of commencement of the program and a report each year thereafter that the program is in effect.

Section 1805-A. Notice of funding.

Upon the initial appropriation of sufficient money to carry out the provisions of this article or a determination by the department that sufficient money is available from existing sources to carry out the provisions of this article, the department shall transmit notice that the program will be implemented with available funds to the Legislative Reference Bureau for publication in the Pennsylvania Bulletin.

Section 1806-A. Expiration.

This article shall expire June 30, 2024, or five years after the effective date of this article, whichever is later.

On November 30, 2016, the Select Subcommittee on Technical Education and Career Readiness issued their final report after 2 years of hearings. That report was guided by the committee and my cochair, Pat Harkins, from Erie County. The select committee was created pursuant to HR 102 of 2015, authored by then chairmen of the Education Committee, Representative/Chairman Stan Saylor and Chairman Roebuck.

These bills have been authored as part of that package as a bipartisan way to restart our career and tech education committee. This is a great start for ensuring we start matching individuals with the jobs of tomorrow. This is bipartisan work. I applaud this body for standing firm on its commitment to make sure these bills are done in a bipartisan fashion and urge my colleagues to vote for the amendment and the underlying bill to make sure we start reinvigorating our career and technical education here in the Commonwealth.

The SPEAKER. Representative Craig Staats, the prime sponsor of the bill, on the amendment, sir.

Mr. STAATS. Thank you, Mr. Speaker.

As we just heard from the Democratic leader and Representative Grove, the House Education Committee has been working on this package of career and technical education bills for two sessions; moving them forward as such makes perfect sense. This is an agreed-to amendment, and I would respectfully ask for an affirmative vote.

Mr. Speaker, over the years we have all heard from many students who have spent time and money on courses and programs only to discover these programs do not always transfer to other institutions in our Commonwealth. Mr. Speaker, all of us are pleased that the Pennsylvania Department of Education already has an electronic database to show the articulation agreements made between our community colleges and the institutions that are part of the Pennsylvania State System of Higher Education, but more can be done.

This House bill is a great asset to all of our students in Pennsylvania by showing all the other articulation agreements that exist beyond those currently on the database and portal. By expanding the database, students and potential students can plan around the courses, programs, and certificates, Mr. Speaker, that would transfer among public schools and institutions of higher learning in our Commonwealth. HB 265 requires all public schools, vocational-technical schools, charter schools, and cyber schools to submit their articulation agreements to the Department of Education so those agreements can be appropriately entered into the comprehensive database. This information would then be posted into a meaningful, user-friendly, and interactive search engine that is available to the public.

It is time to upgrade our system, Mr. Speaker, and it is time to pass HB 265. Thank you.

An Act amending the act of April 9, 1929 (P.L.177, No.175), known as The Administrative Code of 1929, in administrative organization, repealing provisions relating to employees with access to Federal tax information and providing for criminal history background checks of employees and contractors with access to Federal tax information; in organization of independent administrative boards and commissions, providing for Center for Rural Pennsylvania; in Office of State Inspector General, further providing for powers, purpose and duties and for criminal charges; in Commonwealth budget procedures, further providing for submission of budget to General Assembly; in Commonwealth agency fees, further providing for Department of State; in Independent Fiscal Office, further providing for revenue estimates; providing for Joint Underwriting Association accountability; in powers and duties of the Department of Labor and Industry, its departmental administrative and advisory boards and departmental administrative officers, providing for Bureau of Occupational and Industrial Safety; providing for legislative agencies and the continuation of Pennsylvania Commission on Sentencing; and making editorial changes and related repeals.

#### **HB 1614, PN 2214**

An Act amending Titles 18 (Crimes and Offenses) and 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, in firearms and other dangerous articles, further providing for persons not to possess, use, manufacture, control, sell or transfer firearms and for sale or transfer of firearms; and, in commencement of proceedings, further providing for Statewide municipal police jurisdiction, for nonmunicipal police extraterritorial jurisdiction and for agents of the Office of Attorney General and providing for interpretation.

#### **SB 144, PN 1078**

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in preliminary provisions, further providing for definitions; in school directors, further providing for school director training programs; in intermediate units, providing for school safety and security enhancements; in certification of teachers, further providing for continuing professional development, providing for trauma-informed education and further providing for postbaccalaureate certification and for Pennsylvania school leadership standards; in safe schools, further providing for Office for Safe Schools; in school safety and security, further providing for definitions, for School Safety and Security Committee, for survey of school safety and security, for School Safety and Security Grant Program, for Risk and Vulnerability Assessment Teams, for school safety and security coordinator and for school safety and security training and providing for trauma-informed approach; in Safe2Say Program, further providing for

judicial proceeding and for annual report; providing for threat assessment; in school health services, further providing for confidentiality, transference and removal of health records; in early learning programs, further providing for duties of department; providing for the Keystone Telepresence Education Grant Program; in the State Board of Education, further providing for powers and duties of the board and for powers and duties of Council of Basic Education and Council of Higher Education; and providing for references to area career and technical school in statute and regulation.
