#### PRAYER

The SPEAKER. The prayer today will be offered by Capt. Glen Wood, who is the Region Mid-Atlantic Force Chaplain for the United States Navy.

Captain Wood is a native of Red Bluff, California; attended Bethany University in Santa Cruz; received his B.A. (bachelor of arts) in 1989. While in seminary, at Austin Presbyterian Theological Seminary, graduating with his master's in divinity in 1994, he joined the Navy Chaplain Candidate Officer Program.

In July 2012 Chaplain Wood reported to Naval Station Norfolk as the command chaplain. Upon his becoming a captain, he moved back to Okinawa as the Marine Corps Installation Pacific Command Chaplain responsible for the Religious Ministries Program throughout the Asia Pacific. And in 2016 he returned to Norfolk as the Region Mid-Atlantic Force Chaplain.

His personal awards include the Meritorious Service Medal with four gold stars, the Navy Commendation Medal with one gold star, and the Navy Marine Corps Achievement Medal with two gold stars.

The SPEAKER. Representative Ryan, if you will please come up here.

And Representative Ryan, as many of you know, is a Marine, a colonel, and the Chair is going to turn it over to him at this time with respect to HRs 269 and 270. Thank you, sir.

Mr. RYAN. Thank you, Mr. Speaker.

Mr. Speaker, if I could be indulged, please. If I could ask members who are United States Marines, if they would join us in the well of the House while we honor them, and also for Representative Patty Kim and Representative Dawn Keefer, if they could as well to honor our two fallen Marines.

First, I would like to just introduce our Marines that we have with us. Representative Jones and Representative Saylor will introduce the families. I am honored today that we have with us Lt. Col. Raymond Hedger, who was my commanding officer at Echo Company, 2d Battalion, 25th Marines; and joining with us today from Echo Company, 2d Battalion, 25th Marines, are Gunnery Sgt. Mike Hornack and S. Sgt. Markus Cade.

The SPEAKER. Please rise.

Mr. RYAN. Mr. Speaker and members, I truly thank you for allowing us to speak today.

To the families of Staff Sergeant Hines and Staff Sergeant Slutman, I cannot tell you, it is our deepest sympathies and condolences for your loss. We had a chance to meet earlier today, and they all have a tremendous sense of humor. They did ask me if I would enlist everyone from this chamber in the Marine Corps, so we will be doing that at the end. Is that still okay with the families?

Your family has paid the ultimate sacrifice in the defense of this nation. When you realize the sacrifice, the family members who are remaining have paid that ultimate sacrifice as well. We are members of a Marine Corps family, and those sitting in the well of the House are joined by so many people who have understood the value and the honor and the tradition of the Eagle, Globe, and Anchor of the United States Marine Corps. We are taught selfless sacrifice. We are taught to recognize that there is no greater love that one hath than to lay down your life for a friend, and Staff Sergeant Hines and Staff Sergeant Slutman have both done that.

With the tragic loss of their loved ones that we are going to honor today, the term "Marine" should remind you forever that they are our family. I was talking with Wendy and Anna today, and they were making a comment that the Marine Corps has been there, and I would say that is true of every branch of service that I have been with.

When we go through the Crucible in the Marine Corps, it is the day that we receive that Eagle, Globe, and Anchor, and that Crucible is something that tells us the significance of what it means to be a Marine, to honor the Constitution. Our Marine Corps Hymn says it all. It says that we Marines, when we go to heaven, are guarding heaven's gates, and I can assure the Slutman and Hines families that you will be meeting them again as we all will be.

I ask you from the bottom of my heart that Staff Sergeant Slutman and Staff Sergeant Hines fought for our freedoms. I am very familiar with the road where they lost their lives. Please let us use this condolence resolution to recognize the freedoms that they died for for us. Remember the sacrifices of these two Marines, but more importantly, their families, that we have a responsibility forever, as we feel in the Marine Corps, to honor them as our brothers and sisters.

No amount of sacrifice can ever compare to being a Gold Star parent or a Gold Star wife or fiancée, and it is a tribute that we are honored today to have them both with us.

And so on behalf of the Marines, I am going to just say semper fi.

(Rendering of Salute.)

Mr. RYAN. And I would ask, if we could, for Chairman Saylor for remarks.

The SPEAKER. What we are going to do at this time – and we are going to let the good folks here take their seats. Thank you so much. And we are going to be hearing some of the personal information with respect to these two fallen Marines. And, Chairman Saylor, you will be first, and I believe, Representative Jones, you will be speaking as well? You can please come up here at this time.

Chairman Saylor. Thank you, sir.

Mr. SAYLOR. Mr. Speaker, I rise today on this solemn occasion to thank the family of Sgt. Christopher Slutman for them being here today to honor their son's sacrifice to our country.

I am often at a loss for words on occasions like this. It is hard to encapsulate the essence of a soldier in a speech, and we know that no words we speak today truly can thank Sergeant Slutman and his family for their sacrifice, for what they have done for all us in the freedom of this nation.

Sergeant Slutman was a graduate of Dallastown Area High School, and his parents, Fletcher and Mary, who today are here with us with the picture of their son, live in York County.

And it is hard to find individuals with so much courage as Sergeant Slutman had demonstrated throughout his life on a daily basis. Sergeant Slutman's life was defined by service. He bravely served our country in Afghanistan, and he also served the people of New York City as a firefighter. Christopher Slutman was a 15-year veteran for the Fire Department of New York City. He was a decorated firefighter, having received the Chiefs Association memorial award and medal in 2014 for rescuing a woman from a burning apartment. It is often said that firefighters display their bravery by running into situations that others run away from. It is a testament to Christopher that not only did he take up this honorable profession but that he also joined the Marines to serve his country.

In an article I read about Chris, one of his former colleagues from the Kentland Volunteer Fire Company said, "Our job already is pretty dangerous, so for anybody to take on kind of a second career that would be as dangerous, or even more, is slightly mind-boggling. But that's the kind of person Chris was. He didn't shy away from anything like that." I think that sums up the bravery of Sergeant Slutman and how he displayed his bravery every day in New York City and in defending our country and our freedoms in Afghanistan.

And on behalf of the Pennsylvania House of Representatives, I wish to express our sincere condolences to Sergeant Slutman's wife, Shannon; his three daughters, McKenna, Kenley, and Weslynn; and his parents, Fletcher and Mary Slutman, on the loss of their husband, their father, and a son. God bless you.

The SPEAKER. Representative Mike Jones.

Mr. JONES. Likewise, I would like to express condolences to the family of Sgt. Benjamin Hines, who also is a graduate of Dallastown. We just dedicated a bridge 2 weeks ago to another fallen Marine from Dallastown, Sgt. Chris Wrinkle, and we have had others killed in action from Dallastown. So it is particularly heart-wrenching, it really hits home when it is not only my home school district but our own son just graduated and is serving in the Army as we speak. And so we are here to honor Ben, who was a Dallastown graduate, he was a football player, served bravely in Afghanistan.

And his fiancée, Anna, whom I had the pleasure to meet, Anna Steg, is with us, and they would have been married just over a week ago on October 12. His mother, Wendy Hines, is here.

And I think in moments like this and really for our veterans in general for a guy like myself who has not served in the military, I think all we can really just say is thank you and our deepest condolences for your loss. Thank you so much for Ben and for his sacrifice.

This chapter relates to member and employee training and official oversight (ME TOO) for legislative agencies.

§ 2102. Legislative intent.

This chapter is intended to:

(1) Protect employees of legislative agencies from sexual harassment.

(2) Provide for the investigation and resolution of complaints involving sexual harassment of employees of legislative agencies.

(3) Provide for programs of sexual harassment prevention and response training in employment.

§ 2103. Definitions.

The following words and phrases when used in this chapter shall have the meanings given to them in this section unless the context clearly indicates otherwise:

"Caucus." The Democratic or Republican Caucus of the Senate or House of Representatives.

"Complaint." A written report of a violation of section 2104 (relating to prohibition) or 2105 (relating to retaliation) filed by an employee under section 2114 (relating to complaint and hearing) and the policies and procedures established by the office.

"Director." The director of the office.

"Elected official." A member of the Senate or House of Representatives.

"Employee." The following:

(1) An employee of a legislative agency.

(2) An officer of the Senate or House of Representatives.

(3) A paid or unpaid intern of a legislative agency.

"Legislative agency" or "employer." Any of the following:

(1) Subject to paragraph (15), the Senate.

(2) Subject to paragraph (15), the House of

Representatives.

(3) The Capitol Preservation Committee.

(4) The Center for Rural Pennsylvania.

(5) The Joint Legislative Air and Water Pollution

Control and Conservation Committee.

(6) The Joint State Government Commission.

(7) The Legislative Budget and Finance Committee.

(8) The Legislative Data Processing Committee.

(9) The Independent Regulatory Review Commission.

(10) The Legislative Reference Bureau.

(11) The Local Government Commission.

(12) The Pennsylvania Commission on Sentencing.

(13) The Legislative Reapportionment Commission.

(14) The Legislative Audit Advisory Commission.

(15) With respect to an employee of the Senate or House of Representatives other than an employee of an officer of the

Senate or House of Representatives, the caucus with control or supervision of the employee's job responsibilities.

(16) The Office of Compliance established in Subchapter B (relating to Office of Compliance).

(17) The office of an officer of the Senate or House of Representatives.

(18) Another office, agency, board or commission under the control or supervision of the Senate or House of Representatives.

"Office." The Office of Compliance established in Subchapter B. "Party." The employee filing a complaint or the employee or elected official who is the subject of a complaint, as the context shall require.

"Selection committee." The selection committee established in section 2111(b) (relating to Office of Compliance).

"Sexual harassment." Unwelcome sexual advances, requests for sexual favors and other conduct of a sexual nature.

§ 2104. Prohibition.

The following conduct is prohibited:

(1) Using the submission to or rejection by an employee of conduct constituting sexual harassment as a basis for an employment decision affecting the employee.

(2) Making submission to conduct constituting sexual harassment, either explicitly or implicitly, a term or condition of an employee's employment.

(3) Engaging in conduct constituting sexual harassment that unreasonably alters an individual's terms, conditions or privileges of employment, including conduct that is so frequent or severe that it creates a hostile, offensive or intimidating work environment.

§ 2105. Retaliation.

No adverse action may be taken against an employee, other than an employee who is the subject of a complaint or against whom a civil action has been filed, who does any of the following:

(1) files a complaint under section 2114 (relating to complaint and hearing) or a civil action under section 2113 (relating to initiation of proceedings);

(2) participates in proceedings resulting from the filing of a complaint or civil action;

(3) participates in an investigation conducted under section 2114(b); or

(4) discloses, reports or opposes sexual harassment that constitutes a violation of section 2104 (relating to prohibition).

SUBCHAPTER BOFFICE OF COMPLIANCESec.2111. Office of Compliance.2112. Duties.2113. Initiation of proceedings.2114. Complaint and hearing.2115. Judicial review.§ 2111. Office of Compliance.

(a) Establishment.—The Office of Compliance is established as an independent office within the legislative branch of the Commonwealth. The office shall be charged with receiving, investigating and resolving complaints.

(b) Selection committee.—The selection committee is established to appoint a director after conducting a search and interviewing applicants for the position and to exercise other authority provided under this chapter. The selection committee shall consist of one member from each of the four caucuses, to be appointed by:

(1) the Majority Leader and the Minority Leader of the Senate; and

(2) the Majority Leader and the Minority Leader of the House of Representatives.

(c) Director.—

(1) The office shall be headed by a director appointed by the selection committee. The appointment shall be made without

regard to political affiliation and solely on the basis of fitness to perform the duties of director. The director must have training or experience in the application of rights, protections and remedies relating to sexual harassment that constitutes a violation of section 2104 (relating to prohibition).

(2) No individual who is registered as a lobbyist under 65 Pa.C.S. Ch. 13A (relating to lobbying disclosure) or who is an employee at the time of submission of an application for appointment may be eligible for appointment as director.

(3) The compensation of the director shall be set by the selection committee.

(4) The director may not engage in outside employment while serving as director, unless the outside employment is approved in writing by the selection committee.

(d) Term of director.—

(1) The term of office of the director shall be six years. An individual appointed as director to fill a vacancy prior to the expiration of a term shall serve only for the unexpired portion of the term.

(2) An individual who serves as director at the expiration of a term may continue to serve until a successor is appointed by the selection committee.

(3) The director may be removed for cause by a concurrent resolution passed by the Senate and the House of Representatives.

(e) Staff.—

(1) The director shall hire attorneys, individuals to serve as hearing officers, investigators and other staff as the director deems necessary to carry out the duties of the office. Staff shall be hired without regard to political affiliation. The director shall use best efforts to assure that individuals being considered for hire by the office are not biased and do not have a conflict of interest or potential conflict of interest with any individual covered by this chapter. Individuals hired to serve as hearing officers shall be licensed to practice law in this Commonwealth.

(2) Staff of the office shall be compensated at a rate to be determined by the director.

(3) Staff who are designated under section 2112(3) (relating to duties) must have training or experience in the application of rights, protections and remedies relating to sexual harassment that constitutes a violation of section 2104.

#### § 2112. Duties.

The office shall perform the following duties:

(1) Establish and implement policies and procedures for reporting, investigating and resolving complaints not inconsistent with this chapter. The policies and procedures shall include a separate process for complaints filed about an employee of the office, including the director, and shall be posted on the office's publicly accessible Internet website.

(2) Develop and implement the training programs under Subchapter D (relating to prevention and response training).

(3) Prepare and distribute for posting in each legislative agency information regarding how to access the policies and procedures posted under paragraph (1), the availability of the assistance of an attorney or reimbursement for counseling under Subchapter C (relating to administrative provisions) and the names and contact information of the staff in the office with whom employees should be in contact under section 2113(a) (relating to initiation of proceedings) or with whom employees should file a complaint.

(4) Develop and maintain a master list of individuals licensed to practice law in this Commonwealth who are experienced in adjudicating or arbitrating complaints of sexual harassment that constitute a violation of section 2104 (relating to prohibition) to serve as hearing officers under section 2114. The individuals on the list developed and maintained under this paragraph shall supplement individuals hired under section 2111(e)(1) (relating to Office of Compliance) to serve as hearing

officers.

#### § 2113. Initiation of proceedings.

(a) Initial contact.—An employee may contact an individual designated under 2112(3) (relating to duties) for assistance in determining the employee's rights under this chapter and other Federal, State or local law.

(b) Privacy protections.—The individual who is contacted by an employee under subsection (a) may not disclose or acknowledge to any other person any information relating to the initial contact, except when the disclosure or acknowledgment pertains to any of the following:

(1) communicating with staff of the office for purposes of assistance in determining the employee's rights;

(2) consulting with a law enforcement official or agency for the purpose of initiating with the consent of the employee, participating in or responding to an investigation or prosecution by the law enforcement official or agency; or

(3) such other exceptions as the office by regulation may direct.

(c) Filing of complaint or action.—

(1) An employee may file a complaint under section 2114 (relating to complaint and hearing) or a civil action in Commonwealth Court in its original jurisdiction without exhausting administrative remedies available under this chapter.

(2) Nothing in this chapter shall be construed to prohibit an employee from speaking to law enforcement about alleged criminal conduct.

#### § 2114. Complaint and hearing.

(a) Filing of complaint.—An employee may file a complaint with the office. The director shall send a letter setting forth each allegation in the complaint to the following:

(1) The subject of the complaint.

(2) The employer of the subject of the complaint if the subject is an employee.

(3) The elected official's caucus if the subject of the complaint is an elected official.

(b) Investigation.—Upon receipt of the complaint, the director shall assign an investigator to investigate the allegations in the complaint. The investigator shall be authorized to conduct such interviews and review such materials as the investigator deems appropriate, shall prepare a written report of the investigator's findings, and shall provide a copy of the report to the director.

(c) Determination.—Upon review of the report received under subsection (b), the director shall make a determination as to whether or not the findings of the investigator contained in the report support a determination that the complaint states a claim under this chapter. The following shall apply:

(1) If the director determines that the complaint does not state a claim under this chapter, the director shall dismiss the complaint and shall notify the parties in writing of the dismissal.

(2) If the director determines that the complaint states a claim under this chapter, the director shall appoint a hearing officer to consider the complaint, conduct a hearing and render a decision. Staff of the office not involved in the investigation of the complaint may assist the hearing officer.

(d) Hearing.—Unless a complaint is dismissed under subsection (c), a hearing shall be:

(1) Commenced no later than 60 days after the completion of the investigation under subsection (b), except that the office may, for good cause, extend the time for conducting the hearing for up to an additional 30 days.

(2) Conducted in closed session by the hearing officer.

(e) Discovery and attorneys.—

(1) Depositions of witnesses may be taken in the manner prescribed by law of this Commonwealth other than this chapter for the taking of a deposition in a civil action.

(2) Reasonable prehearing discovery may be permitted at the discretion of the hearing officer. Discovery may include access to the investigator's report.

(3) A party may be represented in the hearing by an attorney and may have one additional individual attend the hearing for support.

(f) Subpoenas.—

(1) At the request of a party, the hearing officer may issue subpoenas for the attendance of witnesses and for the production of books, papers, records, accounts, reports, documents and data and information produced and stored by any electronic data processing system as the hearing officer deems necessary.

(2) A person who willfully neglects or refuses to respond to a subpoena issued under this section shall be subject to the penalties provided by law of this Commonwealth other than this chapter in that case.

(3) The hearing officer shall have the power to administer oaths and affirmations to witnesses.

(4) If a person refuses, on the basis of relevance, privilege or other objection, to testify in response to a question or to produce records in connection with a proceeding before a hearing officer, the hearing officer shall rule on the objection.

(g) Burden and standard of proof.—The employee filing the complaint shall have the burden of proving, by a preponderance of the evidence, that a violation of section 2104 (relating to prohibition) or 2105 (relating to retaliation) has occurred.

(h) Confidentiality.—

(1) Except as otherwise provided in this chapter and as may be required by legal process in connection with an appeal of the hearing officer's decision under section 2115 (relating to judicial review):

(i) the complaint and the contents of the complaint, filings by the parties and evidence produced, including investigative reports, in connection with a complaint filed or hearing held under this section shall be confidential; and

(ii) no evidence or testimony taken in a closed session may be released to any person.

(2) The final decision of the hearing officer shall not be confidential, except that at the request of the employee who filed the complaint, the name of the employee and any facts that may lead to the identification of the employee shall be redacted before the decision is issued.

(i) Decision.—

(1) The hearing officer shall issue a final decision in writing as expeditiously as possible, but in no case more than 90 days after the conclusion of the hearing.

(2) The final decision shall be served by the office on the parties and the employer or caucus that received the letter under subsection (a).

(j) Procedure.—

(1) Except as may be provided under this chapter, the procedures described in this section shall be subject to the practices and procedures contained in 2 Pa.C.S. Ch 5 Subch. A (relating to practice and procedure of Commonwealth agencies), except for 2 Pa.C.S. § 508 (relating to notice to Department of Justice).

(2) The office shall promulgate regulations to implement the provisions of this section. In order to facilitate the prompt implementation of this section, the office may promulgate temporary regulations that shall expire not later than two years following the publication of the temporary regulation. The promulgation of temporary regulations under this paragraph shall not be subject to:

(i) Sections 201, 202, 203, 204 and 205 of the act of July 31, 1968 (P.L.769, No.240), referred to as the Commonwealth Documents Law.

(ii) The act of June 25, 1982 (P.L.633, No.181), known as the Regulatory Review Act.

(iii) Sections 204(b) and 301(10) of the act of

October 15, 1980 (P.L.950, No.164), known as the Commonwealth Attorneys Act.

(3) The office's authority to adopt temporary regulations under paragraph (2) shall expire two years after the effective date of this section. Regulations adopted after this period shall be promulgated as provided by law.

§ 2115. Judicial review.

(a) Appeal.—A party aggrieved by a decision of a hearing officer under section 2114 (relating to complaint and hearing) may file a petition for review of the decision in Commonwealth Court, which shall have appellate jurisdiction over the petition.

(b) Standard of review.—The court shall set aside a decision of a hearing officer if the court determines that the decision of the hearing officer was:

(1) arbitrary, capricious, an abuse of discretion or otherwise not consistent with law;

(2) inconsistent with required procedures; or

(3) unsupported by substantial evidence.

§ 2121. Legal assistance.

(a) Option.—

(1) Either an employee who files a complaint or the subject of the complaint may engage an attorney of the employee or subject's choosing to provide legal assistance and advice to the employee or subject in connection with proceedings initiated under this chapter.

(2) If requested by an individual engaging an attorney under paragraph (1), the office shall pay for the reasonable cost of the attorney.

(3) This section shall not apply to an attorney engaged by a party in connection with a civil action filed under section 2113(c) (relating to initiation of proceedings).

(b) Approval.—

(1) An individual who intends to engage an attorney under subsection (a) to be paid for by the office must provide to the director the name of the attorney to be engaged and the name of the attorney's law firm if applicable, and the proposed hourly rate to be charged. The hourly rate shall be subject to the approval of the director.

(2) The director shall approve an hourly rate that is reasonable for the work to be performed and reflects market rates in the location where the attorney practices.

(c) Contract.—

(1) If approval under subsection (b)(2) has been received, the individual engaging the attorney or law firm must enter into a written contract with the attorney or law firm.

(2) Invoices for payment under the contract shall be provided directly to the individual who engaged the attorney or law firm who shall review and approve them for payment by the office. The individual shall provide the office with a written request for payment that only reflects the invoice amount to be paid.

§ 2122. Counseling.

An employee filing a complaint may seek reimbursement from the office for the cost that is not reimbursed by insurance of any counseling sought by the employee from a professional therapist trained in psychological issues arising out of subjection by the employee to sexual harassment constituting a violation of section 2104

(relating to prohibition).

§ 2123. Nondisclosure agreements.

(a) Involuntary agreements.—A nondisclosure agreement or provision may not be imposed on an employee as a condition of the initiation of any of the procedures or assistance available under this chapter.

(b) Voluntary agreements.—Nothing in subsection (a) shall be construed to prohibit the parties to any procedure available under this chapter from voluntarily entering into a settlement agreement with a nondisclosure provision agreed to by each party as part of the settlement of a complaint or a civil action.

(c) Elected officials.—Notwithstanding the provisions of subsection (b), an elected official who is the subject of a complaint shall not benefit from a nondisclosure agreement or provision under subsection (b) if the settlement agreement requires the payment of money to or for the benefit of the employee who filed the complaint from the funds of an entity described in section 2125(a)(1) (relating to settlements and awards). For a settlement agreement under this subsection, at the request of the employee who filed the complaint, any facts that may lead to the identification of the employee shall be redacted.

§ 2124. Workplace adjustments.

(a) General rule.—The employer of an employee filing a complaint shall, upon the request of the employee filing the complaint, make adjustments to the employee's work hours and location that may be appropriate under the circumstances.

(b) Forms of adjustments.—The adjustments may include:

(1) removing the employee filing the complaint or the subject of the complaint from the physical work location of the employee filing the complaint; or

(2) allowing the employee filing the complaint to be placed on administrative leave with continued pay and benefits, if applicable.

§ 2125. Settlements and awards.

(a) Settlements.—The parties may enter into a settlement agreement at any time during the proceedings authorized under this chapter with terms as may be agreed to by the parties. The following shall apply:

(1) If the agreement requires the payment of money to or for the benefit of the employee filing a complaint, the following must be a party to the agreement unless the subject of the complaint has agreed to pay the money from the subject's personal funds:

(i) The employer of the subject of the complaint if the subject is an employee.

(ii) The elected official's caucus if the subject of the complaint is an elected official.

(2) If the agreement requires the payment of money to or for the benefit of the employee who filed the complaint from a source other than the personal funds of the subject of the complaint, the payment shall be made by the party to the agreement under paragraph (1).

(b) Awards.—If the decision of a hearing officer under section 2114 (relating to complaint and hearing) includes an order requiring the payment of money to or for the benefit of the employee filing the complaint, the payment shall be made by one of the following unless the subject of the complaint has agreed to pay the money from the subject's personal funds:

(1) The employer of the subject of the complaint if the subject is an employee.

(2) The elected official's caucus if the subject of the complaint is an elected official.

(c) Personal liability of elected official.—If a payment is made by a legislative agency under subsection (a) or (b) resulting from a complaint filed about an elected official, the elected official shall reimburse the legislative agency for the amount of the payment and shall reimburse the office for any legal fees paid by the office on behalf of the elected official under section 2121 (relating to legal assistance)

if:

(1) the hearing officer's decision finds that a violation of section 2104 (relating to prohibition) or 2105 (relating to retaliation) occurred;

(2) the subject of the complaint admits that a violation of section 2104 or 2105 occurred; or

(3) a civil action filed under section 2113(c) (relating to initiation of proceedings) results in the finding of a violation of section 2104 or 2105.

§ 2126. Right-to-Know Law.

(a) Legislative agency.—For purposes of the act of February 14, 2008 (P.L.6, No.3), known as the Right-to-Know Law, the office shall be considered a legislative agency as defined under section 102 of the Right-to-Know Law and shall provide legislative records in accordance with the Right-to-Know Law, except as otherwise provided in this section.

(b) Final decision.—The final decision of the hearing officer under section 2114 (relating to complaint and hearing) shall be publicly available from the office in response to a request submitted under the Right-to-Know Law. If the decision was redacted under section 2114(h)(2) (relating to complaint and hearing), the redacted version shall be provided to the requester.

(c) Redaction.—At the request of the employee who filed a complaint, the office shall redact the name of the employee and any facts that may lead to the identification of the employee from a record provided in accordance with the Right-to-Know Law.

§ 2127. Reports.

(a) Legislative agencies.—Not later than 60 days after the end of each calendar year, each legislative agency shall publish on its publicly accessible Internet website a report identifying the amount of each award or settlement paid by the legislative agency during the previous year under section 2125 (relating to settlements and awards).

(b) Office.—Not later than 180 days after the effective date of this section and every two years thereafter, the office shall submit a report to the General Assembly that includes the following information for the reporting period:

(1) The number of complaints filed by employees with the office and the type of behavior reported.

(2) Whether the complaints were filed about employees or elected officials.

(3) The average length of time to resolve a complaint.

(4) The number of settlement agreements entered into by the parties.

(5) The number of settlement agreements with nondisclosure provisions.

(6) The total amount of awards or settlements paid to or for the benefit of employees.

(7) The number and types of remedial actions taken as a result of the filing of complaints.

(8) How many employees filing complaints remained employed by the legislative agency following resolution of the complaint.

§ 2128. Safe harbor.

(a) Employees.—The rights, protections and benefits afforded employees by this chapter shall be deemed to supplement, and be in addition to, any right, protection or benefit afforded by any other Federal, State or local law.

(b) Employers.—Notwithstanding subsection (a), an employer shall not be required to establish and maintain separate policies and procedures for the reporting of or response to a complaint alleging the violation of section 2104 (relating to prohibition) or 2105 (relating to retaliation) provided the employer cooperates with the office and otherwise complies with the employer's obligations under this chapter.

SUBCHAPTER D

PREVENTION AND RESPONSE TRAINING

2131. Development of training programs.

2132. Schedule.

§ 2131. Development of training programs.

(a) Duty of office and attendance.—The office shall develop training programs concerning the prevention of and response to sexual harassment that constitutes a violation of section 2104 (relating to prohibition) and conduct that constitutes a violation of section 2105 (relating to retaliation). All employees and elected officials shall attend the training programs.

(b) Contents of training programs.—

(1) The training programs shall be based on the principles of effective prevention and best practices in consultation with a Statewide rape crisis center or other organization with experience in counseling, training and addressing issues of sexual harassment that constitute a violation of section 2104.

(2) The training program for employees and elected officials shall include at least the following elements:

(i) Bystander intervention and other strategies that are found to be effective in workplace prevention.

(ii) The elements of the conduct prohibited under sections 2104 and 2105 and examples of the conduct.

(iii) The effects of sexual harassment constituting a violation of section 2104 on victims and the workplace at large.

(iv) Examples of barriers to reporting incidences of violations of sections 2104 and 2105.

(v) The consequences of being found to be in violation of section 2104 or 2105 or found to be in violation of Federal law prohibiting sexual harassment or retaliation.

(vi) A description of the policies and procedures developed by the office under section 2112(1) (relating to duties), the procedures for contacting the office and filing a complaint and the option for filing a civil action.

(vii) Referrals and resources, including rape crisis centers and other counseling services, attorneys, the United States Equal Employment Opportunity Commission and other similar Federal and State agencies.

(3) The additional training program for employees of the office shall include at least the following elements:

(i) The receipt of disclosure of incidences of sexual harassment, including confidentiality and privacy considerations.

(ii) The provision of referrals and resources to complaining employees and individuals who are the subject of complaints, including to appropriate law enforcement.

(iii) The policies and procedures developed by the office under section 2112(1).

(iv) Trauma-informed systems of response, investigation and resolution.

(v) The anticipated roles of employees and elected officials in the complaint, investigation, hearing and resolution process.

§ 2132. Schedule.

The office shall conduct the training programs developed under section 2131 (relating to development of training programs) as follows:

(1) For an elected official, within 30 days following the election of the elected official and annually thereafter at such dates and times as the director shall determine. It shall be a condition of being sworn in and seated that the elected official shall have completed the training program required by this paragraph.

(2) For employees, annually at such dates and times as the director shall determine. The office shall conduct training for an employee hired after the effective date of this section within 30 days following the commencement of employment by the

employee. It shall be a condition of continued employment that an employee complete the training program required under this paragraph.

(3) For employees of the office, prior to being assigned any work related to a complaint filed under this chapter.

Section 2. The addition of 46 Pa.C.S. Ch. 21 shall apply to conduct constituting a violation of 46 Pa.C.S. § 2104 or 2105 which occurs or is alleged to occur on or after the effective date of this section.

Section 3. This act shall take effect in 60 days.

### MOTION TO SUSPEND RULES

The SPEAKER. Okay. This is a late-filed amendment. It is a late-filed amendment. Representative Krueger is going to offer a motion to suspend because that is what you have to do if it is a late-filed amendment, and as I said, it is amendment 03272.

So, Representative Krueger, if you will state the motion. Please proceed to make your case for the motion, and then I will see where the respective leaders are and the maker of the bill. And remember, it is a suspension motion, I believe. Go ahead, Representative

Ms. KRUEGER. Mr. Speaker, I offer the motion to suspend the rules. My amendment would allow us to finally address the way that we handle allegations of sexual harassment in this legislature. Sixteen months ago in the face of multiple allegations of sexual harassment, assault, and even rape against then sitting legislators, the action that we took was to require a study of sexual harassment and misconduct in the workplace. In June that report came back and it showed that over the past 5 years a total of 554 claims of sexual harassment and misconduct were reported by staff of State agencies. At that time over \$1.9 million in taxpayer funds were used to settle these complaints. Then, Mr. Speaker, in August the Dauphin County grand jury—

The SPEAKER. Now, Representative Krueger, just on the motion to suspend. Okay.

On the question,

Will the House agree to the motion?

The SPEAKER. So at this time – and once we have the vote on the motion to suspend, if the amendment is in front of us, you will have far more latitude.

So at this time does anybody else wish to speak on the motion to suspend, just on the motion itself?

Representative Marcy Toepel, on the motion to suspend.

Mrs. TOEPEL. Thank you, Mr. Speaker.

I would ask members to oppose the motion to suspend. This amendment substantially changes the underlying bill, and I would ask members to oppose the motion. Thank you.

### AMENDMENT WITHDRAWN

The SPEAKER. And on the motion to suspend for a second time, Representative Krueger.

Ms. KRUEGER. Mr. Speaker, in light of the gentlelady's opposition, I will withdraw this amendment, but I do want to point out that this bill, HB 1000, was referred to the State Government Committee on April 2, 2019. I will withdraw this

amendment today in hopes that we can have a real conversation very, very soon about how this chamber addresses allegations of sexual harassment against sitting members.

Thank you, Mr. Speaker.

The SPEAKER. Okay. So that is withdrawn, and there are no other amendments on HB 1803, PN 2567.

The SPEAKER. Yes. Thank you so much, Representative Miller.

I have talked to the Parliamentarian. You certainly may vote on them. You are a member of a class. You are not voting this with respect to you specifically. It is perfectly appropriate for you or any other volunteer or active – I do not know that anybody else is a paid volunteer here – I mean, a paid firefighter here in our chamber, but I do think there are other volunteer firefighters. Each and every one of you may vote on these bills. Thank you for asking, Representative.

Mr. D. MILLER. Thank you, Mr. Speaker.

### **STATEMENT BY MS. ULLMAN**

The SPEAKER. Representative Ullman, the floor is yours.  
Ms. ULLMAN. Thank you, Mr. Speaker.

Last May I was visited by the Council of Southeast Pennsylvania, a pro-advocacy leadership program. They were informing me of a prescription drug concern that experts say has grown in the shadow of the opioid epidemic. That is the increasing use of benzodiazepines, accompanied by an increase in overdose deaths including benzos.

I was informed of this growing crisis through the moving story of a woman who came to tell me the tale of her use of benzodiazepines which resulted in tragic dependency and near death. This woman had been prescribed Klonopin for multiple sclerosis and 12 years later was completely dependent upon this prescription medication. Her increasing dosage made her bedridden, her health compromised, her memory affected. Even today, she is totally weaned off her medication, but she suffers long-term cognitive effects.

Even more tragically, during her 12-year battle trying to wean herself off of Klonopin, this addictive benzodiazepine, her son began taking her Klonopin and he himself became dependent on benzodiazepines and he turned to heroin and died of a heroin overdose in combination with benzos.

This is a combination of drug effects, which is starting to creep up in Pennsylvania and frequently with tragic results. Benzodiazepines, commonly known as benzos, are a highly addictive class of prescription medications. They are used as sedatives and muscle relaxants, and they include such well-known brands as Xanax and Valium.

A benzodiazepine dependency can be developed within just weeks of use. Due to increased usage, it is vital that Pennsylvanians be aware of the signs and symptoms of benzodiazepine dependency. Once an individual is dependent on this drug, any of these drugs, they can demonstrate many physical, personal, and psychological symptoms, including slurred speech, drowsiness, rage, mania, reclusive behavior, loss of personal relationships, suicidal ideation, and sadly, some result in suicide.

Unfortunately, there is no quick fix for beating this dependency and treatment maybe lengthy, as gradual reduction is the most effective method in ending benzodiazepine dependency. As stewards of public health and safety, we must encourage every person to learn more about this class of drugs and the appropriate use to avoid misuse and dependency and be informed about the side effects of treatment. As such, I introduce this September as Benzodiazepine Recovery Month. This is the resolution I am introducing, designating the month of September 2019 as "Benzodiazepine Addiction Recovery Month" in Pennsylvania.

"WHEREAS, Benzodiazepines, more commonly known as "benzos," are a prescription sedative class of drugs that can be highly addictive; and

"WHEREAS, More than 30% of overdoses involving opioids also involve benzodiazepines; and

"WHEREAS, Benzodiazepines raise the level of the inhibitory neurotransmitter GABA in the brain, which helps relax the nervous system; and

"WHEREAS, Common examples of benzodiazepines are diazepam (Valium), alprazolam (Xanax) and clonazepam (Klonopin), which can be prescribed for anxiety, insomnia, alcohol withdrawal, seizure control, muscle relaxation, including amnesia for difficult procedures and given prior to anesthetic; and

"WHEREAS, Benzodiazepine abuse is very common due to widespread availability of the drugs, which can lead to toxic effects and accidental overdoses; and

"WHEREAS, Symptoms of benzodiazepine abuse include weakness, blurred vision, drowsiness, poor judgment or thinking, mood changes and other risk-taking behaviors; and

"WHEREAS, There are a wide range of other symptoms an individual facing benzodiazepine addiction may experience including mania, slurred speech, panic attacks, impaired coordination, fatigue, vertigo, hostility and increased risk of suicide; and

"WHEREAS, An individual can quickly develop a tolerance to benzodiazepines, thus requiring more of the drug to feel the same effects, allowing addiction to develop in as little as a few weeks; and

"WHEREAS, Benzodiazepine addiction recovery can be a long process, involving physical stability, substance withdrawal, trauma treatment, peer support, healthy coping mechanisms, rebound anxiety, co-occurring disorders, family and aftercare; and

"WHEREAS, An effective recovery is possible given the proper support and communication between all involved parties; therefore be it

"RESOLVED, That the House of Representatives designate the month of September 2019 as 'Benzodiazepine Addiction Recovery Month' in Pennsylvania and encourage all Pennsylvanians to learn more about the adverse effects of benzodiazepine addiction."

Thank you, Mr. Speaker.

The SPEAKER. Thank you, Representative Ullman. And as those watching know, HR 492 was passed today unanimously.

### STATEMENT BY MR. NELSON

The SPEAKER. Oh, Representative Eric Nelson is recognized on unanimous consent.

Representative Nelson, the floor is yours, sir.

Mr. NELSON. Thank you, Mr. Speaker.

Today I rise to thank my colleagues for their unanimous vote recognizing "Domestic Violence Awareness Day" in Pennsylvania.

Domestic violence has many facets, and, Mr. Speaker, specifically today I rise to draw awareness to teen dating violence. Surveys show that about 40 percent of 11- and 12-year-olds report that their friends have been victims of verbally abusive relationships, and this includes electronic abuse. Within teen dating relationships, a full third of them have been text messaged 30 to 40 times an hour by a controlling boyfriend or girlfriend wanting to know where they are, what they are doing, what they are wearing, or whom they are allowed to be with.

Mr. Speaker, as a father of six children, five of them being current teenagers, our house is a rather busy place, but my wife, Susan, and I are keenly aware of the importance of teen dating violence. Many think it cannot happen to them, but unfortunately, Mr. Speaker, 12 years ago the daughter of one of my constituents, Demi Brae Cuccia, had just turned 16 years old. I myself have a daughter who just turned 16 years old. When Demi Brae broke up with her boyfriend, he came to their house and stabbed her to death in their kitchen. This horrific crime, Mr. Speaker, occurred because of an unknown situation that the parents were not aware of.

Since then, Gary and Jodi Cuccia created the Demi Brae Cuccia Awareness Organization to increase awareness for the importance of the warning signs of teen violence. They have trained thousands of students within our region to help establish expectations, warning signs, and unacceptable behavior. It is an honor for me to both remember Demi Brae and salute her parents for what they have done to try to help all of us be aware.

I encourage all parents, Mr. Speaker, who have teens that are dating, that they should either have a finger password or a face recognition access to their son or daughter's phone; that they should realize that Snapchat itself does not record the history of those messages, they are blocked out, and so a parent needs to be

vigilant, Mr. Speaker, to make sure that their son or daughter is not heading down the pathway of what could be a tragic ending.

So thank you for the time. Thank you to the members of the House for your support in domestic violence awareness. Thank you, Mr. Speaker.
