We are now going to proceed to swear in our new Comptroller, Jennifer A. Benko. She and her family are sitting here in the well of the House. Members, please take your seats.

Members, please take your seats. We are now proceeding to swear in our new Comptroller. The Sergeants at Arms, please clear the aisles. Members, please take any conversations off the back of the House.

ELECTION OF COMPTROLLER

The SPEAKER. Pursuant to Act 104 of 1979, the Bipartisan Management Committee has unanimously selected Jennifer A. Benko as the Comptroller of the Pennsylvania House of Representatives. This act also provides that the Bipartisan Management Committee's nominee must be confirmed by a two-thirds vote of the House.

On the question of the confirmation of Jennifer A. Benko as the Comptroller of this House, the Chair recognizes the Republican leader from Centre County, Mr. Benninghoff.

Mr. BENNINGHOFF. Thank you, Mr. Speaker.

It is with great honor and joy that we stand on behalf of the House Republican Caucus and I want to welcome our new Comptroller to the General Assembly, Jennifer Benko. Jennifer, you were unanimously voted on by the Bipartisan Management Committee, and we want you to know that we stand with you and we want you to be successful.

To your family, it is a great honor to have you here as well, and I hope that you are just as proud of Mom and wife of her accomplishments, and we suspect she will do very, very well. I would be remiss to not acknowledge Alexis Brown, who also joins us — a tough pair of shoes to follow. She gave her 40 years of service here to the Commonwealth. But we know that you are going to do very well. I remember very adamantly in our interview with you, and I thought, this is the kind of person we need, and we are very glad about that.

We also want you to share with us some of your suggestions and things to make the position go well, and working with your staff, we remain here to support you. Your work as a school business official has really put you on the front lines of financial management and compliance, some of the very issues that we will deal with here in the General Assembly.

As with many folks who work in the school setting, you have also had to be a jack-of-all-trades and a master of debt financing. What a good time to be coming here. You have had to answer a lot of tough questions from the public and oversee facility management and maintenance as well. Your background in the private sector reflects the ability to be nimble and take large tasks on, especially when it comes to government accounting, and we are looking forward to your accounting and your auditing abilities to share with us here in the General Assembly.

We are glad that you are on board. We welcome you wholeheartedly and we welcome all your contributions and your ideas. While we may not always agree on issues, we are open to hearing suggestions. To you and your family, we say thank you very much for joining us, and congratulations for becoming the new Comptroller here to the House of Representatives.

The SPEAKER. The Chair thanks the gentleman and recognizes the Democratic leader, the gentleman from Allegheny County, Representative Dermody.

Mr. DERMODY. Thank you, Mr. Speaker.

Mr. Speaker, the Comptroller of the House is responsible for ensuring that the House accounts are in good order, the records are maintained, and that the payroll and other expenses are carefully tracked. The Comptroller operates largely behind the scenes, but it is a critical position for the proper functioning of everything else that we do here.

Like almost every other public agency, we are funded by taxpayer dollars and we are entrusted to use those dollars wisely and efficiently, and that requires attention to detail as well as the vision to make plans for the future. Not only does this person need the ability to evaluate numbers very closely, they also need to recognize the unusual demands of our institution, for each one of the members who serves here is elected to represent more than 60,000 people. It is the Comptroller's role to manage cash flow, to ask questions, and sometimes even to say no. It is important that the House choose a person for this role who is capable, trustworthy, and resolute.

Mr. Speaker, I believe Jennifer Benko is the right person to be our new Comptroller. She has years of experience as an auditor for leading private firms here in Pennsylvania, and not only was she a senior auditor for outside audits conducted on the General Assembly's financial statements and checkbooks, she also conducted audits of many other State and county government agencies. That background equipped Jennifer Benko with an understanding of the special environment in which we work. She is familiar with the challenges that come with public service. She knows the importance of making sure that financial data is reported clearly and accurately.

For the last 7 years she served at Dover Area School District, first as director of accounting services, and then as business manager. Doing this work for a large school district even further prepared Jennifer for the work she can now do for us. I believe we can make a wise choice today and be well served in selecting Jennifer Benko. I look forward to working with you, Jennifer, as we complete this year's session and prepare for the work we must do in the future years, while we are facing some very, very challenging circumstances. It will not be easy work, but I know you are eager to get started, and, Mr. Speaker, I urge a positive vote. Thank you.

OATH OF OFFICE ADMINISTERED TO COMPTROLLER

The SPEAKER. The oath of office to the Comptroller-elect will now be administered by the Honorable J. Andrew Crompton, judge, Commonwealth Court of Pennsylvania.

Judge Crompton is no stranger to many of us here in the House. Prior to taking his seat on the court earlier this year, Drew served as chief of staff to the President Pro Tempore Joe Scarnati and general counsel to the Senate majority caucus. Drew also served as chief of staff and counsel to Scarnati in his capacity as Pennsylvania's Lieutenant Governor. He was counsel to President Pro Tempore Robert Jubelirer from 1994 to 2006.

Drew currently serves on the Pennsylvania Supreme Court's Appellate Court Procedural Rules Committee. He coaches girls basketball for the Cumberland Valley Youth Basketball Association and is captain of the West Shore Country Club Men's Tennis Team. He is a 1993 graduate of Widener University School of Law and a 1990 graduate of Dickinson College.

FAREWELL ADDRESS BY MR. TOBASH

The SPEAKER. I will please ask members to please take your seats. As we wind down session, it is customary that we allow members to take a brief time to share some of their experiences while they were here in this chamber, and prior to the break, we will recognize Representative Mike Tobash.

Representative Tobash is serving in his fourth term as the Representative from the 125th Legislative District. He serves on the Agriculture and Rural Affairs, Education, Insurance, and Liquor Control Committees. He also serves as a deputy Policy chair for the Policy Committee.

Mike is very active in his community and currently serves as an ex officio member of the Penn State University Schuylkill Advisory Board and is a charter member of the Tri-Valley Lions Club. He is also a member of the National Rifle Association, Valley View Gun Club, Good Intent Fire Company, Friedensburg Fish and Game Association, and Trout Unlimited. Mike and his wife, Amie, reside in Pottsville with their daughters, Lexi and Mikaela.

Representative Tobash.

Mr. TOBASH. Thank you, Mr. Speaker.

I appreciate the opportunity to address the General Assembly. It is a big day. There are many people, friends and constituents, that had sent me notes and well wishes, and I really appreciate the opportunity. I really could tell it is a big day because this morning when I got up, on my sink I had this note from my wife, Amie, who is joining us today. Amie, do you remember what it says? It says, "Good luck. Call the plumber." So I negotiated with the plumber on the way down here. I think we are going to be okay.

I also want to thank the 60,000 or so constituents that have given me the chance to enjoy the opportunity to serve. When you sit there in those seats – and I visit mine frequently – you get to admire Pennsylvania's past, the history that exists within this

great hall and the architecture and the murals; behind us "The Apotheosis of Pennsylvania" with William Penn, Benjamin Franklin, Daniel Boone, Thaddeus Stevens. There is a passage that is included and it says, "Remember the days of old, consider the years of many generations...." But from this perch, you have an opportunity to see Pennsylvania's future. From here you can see the talents and the dedication that you all bring to your service. Seeing that tells me that the future of Pennsylvania is actually very bright, not only do we have incredible natural resources and we are close to many of the population centers in this country, but we have a robust, thoughtful, engaged legislature that is leading the way. The problem-solving skills of the tradesmen, the assertiveness of the lawyers, the compassion of the teachers, the practicality of the accountants, the discipline of our servicemen – all represented here within you and by you.

How about my good friend, Jerry Knowles, who I think has been most of those things at one point in time. In fact, we were at an event over the weekend and Jerry started going down through the list of his different positions, from drafting to police officer, mayor, county commissioner, grocery store owner. I said, "Wow, Jerry, you've got a ton of experience," and he said, "Well, I just really had difficulty holding down a job."

The thing that is amazing to me is how much we are the same with all our varied experience. I came across a quote the other day and it says, "We may have all come on different ships, but we're in the same boat now." Working through the process is something that makes us all very much the same.

It was just a little less than 10 years ago I was honored to win a campaign for this seat in the House. My oldest daughter, Lexi, who was 15 years old, and Mikaela – who is being joined by her friend, Nate, the young, youthful mayor of Tamaqua – was 9 at that time. I can remember her soccer team. They were our campaign parade on-the-float cheering group. When I think about it now, I can tell you we loved every minute of it. My beautiful wife, Amie, is here as well, as she has been every step of the way. When I talk about how different and unique we are in our perspectives, we are surely the same in how deeply we understand the sacrifices that family makes. My girls have grown into beautiful and thoughtful young women, and Amie has mentored them every step of the way. I love you guys very much.

In this time, I have lost some of my biggest supporters. My mother-in-law and father-in-law and my father have passed away; my mom is sidelined today, watching from home with a broken ankle. But after 10 years, I think I have come full circle in this idea of understanding how much we are all alike.

I can remember at the very beginning you have a special bond with your freshman class, and ours was the class of 2010. We endured the same campaign struggles. We were confused by the first leadership election that happens about 10 minutes after you enter the building. We were disappointed that there are not more seats at the table. And then geography, our backgrounds, campaign promises, constituent concerns – they all get in the way a little bit. But we do have this one common bond, and that bond is that we all want to have a chance to change the rules when people we represent are not satisfied with the outcomes. And that is our awesome responsibility. That is our service. Very few people ever get the opportunity to change the laws, and it is something that is very important and humbling.

We are the same on commonsense ideas like not higher taxes, why borrow when there is cash, how about growing our economy, supporting students toward rewarding careers. When you have the honor to serve, then you understand that the issues

that often seem very simple – and they are very simple – are not so easy to fix.

And how about the process. At times it is maddening if nothing else. On a session day you look at the calendar, and to your surprise, legislation that you have opposed is being voted and some that you have championed is over for the day with no vote in sight. I can tell you, it can be frustrating.

You have people that have become your very best friends, whom you want to high five one minute, choke them the next, and hug them soon after that. At times we debate minor details for hours and substantive change for only a few minutes. But that process, and the fact that I have been so fortunate to be a part of it, is something I will always be proud of.

But as with so many things that we do, the people and the friendships are really what matters, like our little hole in the wall, "the bunker." There are some great memories in those humble surroundings. We never got out of the basement, but we definitely hosted some terrific meetings. Legislative issues vetted by our legal staff, including friends like Jim and Rod, Jill, Alli, and Ashley.

Our friends from early on, Masser, Heffley, Kampf; in fact, a few of us took a trip not so long ago, and as I was leaving, Amie said, "Remember, you are the adult in the room." So I was proud to be the adult in the room, and then I thought, wait a minute. I am not sure that is a compliment. Stephens, Heffley, and Masser – you do not have to be that grown-up to be the adult in that room.

I gave you a picture, Mr. Speaker. You see I am being ignored by the caucus administrator.

So we talk about differences. Todd Stephens and I-you know, it is kind of weird when you get assigned a roommate like in college or at camp or in the Pennsylvania House. Todd and I have differences. Todd says one day to me, "I'm going to be the Humane Society Legislator of the Year," and I said, "Well, I'm from Schuylkill County, not likely to be the Humane Society's County of any year." And Todd, he is often the passionate voice in favor of what almost everyone else in the caucus is not going to vote for. But I could not have possibly shared office space with a more thoughtful, dedicated, and effective legislator. Todd is truly a very good friend.

And how about my friend, Kurt Masser. It is time to put the paper back up, Kurt. When you talk about knowledge - I talked about it earlier - Kurt has tremendous knowledge, but it is mostly about different types of meat, like kielbasi and soupies and torpedoes. He knows so much about that.

I want to say that it was a number of years ago – Kurt said that he wanted to be the caucus administrator, and he said, "And if I get back from my cruise on time next year, I'm going to run for the office and I'm going to give you a great seat on the floor of the House." I have to tell you that Kurt's skill as a caterer and restaurant owner make him an outstanding administrator.

And how about our good friend, Doyle Heffley. Have you ever stopped to wonder what is going on in Doyle's head? So I know, actually, because I hear – it is that Geico commercial with the camel – it is, "Mike, Mike,

Mike, Mike, Mike, Mike, Mike, what day is it?" And I am like, "Doyle, it's Tuesday. Let's save it for tomorrow." He also does this little impersonation of me that I do not get. Some people think it is funny, I will see if I can do it. It goes like this, "Pension, pension, pension, pension, pension, pension, pension, pension,

pension, pension." I do not really understand it, but I want to say this, that these guys are the best of my friends, as many of you are here.

And in closing I will mention that Amie is not a huge fan of public thank-yous, so I will be brief. My tremendous support, the support that I have had from leadership to communications to committee staff. Within our office – we have our guests from the district in here – Tya and Nicole, Matt and Tarah; others that are willing to be roped into projects like Francesca, Jill, Susan Boyle, and many, many, many more. I am grateful for your support, your friendship, your competence, and your dedication.

To everyone that I have served with, I am proud to have served with you and to better understand how our differences have brought us together. I truly value our working relationship, your time, and our friendship. Thank you, and God bless you all.

STATEMENT BY MRS. ISAACSON

I was honored to introduce this resolution in celebration of the life and vital contributions of Justice Ruth Bader Ginsburg. R.B.G. was our gladiator of feminism and constitutional equality, and she will forever be missed, remembered, and honored for her contributions. While our beloved R.B.G. lived an incredible and noteworthy life, accomplishing many historic personal and public victories, so many people do not know or understand how many of her landmark decisions in cases affect all of us on a daily basis in each of our lives.

Let me remind you. If you are a woman in the United States and you have a bank account or a credit card in your own name, it is because of Justice Ruth Bader Ginsburg. If you ever purchased a home without having a man act as a cosigner, it is because of Ruth Bader Ginsburg. If you have ever served as a woman juror or alongside a woman during jury duty, it is because of Ruth Bader Ginsburg. If you, as a woman, have ever attended a State-funded school, it is because Ruth Bader Ginsburg required them to admit you. If you have never been discriminated against by your employer due to your gender or reproductive choices, it is because Justice Ginsburg told them that they could not legally do so. If you have received equal caregiver and Social Security rights and privileges as your male or female colleagues, it is because R.B.G. said that they had to. Women have the right to financial independence and equal benefits because Justice Ruth Bader Ginsburg fought and won them for all of us.

May her memory be a revolution we fight to ensure and that our Supreme Court continues in her legacy of extending rights to all citizens, not on restricting them. May this incredible icon rest in power. Thank you.

VETO OF HOUSE BILL

The Speaker laid before the House a communication in writing from the office of His Excellency, the Governor of the Commonwealth, advising that the following House bill had been vetoed by the Governor:

HB 2025, PN 3907.

Said bill having been returned with the following message:

Commonwealth of Pennsylvania Office of the Governor Harrisburg

September 24, 2020

TO THE HONORABLE HOUSE OF REPRESENTATIVES OF THE COMMONWEALTH OF PENNSYLVANIA

Pursuant to Article IV, Section 15 of the Pennsylvania Constitution, I am returning herewith, without my approval, House Bill 2025, Printer's Number 3907.

Addressing the global climate crisis is one of the most important and critical challenges we face. This legislation is extremely harmful to public health and welfare as it prevents the Pennsylvania Department of Environmental Protection (Department) from taking any measure or action to abate, control or limit carbon dioxide emissions, a greenhouse gas and major contributor to climate change impacts, without prior approval of the General Assembly. Like every state in the country, the Commonwealth has already begun to experience adverse impacts from climate change, such as higher temperatures, changes in precipitation, and frequent extreme weather events, including large storms, flooding, heat waves, heavier snowfalls, and periods of drought. Reductions in carbon dioxide emissions are even more significant now as emerging evidence links chronic exposure to air pollution with higher rates of morbidity and mortality from COVID-19.

This legislation also prohibits the Commonwealth from participating in the Regional Greenhouse Gas Initiative (RGGI), a regional initiative among Northeast and Mid-Atlantic states to reduce greenhouse gas emissions while generating economic growth, unless additional legislation is enacted. RGGI participating states have reduced power sector carbon dioxide pollution by 45 percent since 2005, while the region's per-capita gross domestic product has continued to grow. By joining RGGI, Pennsylvania has the opportunity to make real progress on limiting climate change – causing carbon pollution while generating thousands of new jobs, providing for worker training, and offering future electric bill savings.

In addition to the legislation's failure to address climate change, the immediate effect of this legislation would be to halt a rulemaking package I directed the Department to develop by executive order pursuant to the authority of the Air Pollution Control Act to abate, control, or limit carbon dioxide emissions from fossil-fuel-fired electric power generators. The Regulatory Review Act and the Air Pollution Control Act afford the opportunity for extensive public participation, including public comment and public hearings, in the rulemaking process. Members of the General Assembly also have a robust role in the rulemaking process, including through their appointments on advisory committees and the Environmental Quality Board. This legislation creates burdensome and duplicative processes that will thwart the Department's ability to take any action to regulate the greenhouse gas most responsible for climate change in the transportation, industrial, and commercial sectors, as well as the electric power sector.

The citizens of this Commonwealth cannot afford to wait any longer. Given the urgency of the climate crisis facing Pennsylvania, the Commonwealth must take concrete, economically sound, and immediate steps to reduce greenhouse gas emissions. Allowing this legislation to become law would effectively deny that climate change is an urgent problem that demands prudent solutions.

For the reasons set forth above, I must withhold my signature from House Bill 2025, Printer's Number 3907.

REMARKS SUBMITTED FOR THE RECORD

Mr. KAUFFMAN submitted the following remarks for the Legislative Journal:

Thank you, Mr. Speaker.

I appreciate my colleagues including my amendment in SB 1216. It was a critical addition. All children in Pennsylvania deserve a quality education, and to receive that education the children of our Commonwealth need to be in school when a school decides to resume in-person education.

The requirement for public schools to provide funding to transport children to charter schools is clear. Any time a child is receiving in-person education in a charter school, the public school shall provide transportation for that child. This funding is required whether or not a pandemic exists.

However, the transportation provisions for nonpublic, nonprofit schools is not quite as clear. This legislation will ensure that nonpublic, nonprofit schools who provide education to our children will receive transportation funding. SB 1216 ensures the certainty that funding for transportation will be provided to all school providers during the uncertainty of this pandemic.

As the 2020-21 scholastic year progresses, if more uncertainty arises regarding transportation of children to their school facilities, then we will return to address those problems. This issue for our nonpublic, nonprofit schools is immediate and we must ensure that the certainty of funding that has been extended to charter schools is now extended to nonpublic, nonprofit schools who are equally important to the educational system here in Pennsylvania. I urge a "yes" vote for SB 1216.

STATEMENTS BY MR. MURT

The SPEAKER. Moving on to comments regarding resolutions, the Chair recognizes the gentleman, Representative Murt.

Mr. MURT. Thank you, Mr. Speaker.

Mr. Speaker, I would like to speak on HR 949, which recognizes the month of September as "Military Service-Related Post-Traumatic Stress Injury Awareness Month" in the Commonwealth of Pennsylvania. Mr. Speaker, by passing HR 949, we have recognized one of the most demanding issues we face as many of our veterans return from the battlefield – Iraq and Afghanistan – with emotional, social, physical, and spiritual challenges. Mr. Speaker, as we know, many of our veterans are struggling to readjust to life outside the military. Some are always on edge and overwhelmed by feelings of panic. Others are known to explode at the slightest provocation. Still others are emotionally numb and disconnected from their loved ones. They have lost all sense of normalcy.

But, Mr. Speaker, for all too many veterans, these are common experiences. These are the lingering symptoms of post-traumatic stress disorder, PTSD. Mr. Speaker, it is hard living with untreated post-traumatic stress disorder, and with long VA (Veterans' Administration) wait times, it is easy to get discouraged. As a legislature, we must commit ourselves to helping the veterans in our communities receive the help they need. We must help those who feel lost receive the professional treatment they need. Post-traumatic stress disorder is not — I repeat — not a sign of weakness, but a symptom of an illness that can be overcome. Our vote today recognizes this. It also acknowledges that as a legislature, we are committed to making the lives of our veterans better, and, Mr. Speaker, this is the least we can do for those who have given so much to secure our freedoms.

While I am here, Mr. Speaker, I also want to express my gratitude for the passage of HR 950, which recognizes fetal alcohol syndrome. Mr. Speaker, the truth is, fetal alcohol syndrome affects more infants than spina bifida, Down syndrome, and muscular dystrophy combined. Fetal alcohol syndrome is a group of mental, physical, and neurological birth defects that are the direct result of alcohol use during pregnancy. And recognizing fetal alcohol spectrum disorders can be difficult. Early and accurate identification is key to receiving appropriate educational and mental support. Fetal alcohol syndrome covers a wide range of problems, including hyperactivity, heart problems, deformed limbs, poor social skills, problems with seeing and hearing, kidney defects, and delayed development in thinking, speech, and movement.

Mr. Speaker, what is so frustrating is that these conditions are easily preventable. According to the Centers for Disease Control and Prevention, as many as 5 per 100 babies are impacted by prenatal exposure to alcohol. Complicating this, more than 50 percent of the women of child-bearing age drink alcohol, while 10 percent actually drink alcohol while they are pregnant. By declaring September 2020 as "Fetal Alcohol Awareness Month" in Pennsylvania, we are taking an important step in educating women who consume alcohol and are or could become pregnant. Consuming alcohol, even the smallest amount, Mr. Speaker, can cause serious problems for a child. Today we send an important message that there is no safe amount of alcohol that can be consumed during pregnancy. Abstaining from alcohol during pregnancy is the surest way to prevent fetal alcohol syndrome.
